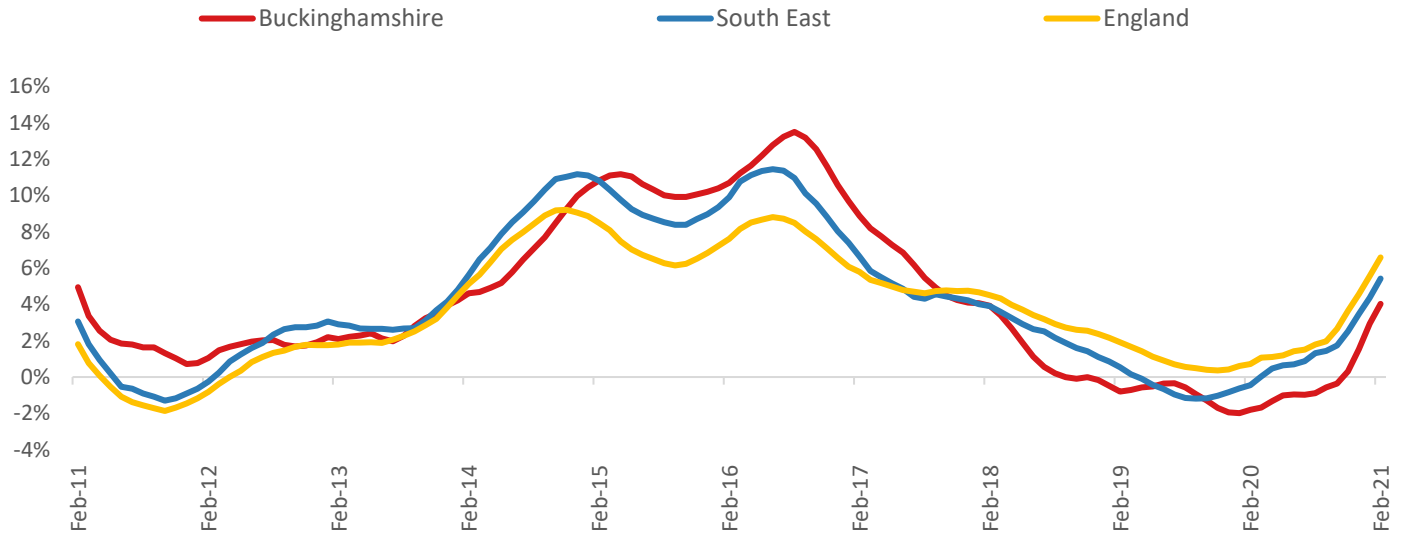

House Price Growth (February 2021 data)

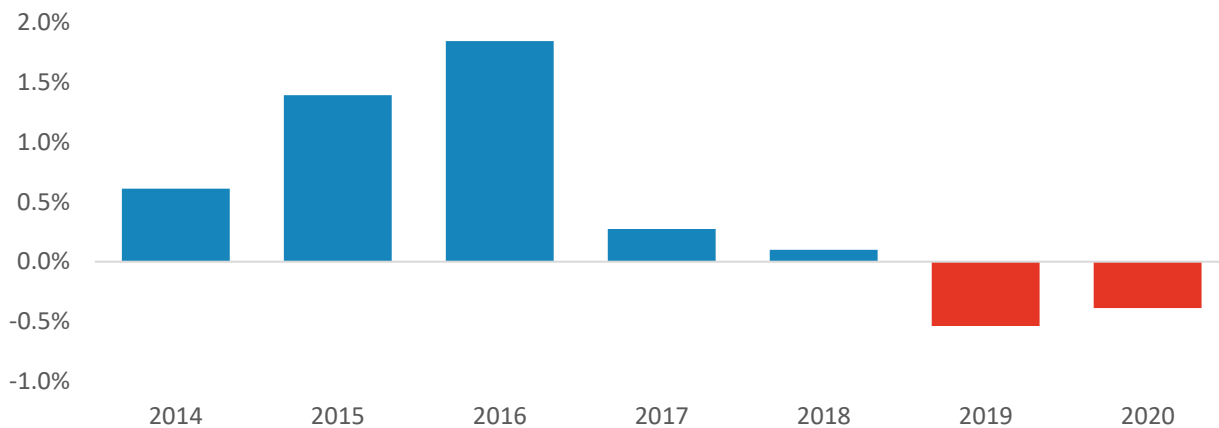
Annual Change in House Prices



House prices in Buckinghamshire grew by 4.0% in the 12 months to February 2021 (based on 6-month smoothed data). By comparison national house prices grew by 6.6% and prices in the South East grew by 5.4% over the same period.

Buckinghamshire house prices are now 42.9% above their previous peak in 2007, compared to +42.8% for the South East and +36.1% across England.

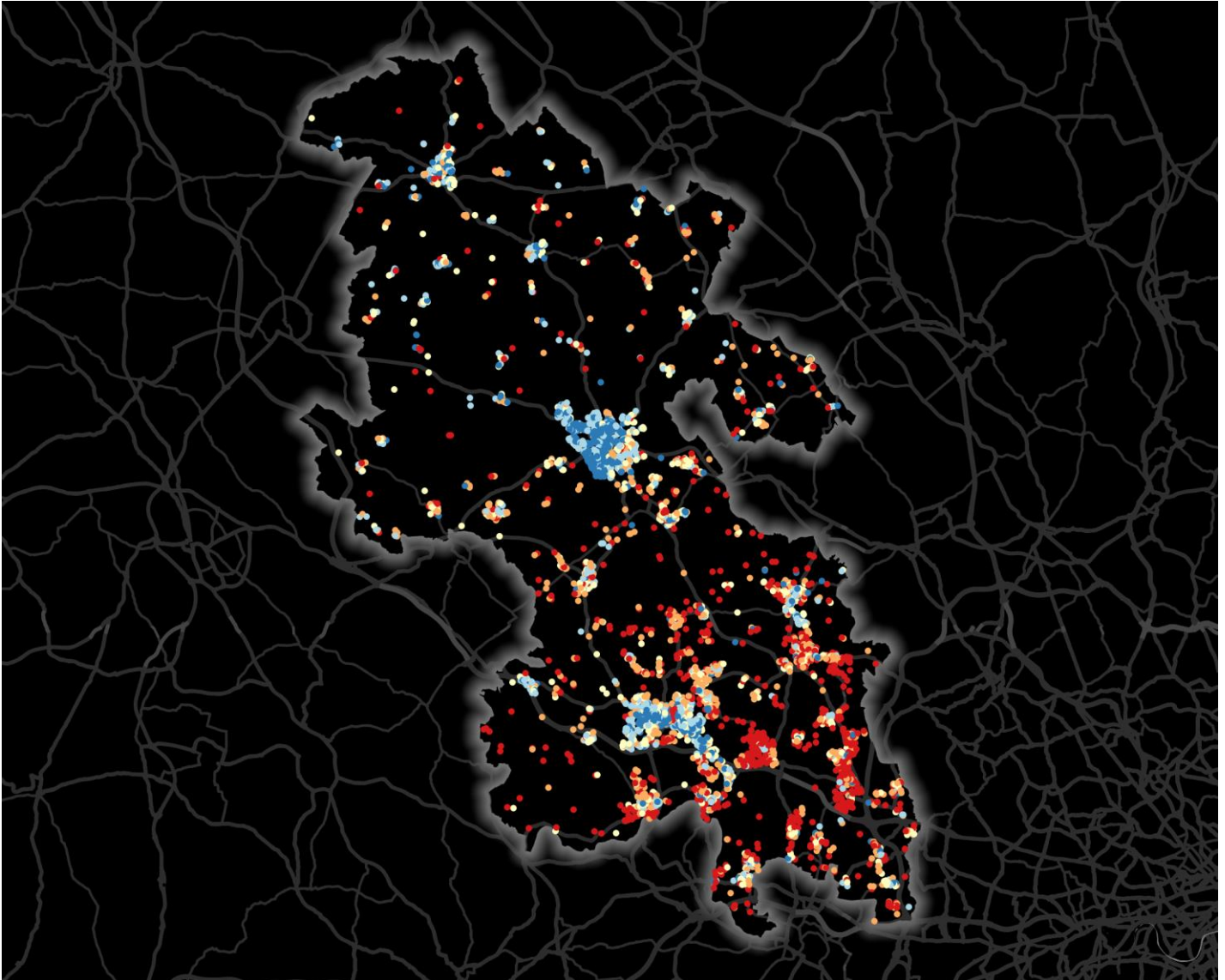
Year-To-Date Change in House Prices, December to February



Local prices have fallen by 0.4% in 2021 so far, compared to a fall of 0.5% over the same period last year.

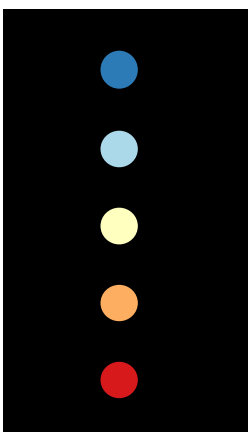
House Price Map

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

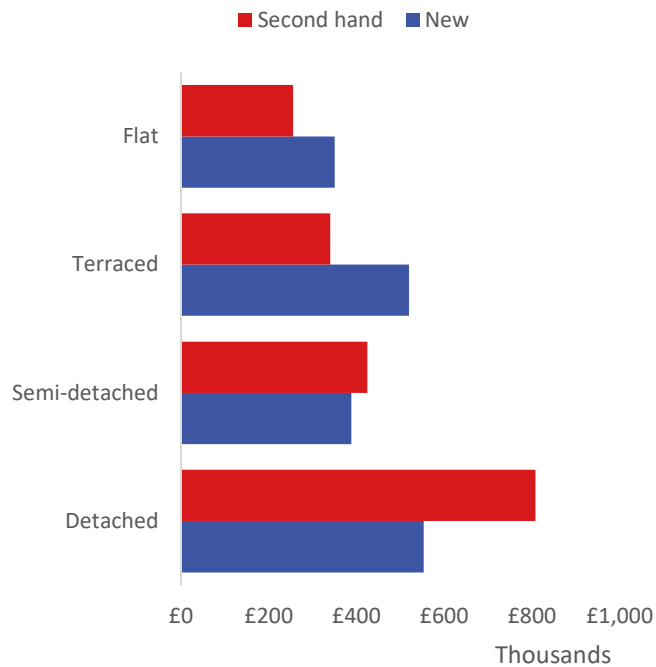

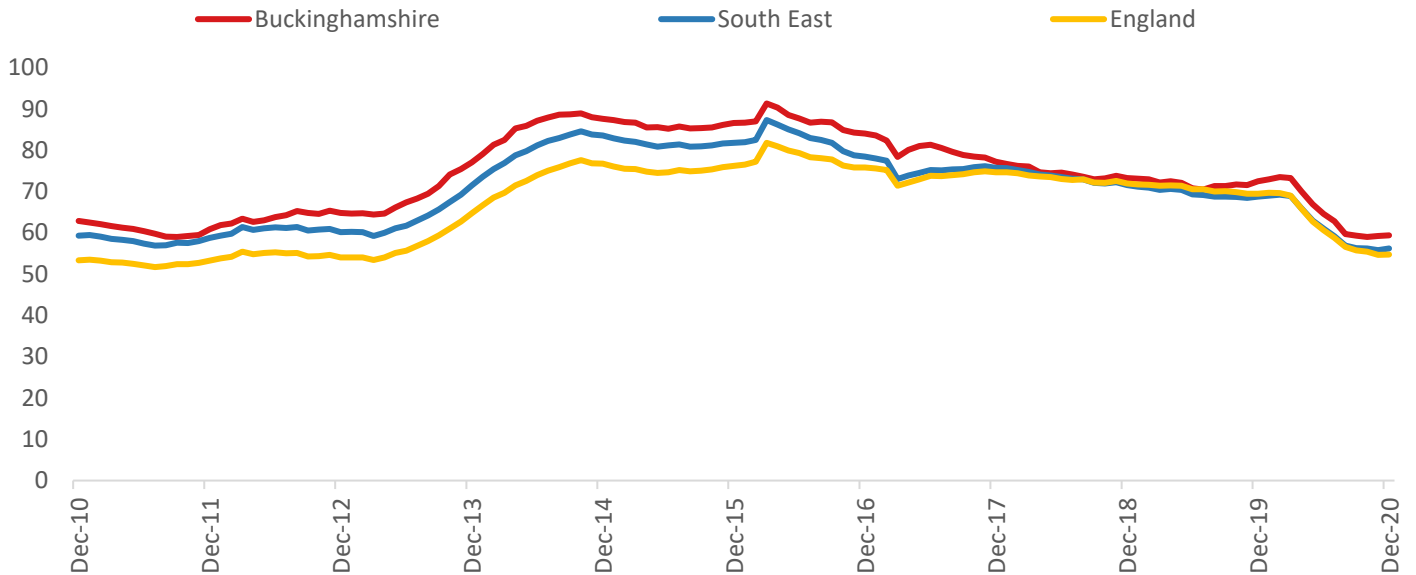

Transactions (December 2020 data)

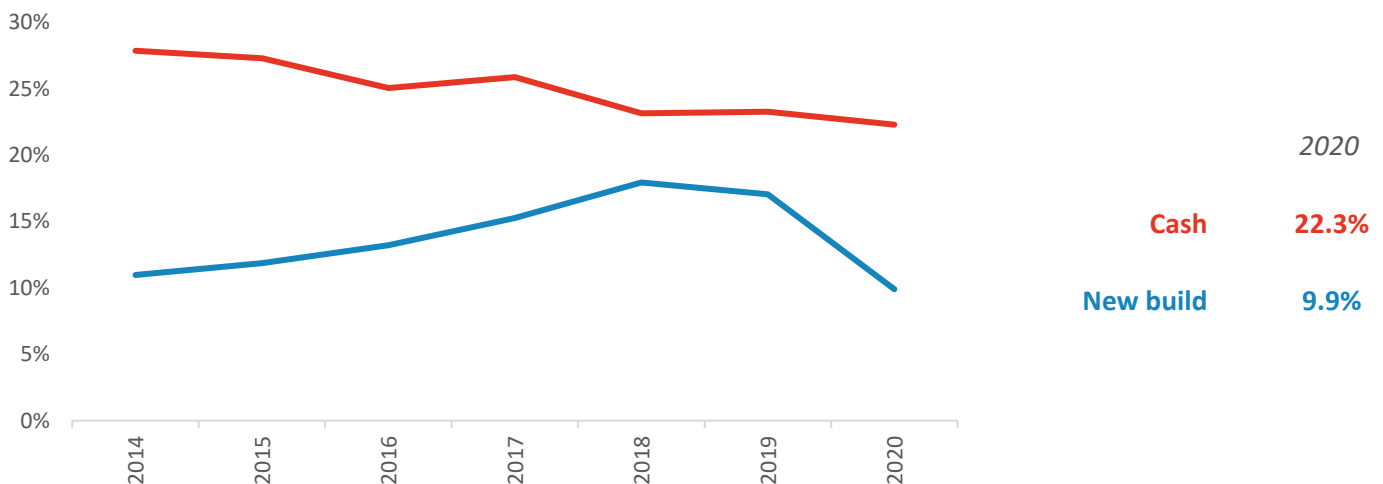
Annual Transactions, Indexed (2001-05 average = 100)



There were 6,649 transactions in Buckinghamshire during the 12 months to December 2020. This is 59% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Buckinghamshire have fallen by 32.2% since 2014, compared to changes of -32.8% for South East and -28.7% for England.

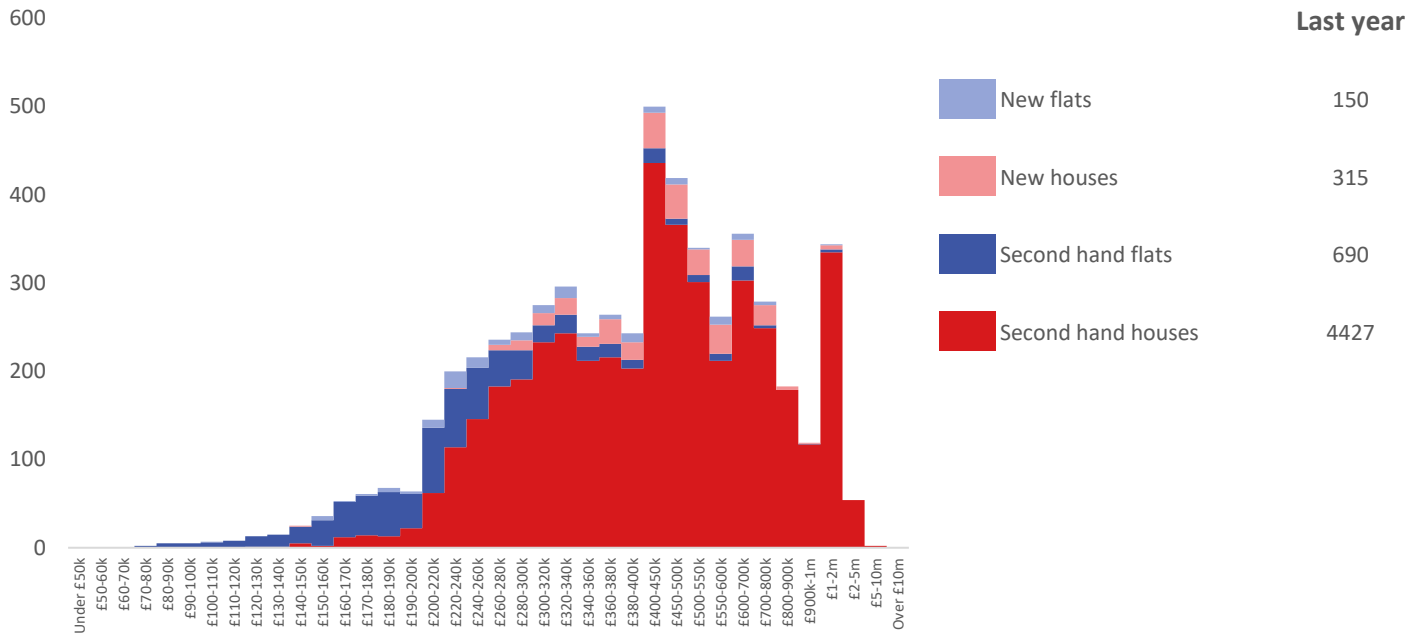
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

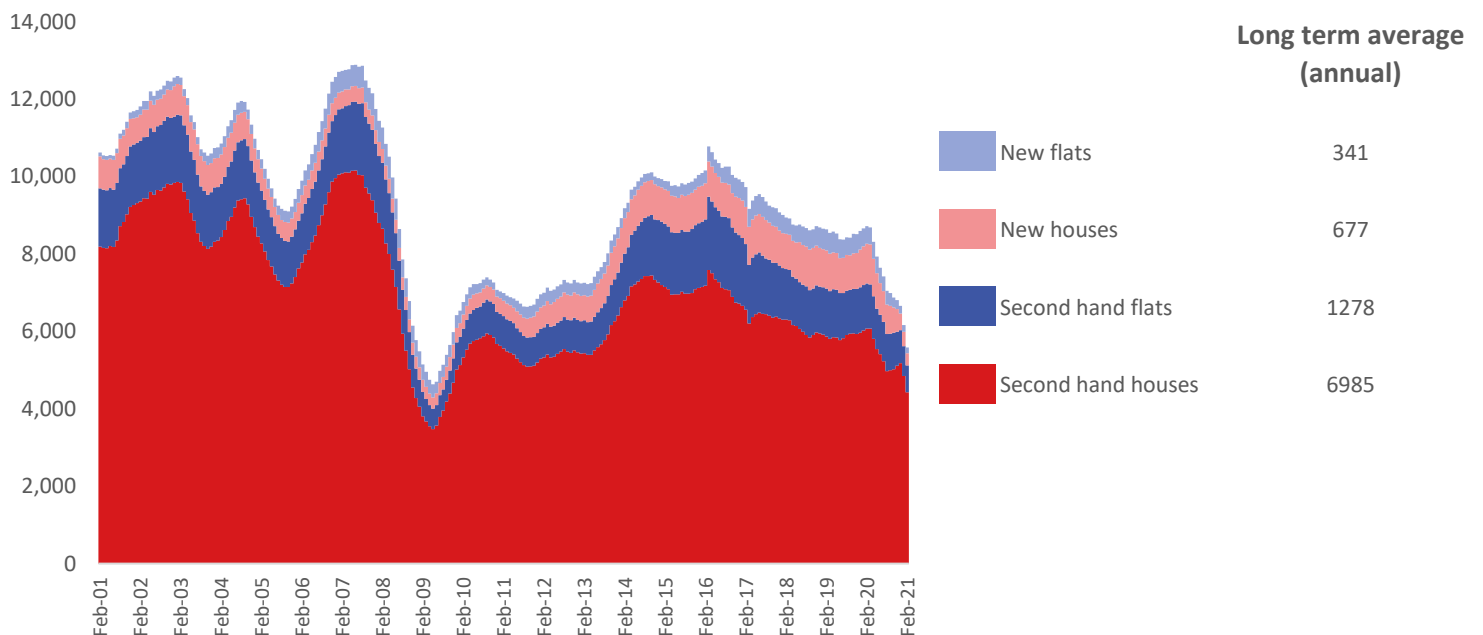
12 months to February 2021



The most common property type transacted over the past 12 months in Buckinghamshire was 'second hand houses' with 4,427 sales, 79% of all sales over the same period. The annual total of 5,582 transactions is equivalent to 60% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 6,985 sales per year on average, making up 75% of the typical annual total over that period.
