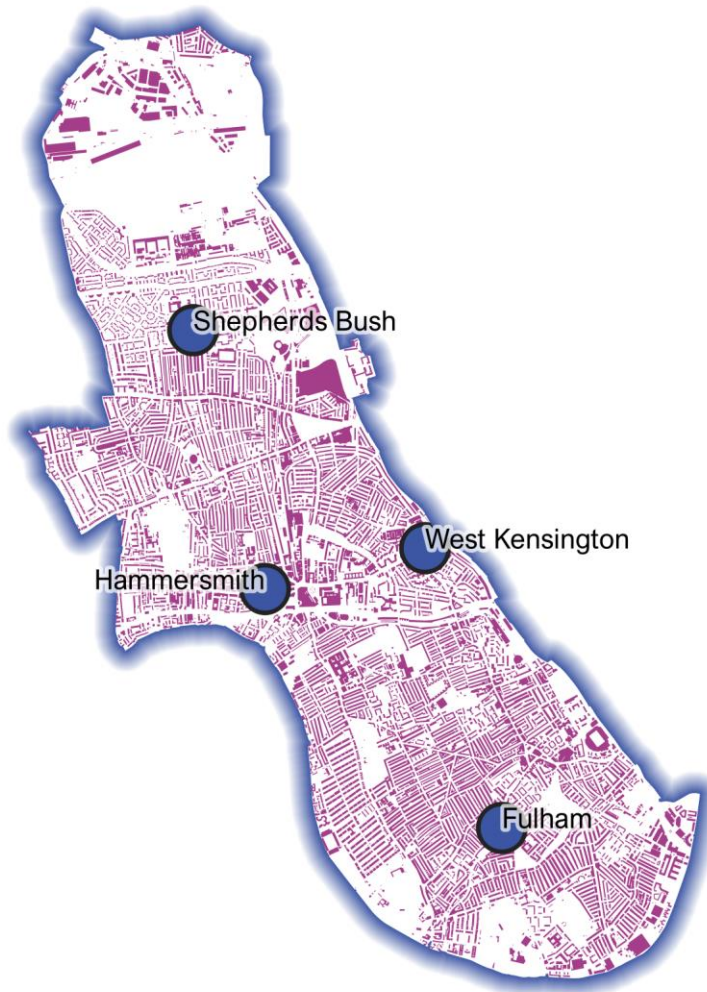

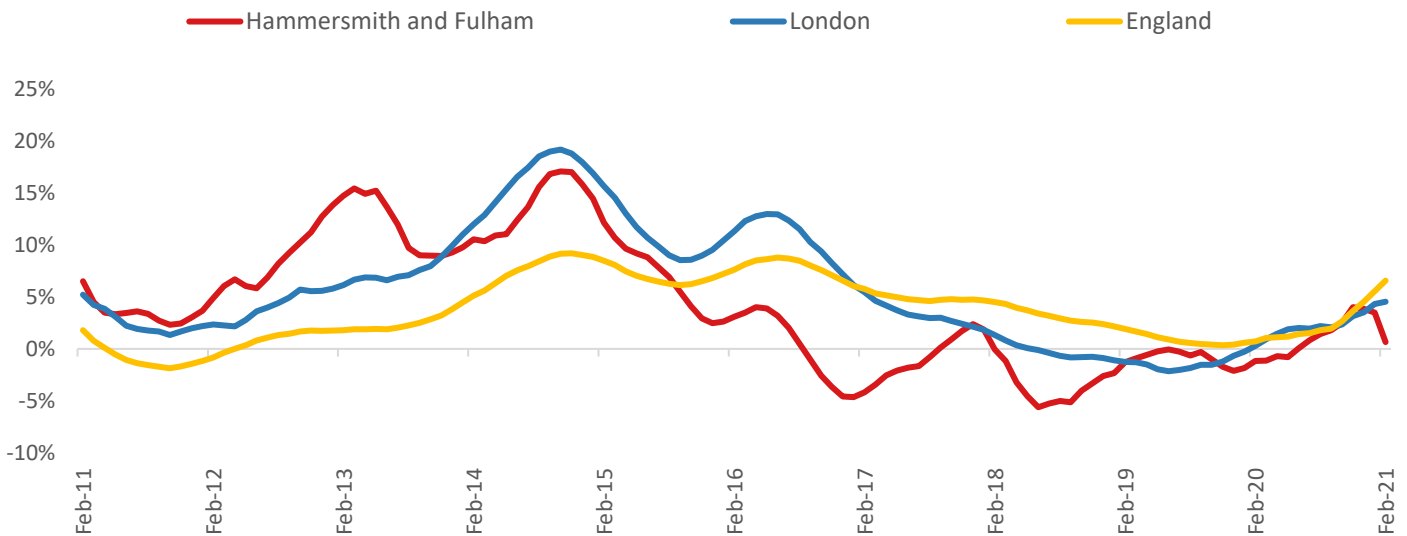

House Price Growth (February 2021 data)

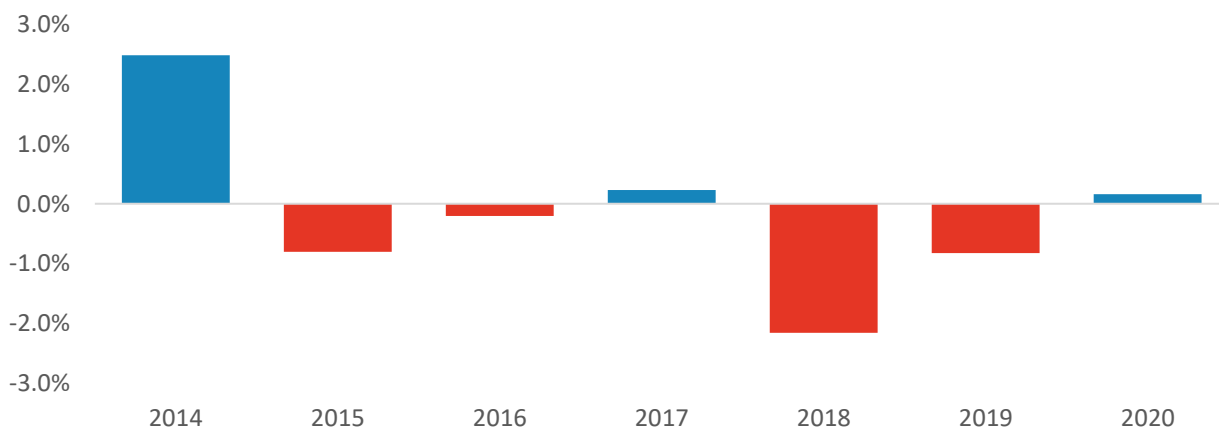
Annual Change in House Prices



House prices in Hammersmith and Fulham grew by 0.6% in the 12 months to February 2021 (based on 6-month smoothed data). By comparison national house prices grew by 6.6% and prices in London grew by 4.5% over the same period.

Hammersmith and Fulham house prices are now 43.4% above their previous peak in 2007, compared to +66.5% for London and +36.1% across England.

Year-To-Date Change in House Prices, December to February



Local prices have grown by 0.2% in 2021 so far, compared to a fall of 0.8% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

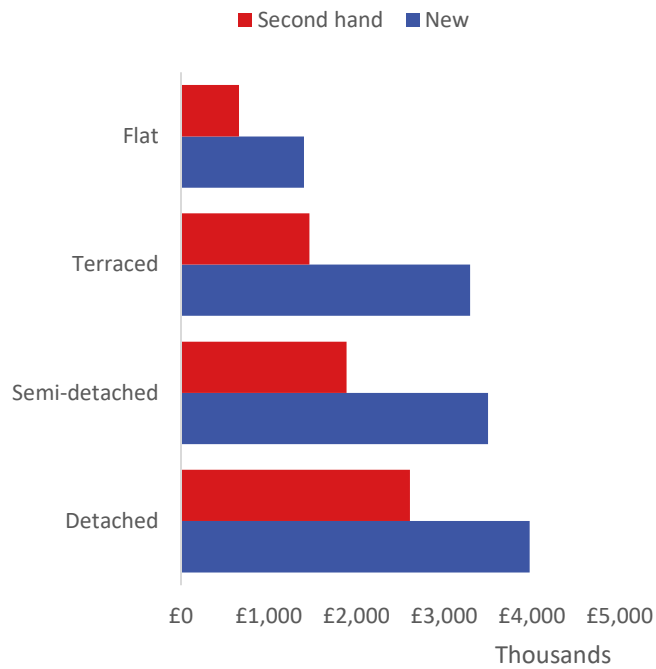

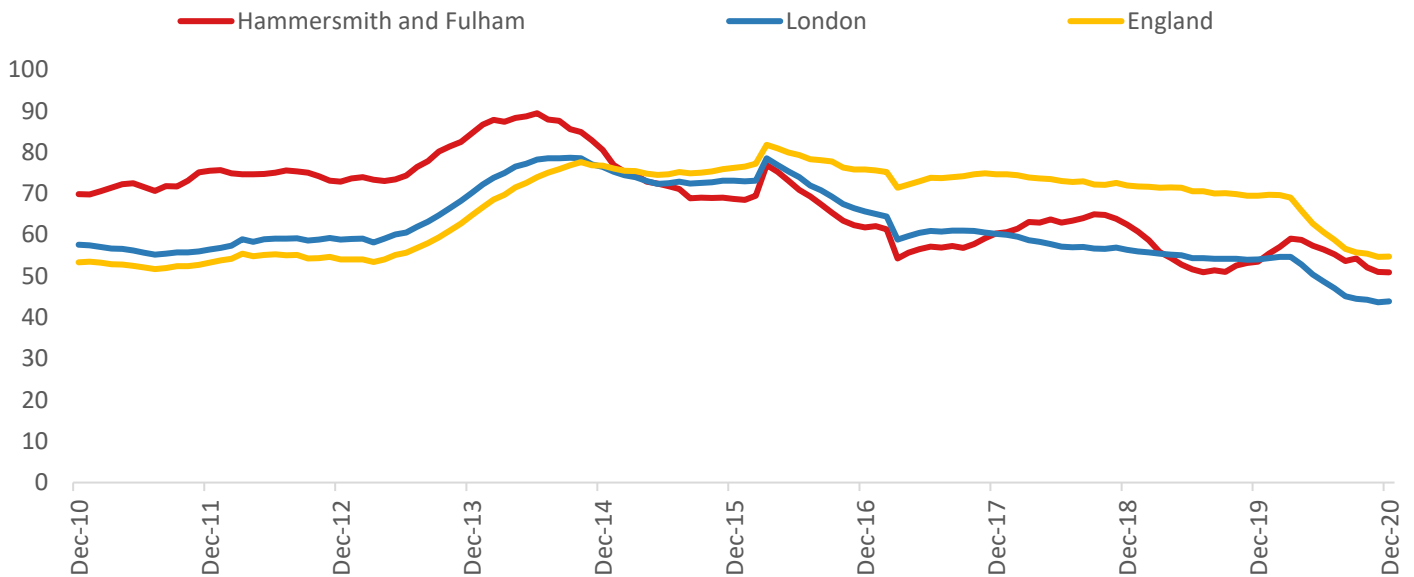

Transactions (December 2020 data)

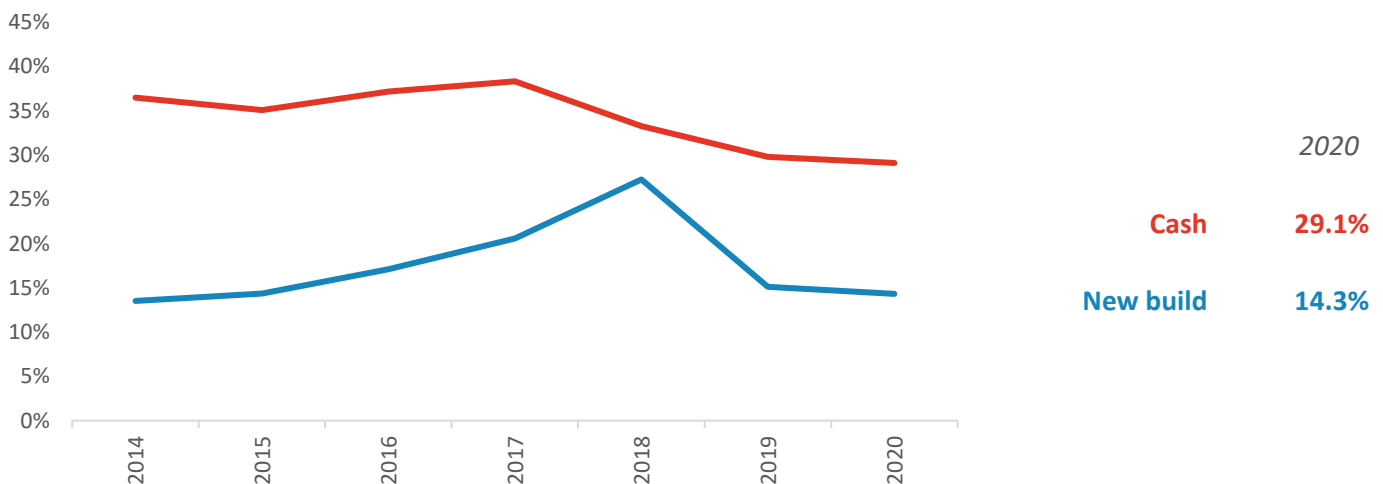
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,814 transactions in Hammersmith and Fulham during the 12 months to December 2020. This is 51% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hammersmith and Fulham have fallen by 36.8% since 2014, compared to changes of -42.6% for London and -28.7% for England.

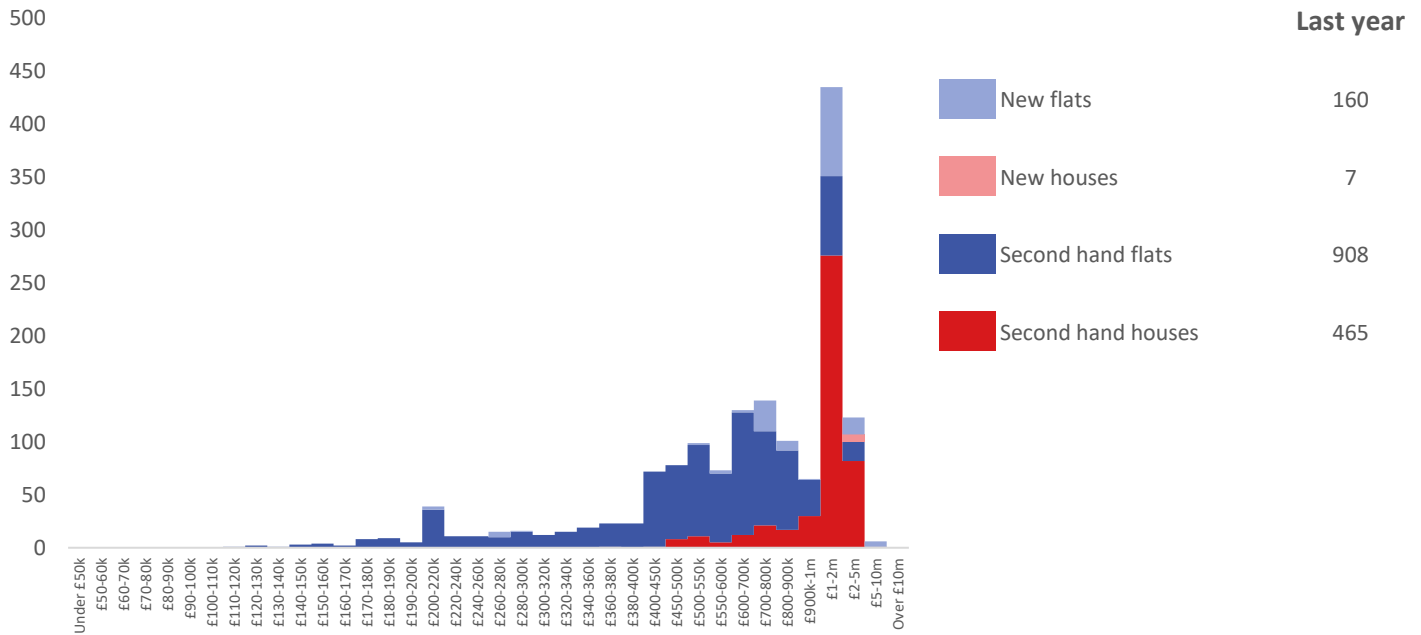
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

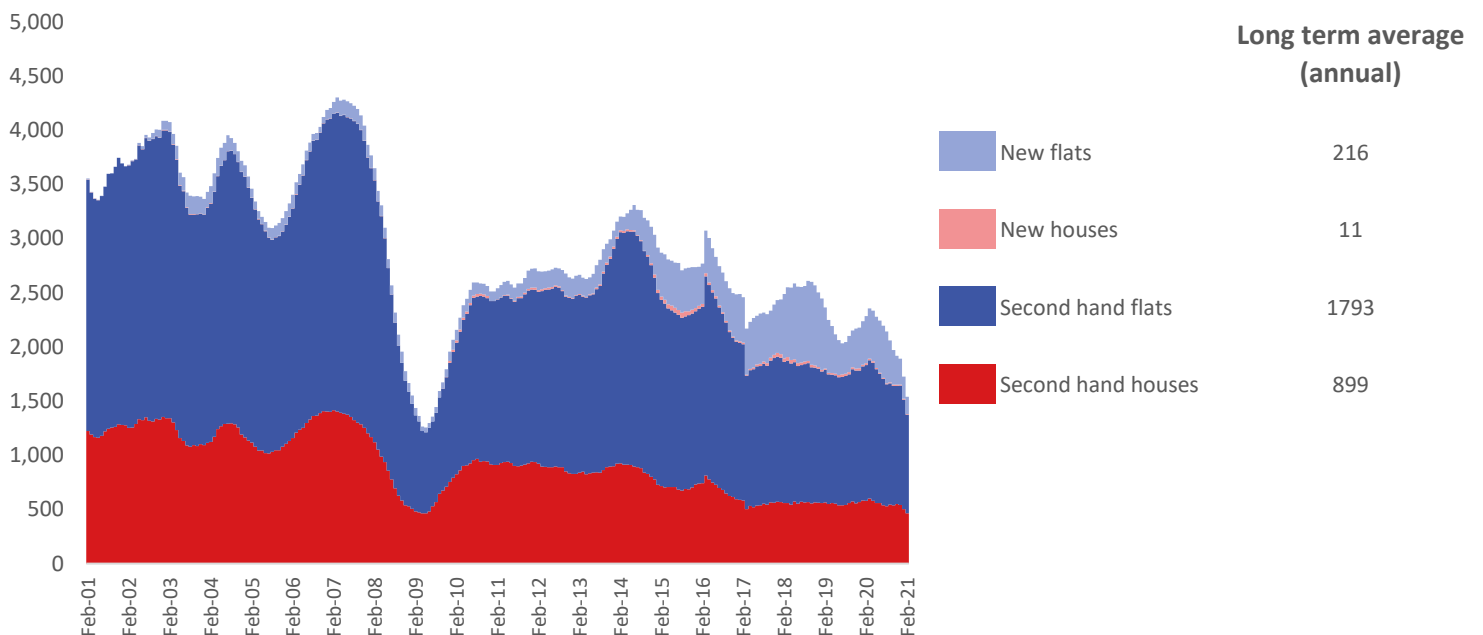
12 months to February 2021



The most common property type transacted over the past 12 months in Hammersmith and Fulham was 'second hand flats' with 908 sales, 59% of all sales over the same period. The annual total of 1,540 transactions is equivalent to 53% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand flats' with the equivalent of 1,793 sales per year on average, making up 61% of the typical annual total over that period.
