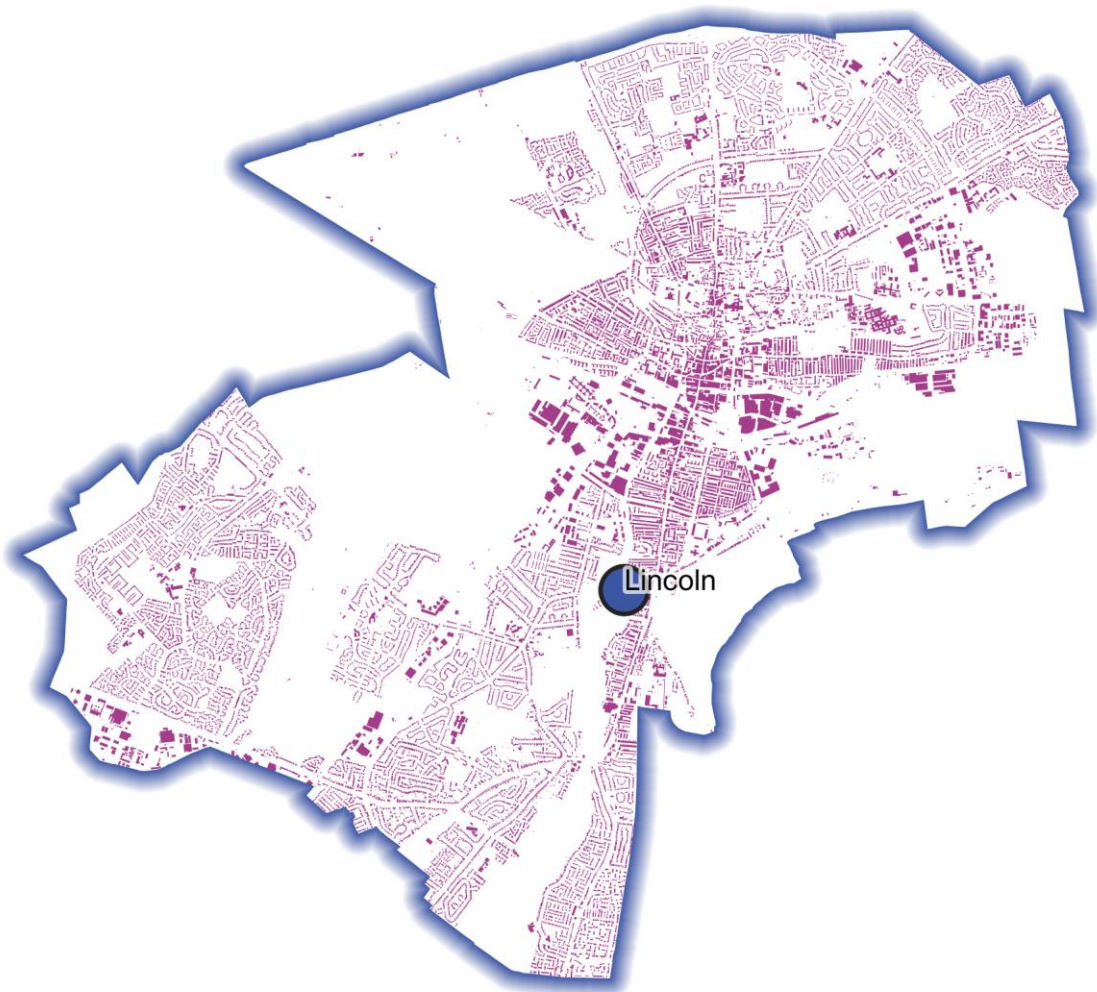

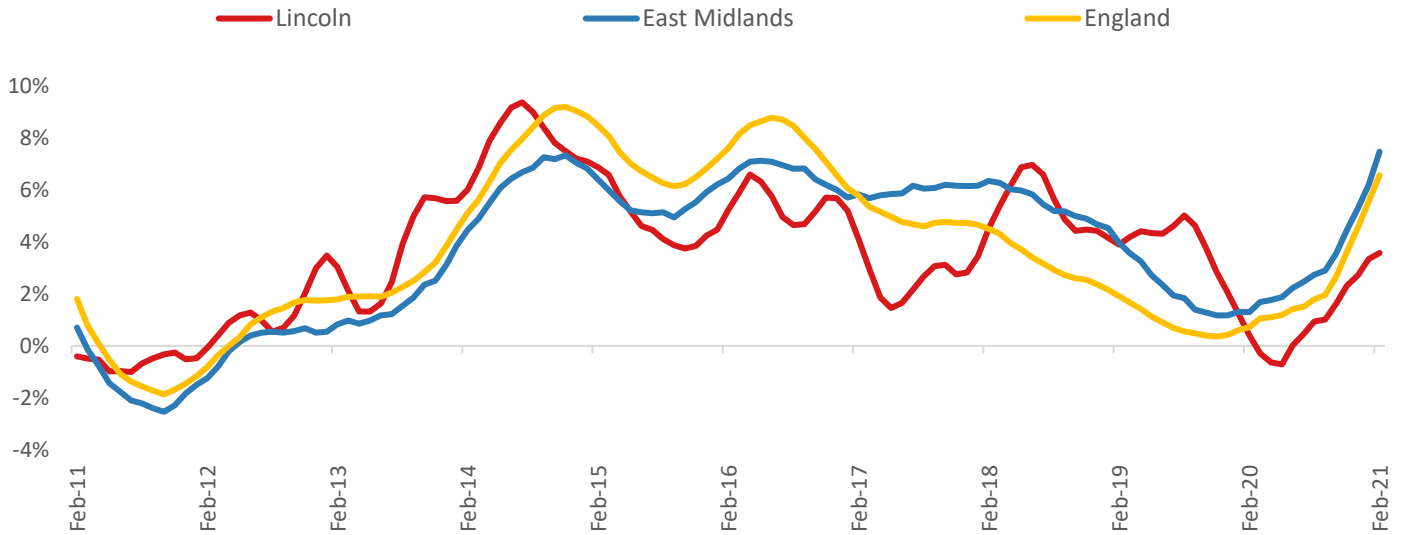

House Price Growth (February 2021 data)

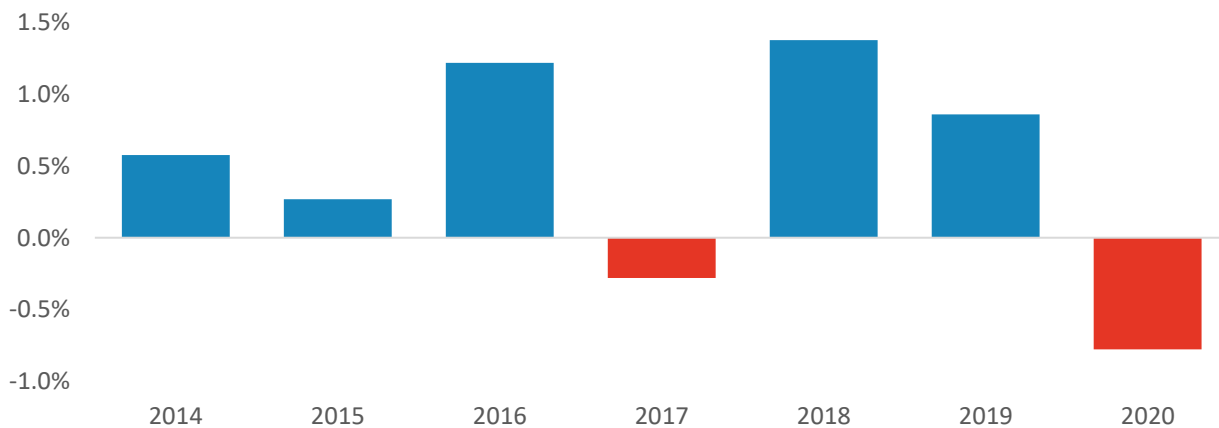
Annual Change in House Prices



House prices in Lincoln grew by 3.6% in the 12 months to February 2021 (based on 6-month smoothed data). By comparison national house prices grew by 6.6% and prices in the East Midlands grew by 7.5% over the same period.

Lincoln house prices are now 24.5% above their previous peak in 2007, compared to +32.2% for the East Midlands and +36.1% across England.

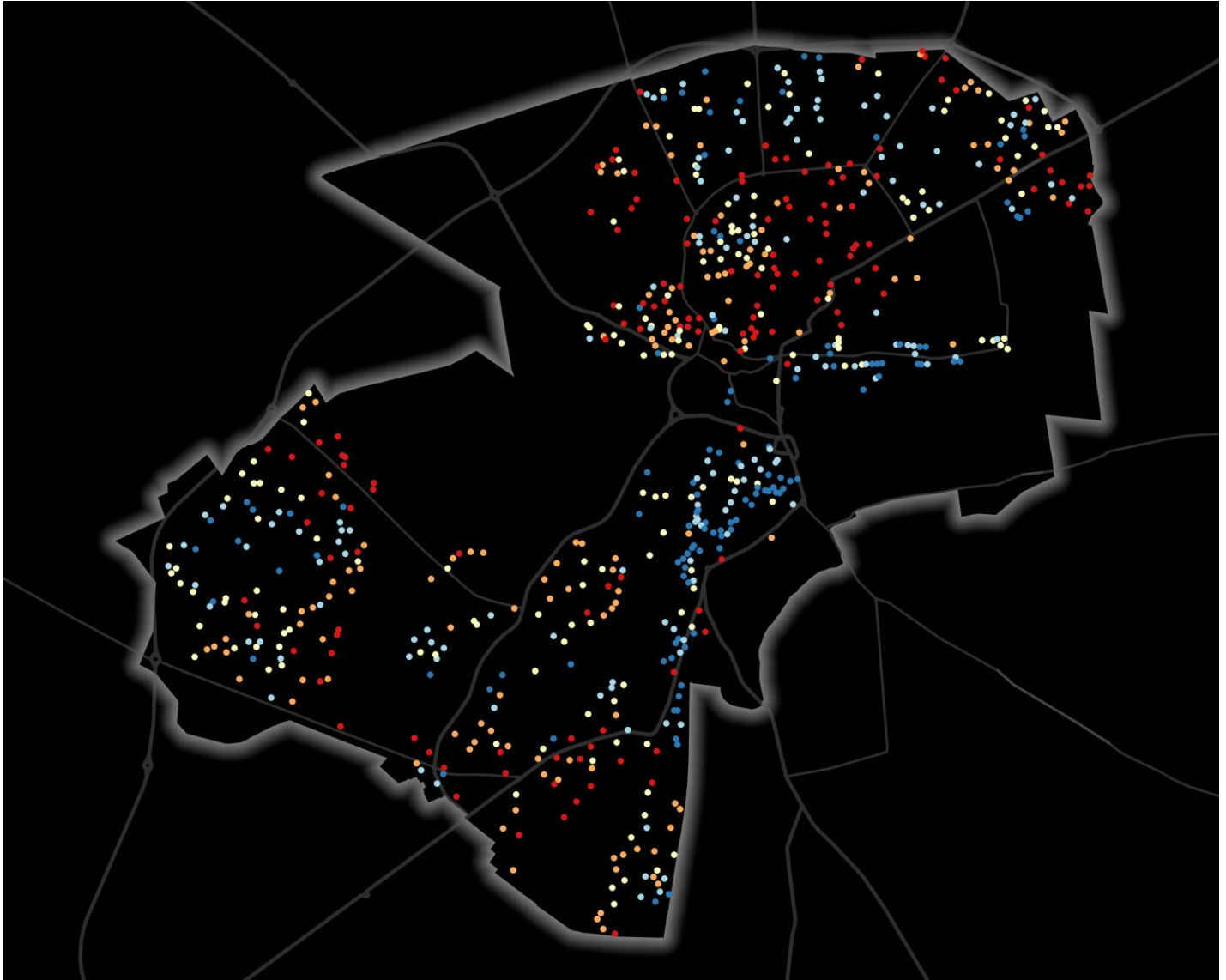
Year-To-Date Change in House Prices, December to February



Local prices have fallen by 0.8% in 2021 so far, compared to growth of 0.9% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

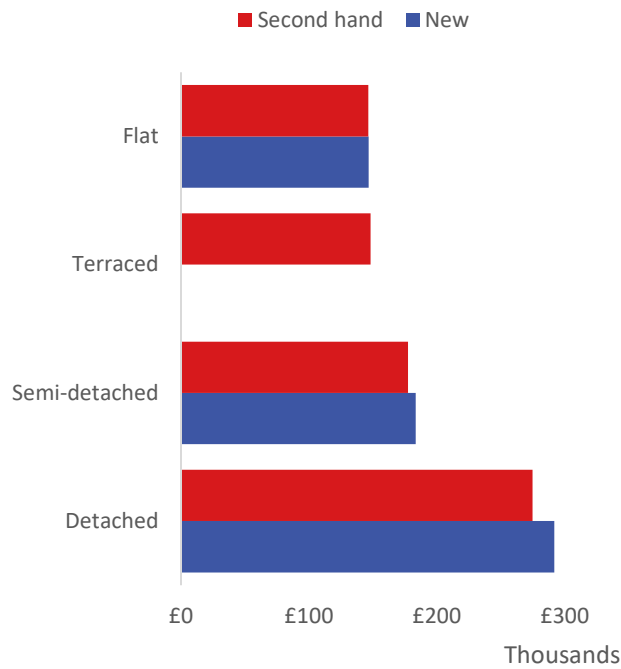

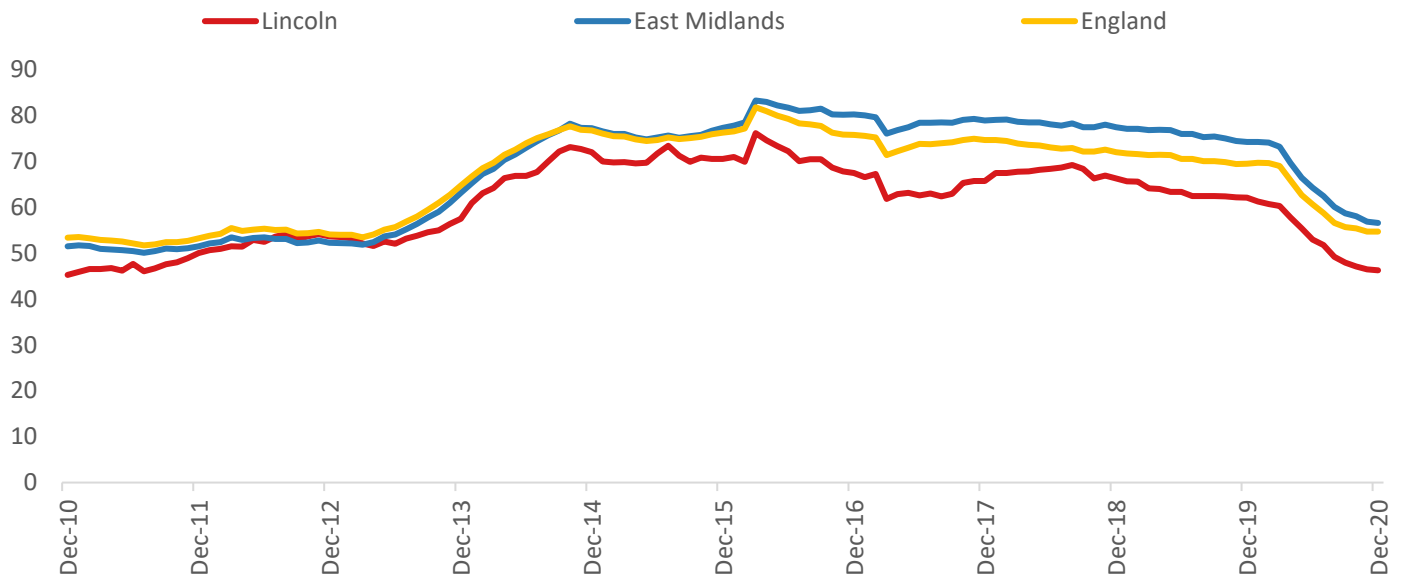

Transactions (December 2020 data)

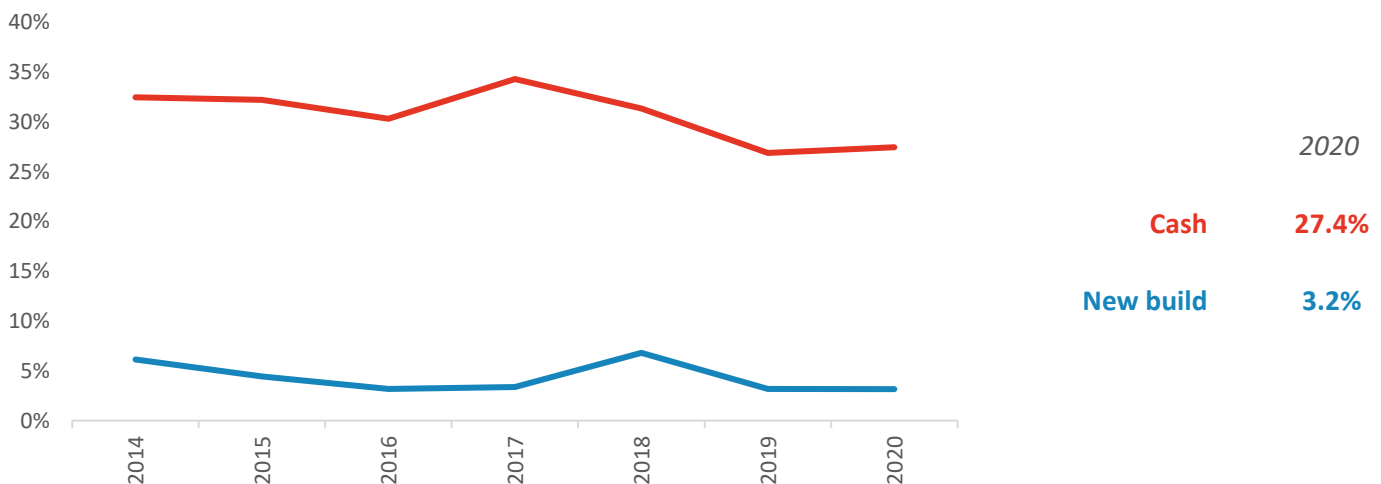
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,170 transactions in Lincoln during the 12 months to December 2020. This is 46% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Lincoln have fallen by 35.7% since 2014, compared to changes of -26.7% for East Midlands and -28.7% for England.

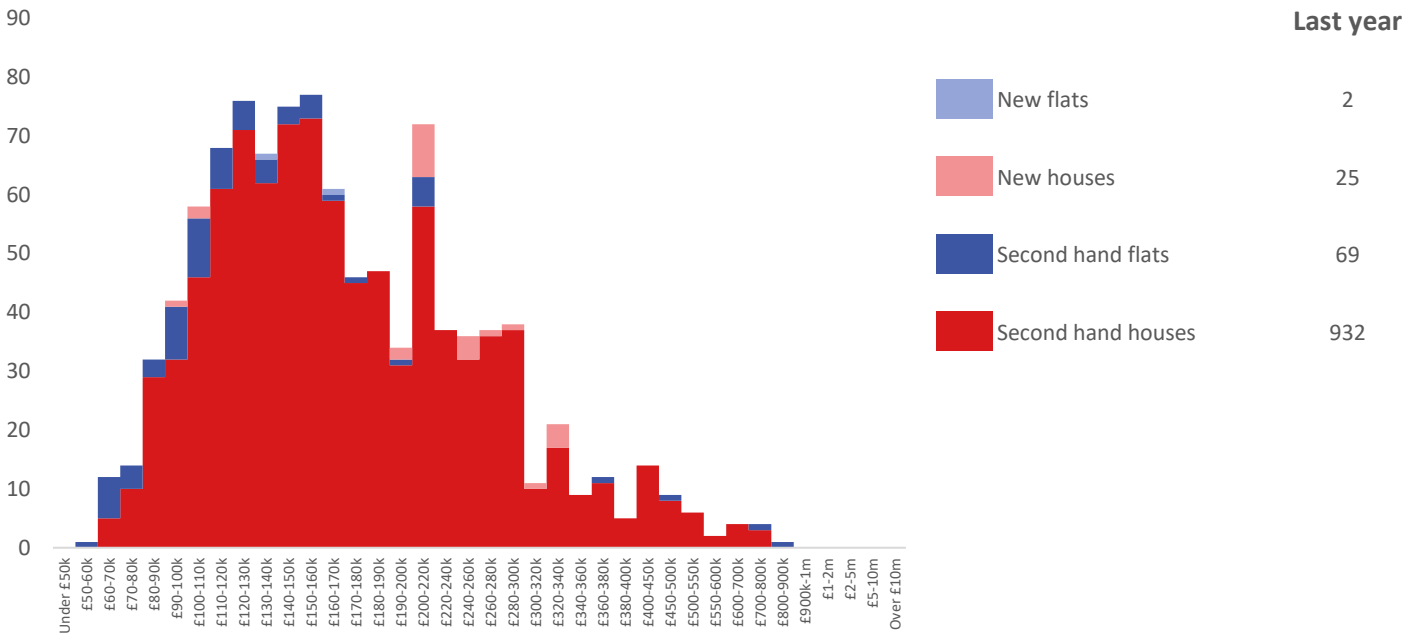
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

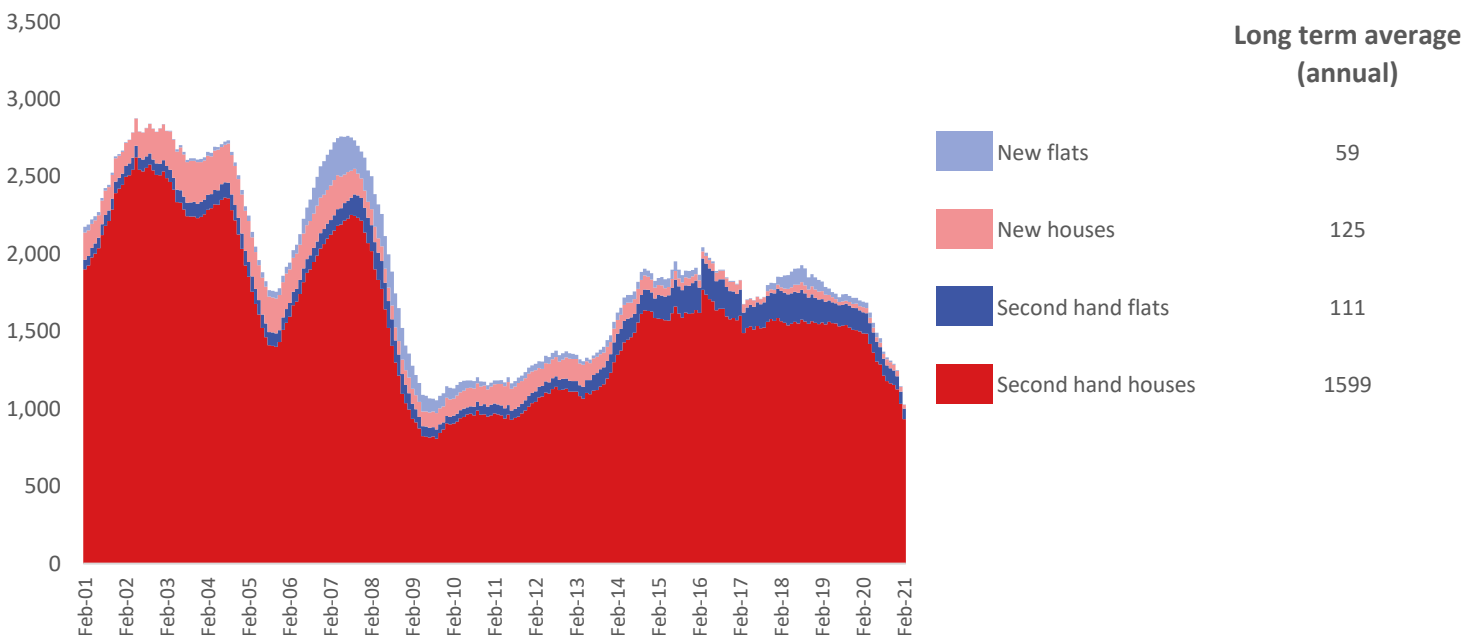
12 months to February 2021



The most common property type transacted over the past 12 months in Lincoln was 'second hand houses' with 932 sales, 91% of all sales over the same period. The annual total of 1,028 transactions is equivalent to 54% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,599 sales per year on average, making up 84% of the typical annual total over that period.
