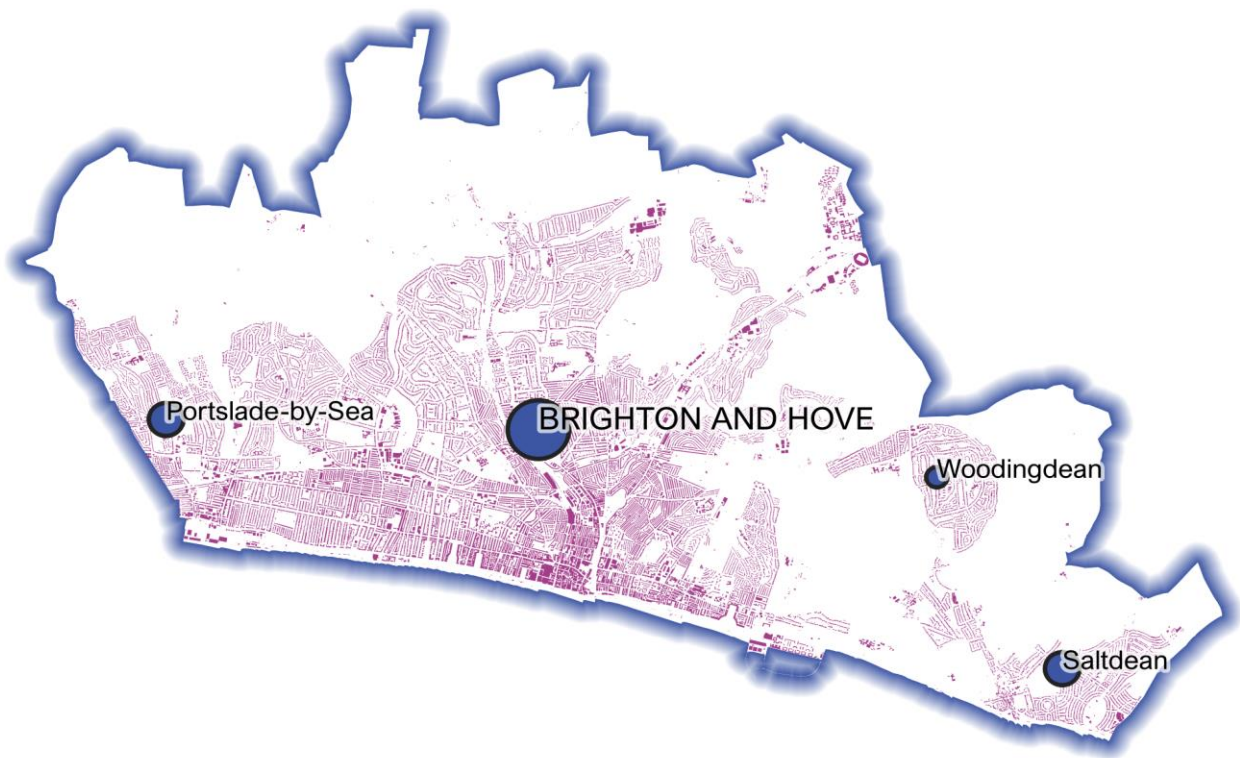

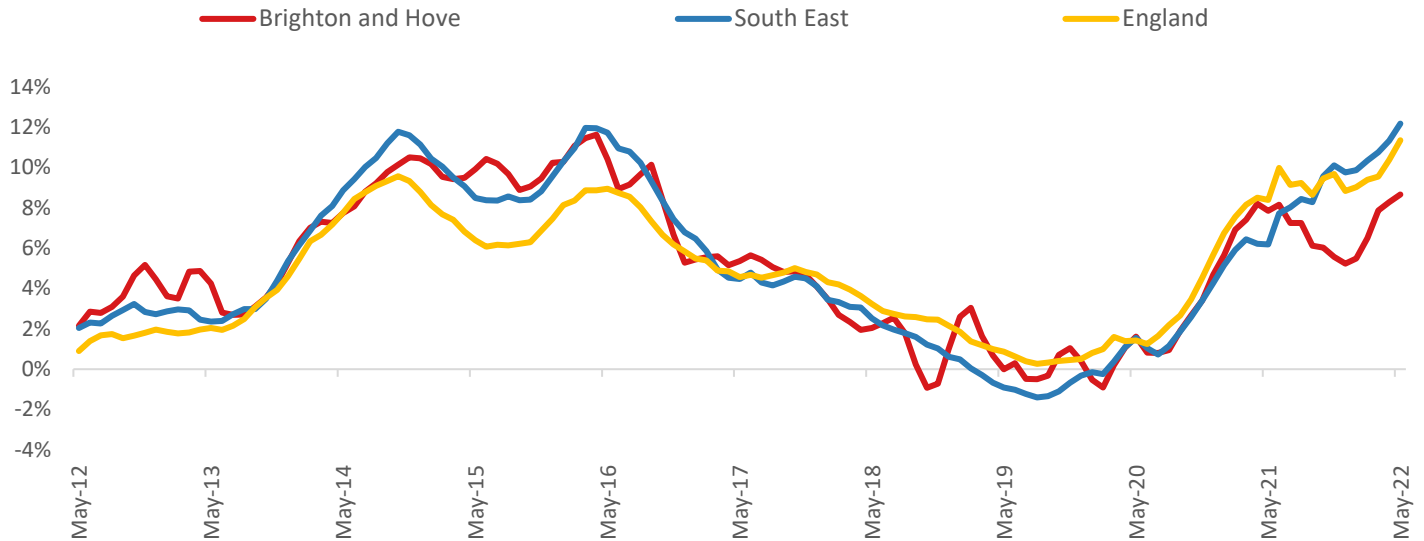

House Price Growth (May 2022 data)

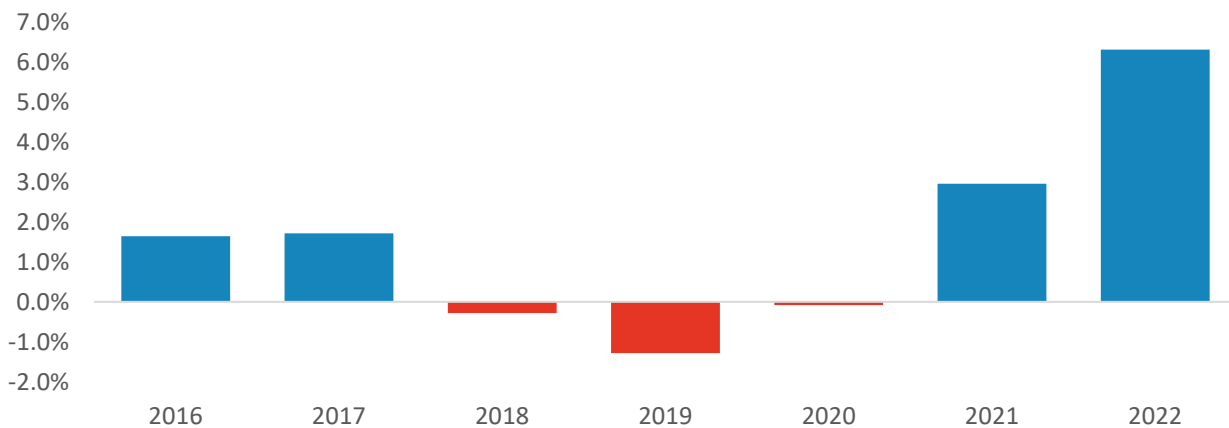
Annual Change in House Prices



House prices in Brighton and Hove grew by 8.7% in the 12 months to May 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in the South East grew by 12.2% over the same period.

Brighton and Hove house prices are now 67.1% above their previous peak in 2007, compared to +62.0% for the South East and +53.8% across England.

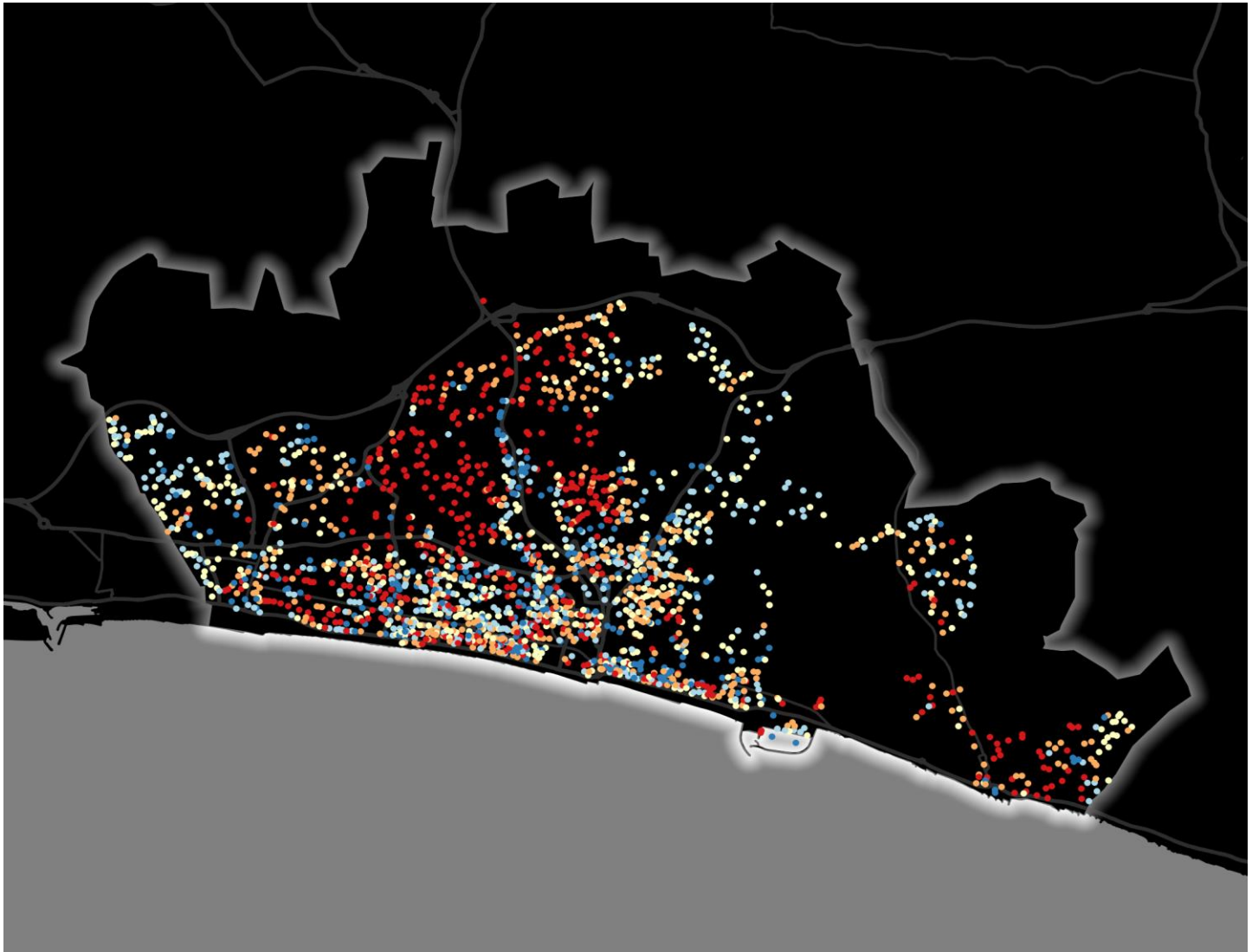
Year-To-Date Change in House Prices, December to May



Local prices have grown by 6.3% in 2022 so far, compared to growth of 3.0% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

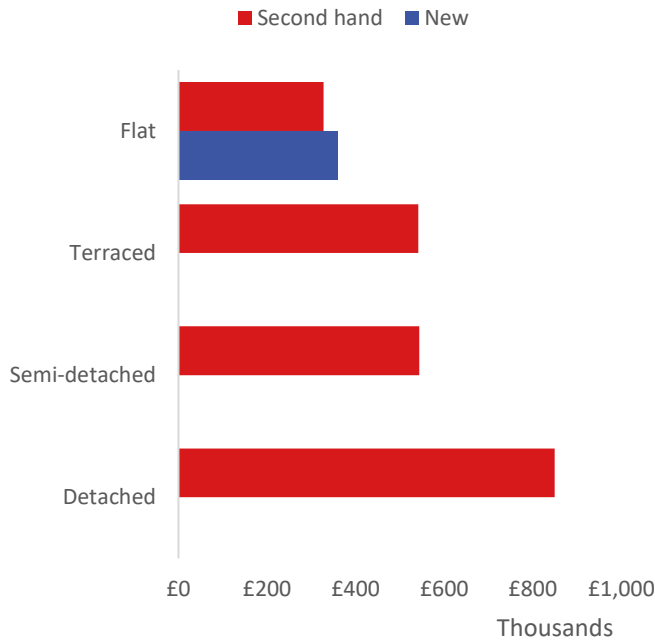

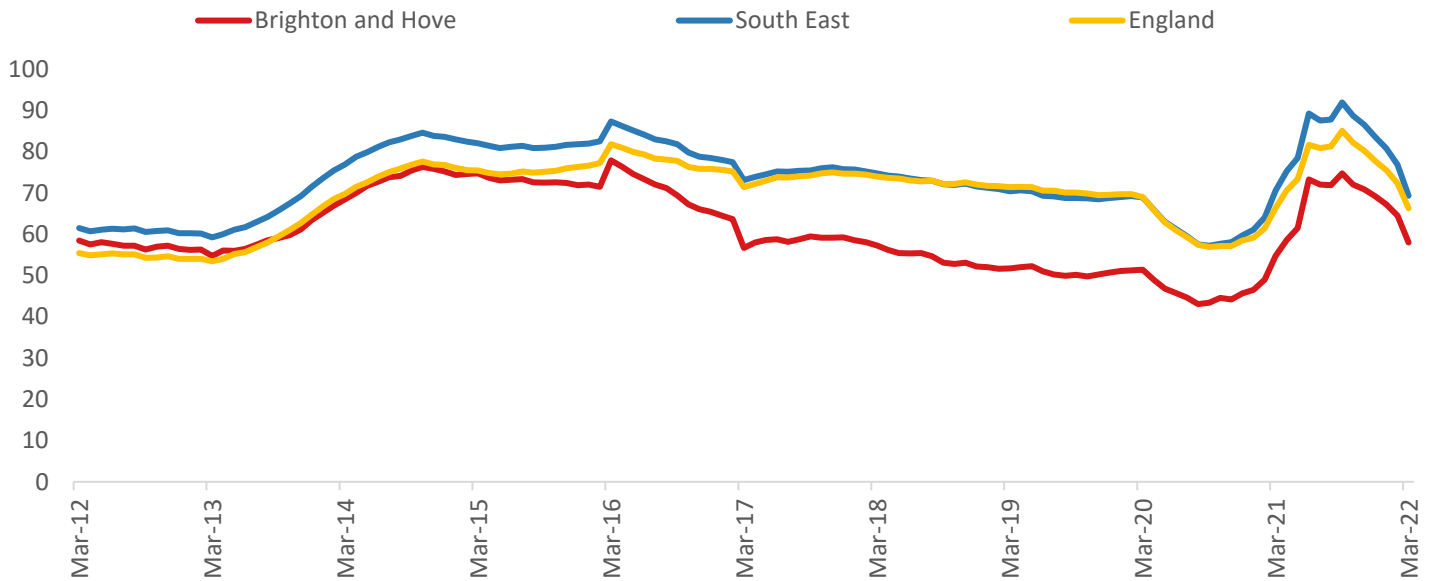

Transactions (March 2022 data)

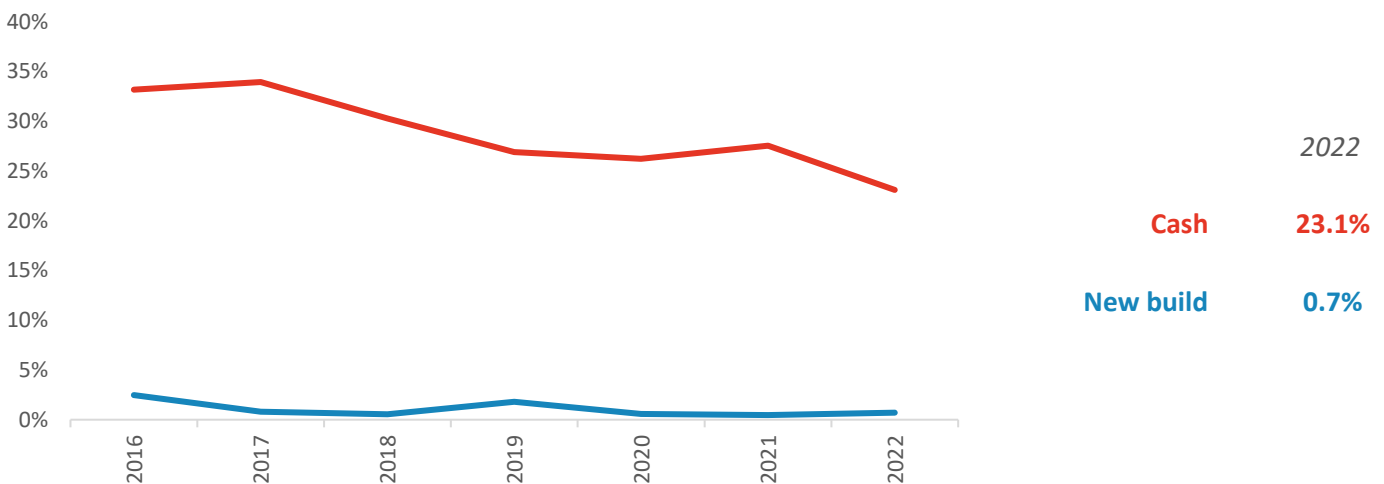
Annual Transactions, Indexed (2001-05 average = 100)



There were 4,339 transactions in Brighton and Hove during the 12 months to March 2022. This is 58% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Brighton and Hove have fallen by 22.9% since 2014, compared to changes of -17.1% for South East and -13.6% for England.

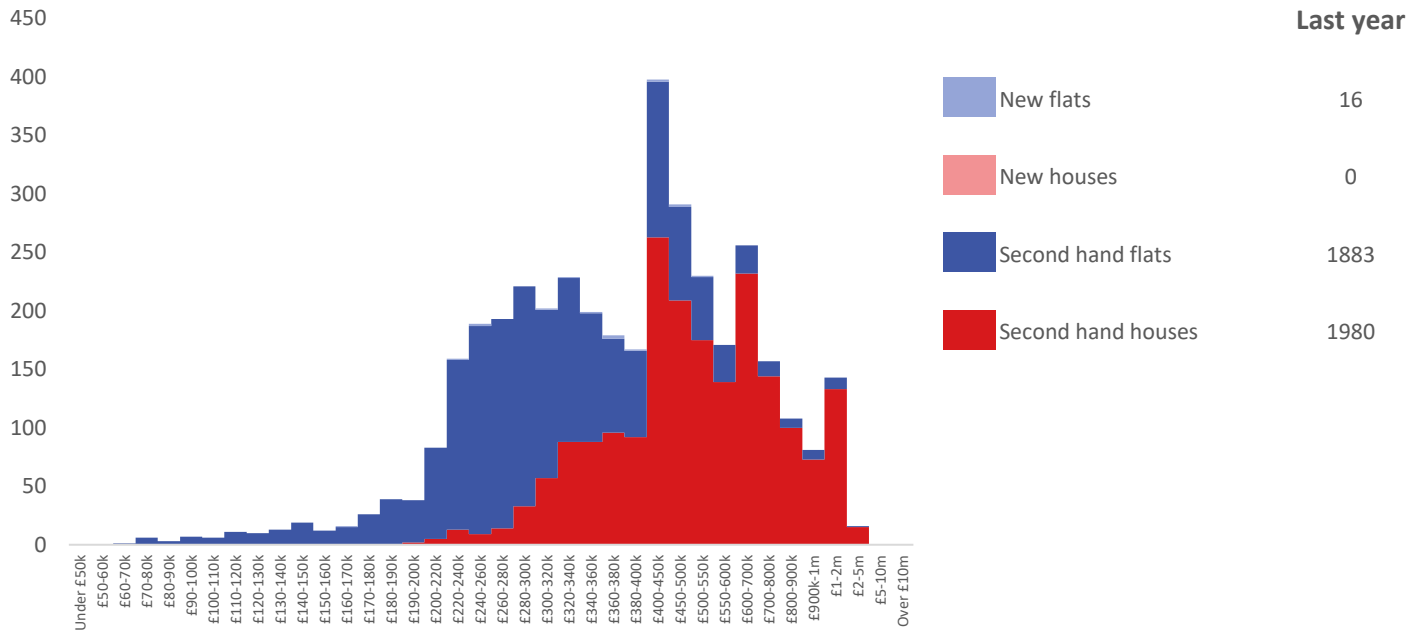
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

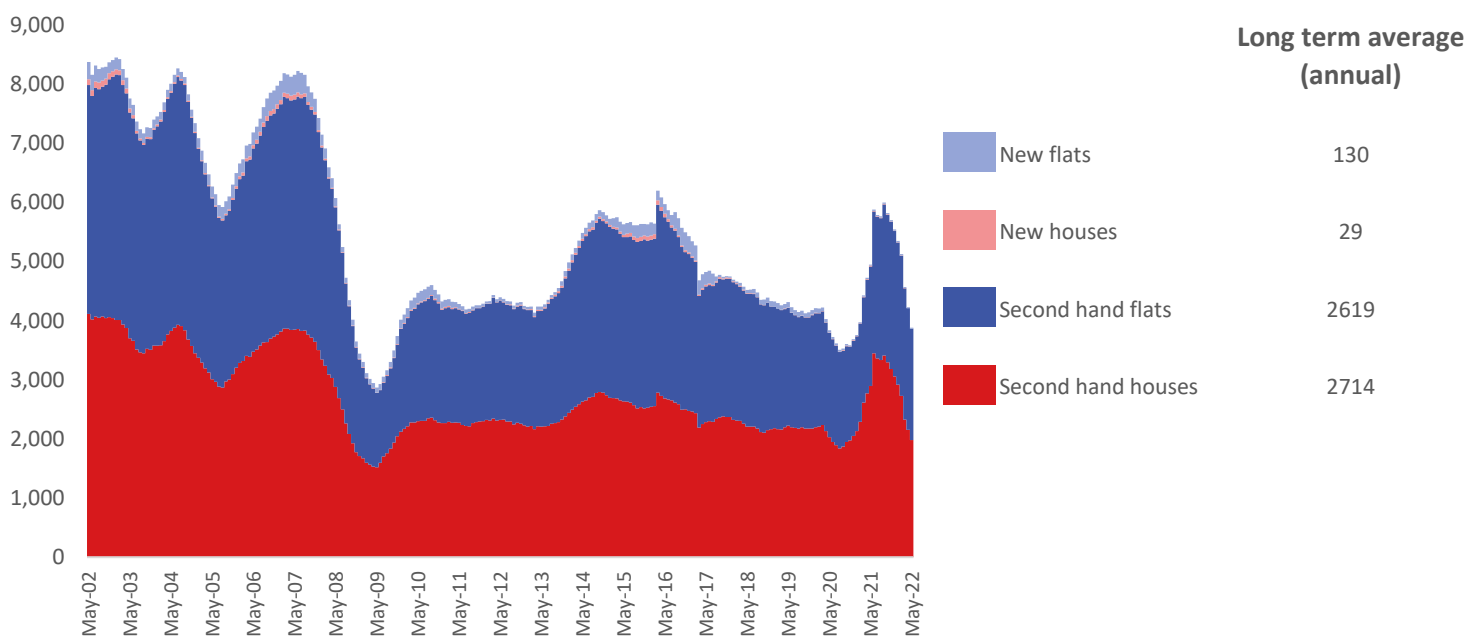
12 months to May 2022



The most common property type transacted over the past 12 months in Brighton and Hove was 'second hand houses' with 1,980 sales, 51% of all sales over the same period. The annual total of 3,879 transactions is equivalent to 71% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 2,714 sales per year on average, making up 49% of the typical annual total over that period.
