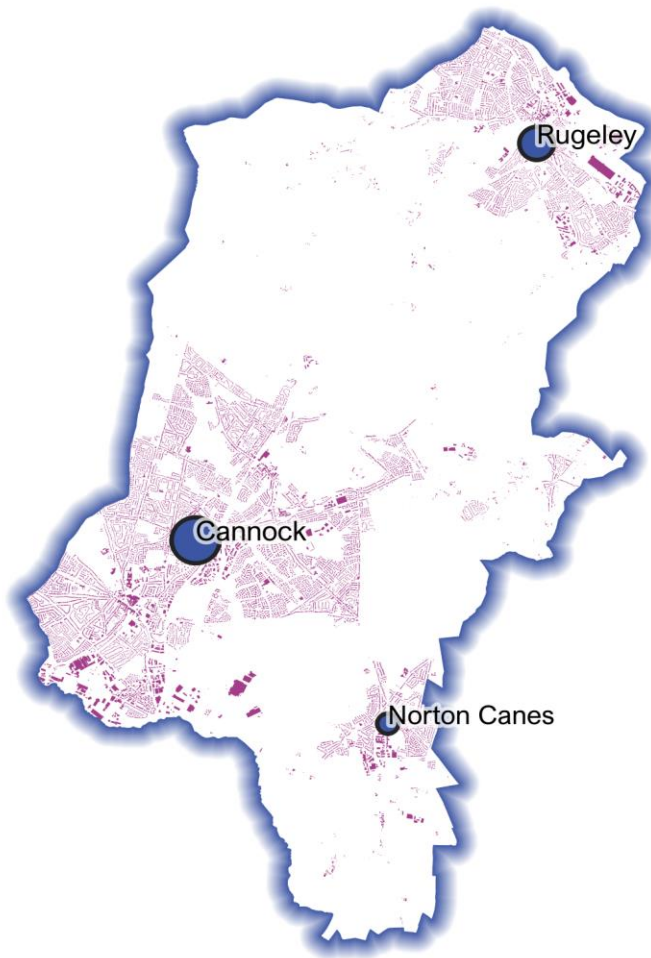

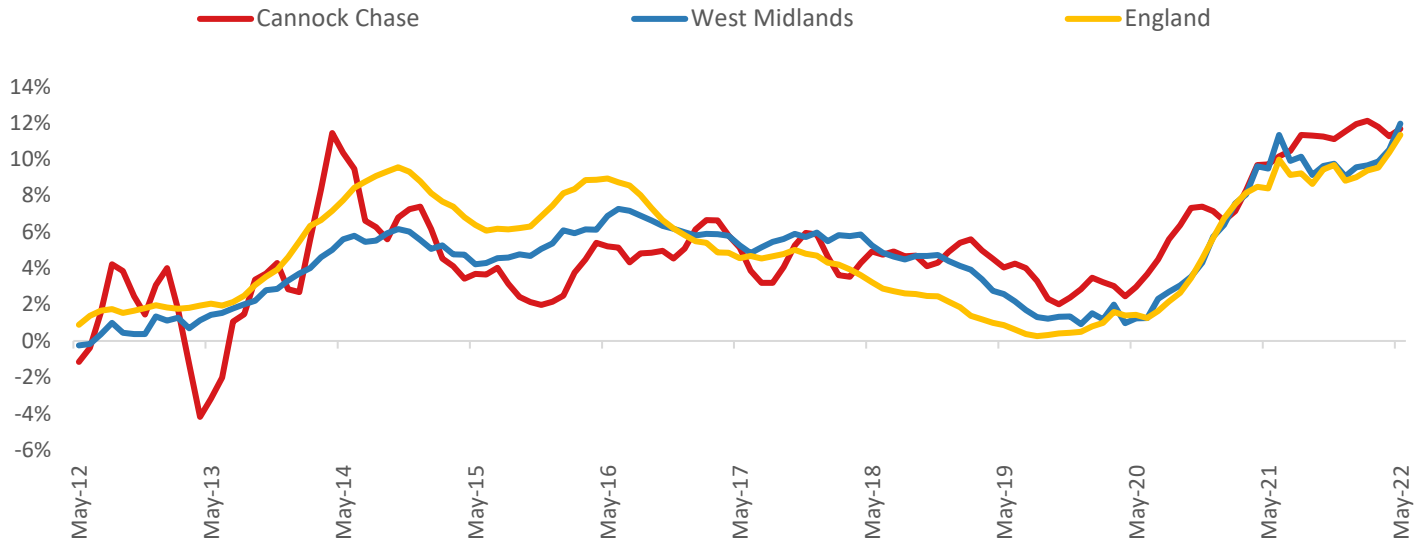

**House Price Growth (May 2022 data)**

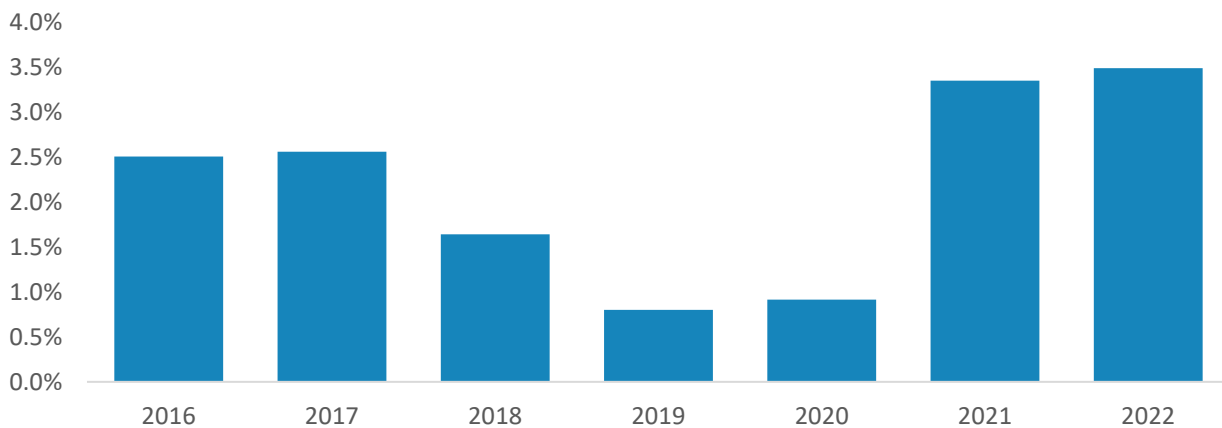
*Annual Change in House Prices*



House prices in Cannock Chase grew by 11.7% in the 12 months to May 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in the West Midlands grew by 12.0% over the same period.

Cannock Chase house prices are now 45.9% above their previous peak in 2007, compared to +47.4% for the West Midlands and +53.8% across England.

*Year-To-Date Change in House Prices, December to May*



Local prices have grown by 3.5% in 2022 so far, compared to growth of 3.3% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

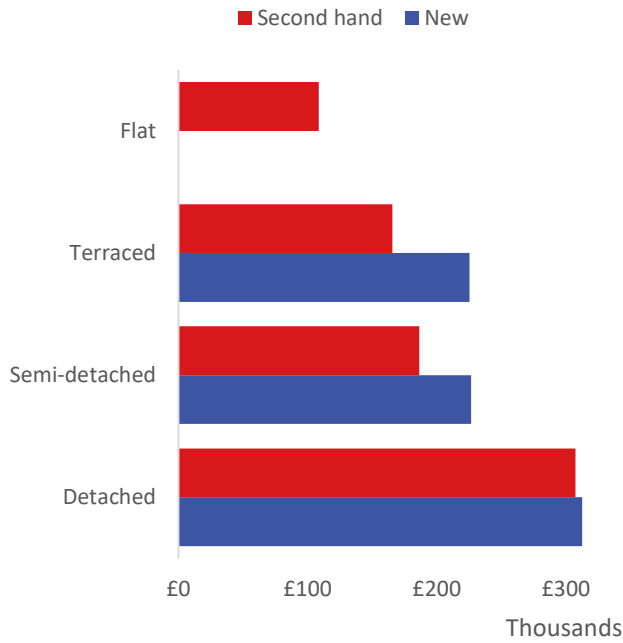

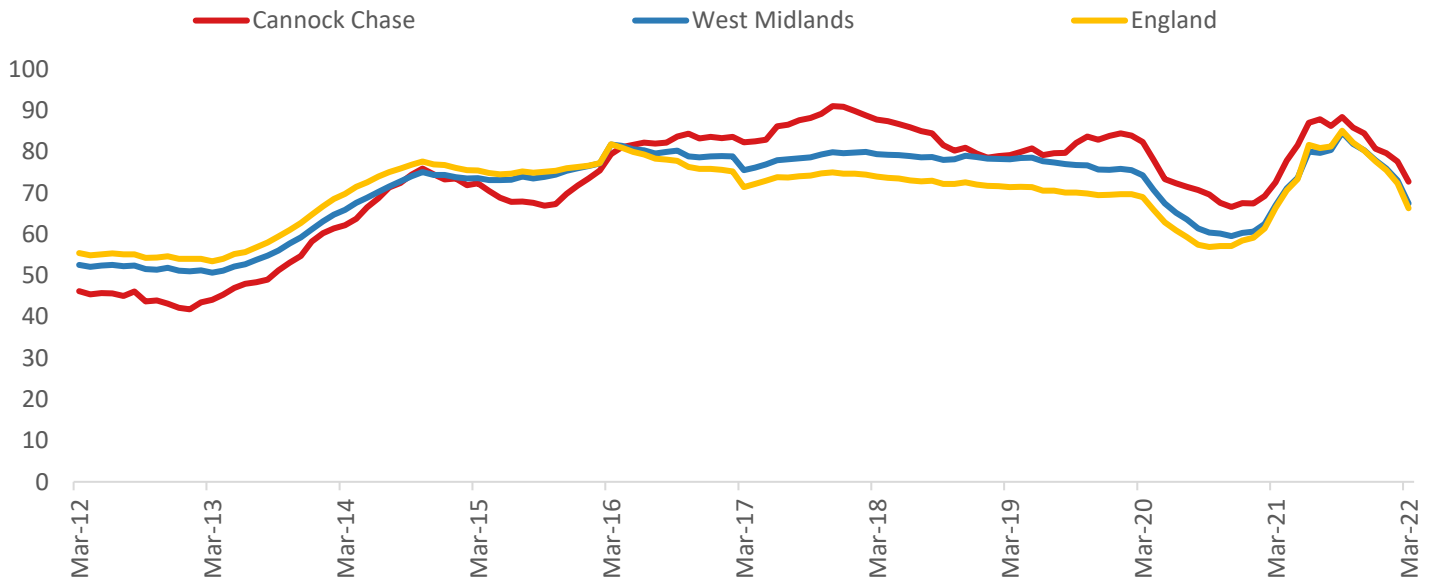

### Transactions (March 2022 data)

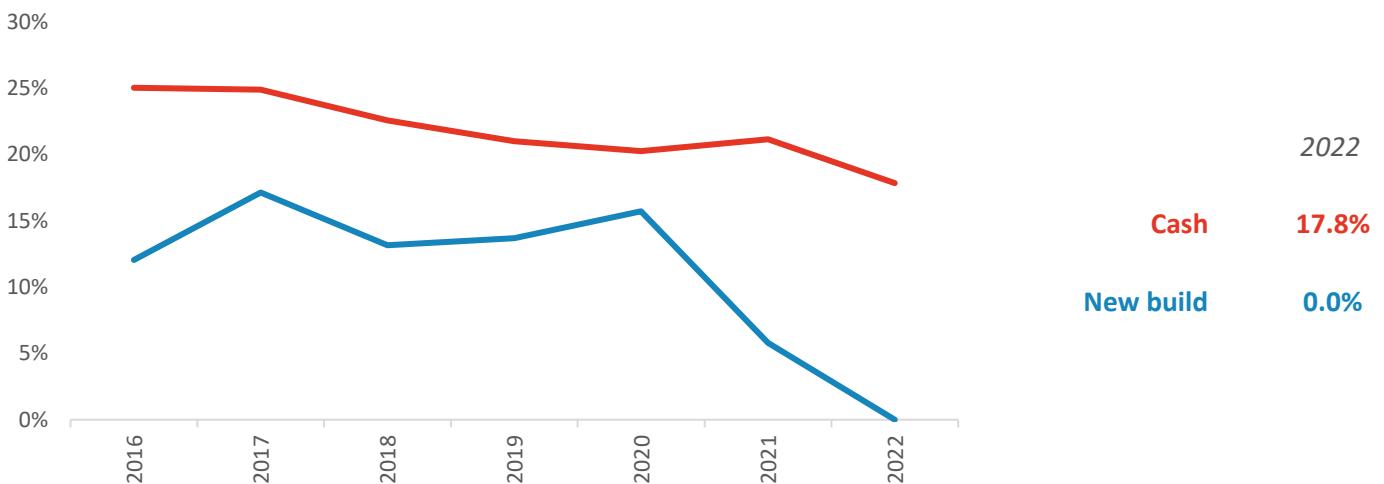
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,497 transactions in Cannock Chase during the 12 months to March 2022. This is 73% of the average from 2001-05 and suggests activity is below pre-downturn levels.

Transactions in Cannock Chase have fallen by 0.7% since 2014, compared to changes of -9.3% for West Midlands and -13.6% for England.

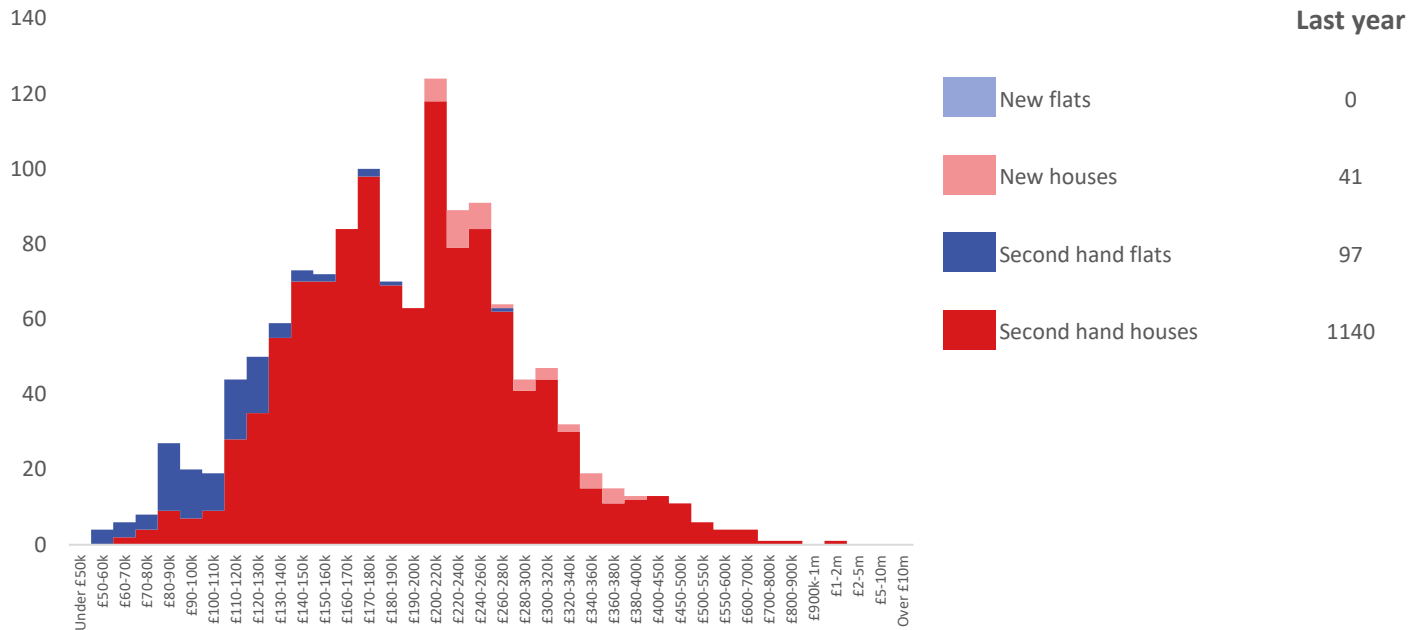
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

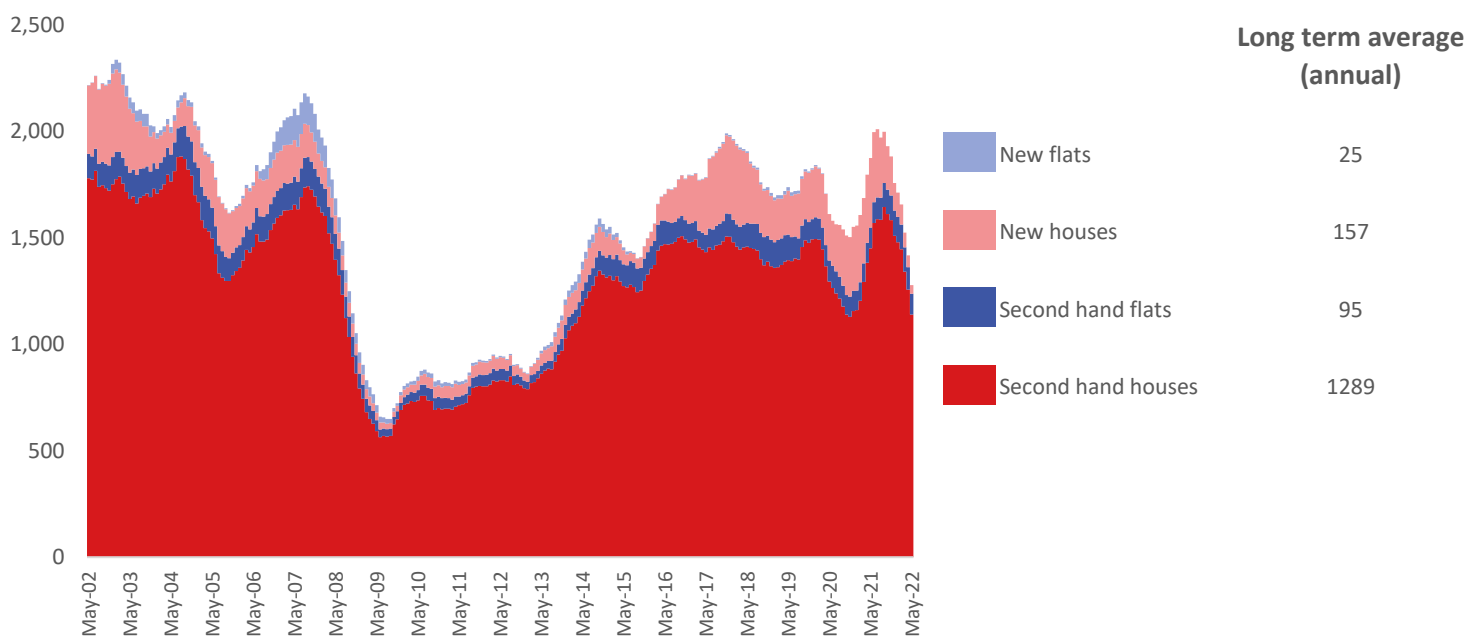
12 months to May 2022



The most common property type transacted over the past 12 months in Cannock Chase was 'second hand houses' with 1,140 sales, 89% of all sales over the same period. The annual total of 1,278 transactions is equivalent to 82% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,289 sales per year on average, making up 82% of the typical annual total over that period.
