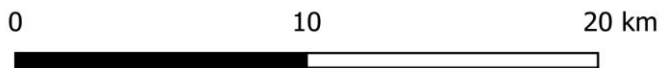
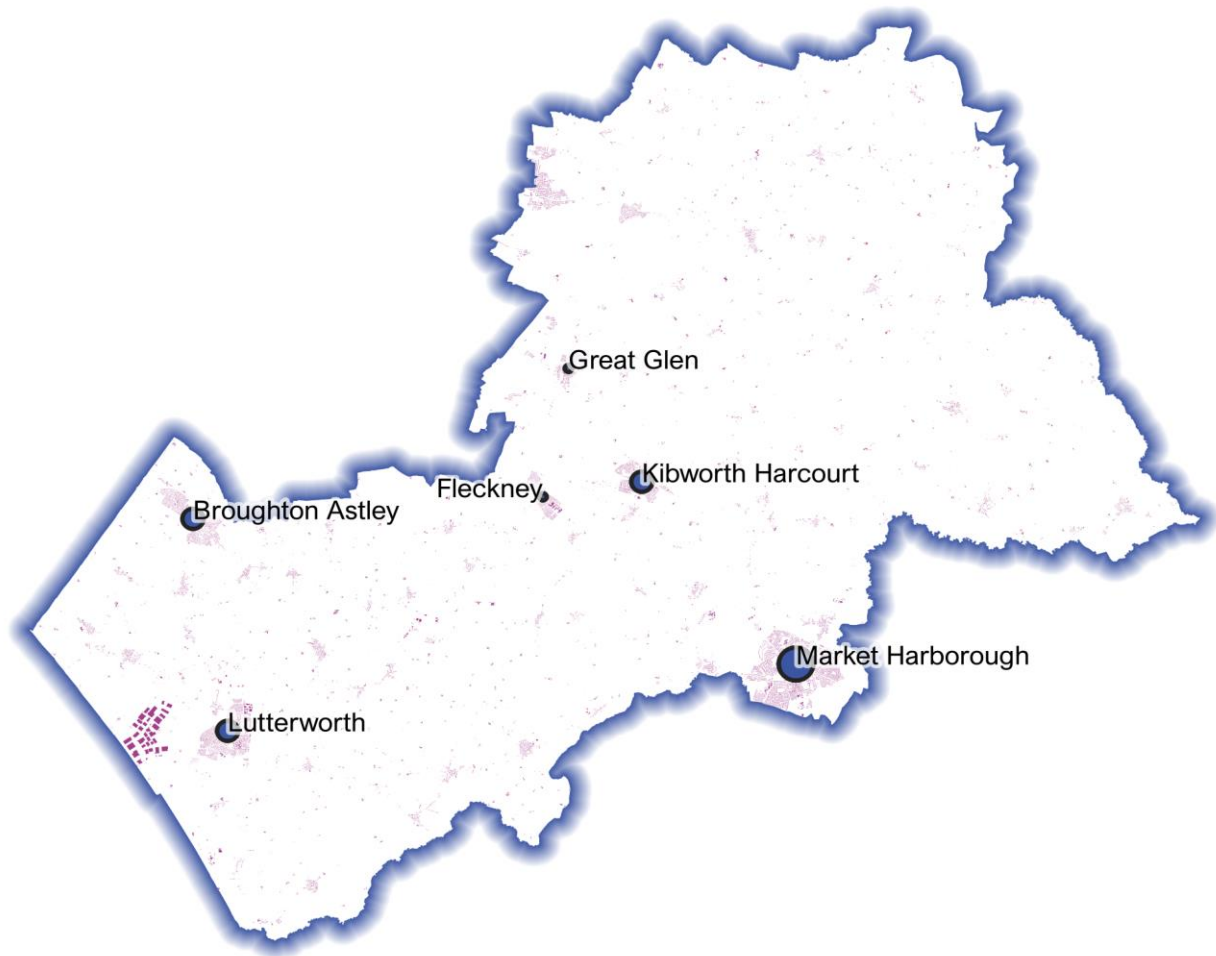

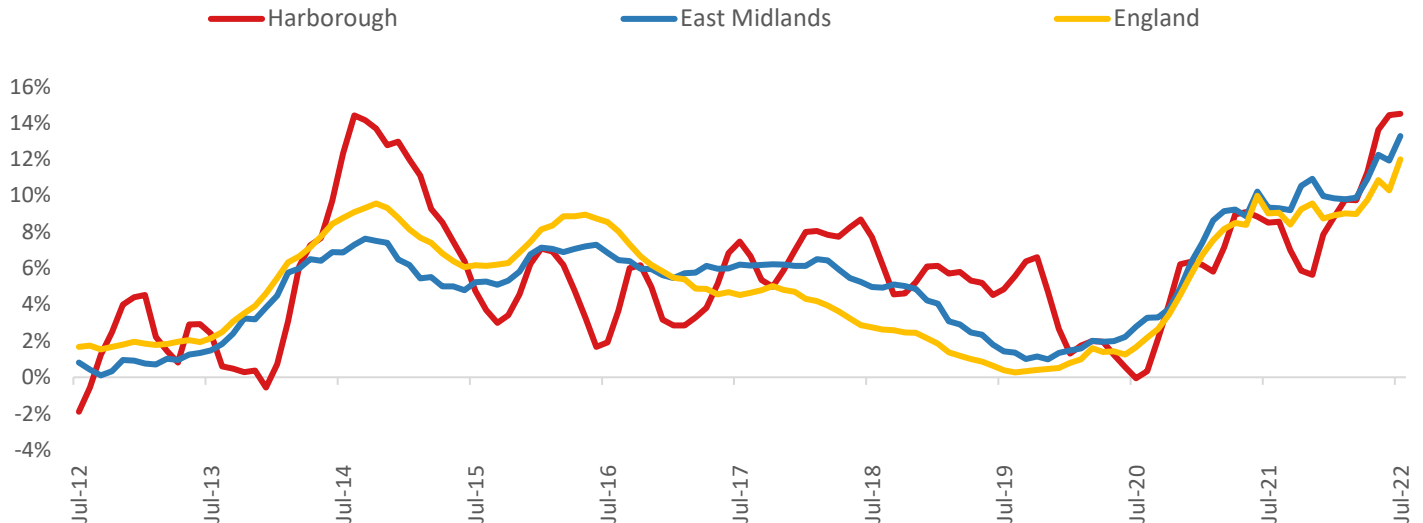

House Price Growth (July 2022 data)

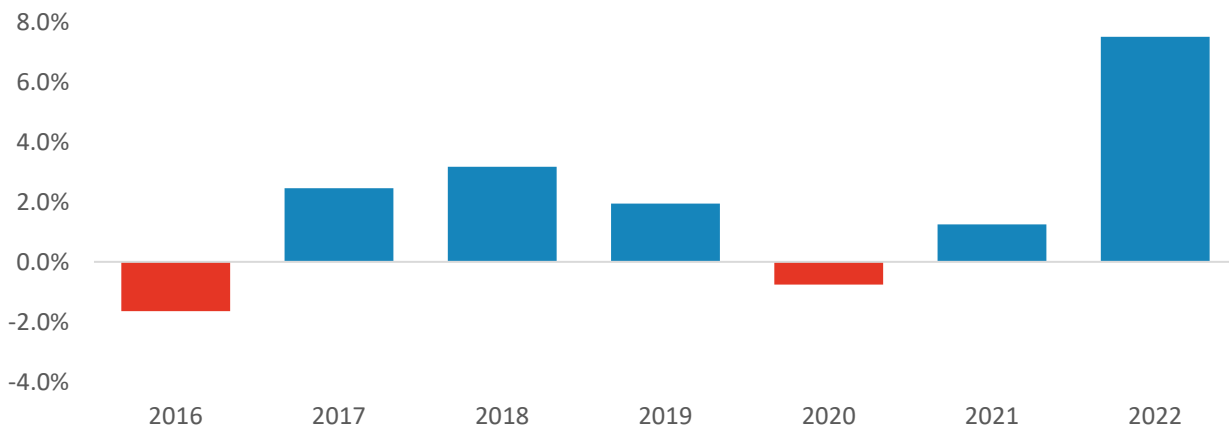
Annual Change in House Prices



House prices in Harborough grew by 14.5% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the East Midlands grew by 13.3% over the same period.

Harborough house prices are now 68.5% above their previous peak in 2007, compared to +54.9% for the East Midlands and +57.4% across England.

Year-To-Date Change in House Prices, December to July



Local prices have grown by 7.5% in 2022 so far, compared to growth of 1.3% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

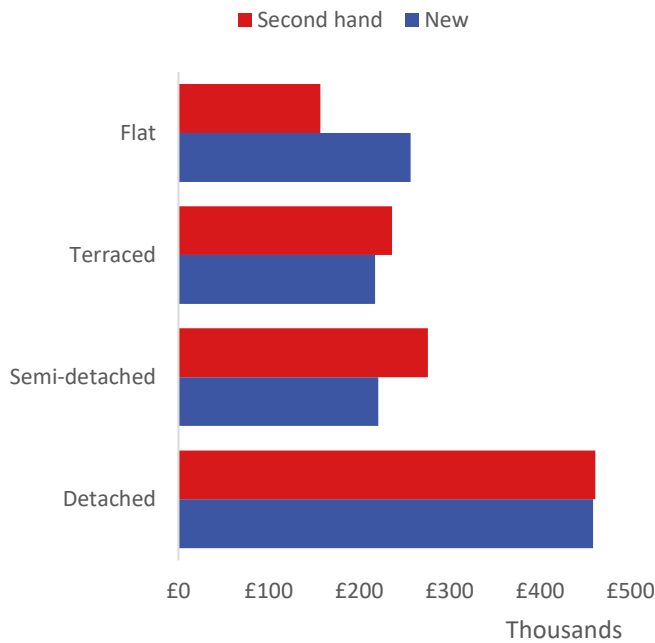

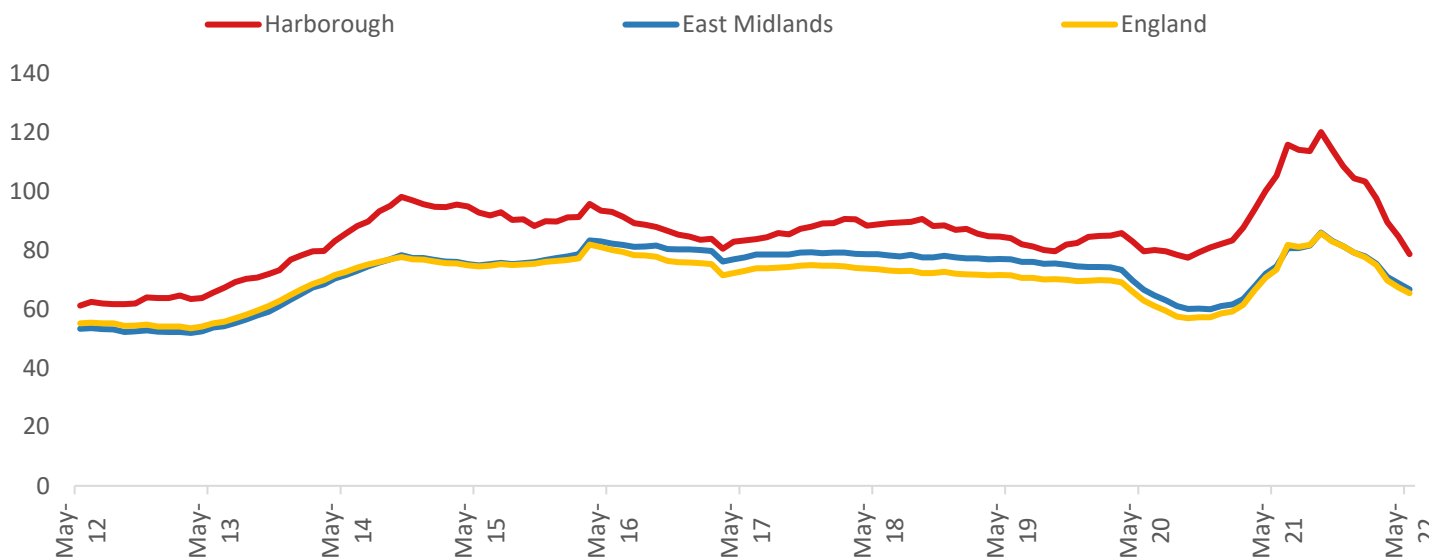

Transactions (May 2022 data)

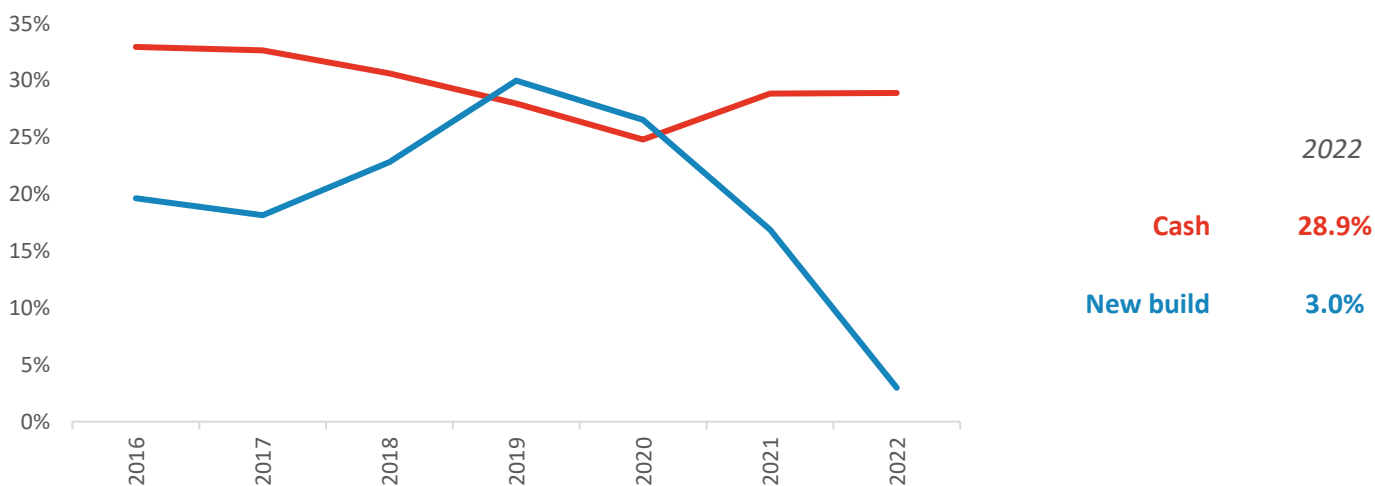
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,614 transactions in Harborough during the 12 months to May 2022. This is 79% of the average from 2001-05 and suggests activity is below pre-downturn levels.

Transactions in Harborough have fallen by 17.7% since 2014, compared to changes of -13.8% for East Midlands and -14.9% for England.

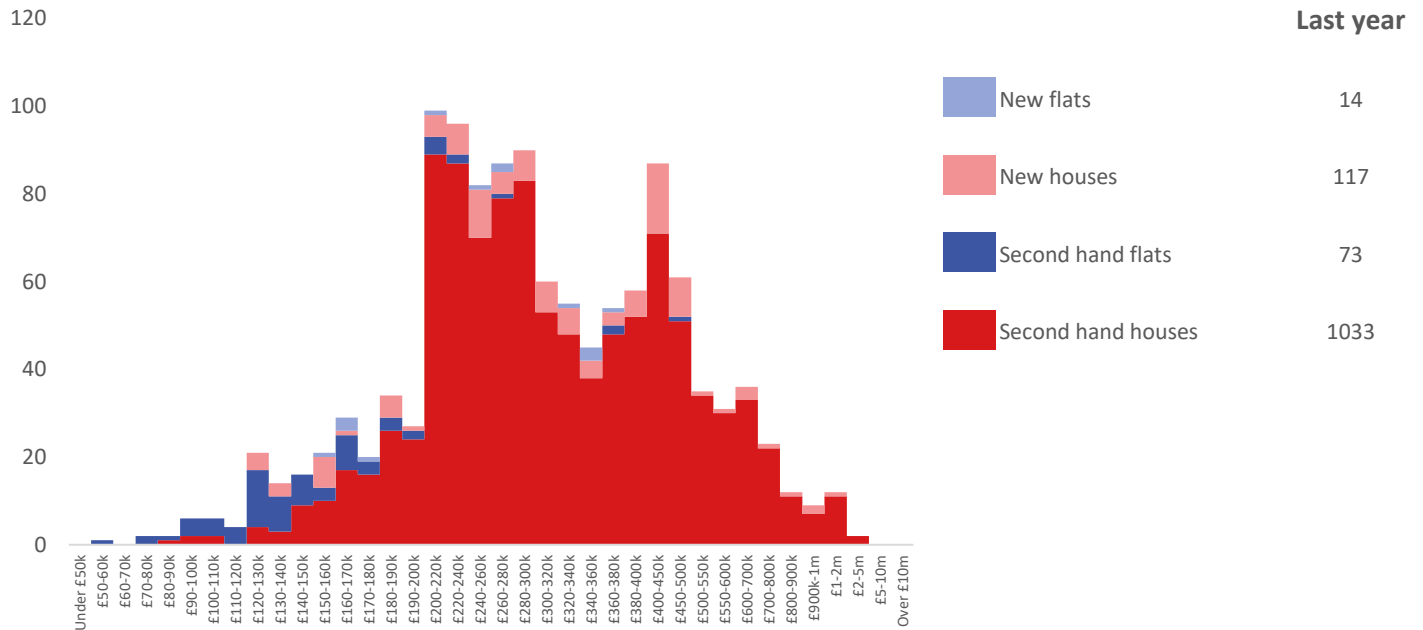
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

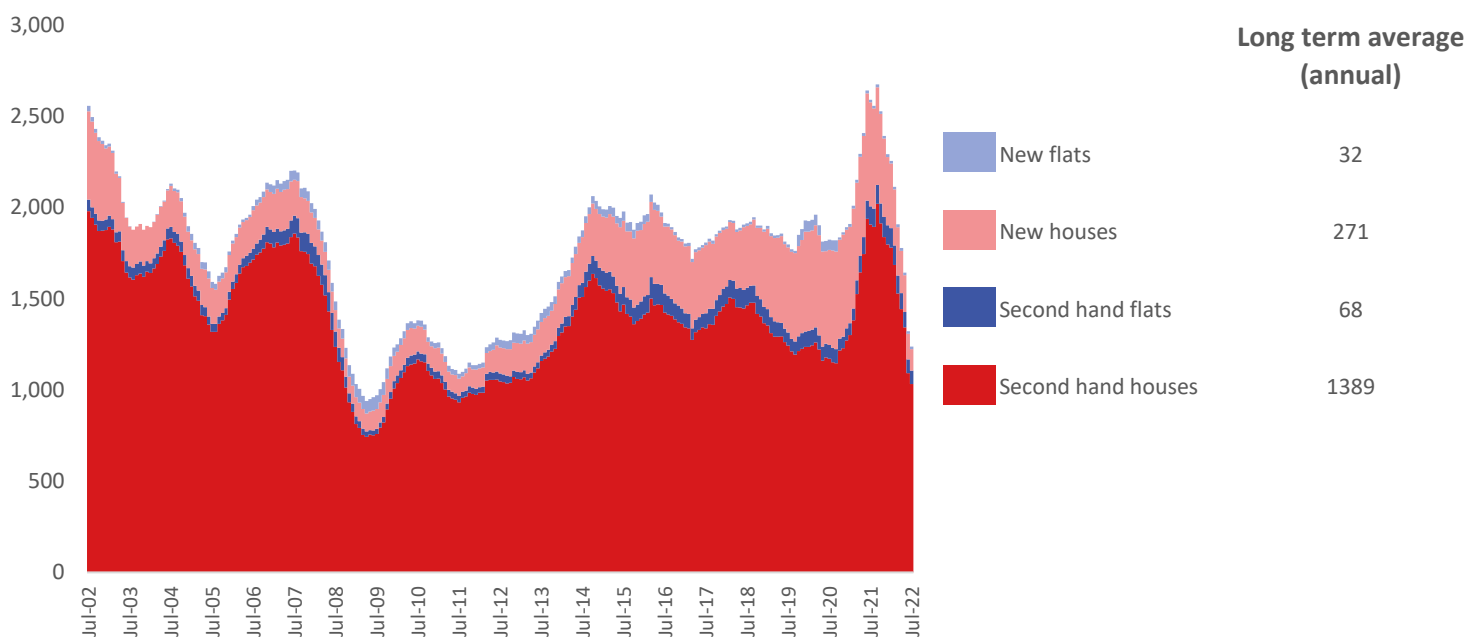
12 months to July 2022



The most common property type transacted over the past 12 months in Harborough was 'second hand houses' with 1,033 sales, 84% of all sales over the same period. The annual total of 1,237 transactions is equivalent to 70% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,389 sales per year on average, making up 79% of the typical annual total over that period.
