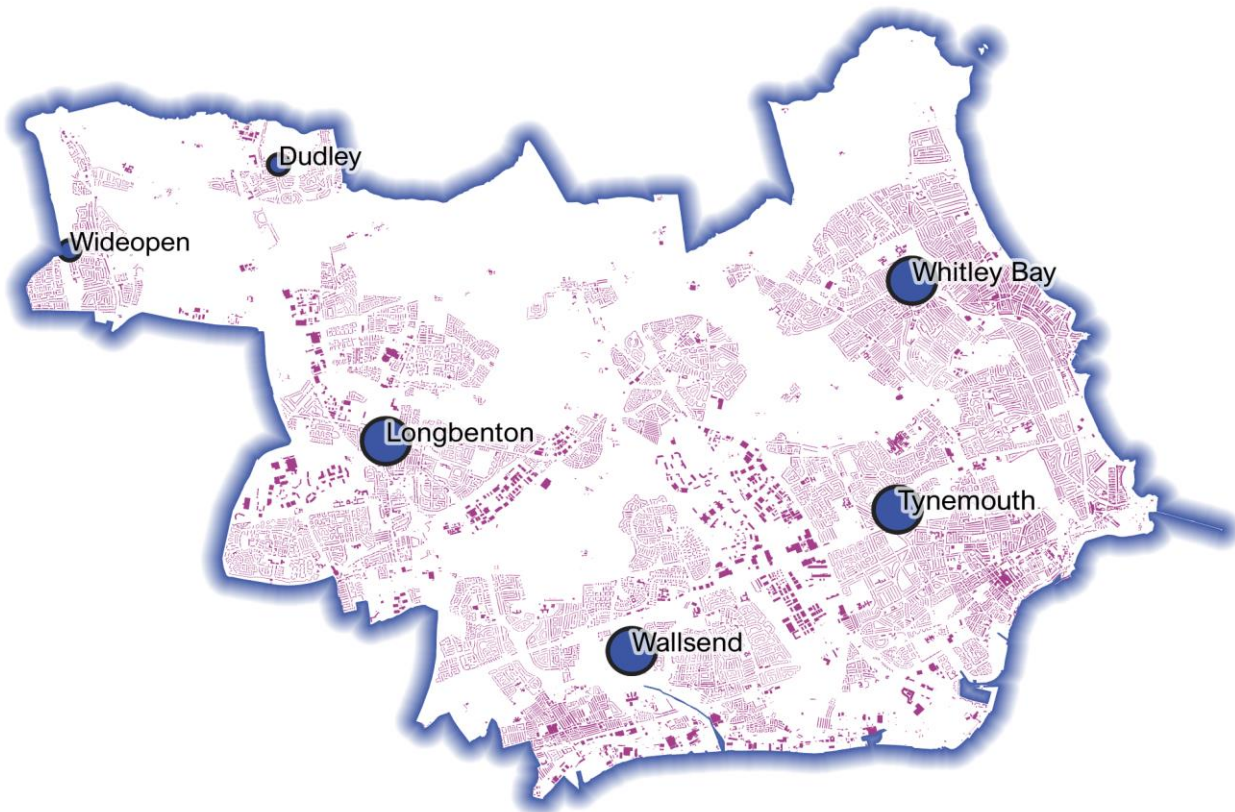

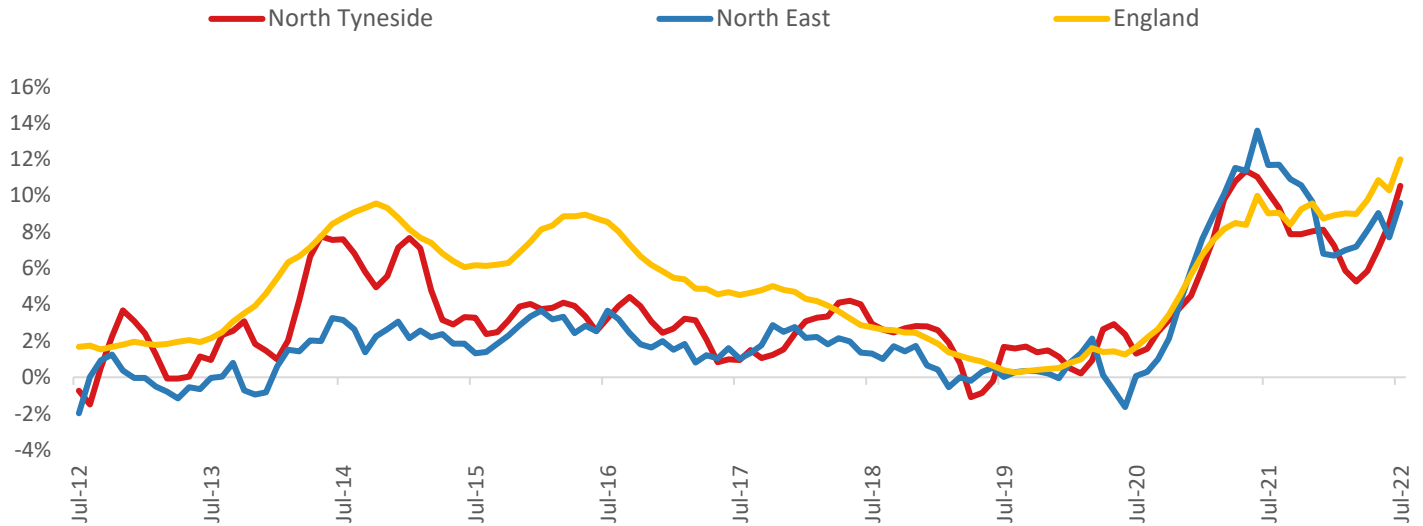

House Price Growth (July 2022 data)

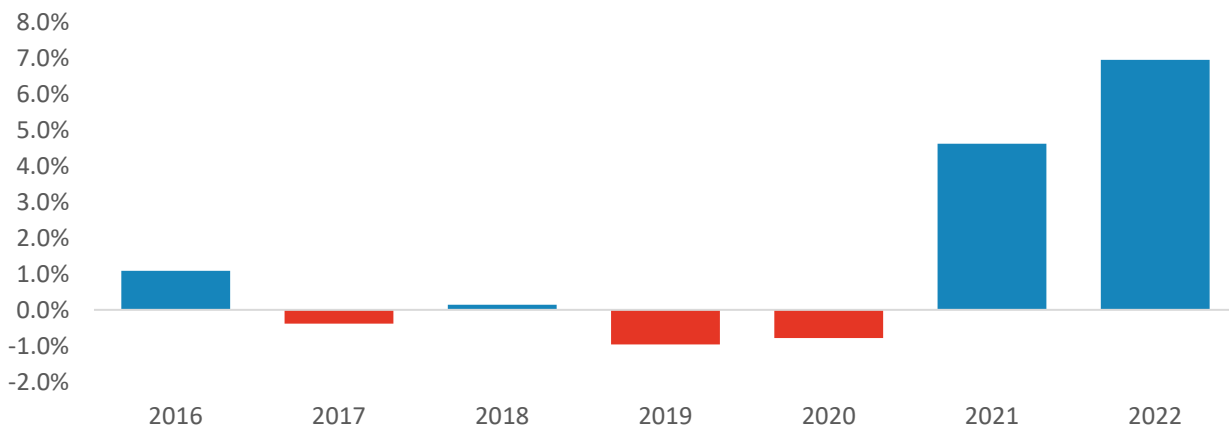
Annual Change in House Prices



House prices in North Tyneside grew by 10.5% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the North East grew by 9.6% over the same period.

North Tyneside house prices are now 30.3% above their previous peak in 2007, compared to +14.4% for the North East and +57.4% across England.

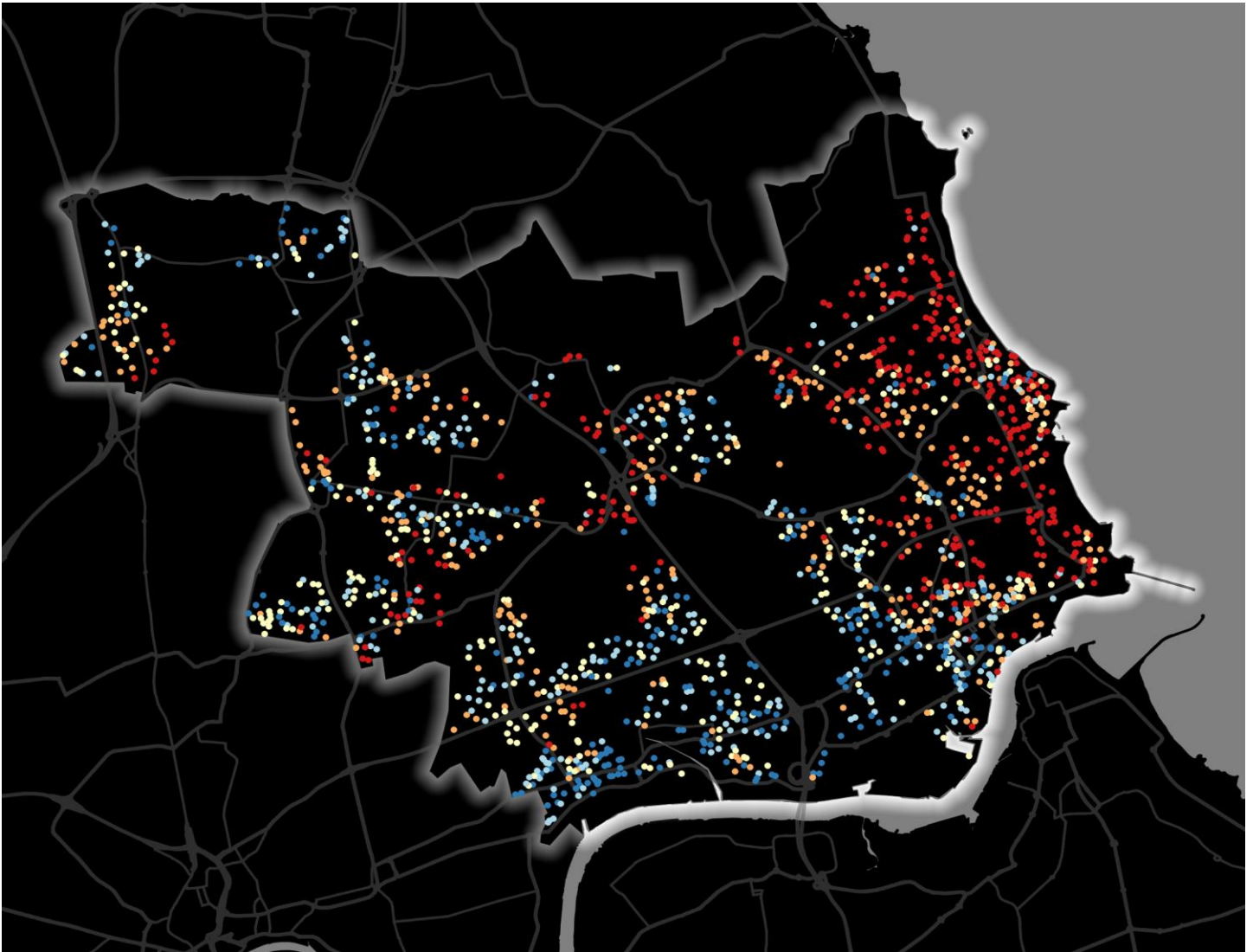
Year-To-Date Change in House Prices, December to July



Local prices have grown by 6.9% in 2022 so far, compared to growth of 4.6% over the same period last year.

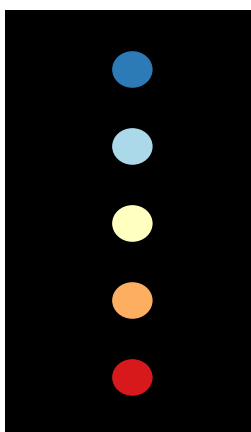
House Price Map

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

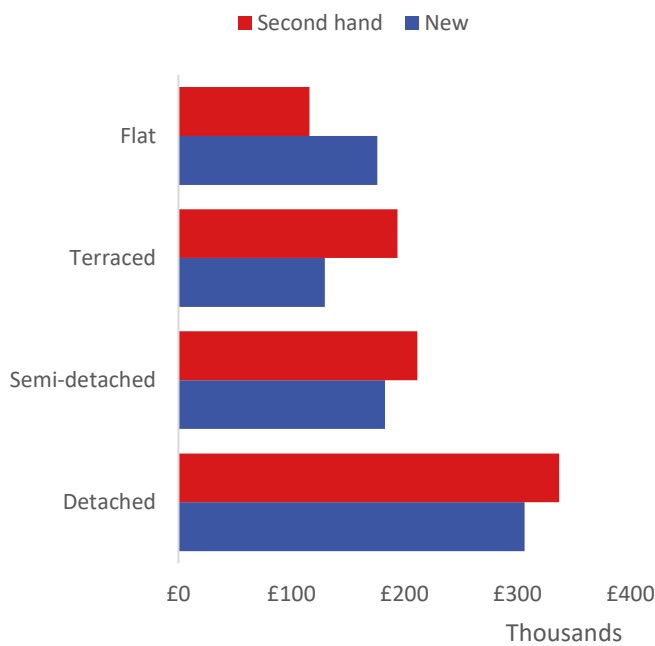

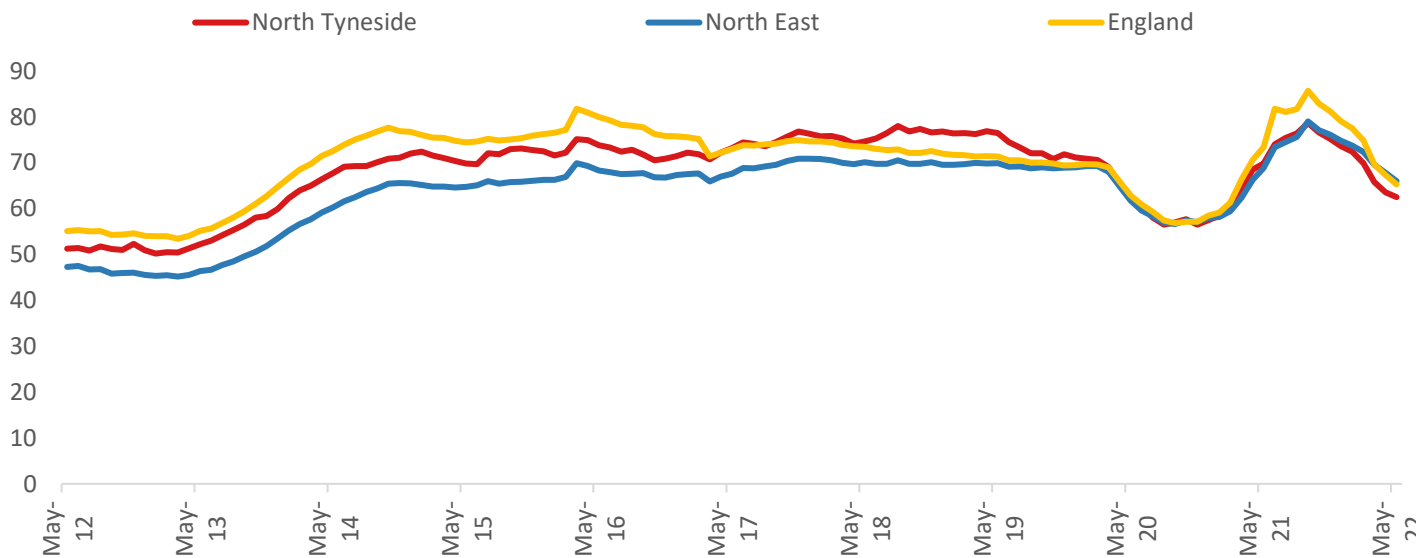

Transactions (May 2022 data)

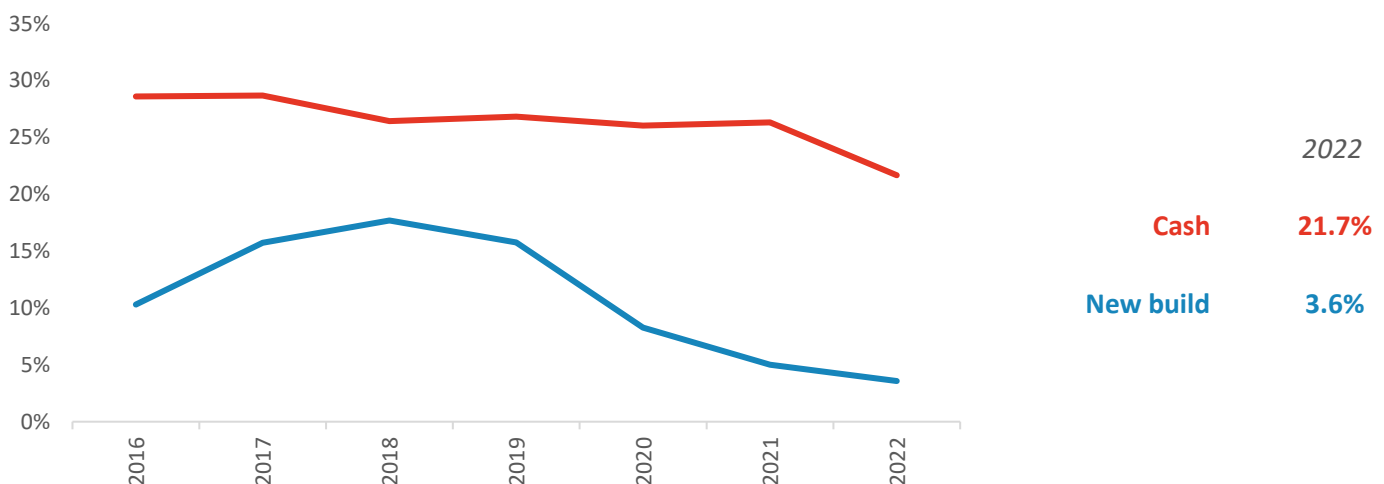
Annual Transactions, Indexed (2001-05 average = 100)



There were 3,101 transactions in North Tyneside during the 12 months to May 2022. This is 62% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in North Tyneside have fallen by 13.2% since 2014, compared to changes of +0.7% for North East and -14.9% for England.

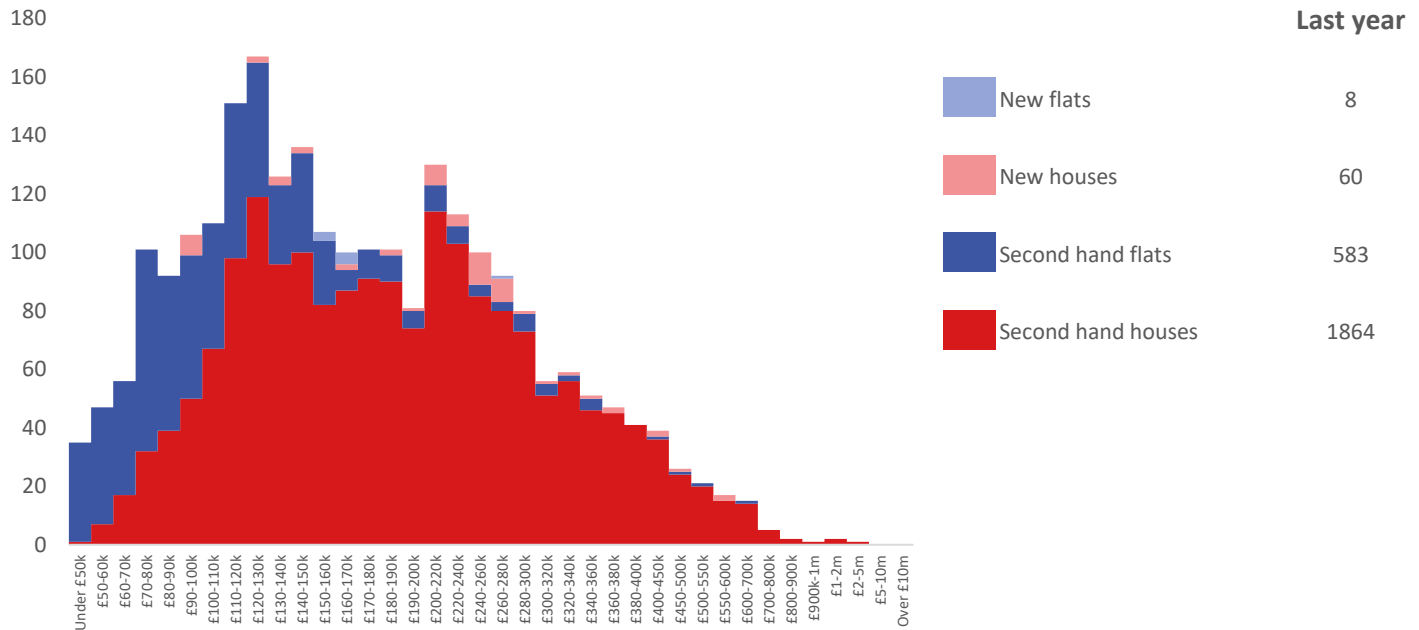
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

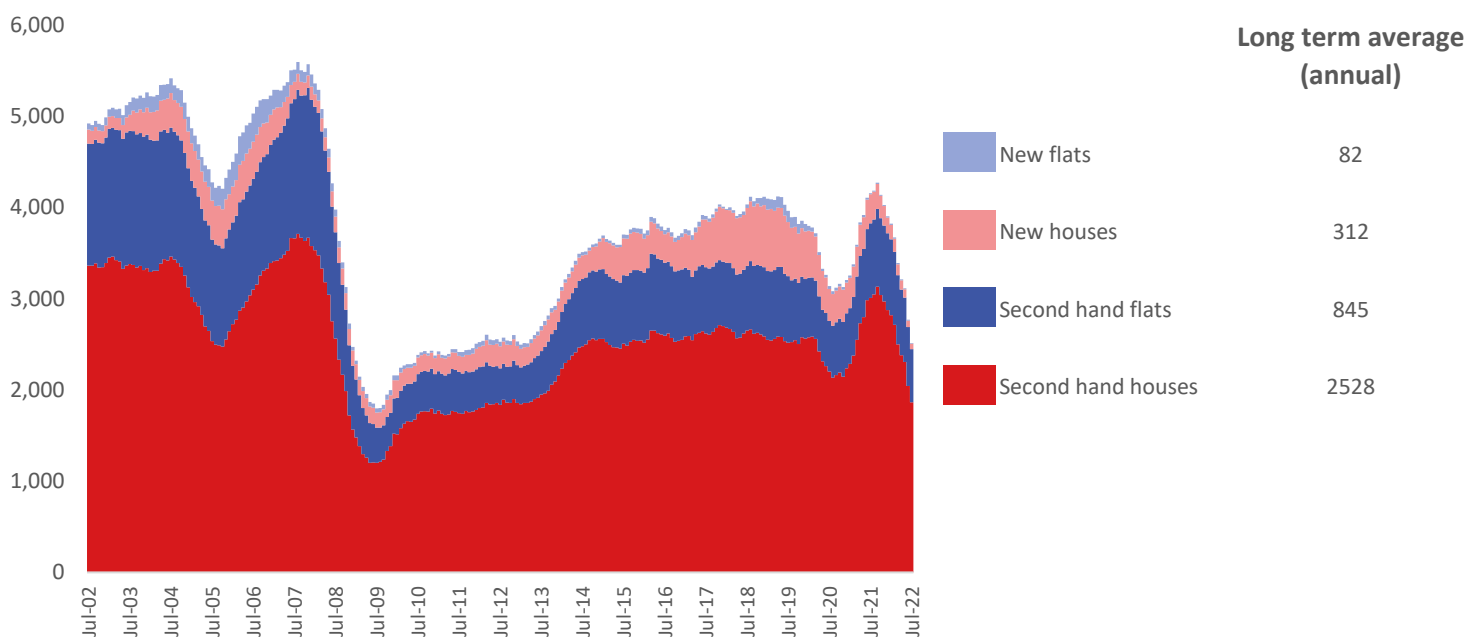
12 months to July 2022



The most common property type transacted over the past 12 months in North Tyneside was 'second hand houses' with 1,864 sales, 74% of all sales over the same period. The annual total of 2,515 transactions is equivalent to 67% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 2,528 sales per year on average, making up 67% of the typical annual total over that period.
