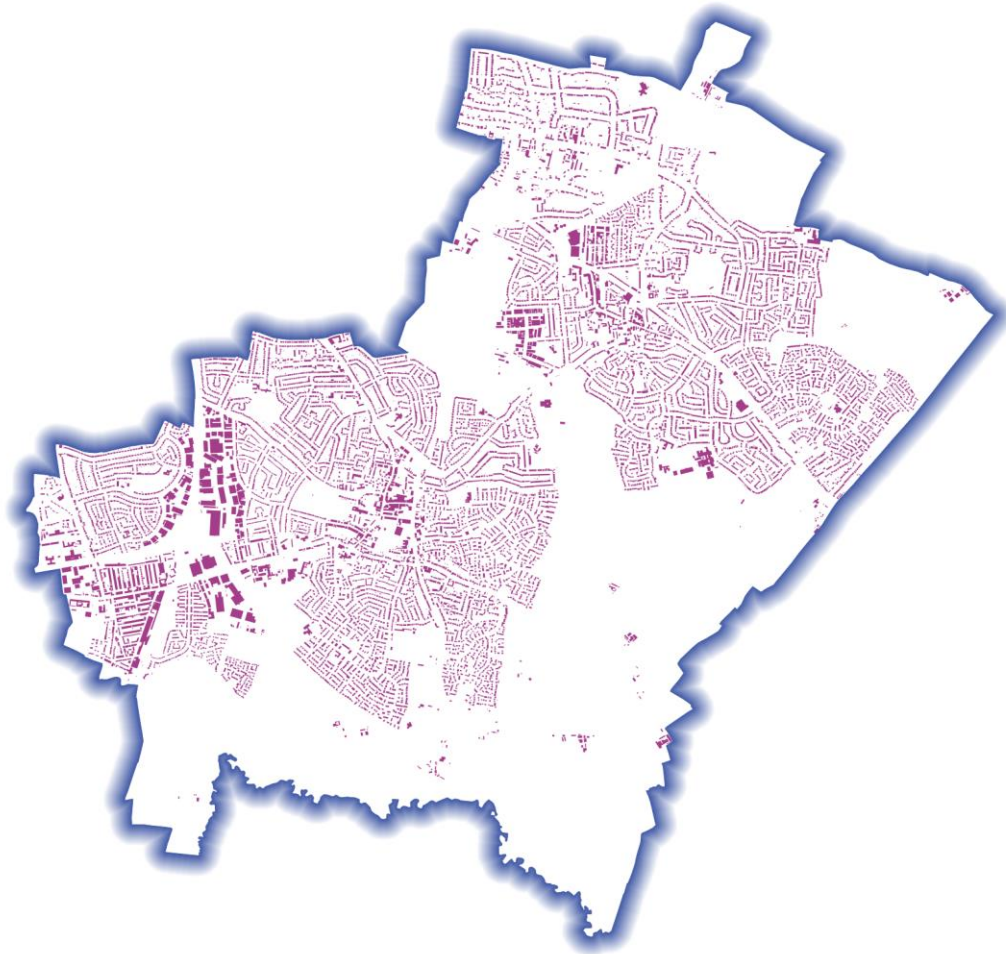

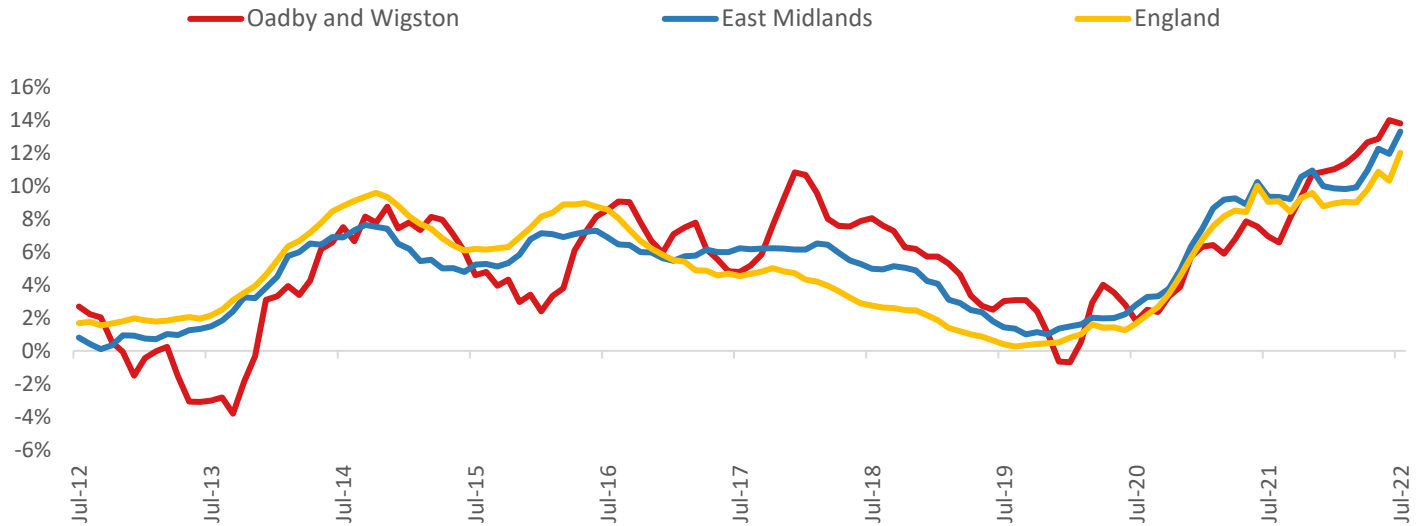

House Price Growth (July 2022 data)

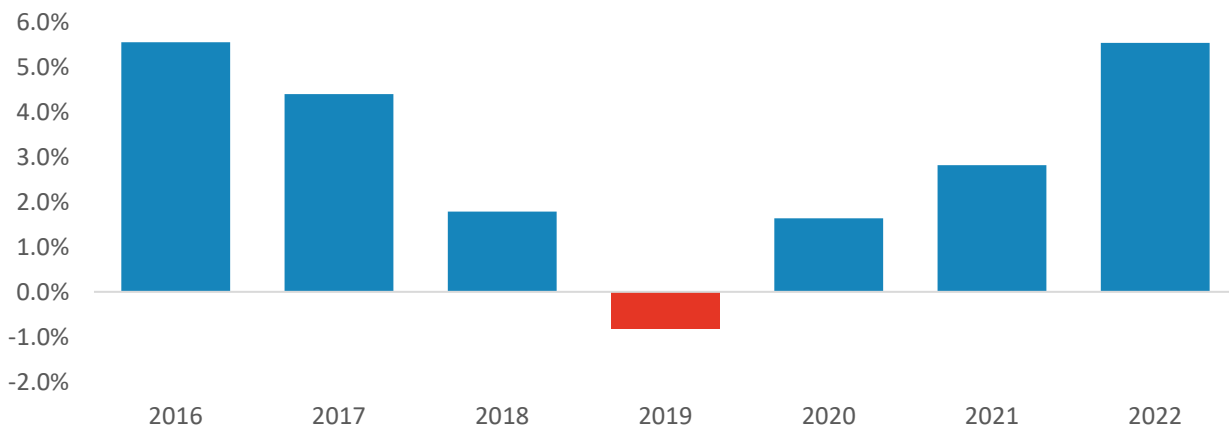
Annual Change in House Prices



House prices in Oadby and Wigston grew by 13.8% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the East Midlands grew by 13.3% over the same period.

Oadby and Wigston house prices are now 56.7% above their previous peak in 2007, compared to +54.9% for the East Midlands and +57.4% across England.

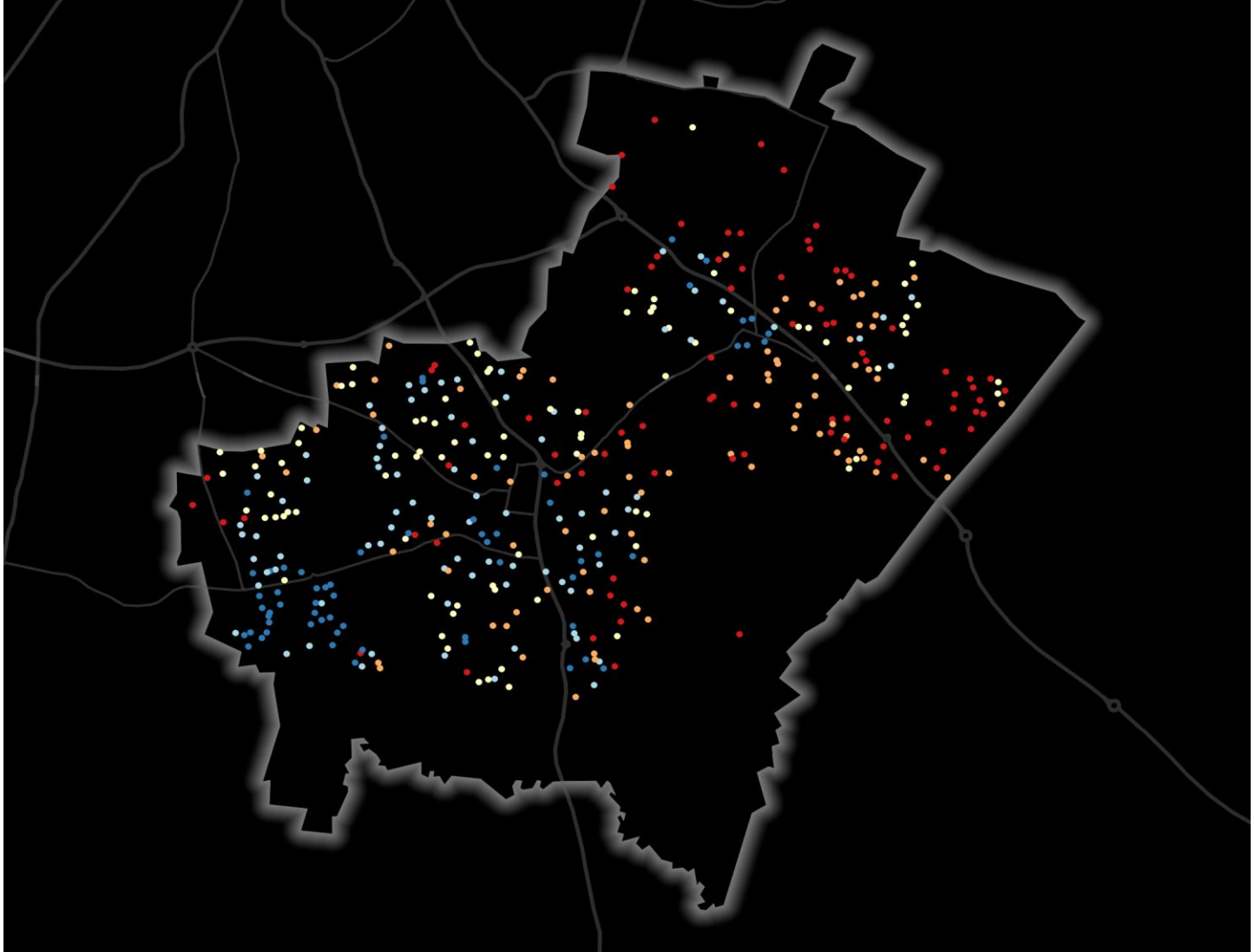
Year-To-Date Change in House Prices, December to July



Local prices have grown by 5.5% in 2022 so far, compared to growth of 2.8% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

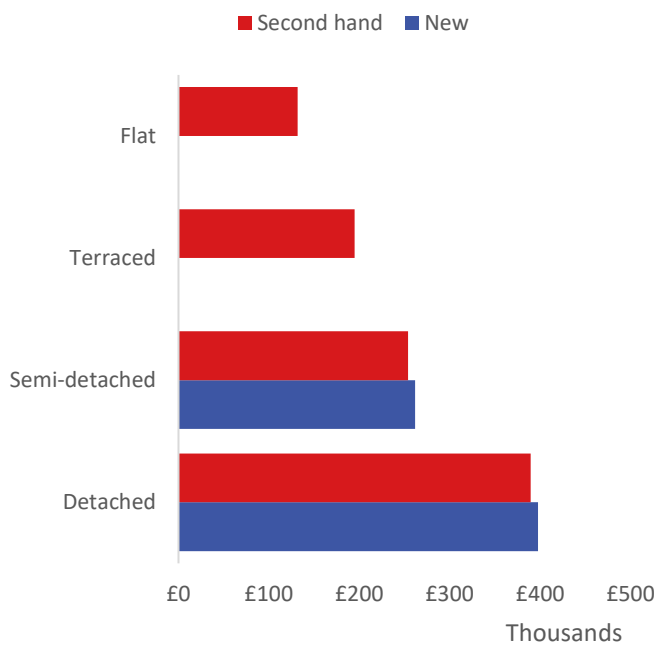

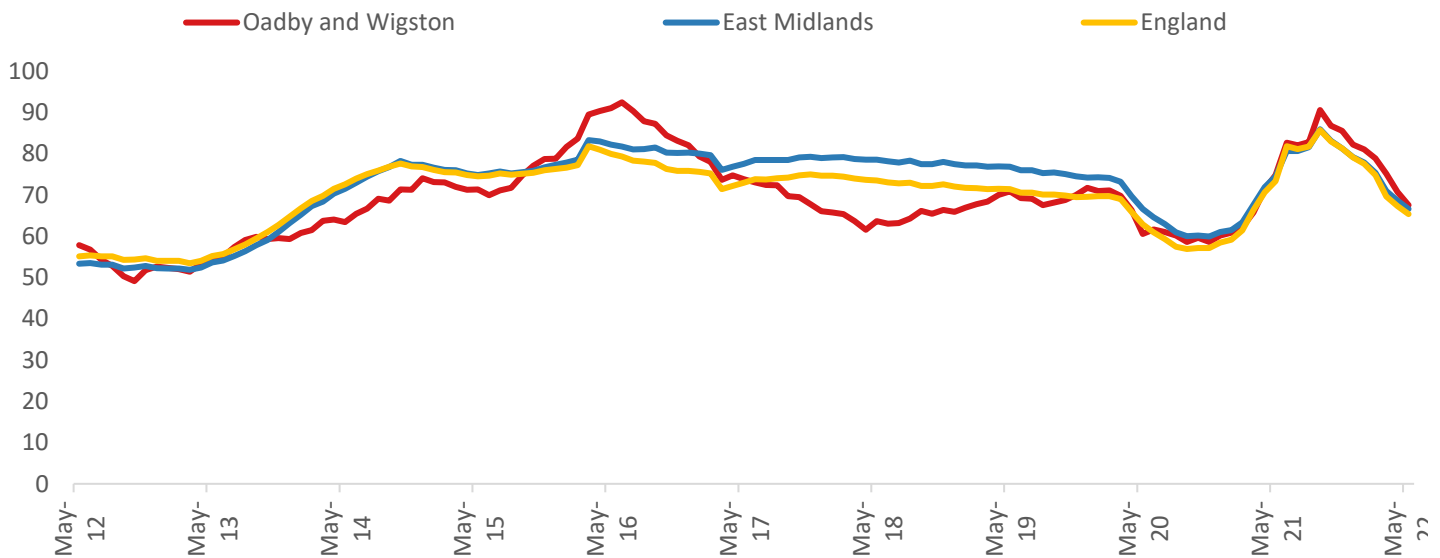

Transactions (May 2022 data)

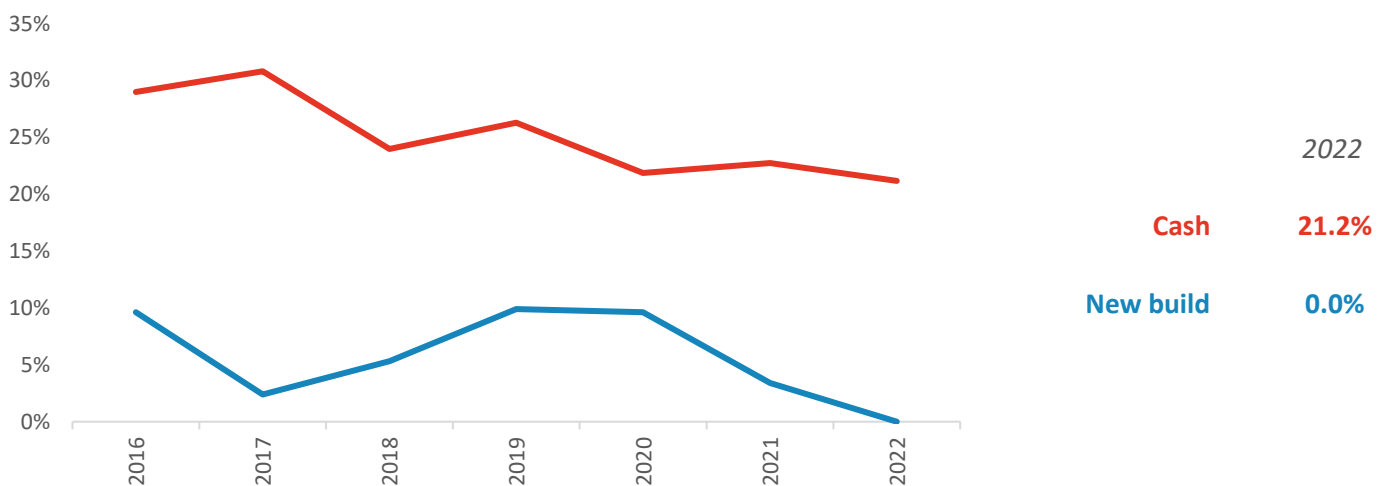
Annual Transactions, Indexed (2001-05 average = 100)



There were 770 transactions in Oadby and Wigston during the 12 months to May 2022. This is 68% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Oadby and Wigston have fallen by 8.8% since 2014, compared to changes of -13.8% for East Midlands and -14.9% for England.

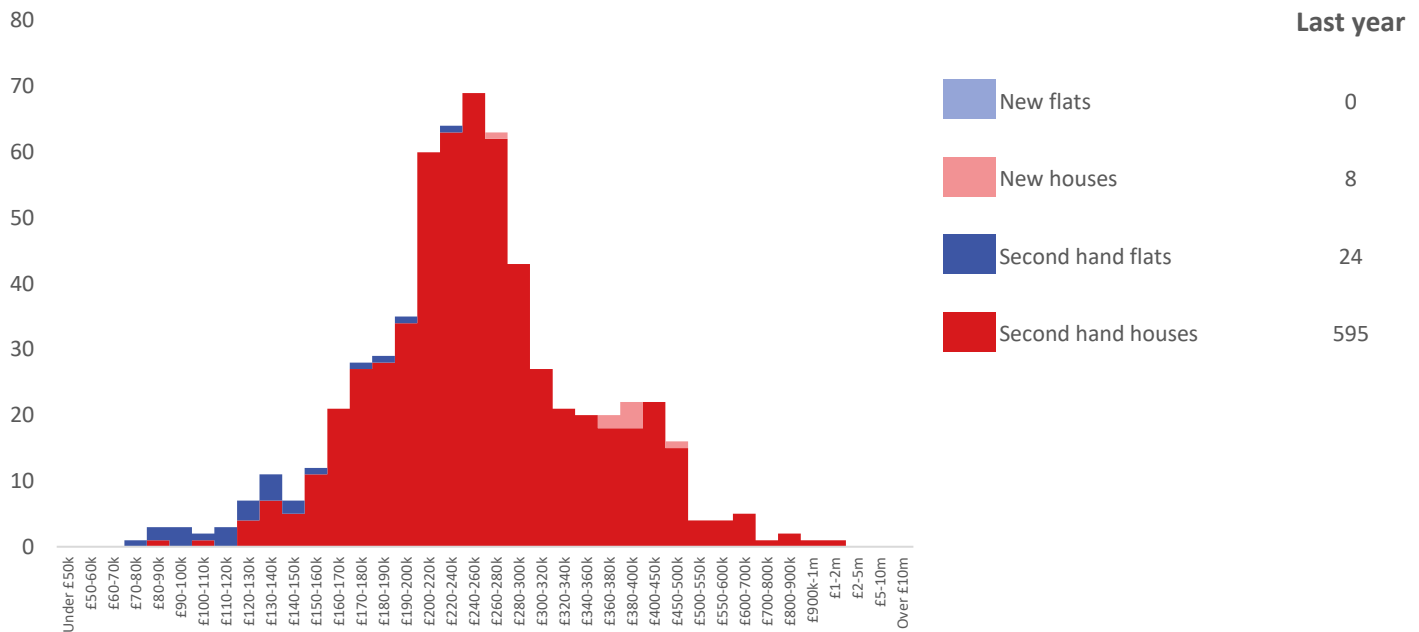
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

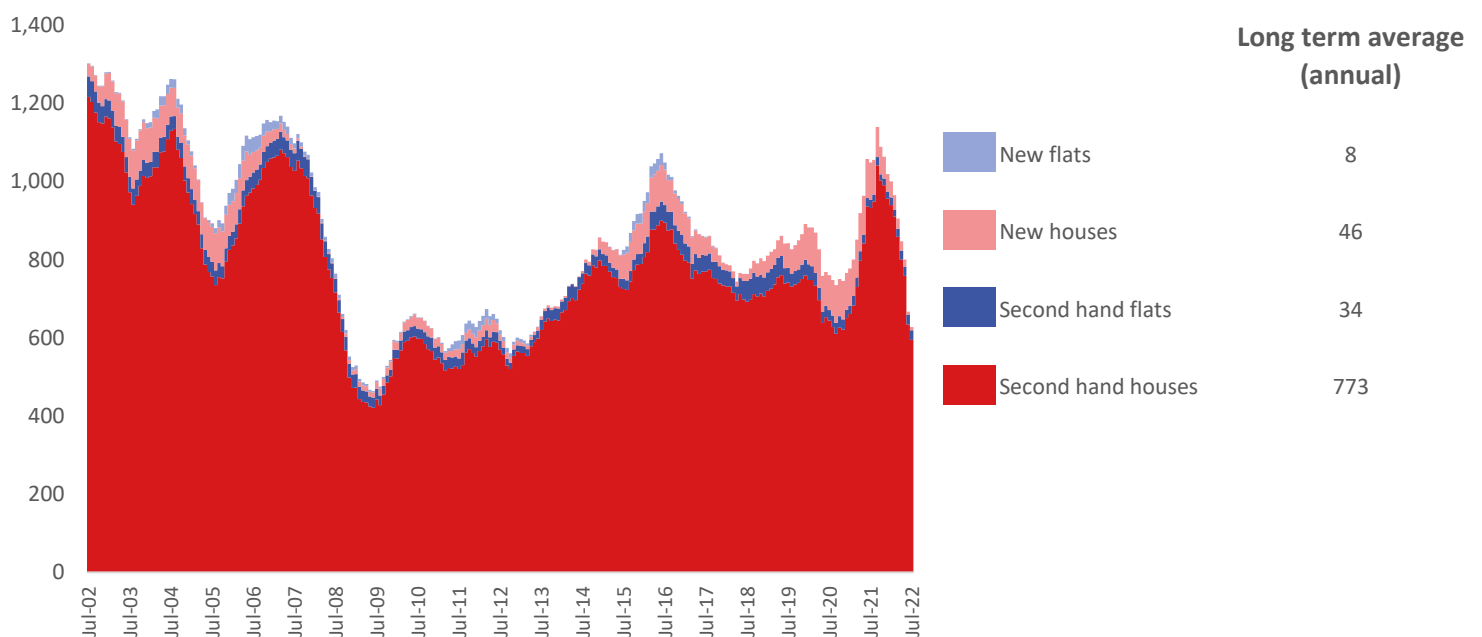
12 months to July 2022



The most common property type transacted over the past 12 months in Oadby and Wigston was 'second hand houses' with 595 sales, 95% of all sales over the same period. The annual total of 627 transactions is equivalent to 73% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 773 sales per year on average, making up 90% of the typical annual total over that period.
