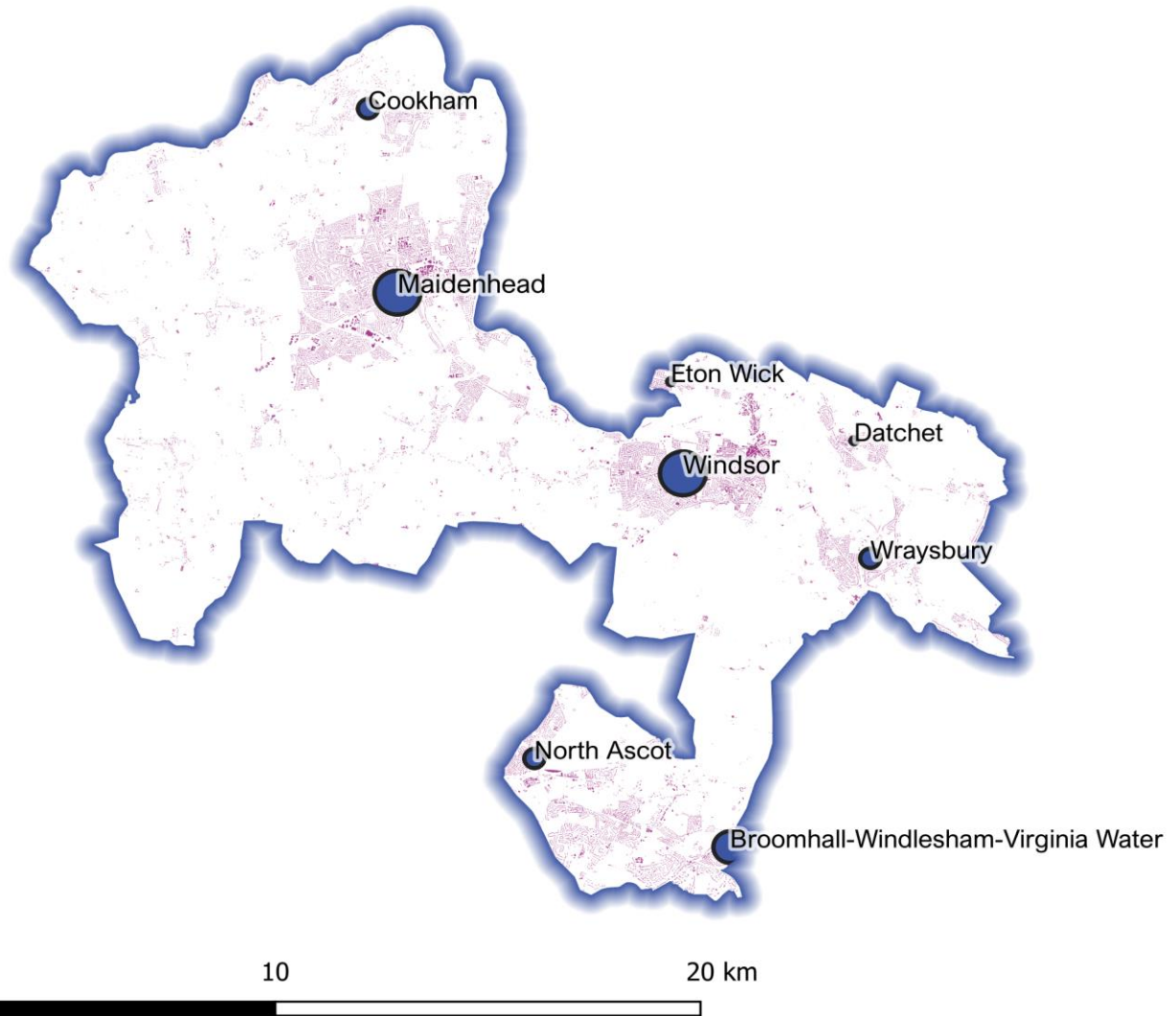

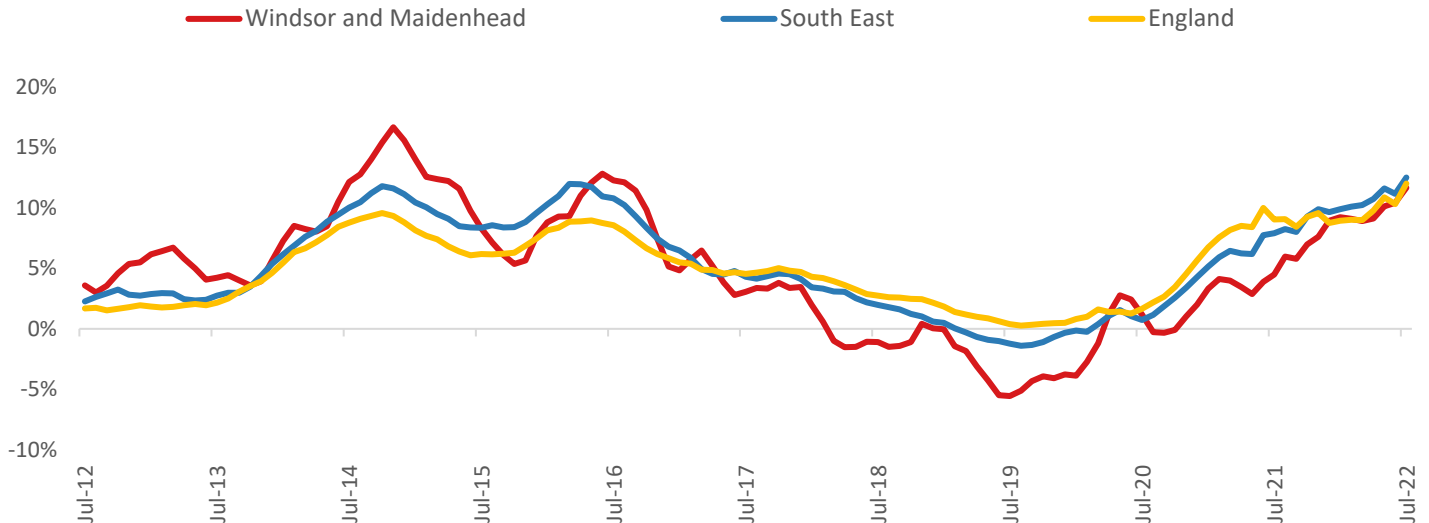

House Price Growth (July 2022 data)

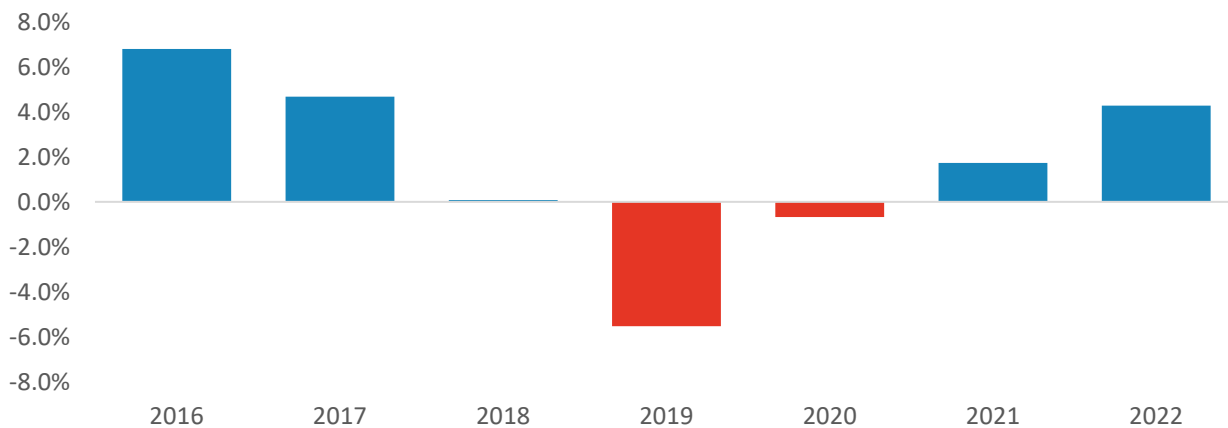
Annual Change in House Prices



House prices in Windsor and Maidenhead grew by 11.7% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the South East grew by 12.5% over the same period.

Windsor and Maidenhead house prices are now 58.6% above their previous peak in 2007, compared to +65.1% for the South East and +57.4% across England.

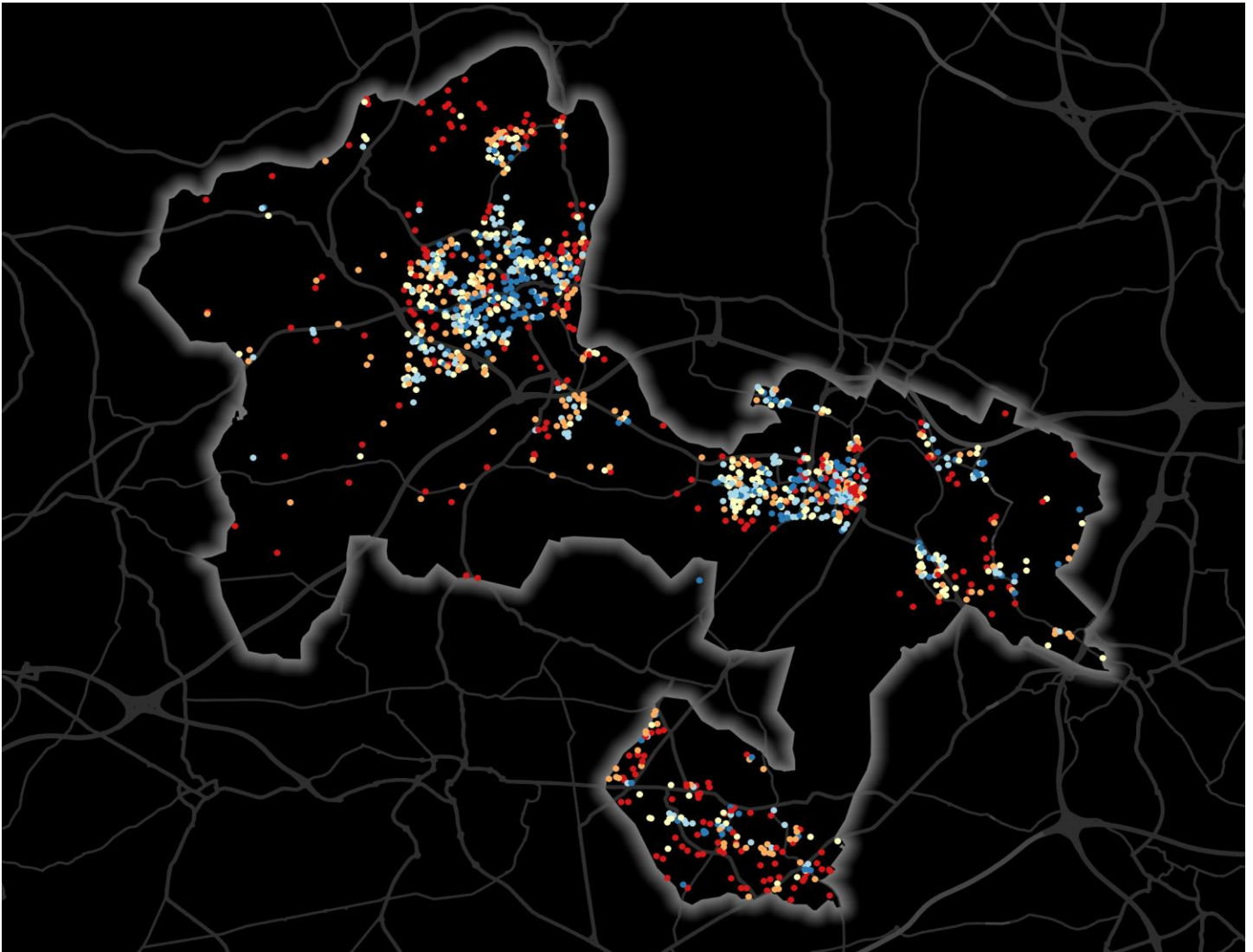
Year-To-Date Change in House Prices, December to July



Local prices have grown by 4.3% in 2022 so far, compared to growth of 1.7% over the same period last year.

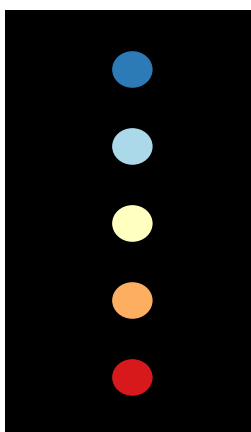
House Price Map

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

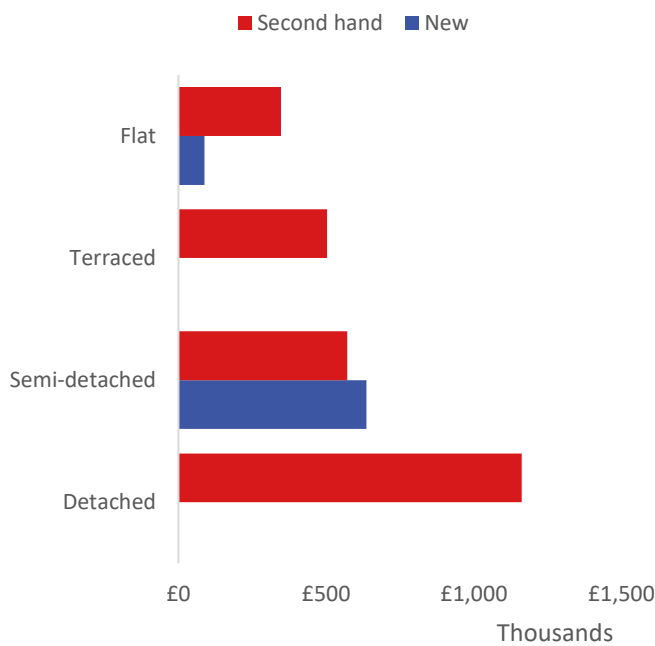

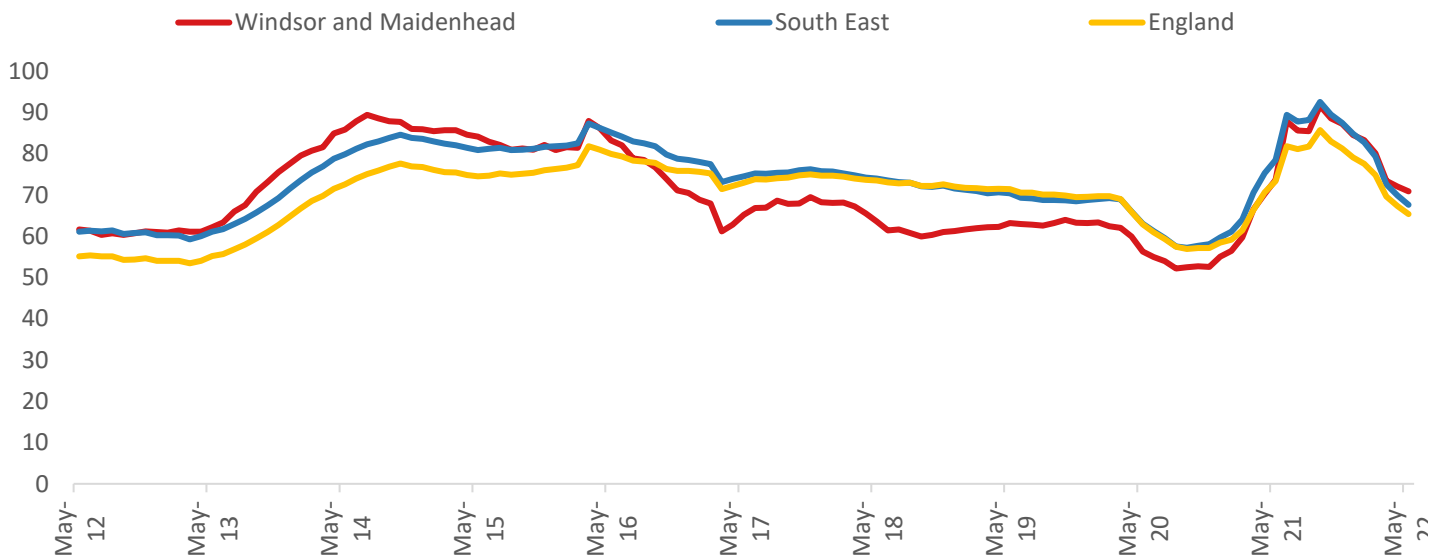

Transactions (May 2022 data)

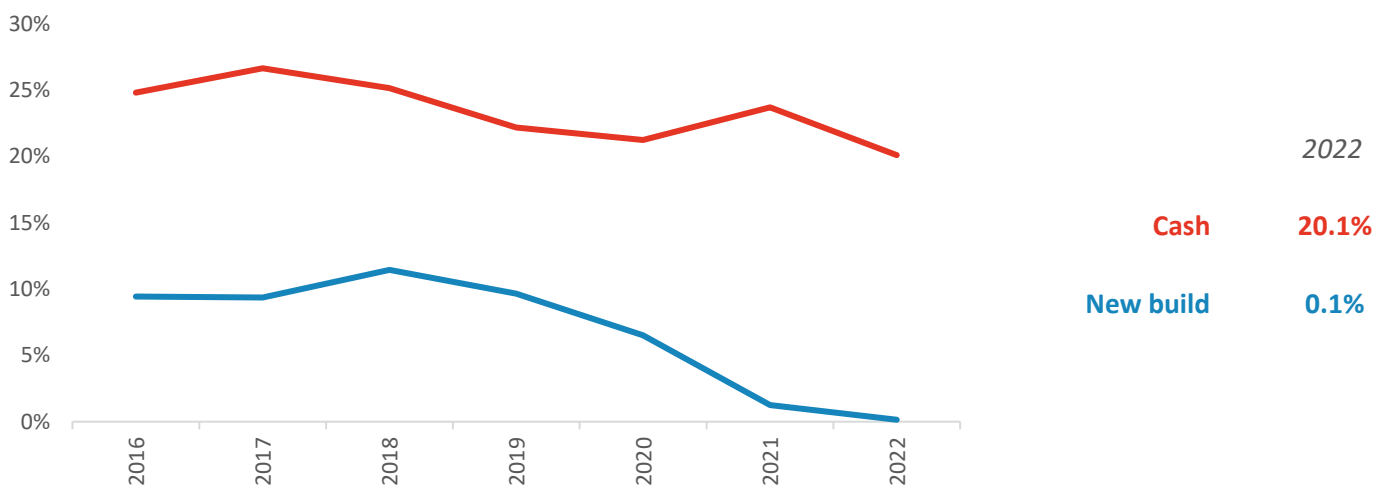
Annual Transactions, Indexed (2001-05 average = 100)



There were 2,195 transactions in Windsor and Maidenhead during the 12 months to May 2022. This is 71% of the average from 2001-05 and suggests activity is below pre-downturn levels.

Transactions in Windsor and Maidenhead have fallen by 17.5% since 2014, compared to changes of -19.1% for South East and -14.9% for England.

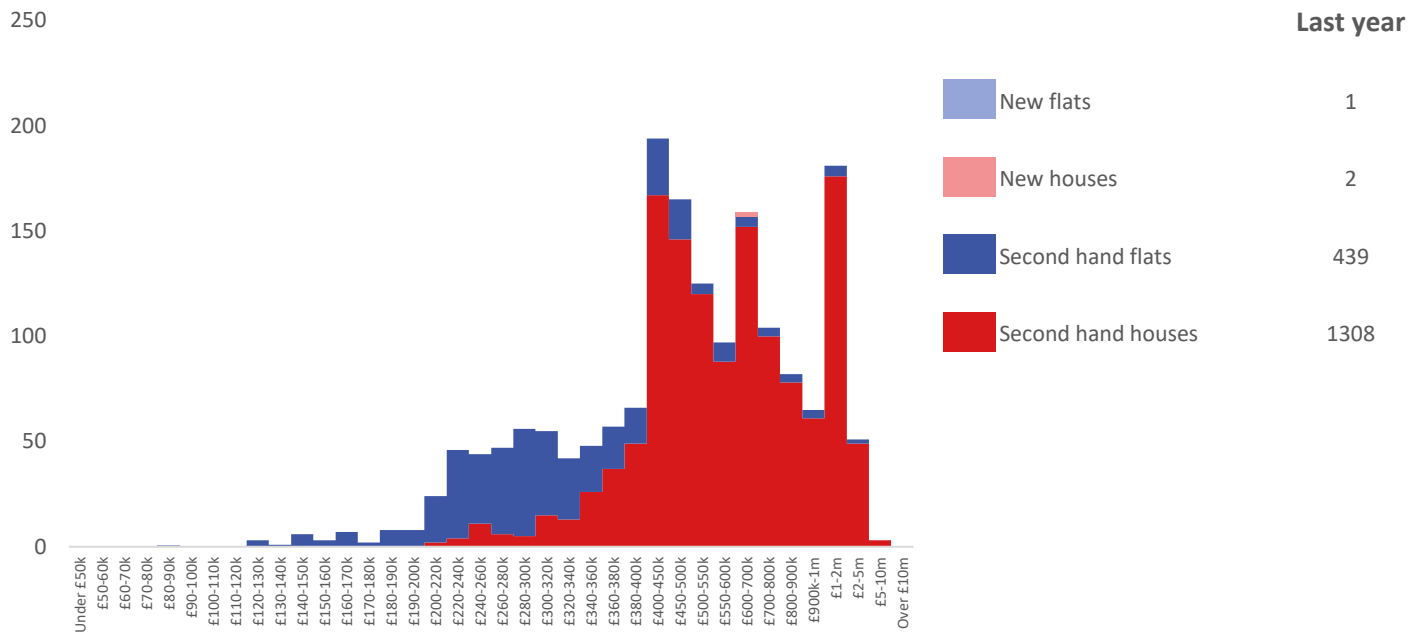
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

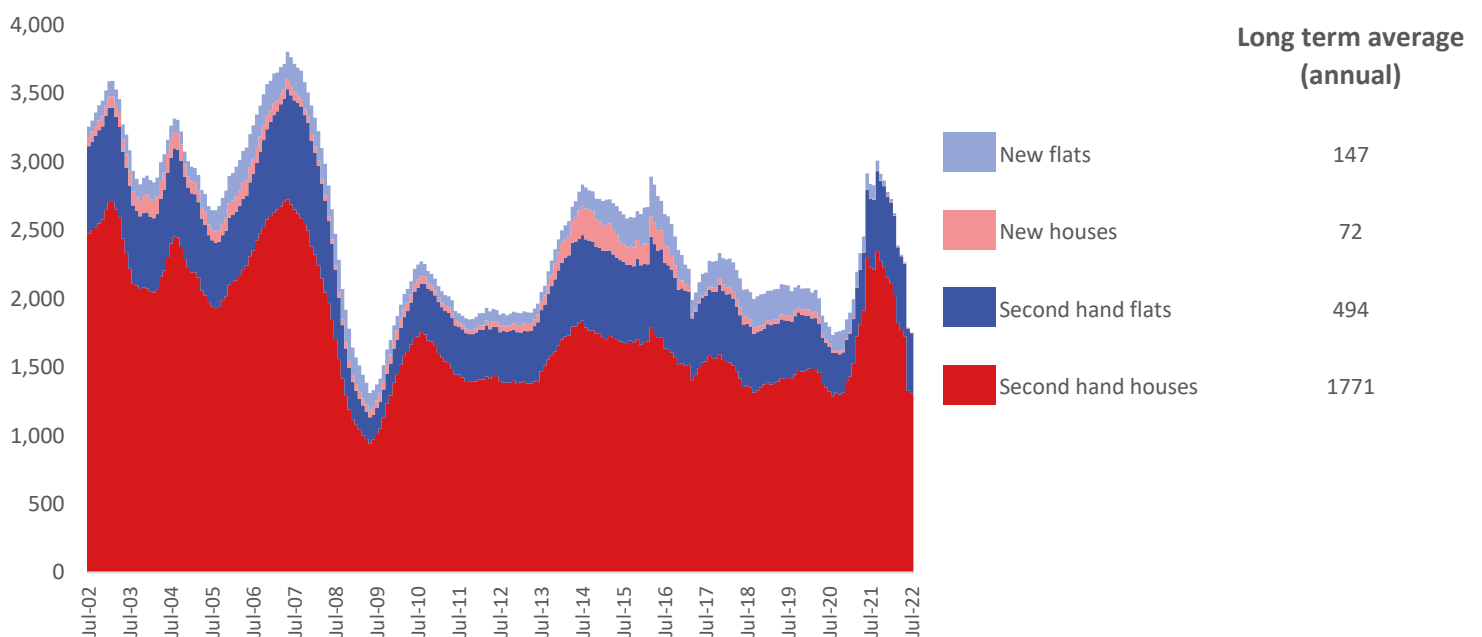
12 months to July 2022



The most common property type transacted over the past 12 months in Windsor and Maidenhead was 'second hand houses' with 1,308 sales, 75% of all sales over the same period. The annual total of 1,750 transactions is equivalent to 70% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,771 sales per year on average, making up 71% of the typical annual total over that period.
