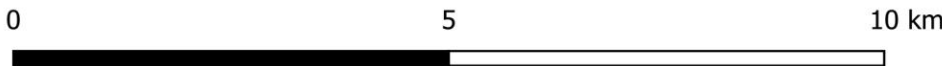

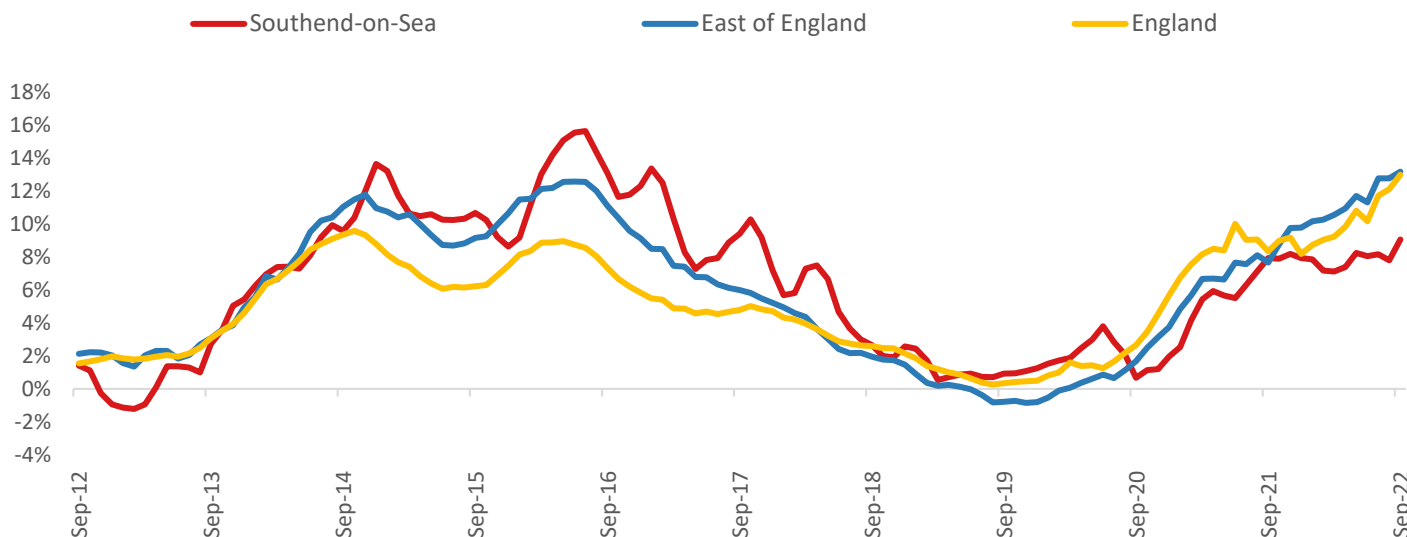

House Price Growth (September 2022 data)

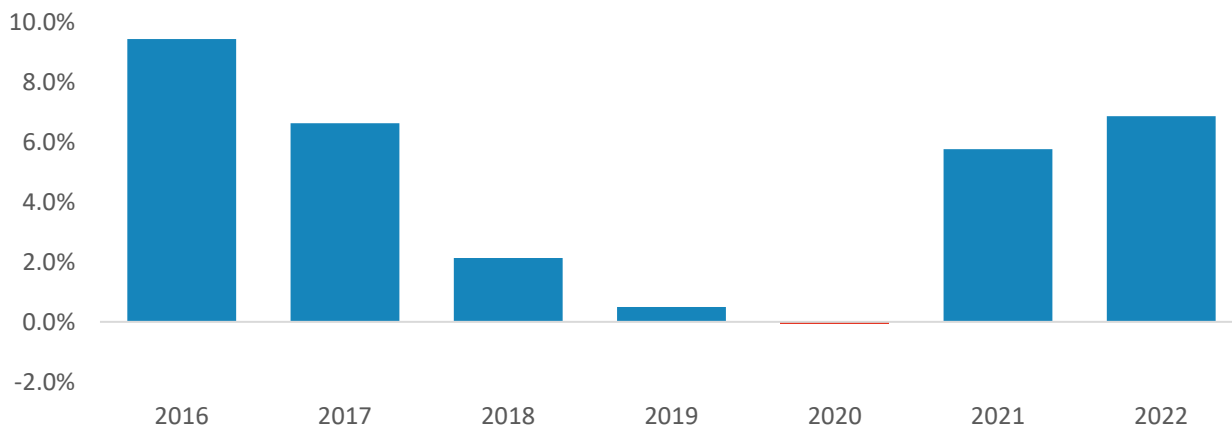
Annual Change in House Prices



House prices in Southend-on-Sea grew by 9.0% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the East of England grew by 13.2% over the same period.

Southend-on-Sea house prices are now 75.4% above their previous peak in 2007, compared to +72.7% for the East of England and +61.0% across England.

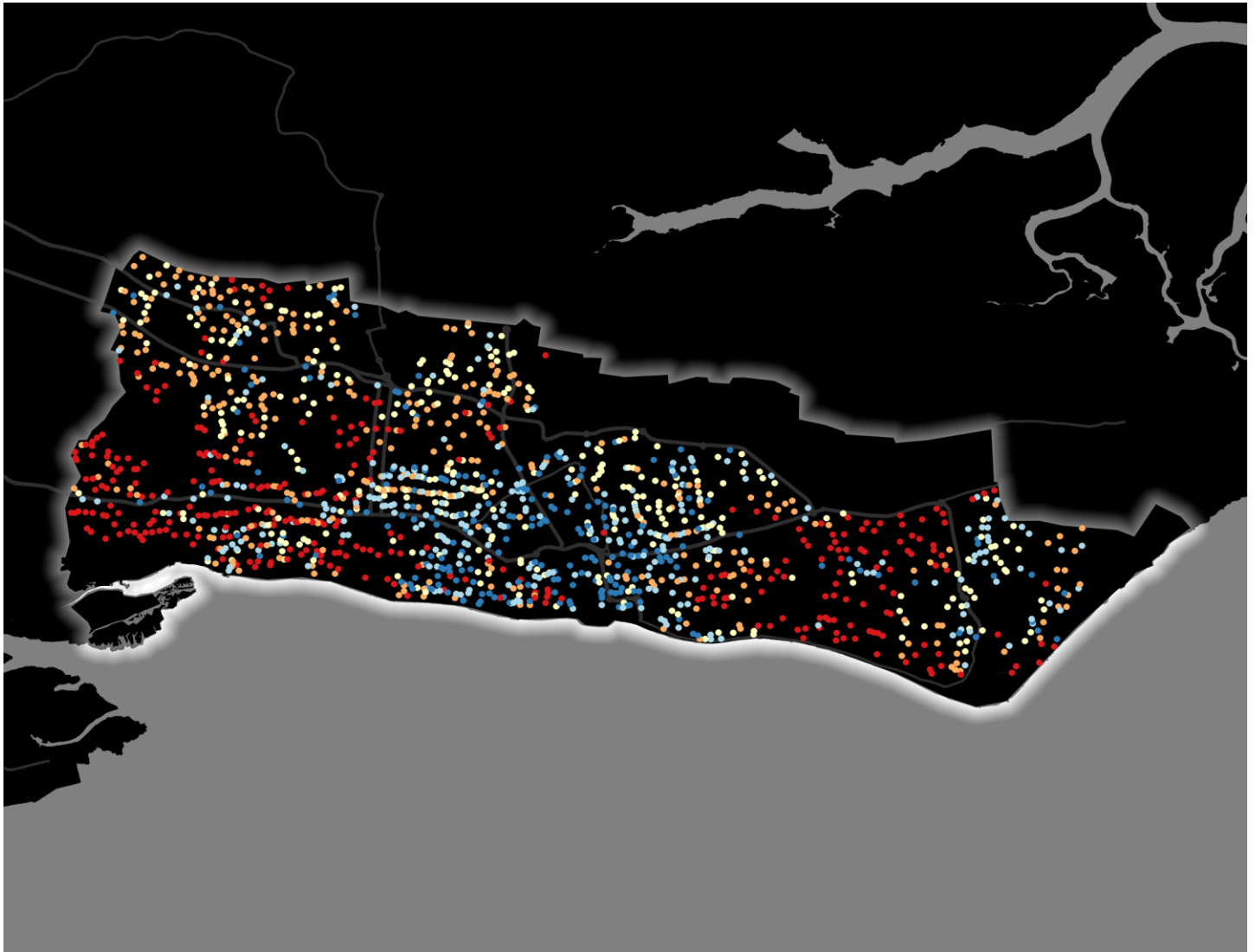
Year-To-Date Change in House Prices, December to September



Local prices have grown by 6.9% in 2022 so far, compared to growth of 5.8% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

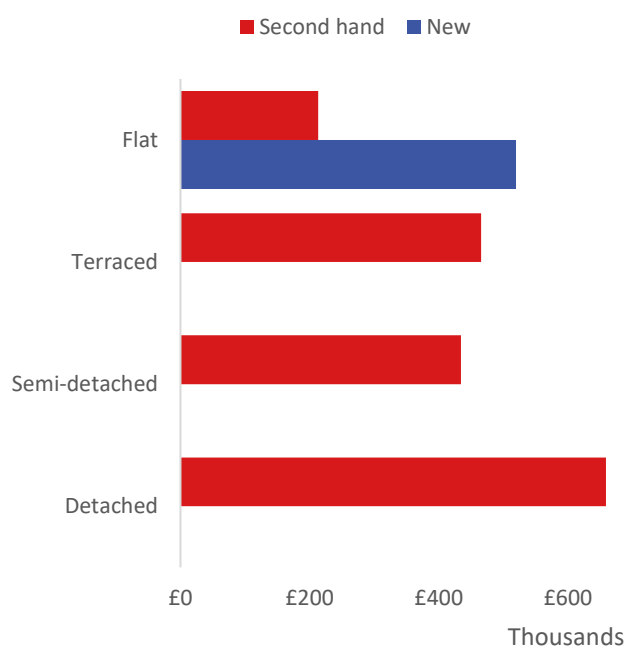

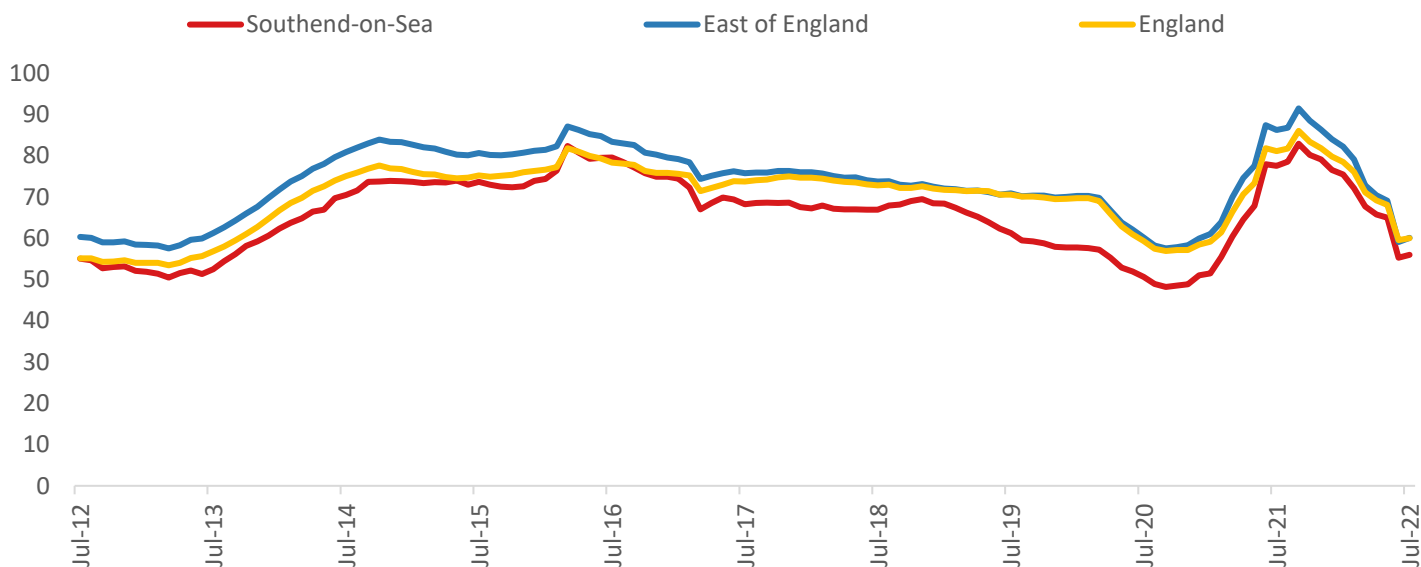

Transactions (July 2022 data)

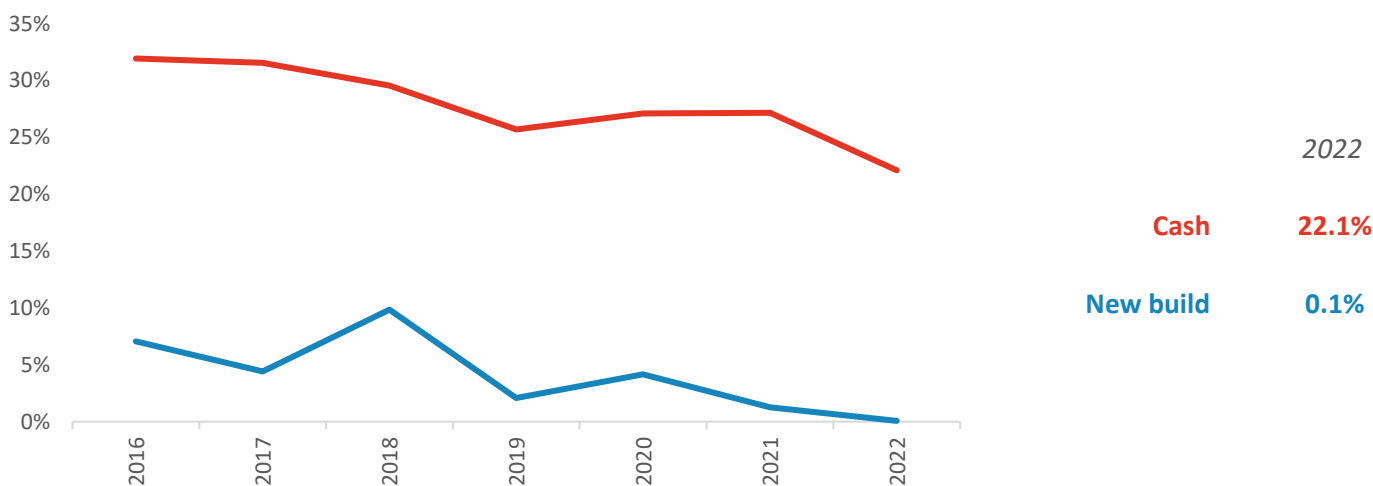
Annual Transactions, Indexed (2001-05 average = 100)



There were 2,666 transactions in Southend-on-Sea during the 12 months to July 2022. This is 56% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Southend-on-Sea have fallen by 24.1% since 2014, compared to changes of -27.9% for East of England and -21.9% for England.

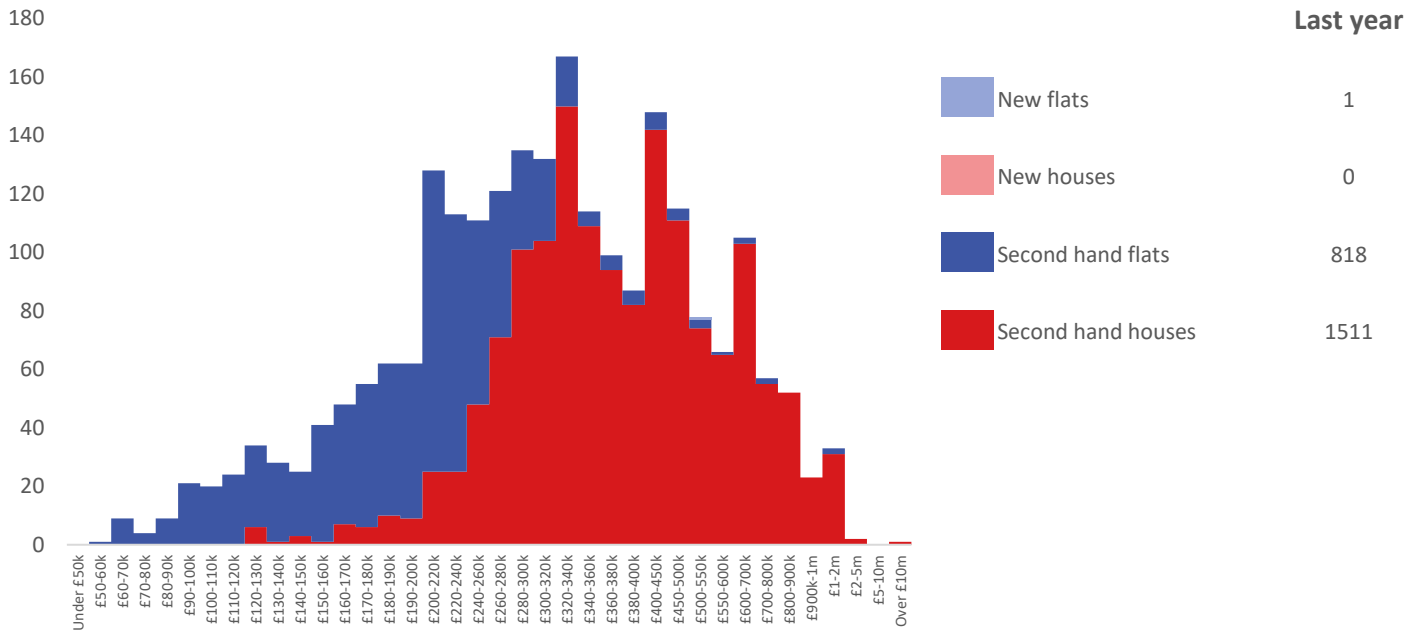
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

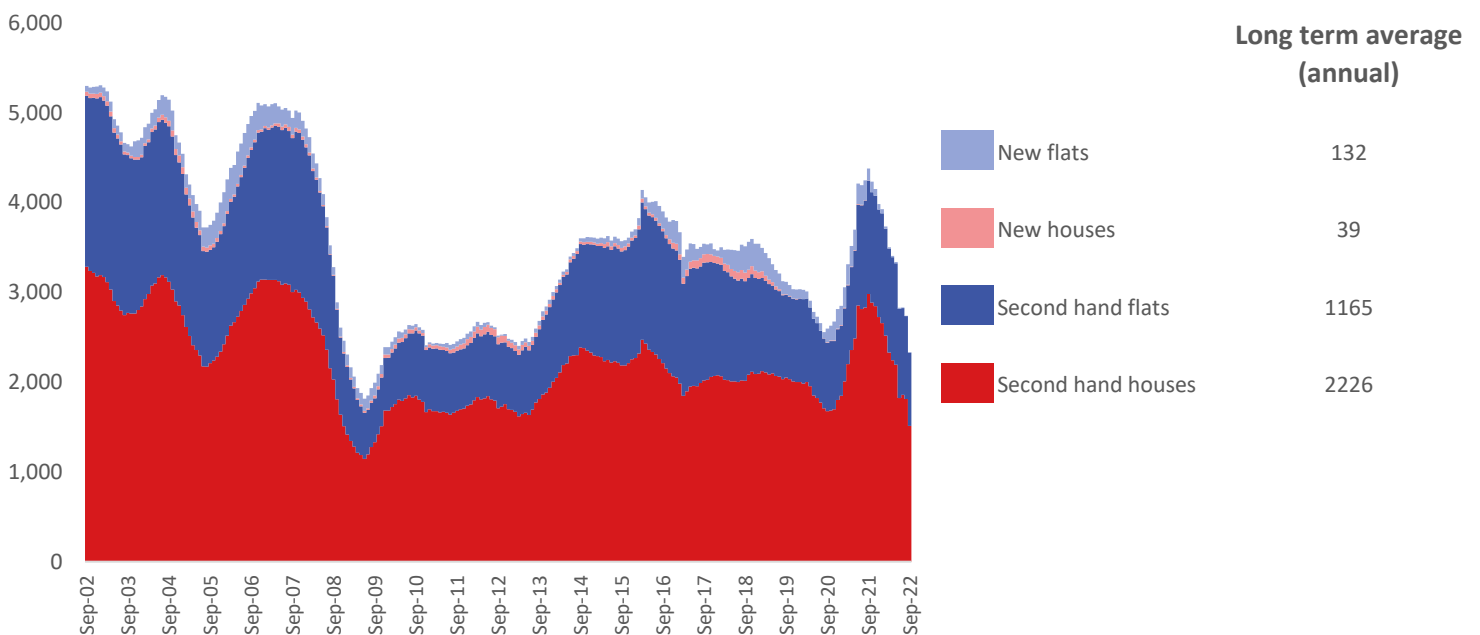
12 months to September 2022



The most common property type transacted over the past 12 months in Southend-on-Sea was 'second hand houses' with 1,511 sales, 65% of all sales over the same period. The annual total of 2,330 transactions is equivalent to 65% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 2,226 sales per year on average, making up 62% of the typical annual total over that period.
