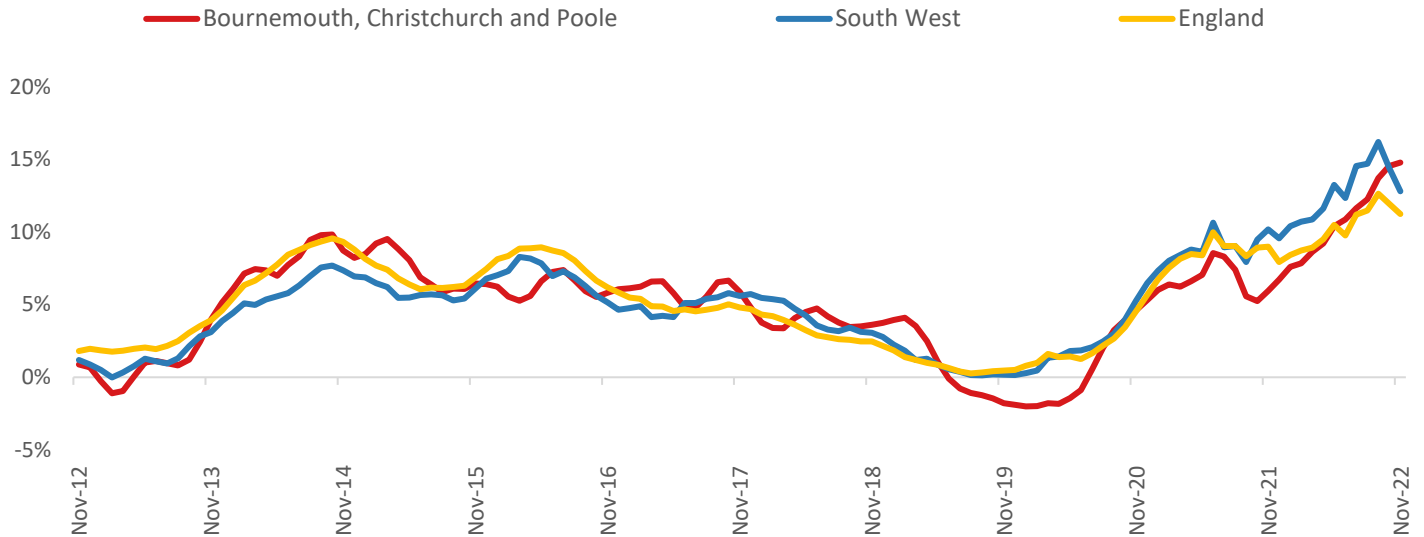

House Price Growth (November 2022 data)

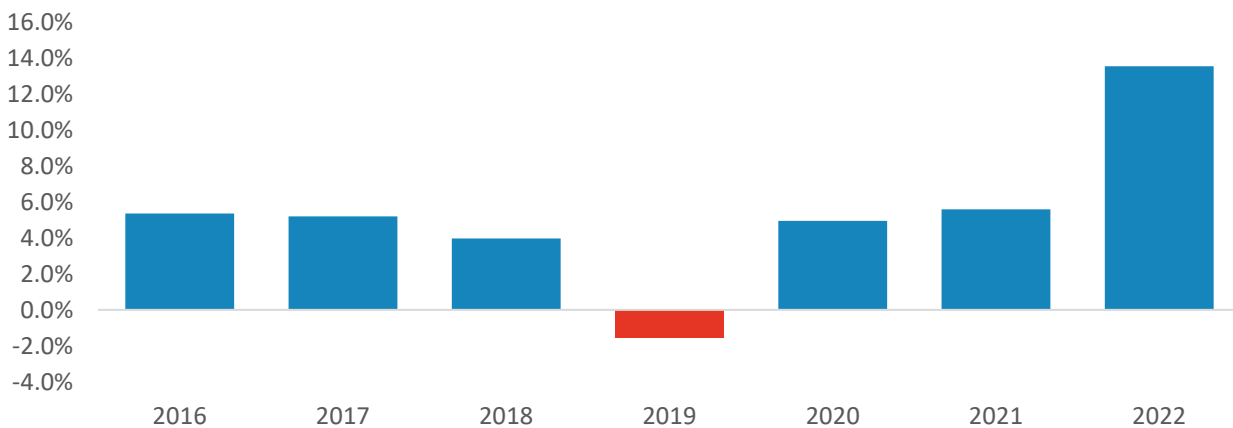
Annual Change in House Prices



House prices in Bournemouth, Christchurch and Poole grew by 14.8% in the 12 months to November 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.2% and prices in the South West grew by 12.8% over the same period.

Bournemouth, Christchurch and Poole house prices are now 58.5% above their previous peak in 2007, compared to +59.9% for the South West and +62.2% across England.

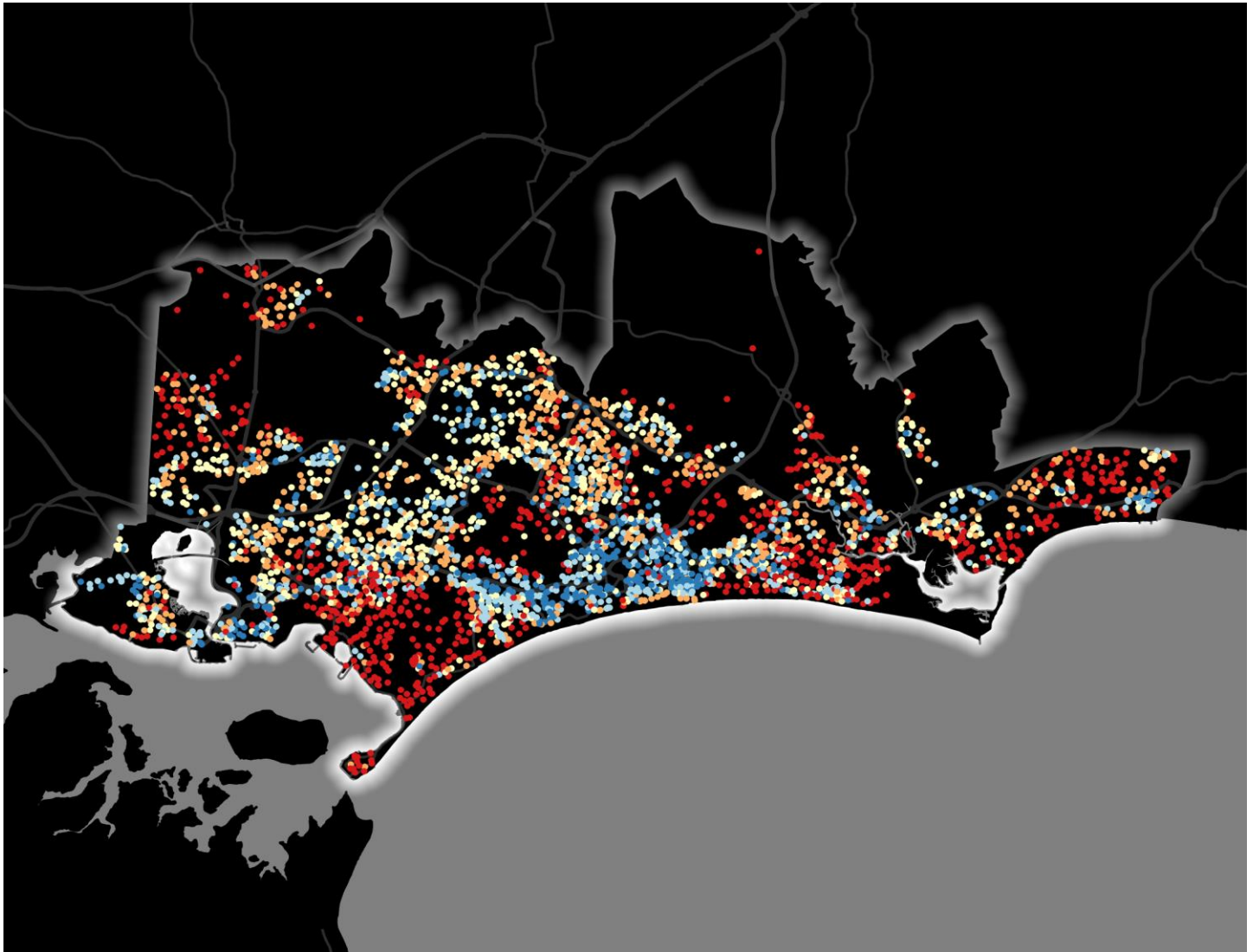
Year-To-Date Change in House Prices, December to November



Local prices have grown by 13.5% in 2022 so far, compared to growth of 5.6% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

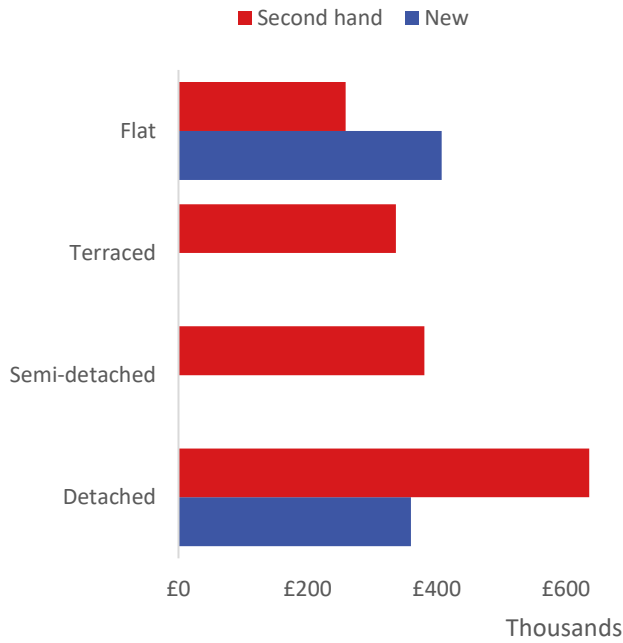

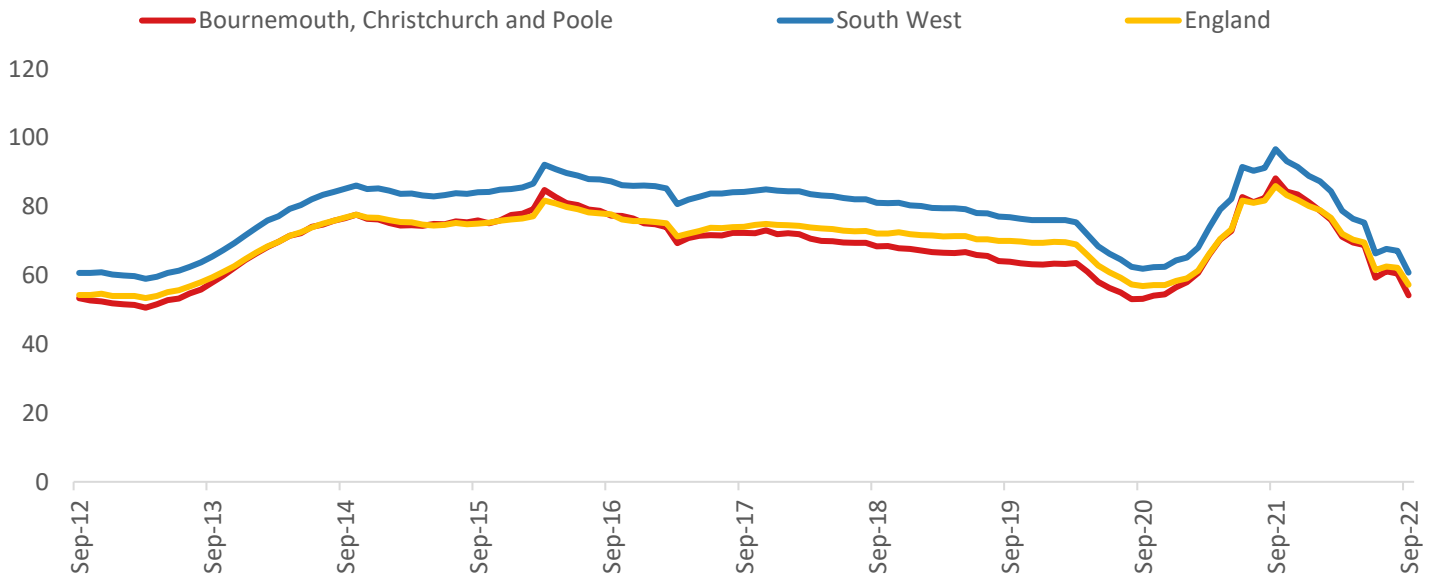

Transactions (September 2022 data)

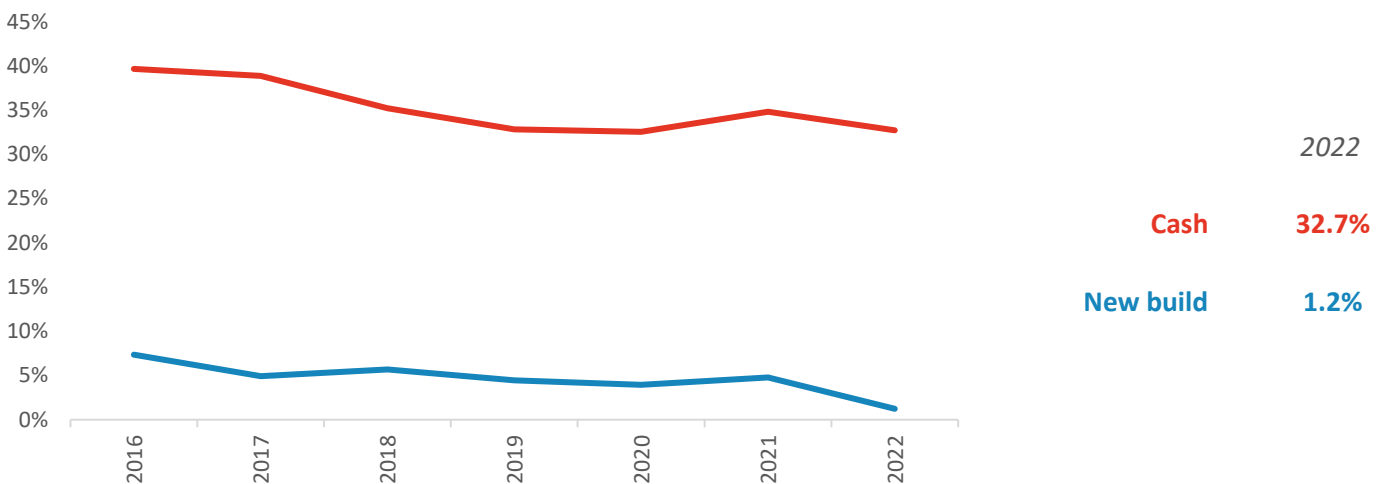
Annual Transactions, Indexed (2001-05 average = 100)



There were 5,957 transactions in Bournemouth, Christchurch and Poole during the 12 months to September 2022. This is 54% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Bournemouth, Christchurch and Poole have fallen by 29.0% since 2014, compared to changes of -28.7% for South West and -25.4% for England.

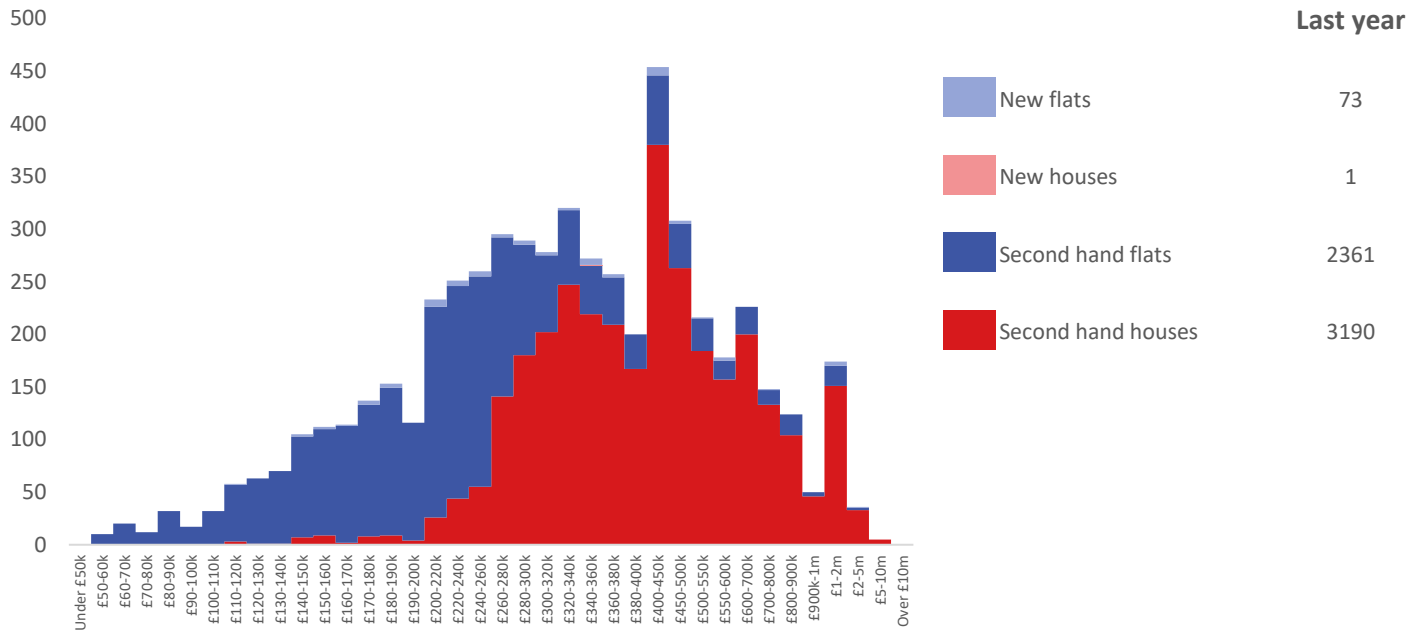
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

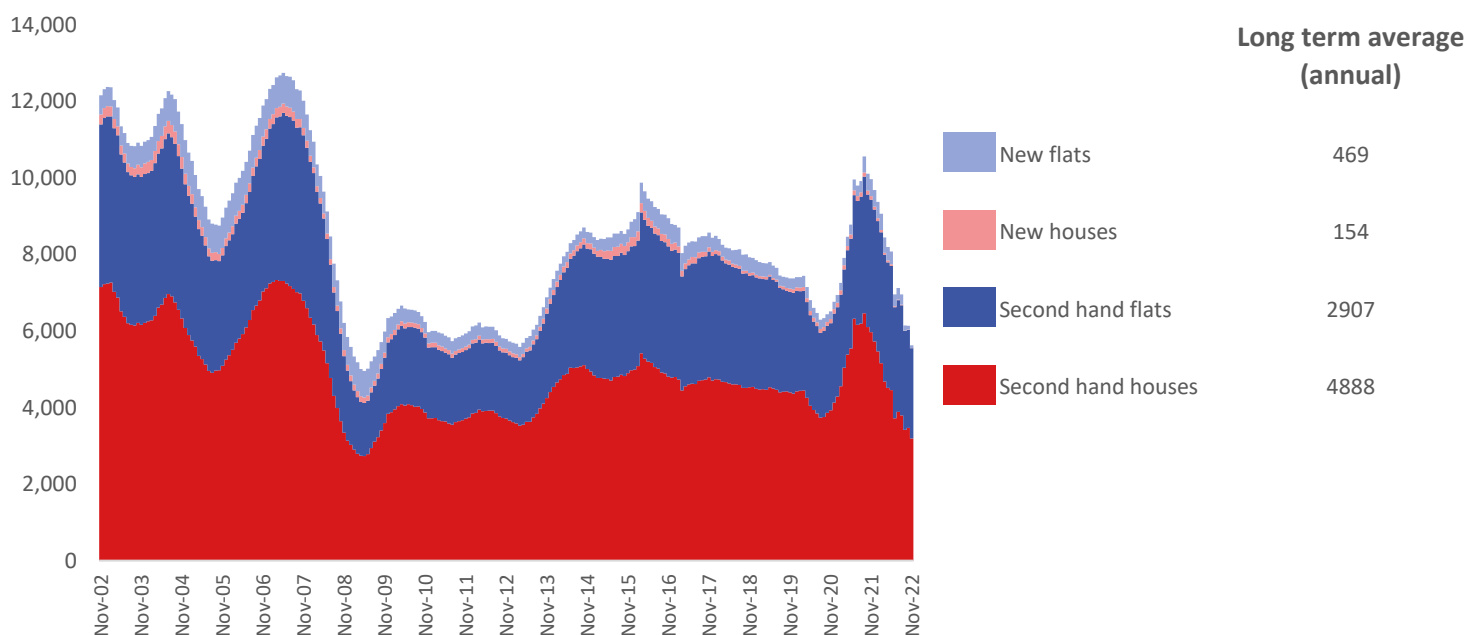
12 months to November 2022



The most common property type transacted over the past 12 months in Bournemouth, Christchurch and Poole was 'second hand houses' with 3,190 sales, 57% of all sales over the same period. The annual total of 5,625 transactions is equivalent to 67% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 4,888 sales per year on average, making up 58% of the typical annual total over that period.
