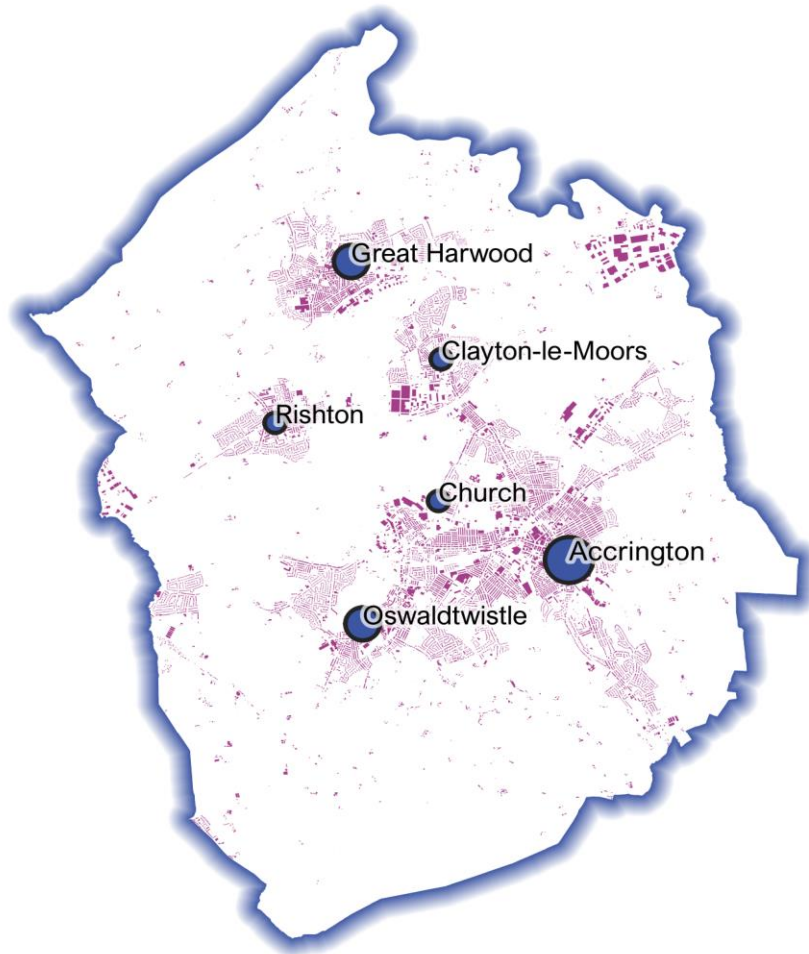

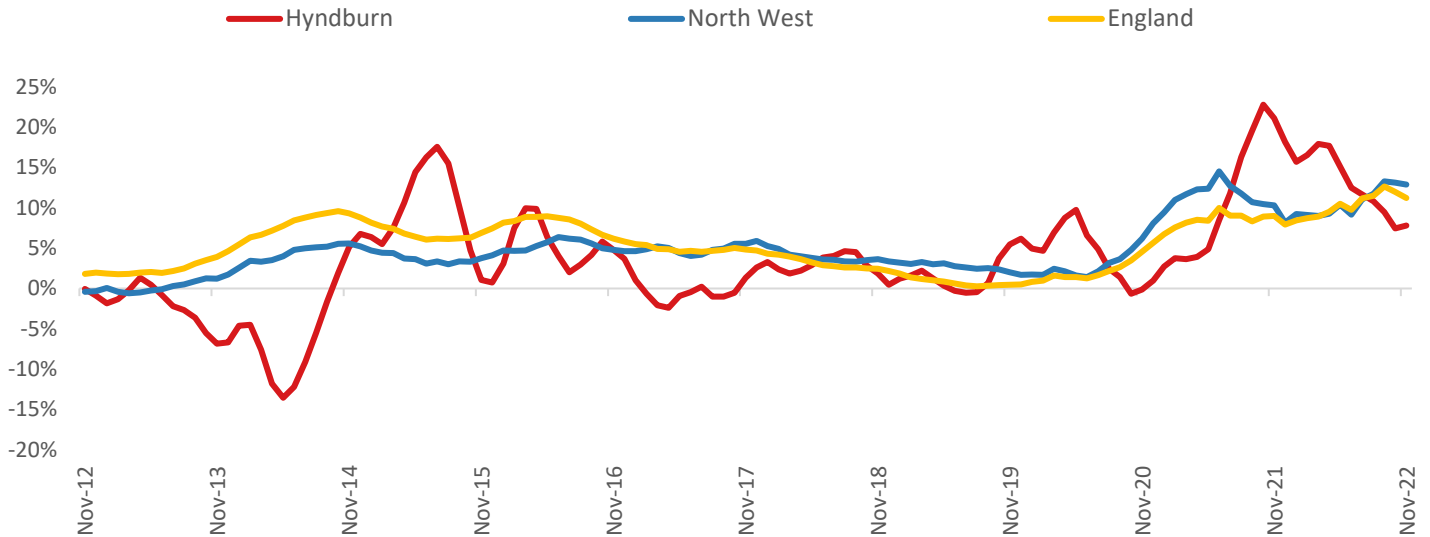

**House Price Growth (November 2022 data)**

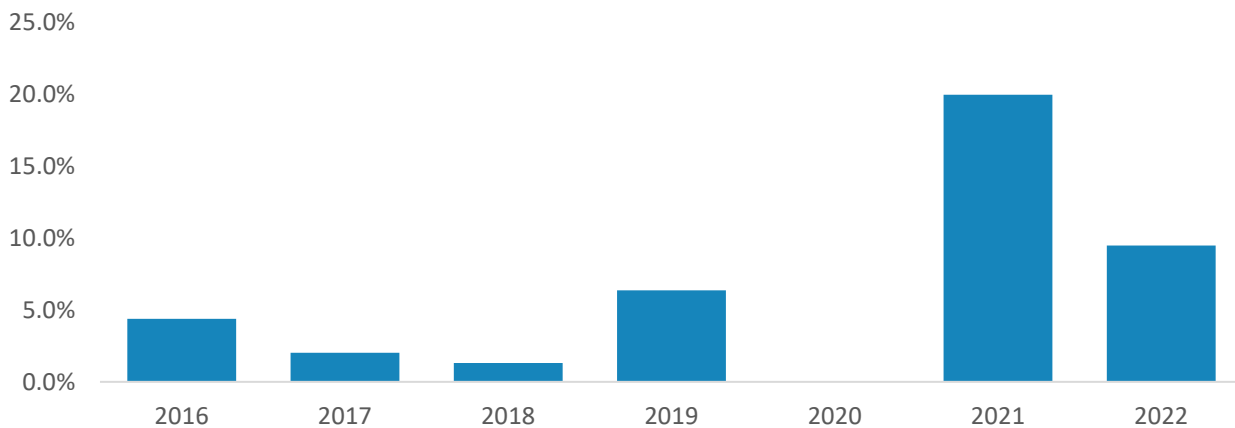
*Annual Change in House Prices*



House prices in Hyndburn grew by 7.8% in the 12 months to November 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.2% and prices in the North West grew by 12.9% over the same period.

Hyndburn house prices are now 23.4% above their previous peak in 2007, compared to +45.6% for the North West and +62.2% across England.

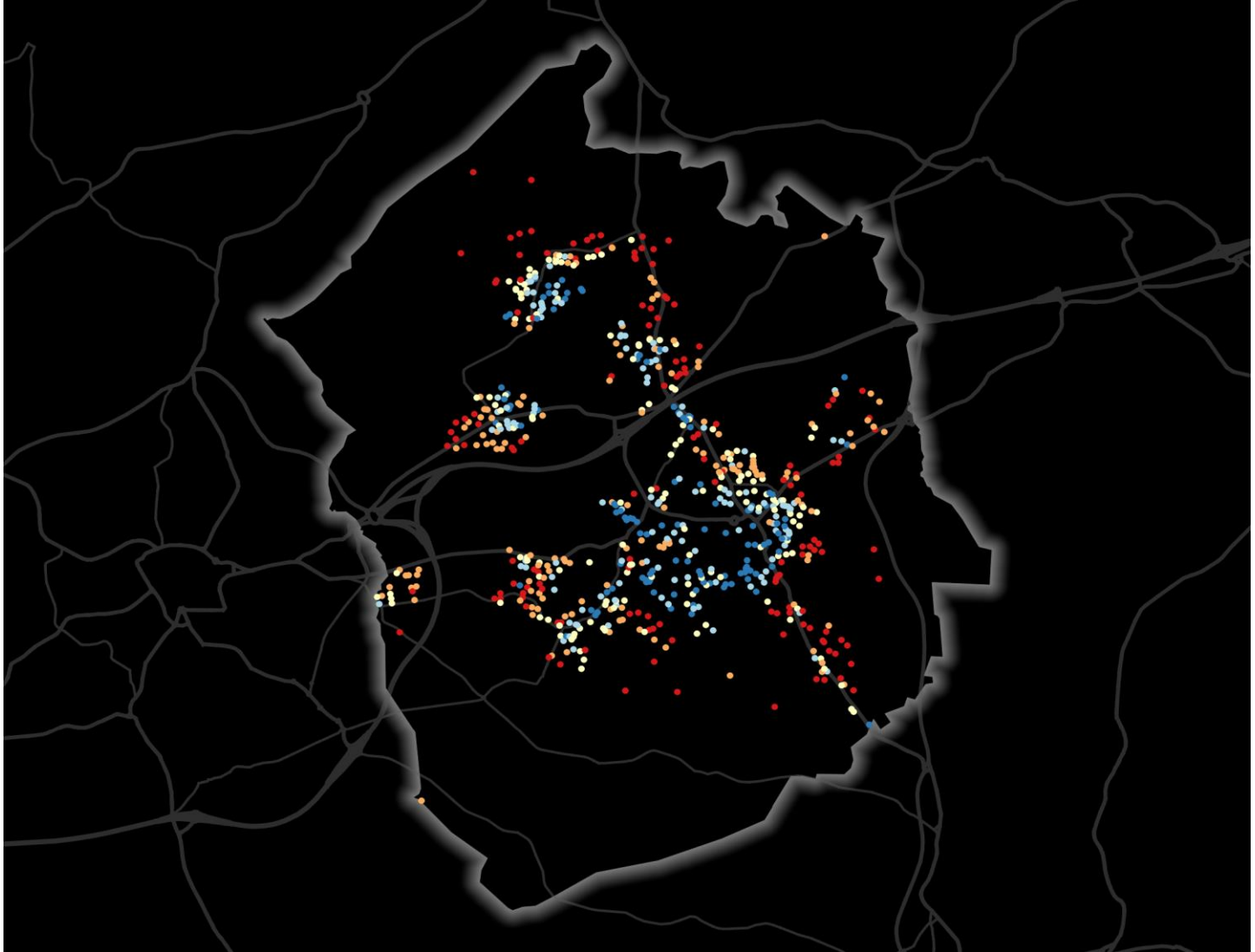
*Year-To-Date Change in House Prices, December to November*



Local prices have grown by 9.5% in 2022 so far, compared to growth of 19.9% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

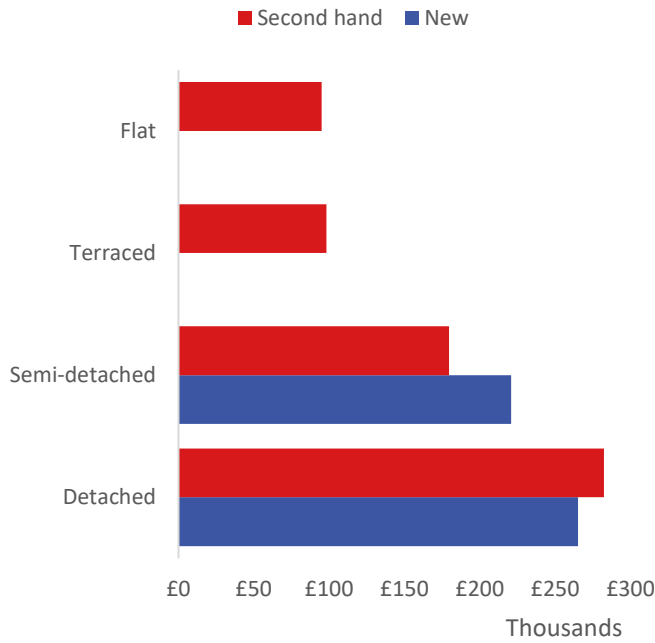

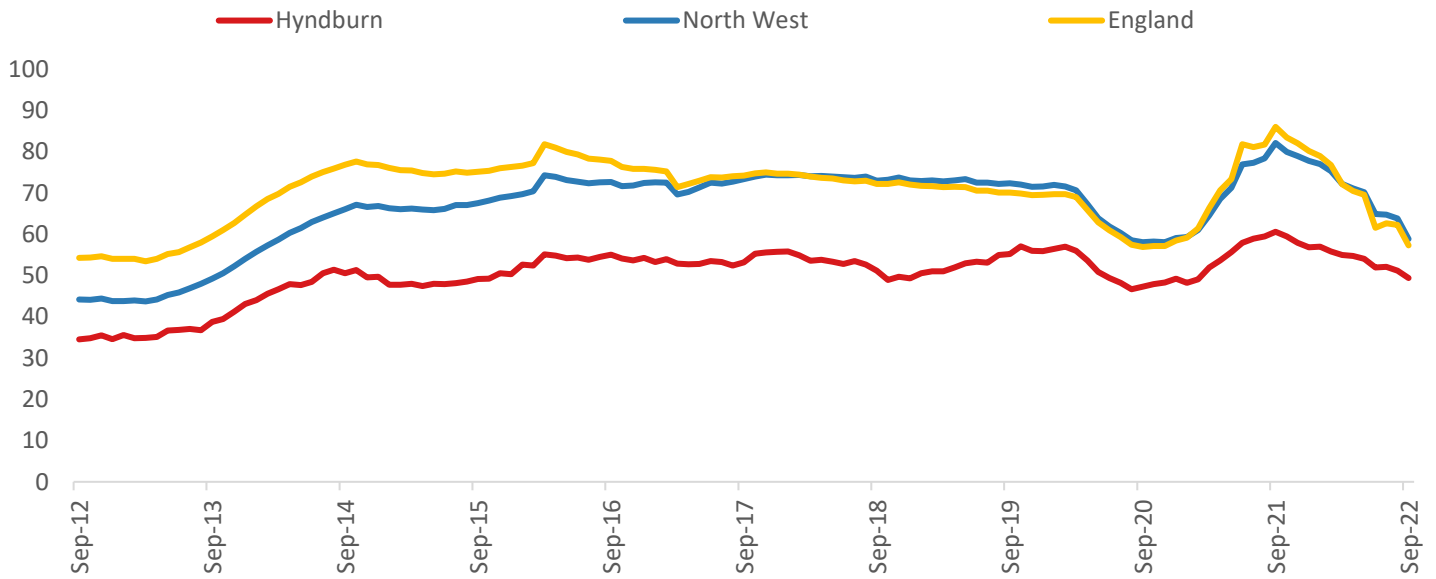

### Transactions (September 2022 data)

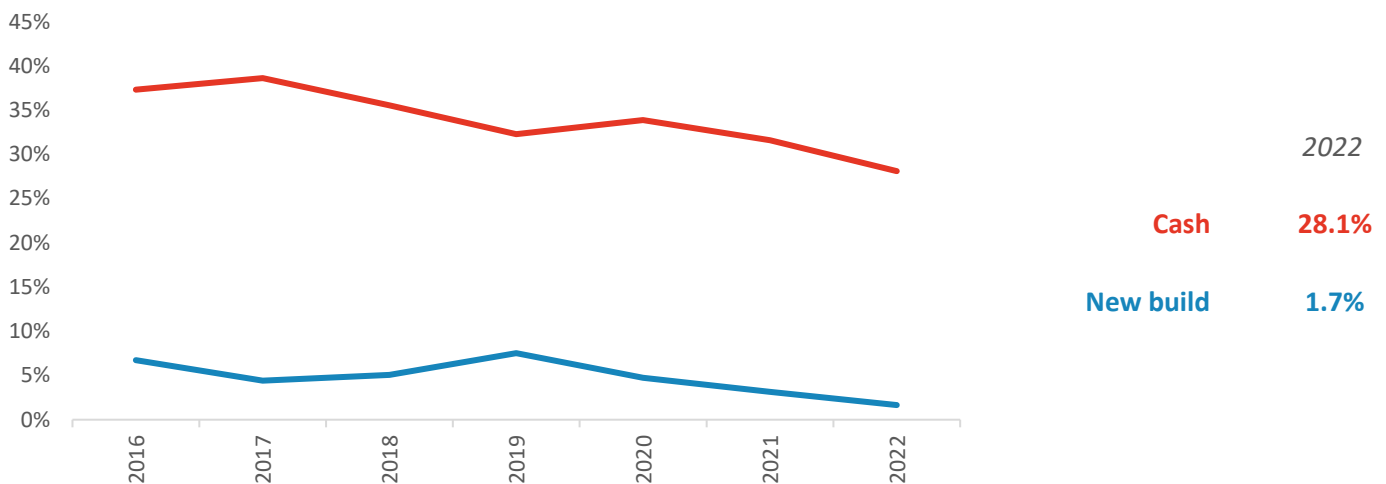
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,163 transactions in Hyndburn during the 12 months to September 2022. This is 49% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hyndburn have fallen by 0.7% since 2014, compared to changes of -11.9% for North West and -25.4% for England.

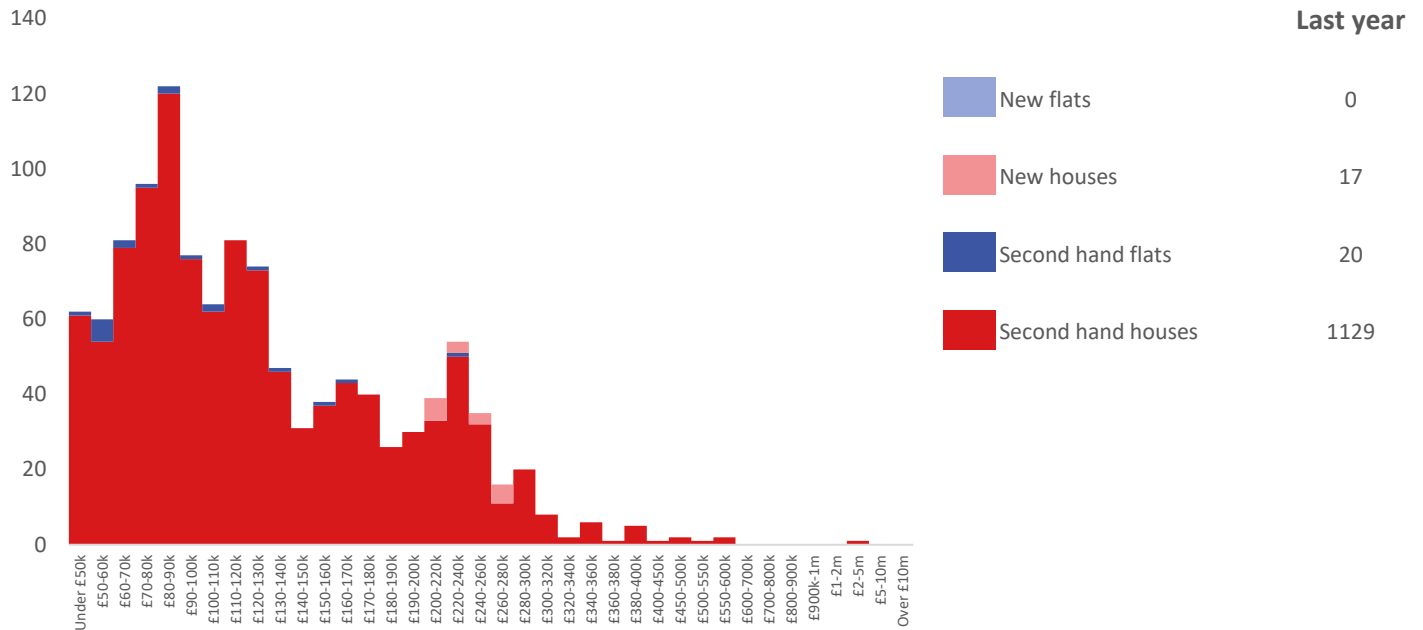
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

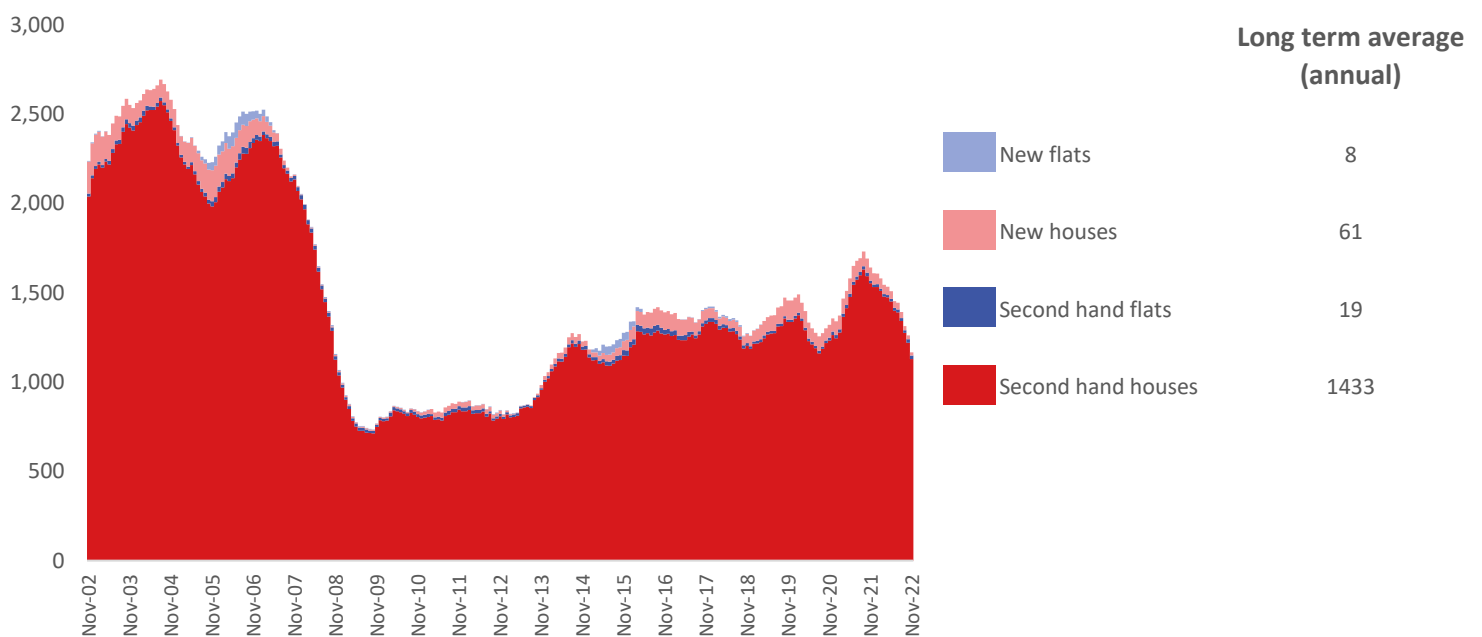
12 months to November 2022



The most common property type transacted over the past 12 months in Hyndburn was 'second hand houses' with 1,129 sales, 97% of all sales over the same period. The annual total of 1,166 transactions is equivalent to 77% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,433 sales per year on average, making up 94% of the typical annual total over that period.
