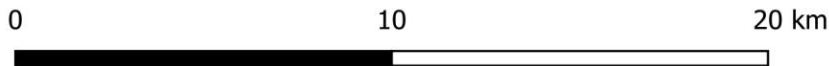
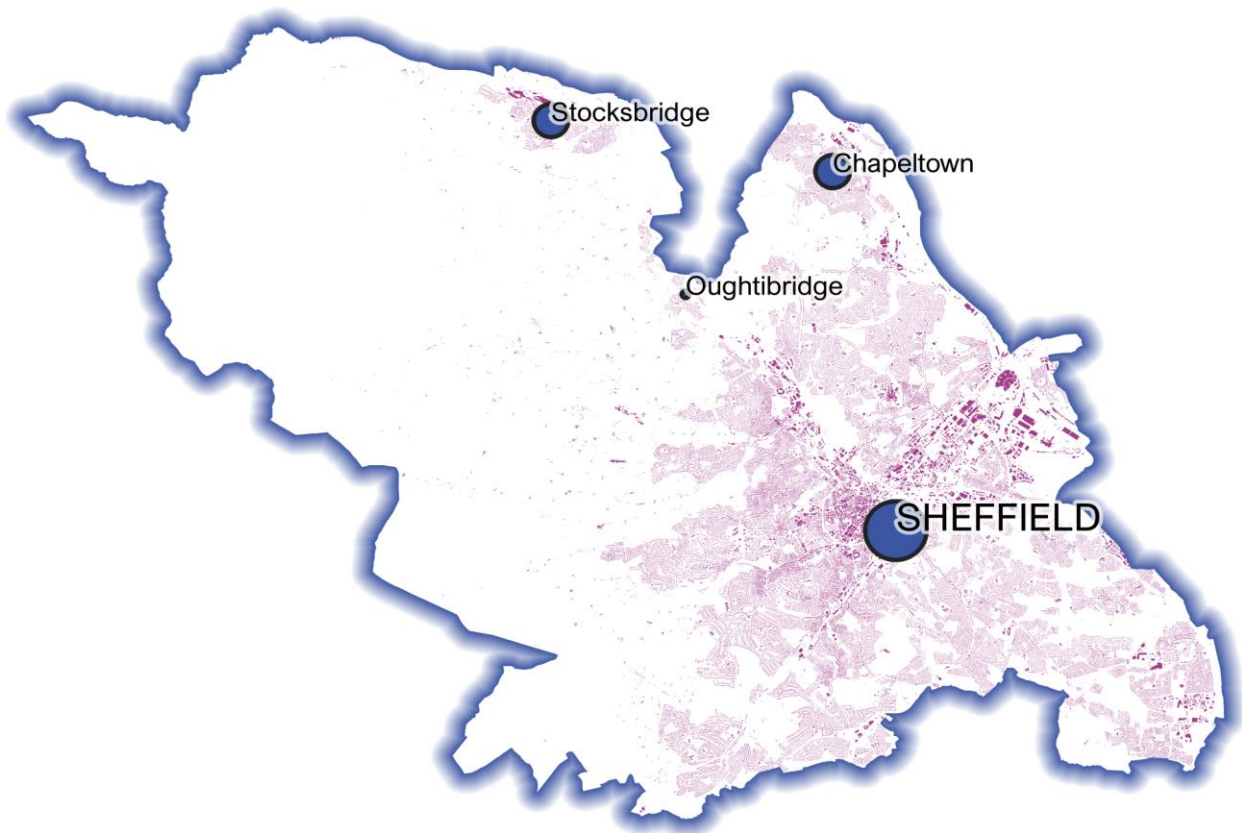

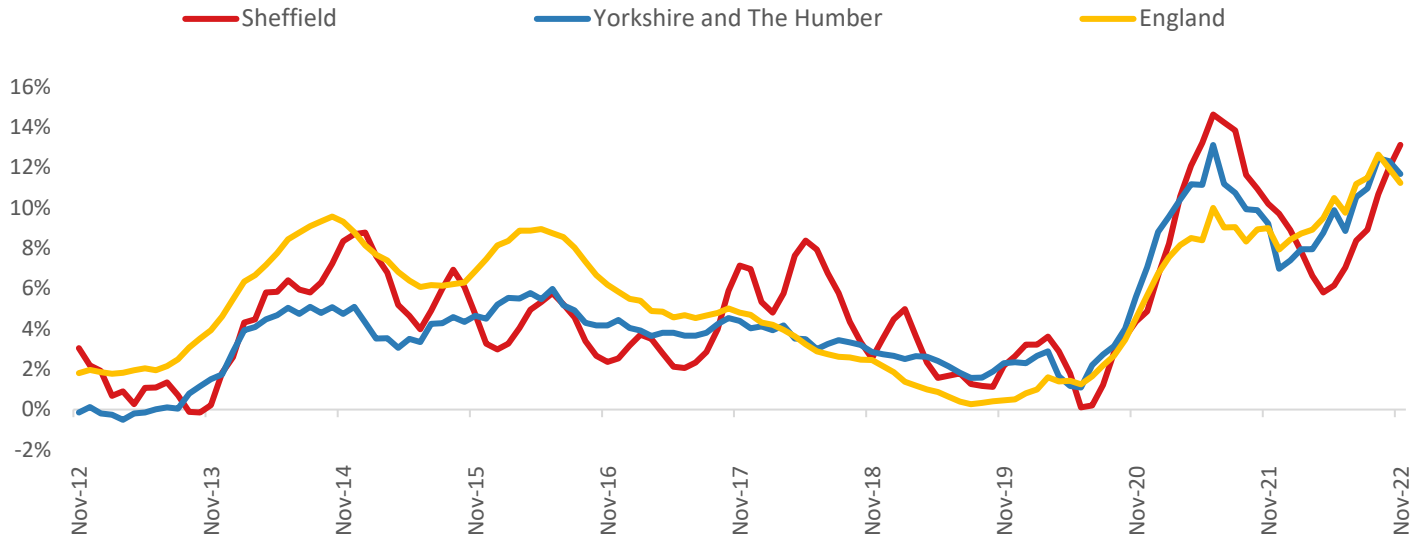

**House Price Growth (November 2022 data)**

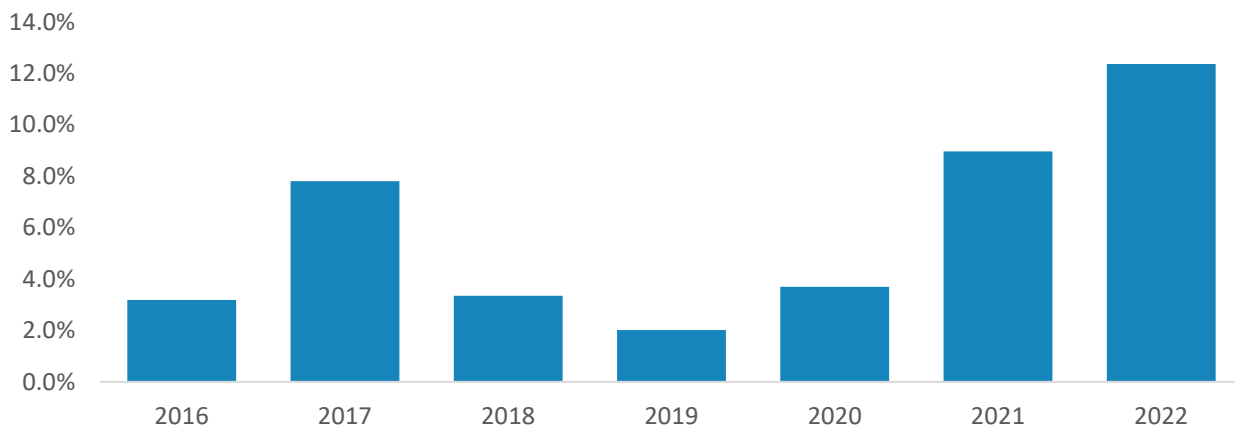
*Annual Change in House Prices*



House prices in Sheffield grew by 13.1% in the 12 months to November 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.2% and prices in Yorkshire and The Humber grew by 11.7% over the same period.

Sheffield house prices are now 51.8% above their previous peak in 2007, compared to +42.2% for Yorkshire and The Humber and +62.2% across England.

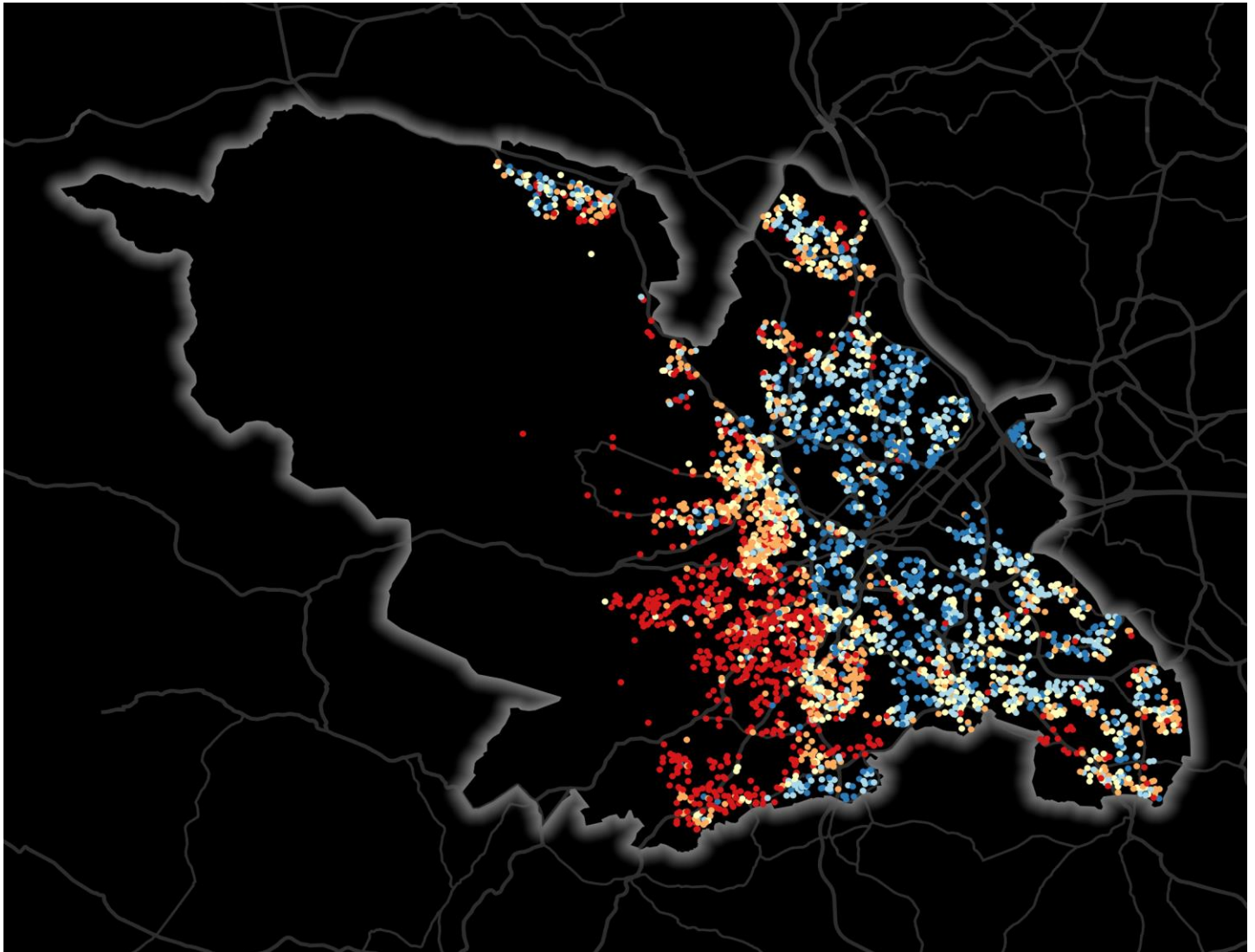
*Year-To-Date Change in House Prices, December to November*



Local prices have grown by 12.4% in 2022 so far, compared to growth of 9.0% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

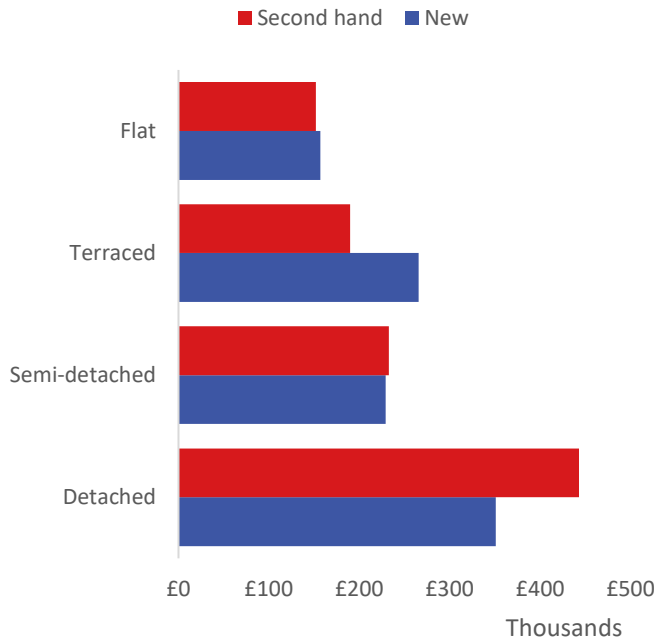

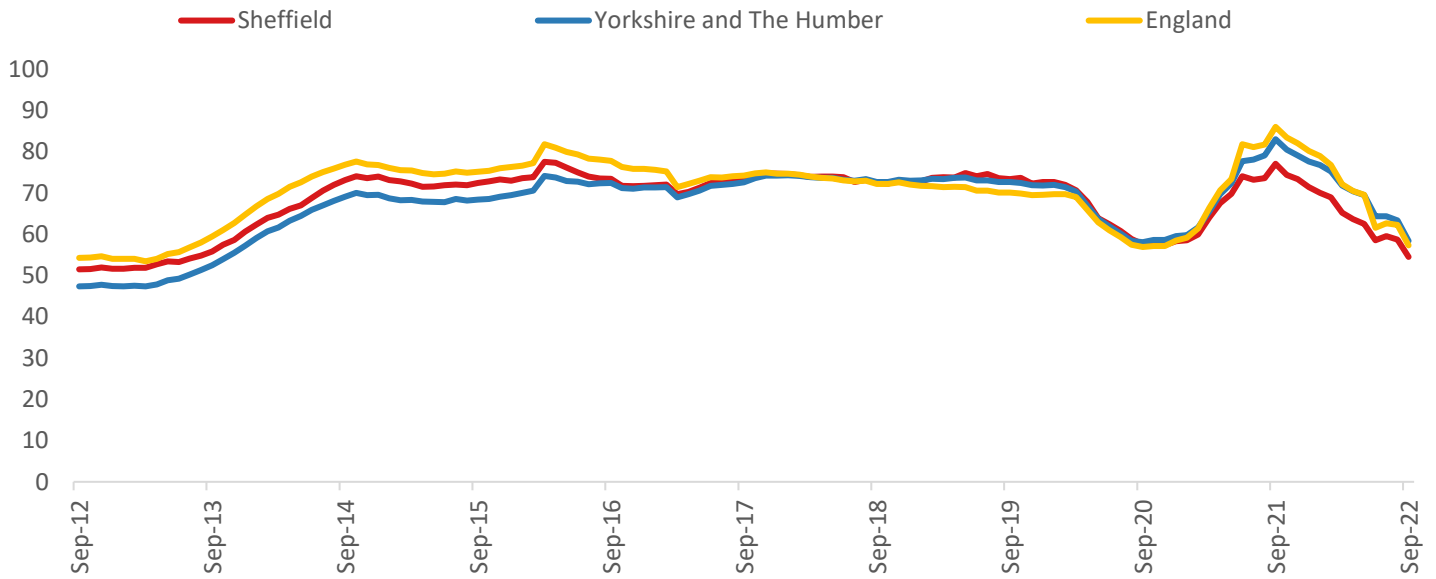

### Transactions (September 2022 data)

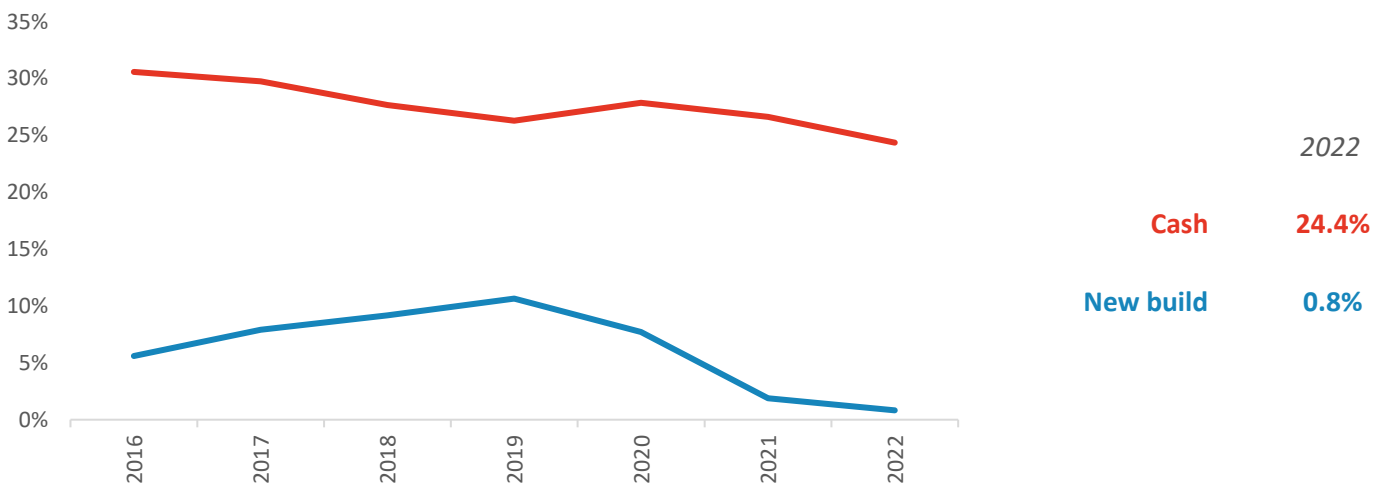
Annual Transactions, Indexed (2001-05 average = 100)



There were 5,647 transactions in Sheffield during the 12 months to September 2022. This is 54% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Sheffield have fallen by 26.3% since 2014, compared to changes of -16.0% for Yorkshire and The Humber and -25.4% for England.

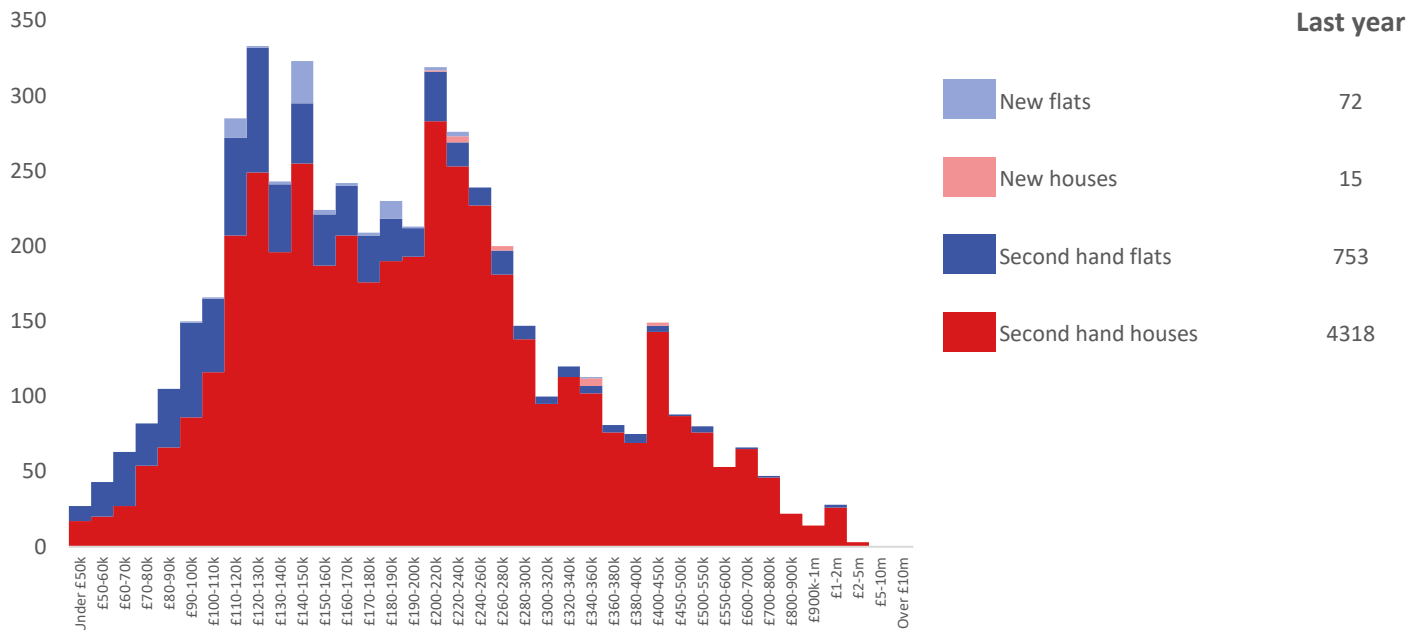
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

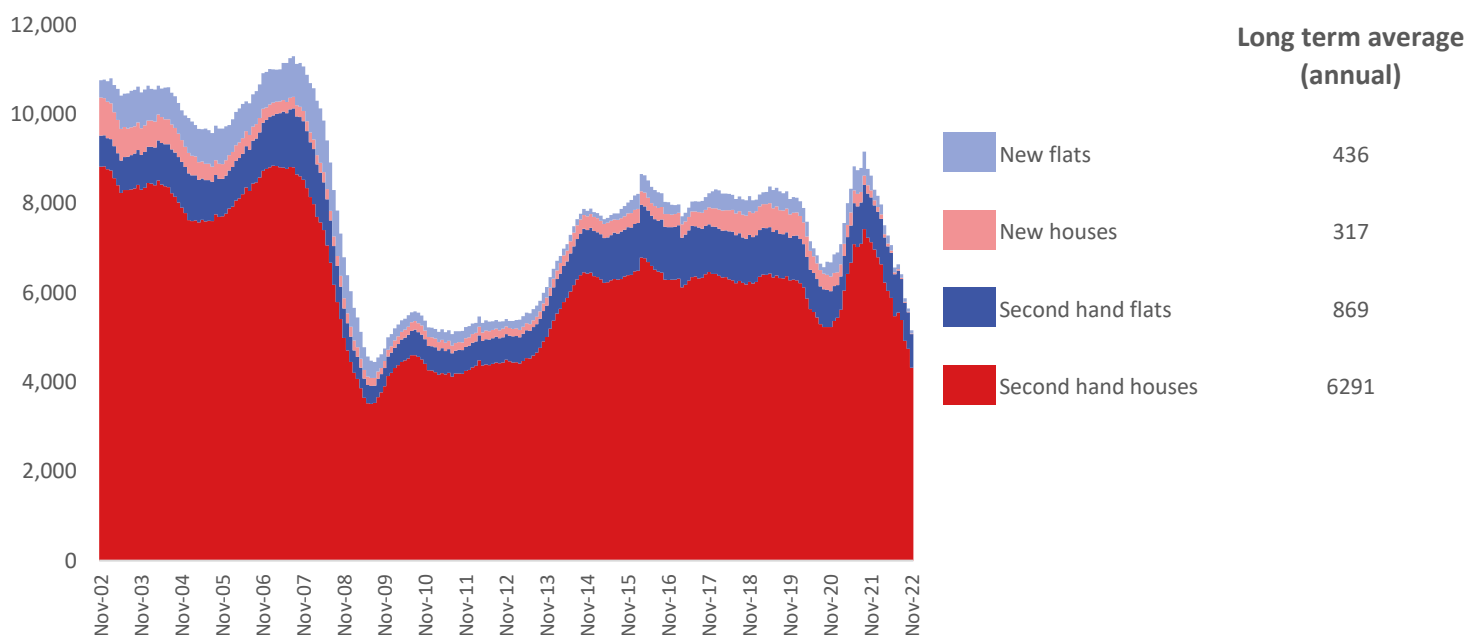
12 months to November 2022



The most common property type transacted over the past 12 months in Sheffield was 'second hand houses' with 4,318 sales, 84% of all sales over the same period. The annual total of 5,158 transactions is equivalent to 65% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 6,291 sales per year on average, making up 80% of the typical annual total over that period.
