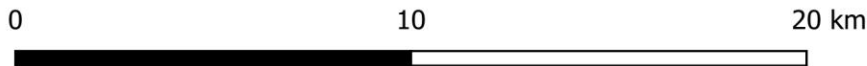

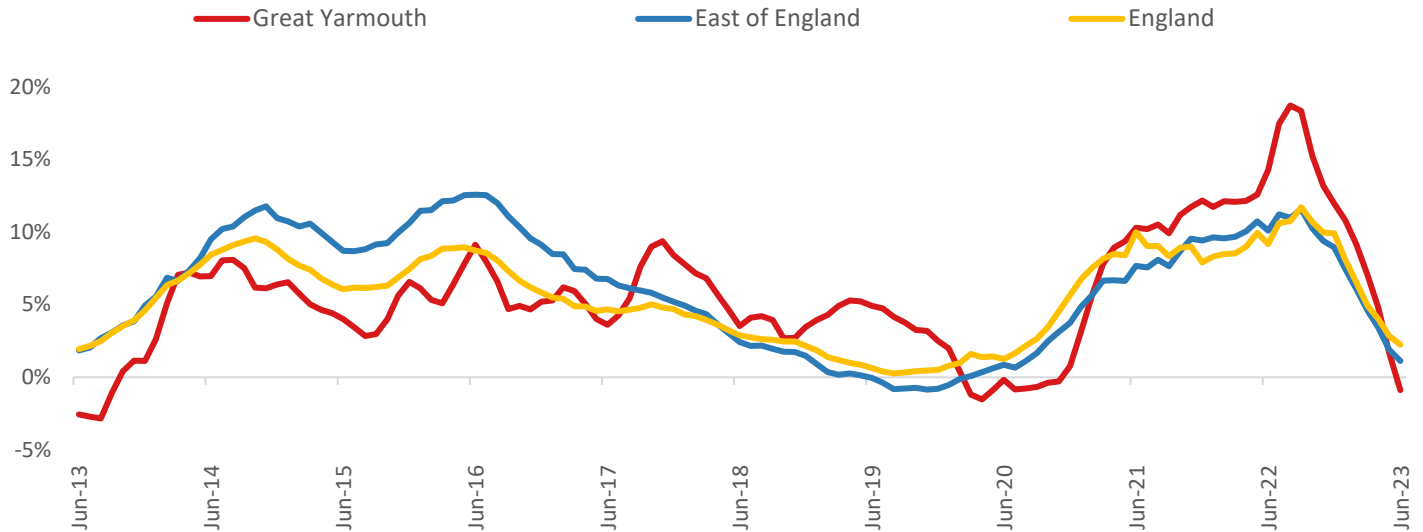

**House Price Growth (June 2023 data)**

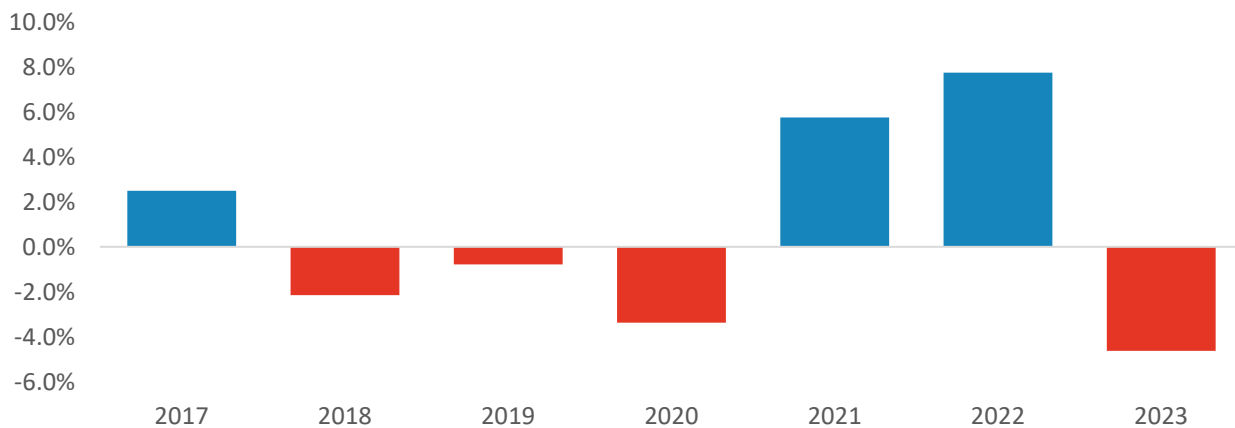
*Annual Change in House Prices*



House prices in Great Yarmouth fell by 0.9% in the 12 months to June 2023 (based on 3-month smoothed data). By comparison national house prices grew by 2.2% and prices in the East of England grew by 1.1% over the same period.

Great Yarmouth house prices are now 43.4% above their previous peak in 2007, compared to +66.9% for the East of England and +56.8% across England.

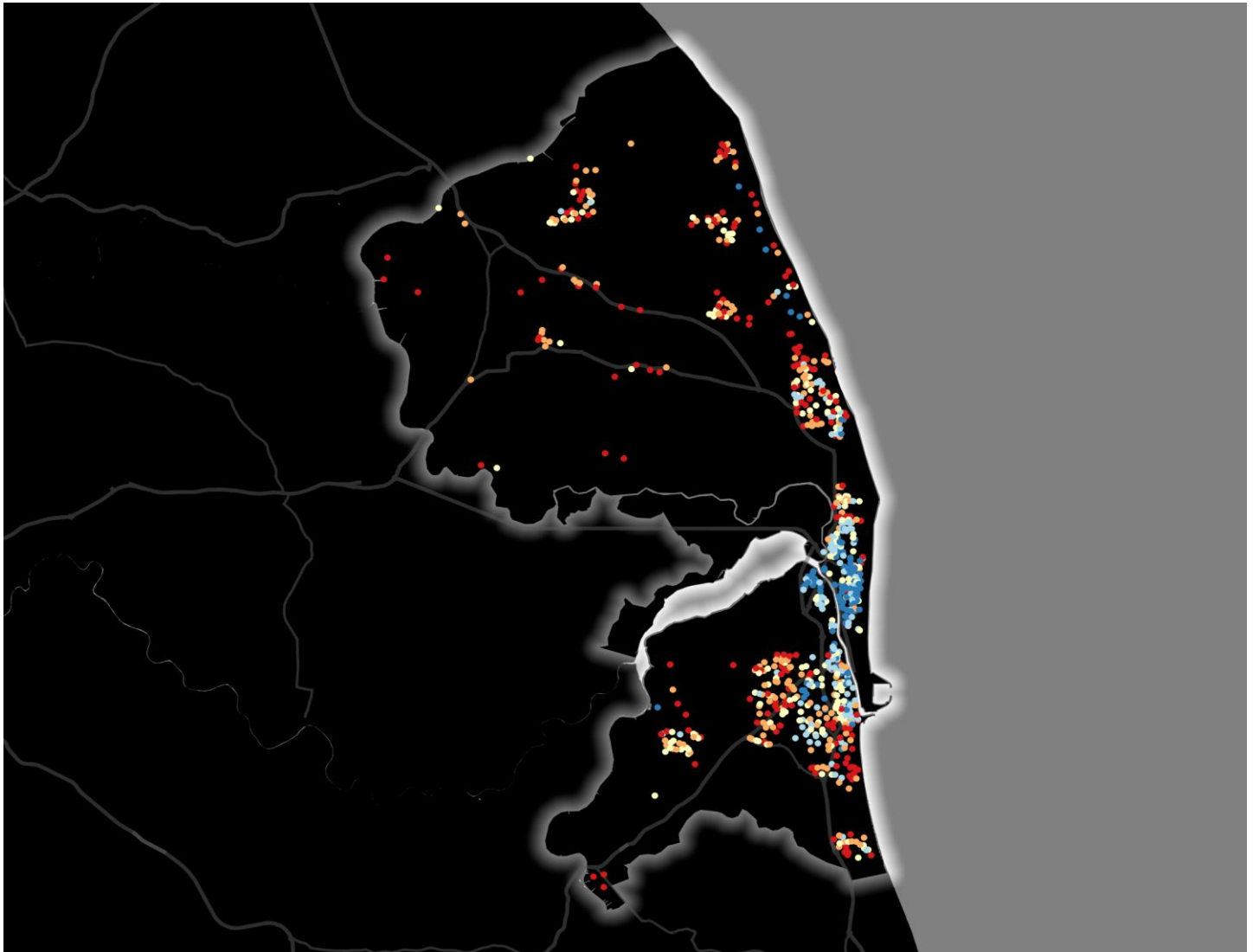
*Year-To-Date Change in House Prices, December to June*



Local prices have fallen by 4.6% in 2023 so far, compared to growth of 7.7% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

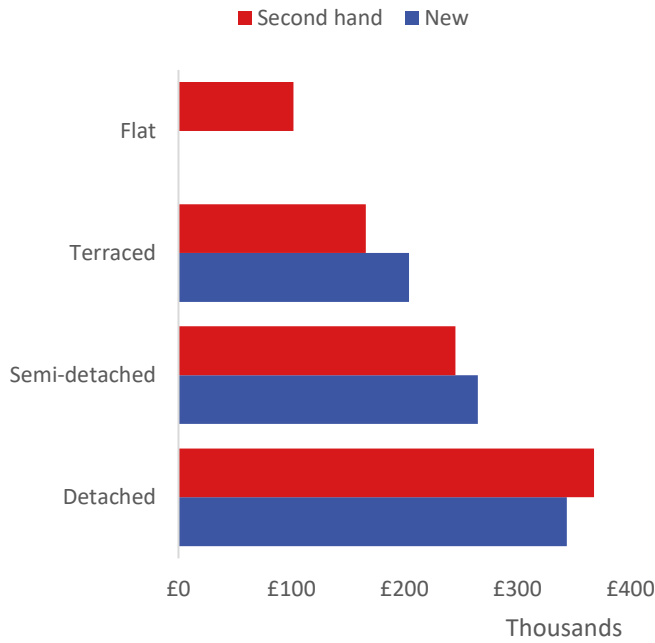

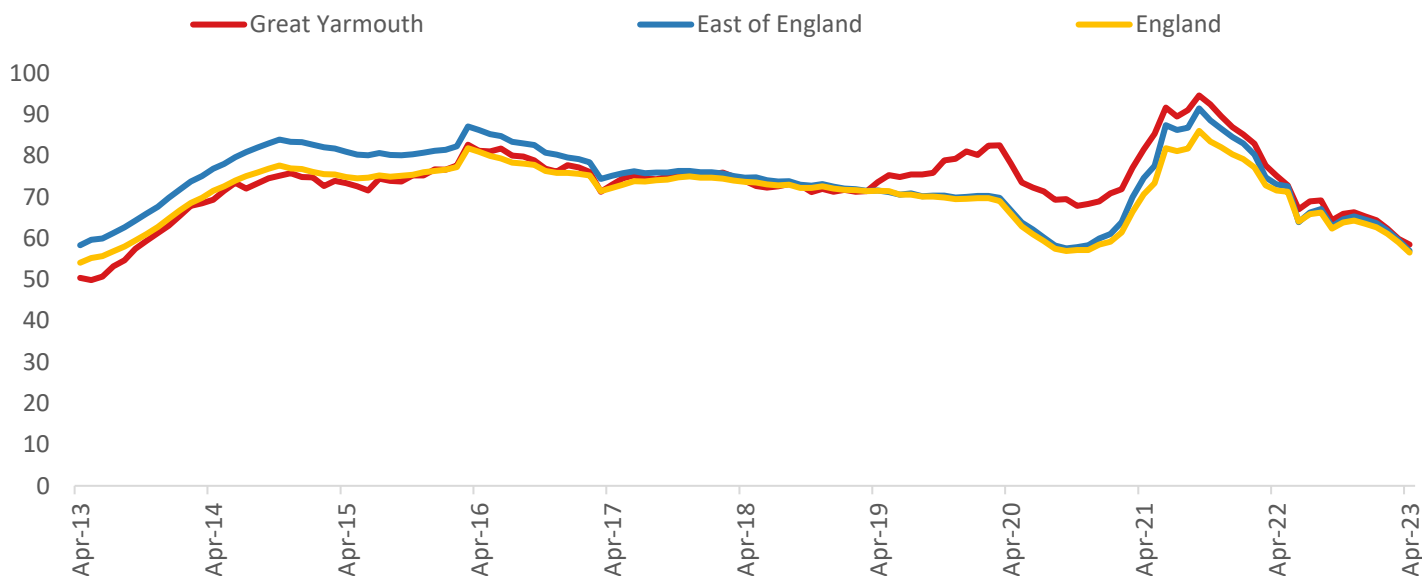

### Transactions (April 2023 data)

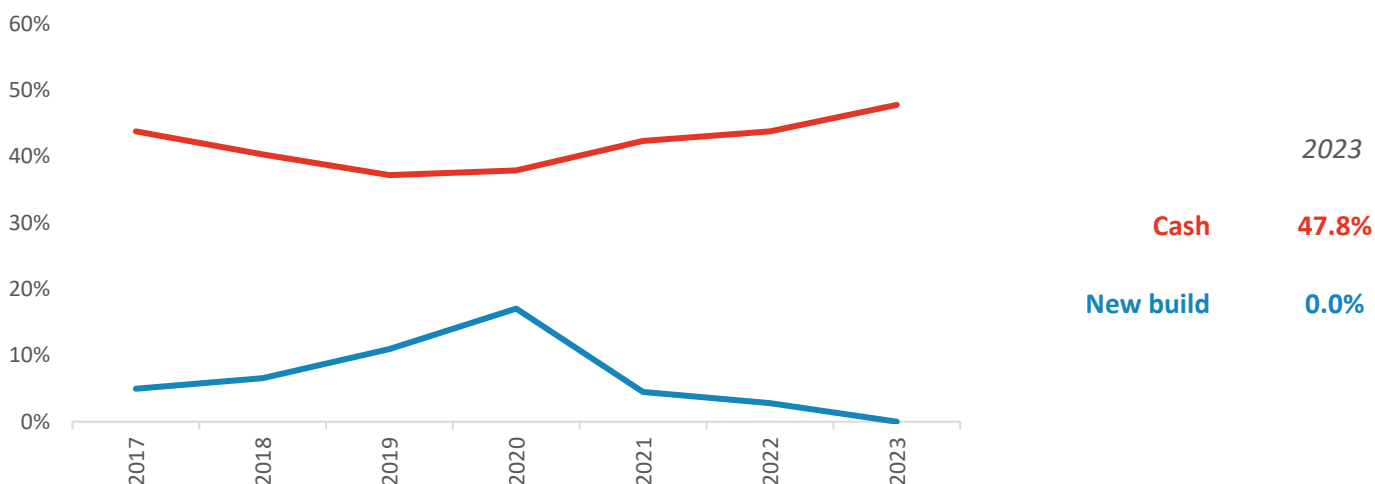
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,324 transactions in Great Yarmouth during the 12 months to April 2023. This is 58% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Great Yarmouth have fallen by 21.9% since 2014, compared to changes of -31.6% for East of England and -26.4% for England.

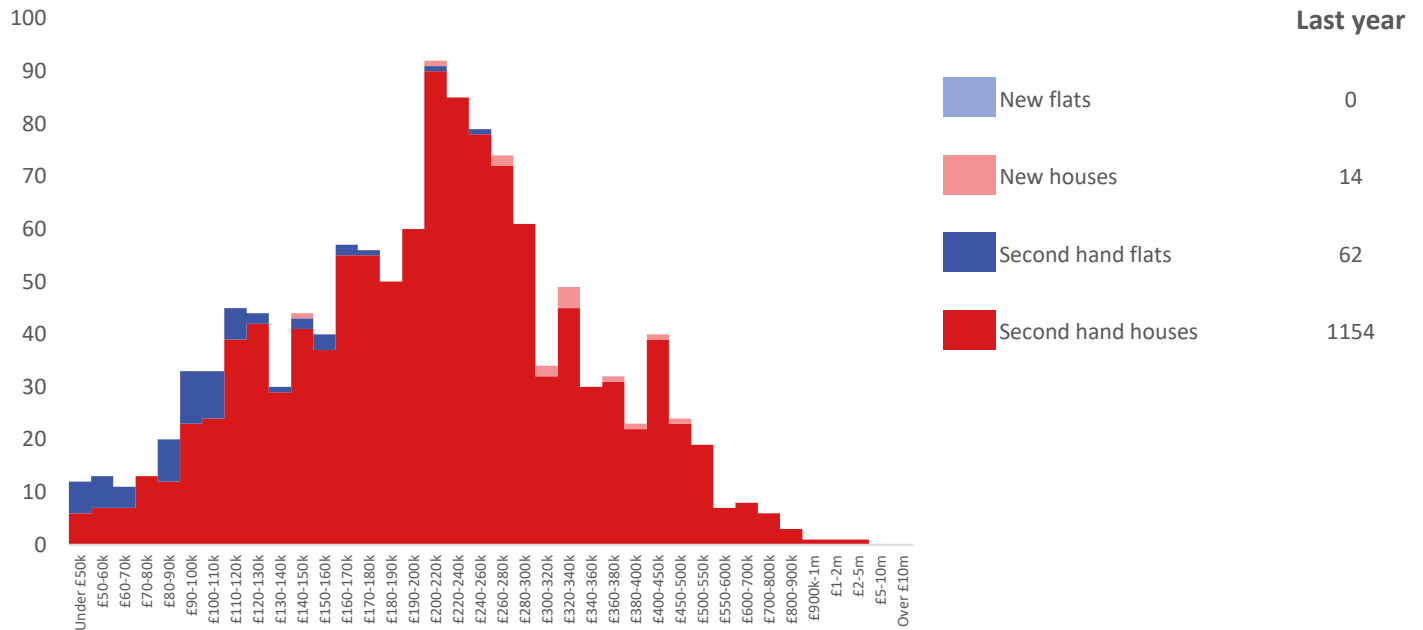
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

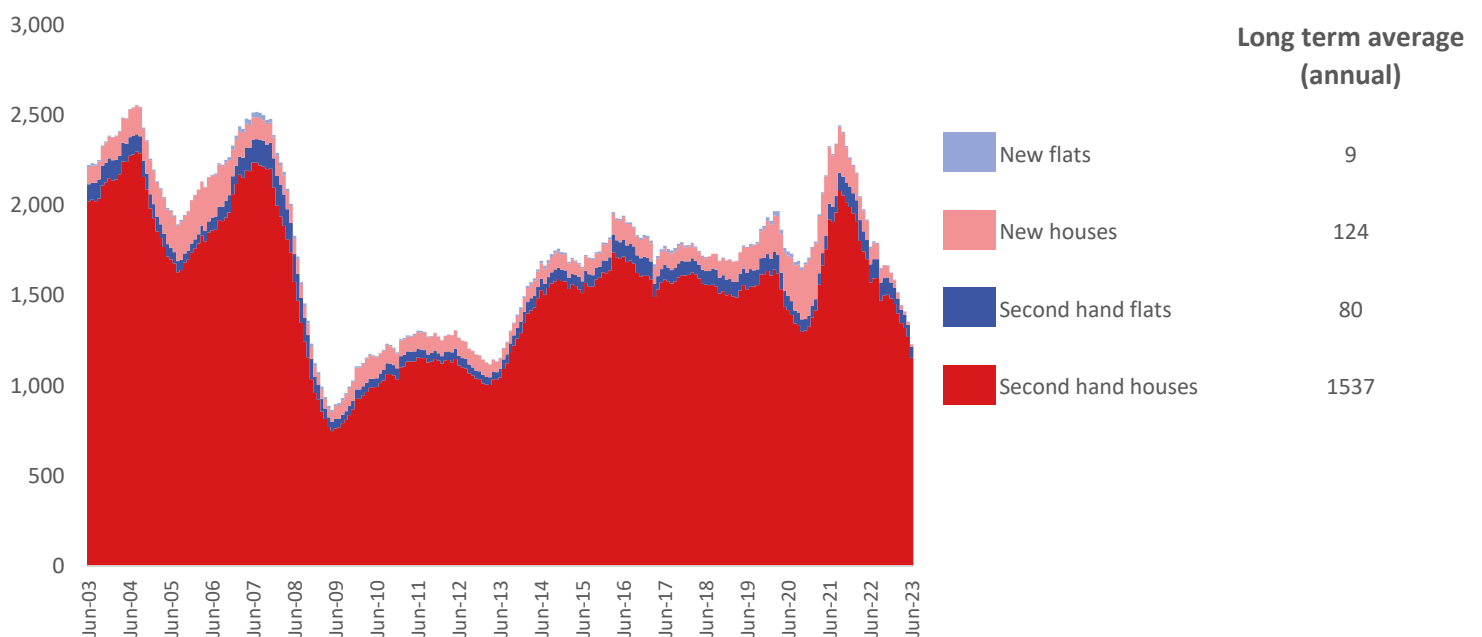
12 months to June 2023



The most common property type transacted over the past 12 months in Great Yarmouth was 'second hand houses' with 1,154 sales, 94% of all sales over the same period. The annual total of 1,230 transactions is equivalent to 70% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,537 sales per year on average, making up 88% of the typical annual total over that period.
