



House Price Growth (June 2023 data)


Annual Change in House Prices



House prices in Kensington and Chelsea fell by 12.9% in the 12 months to June 2023 (based on 3-month smoothed data). By comparison national house prices grew by 2.2% and prices in London grew by 0.7% over the same period.

Kensington and Chelsea house prices are now 64.1% above their previous peak in 2007, compared to +77.2% for London and +56.8% across England.

Year-To-Date Change in House Prices, December to June



Local prices have fallen by 2.9% in 2023 so far, compared to growth of 5.4% over the same period last year.


House Price Map

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).





Transactions (April 2023 data)


Annual Transactions, Indexed (2001-05 average = 100)



There were 1,605 transactions in Kensington and Chelsea during the 12 months to April 2023. This is 42% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Kensington and Chelsea have fallen by 40.6% since 2014, compared to changes of -36.4% for London and -26.4% for England.


Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type


12 months to June 2023



The most common property type transacted over the past 12 months in Kensington and Chelsea was 'second hand flats' with 1,196 sales, 75% of all sales over the same period. The annual total of 1,592 transactions is equivalent to 61% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand flats' with the equivalent of 2,008 sales per year on average, making up 77% of the typical annual total over that period.
