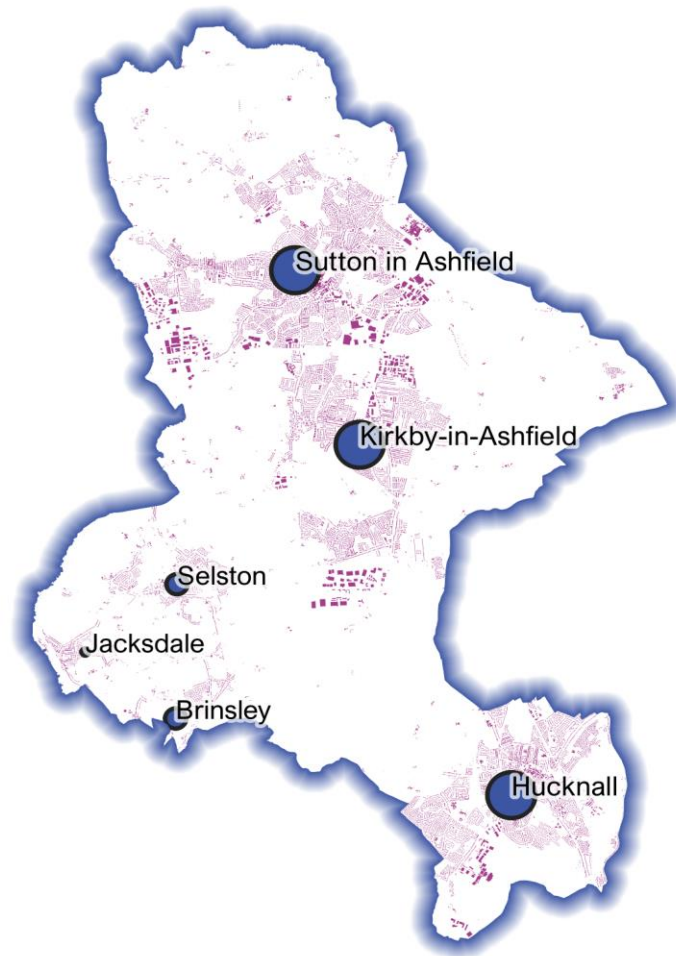

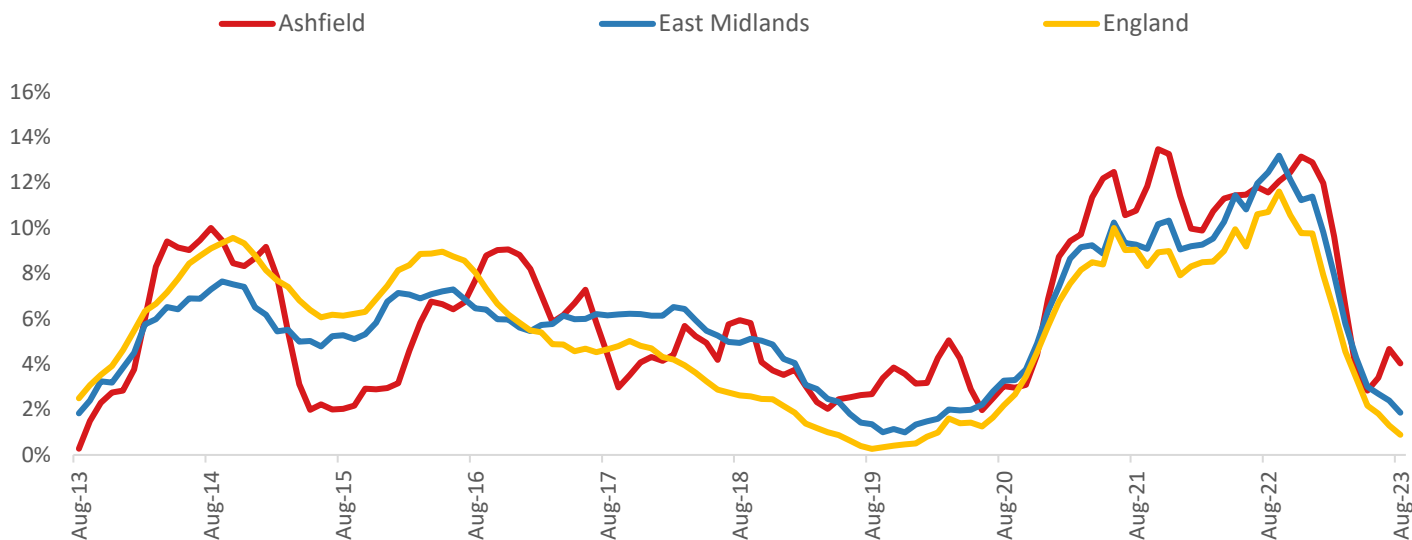

**House Price Growth (August 2023 data)**

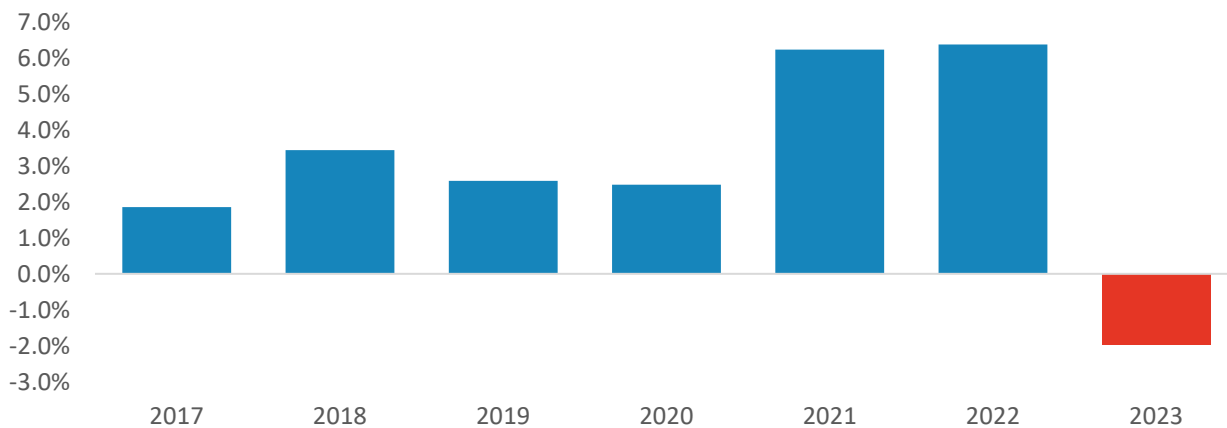
*Annual Change in House Prices*



House prices in Ashfield grew by 4.0% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in the East Midlands grew by 1.9% over the same period.

Ashfield house prices are now 57.3% above their previous peak in 2007, compared to +58.2% for the East Midlands and +58.7% across England.

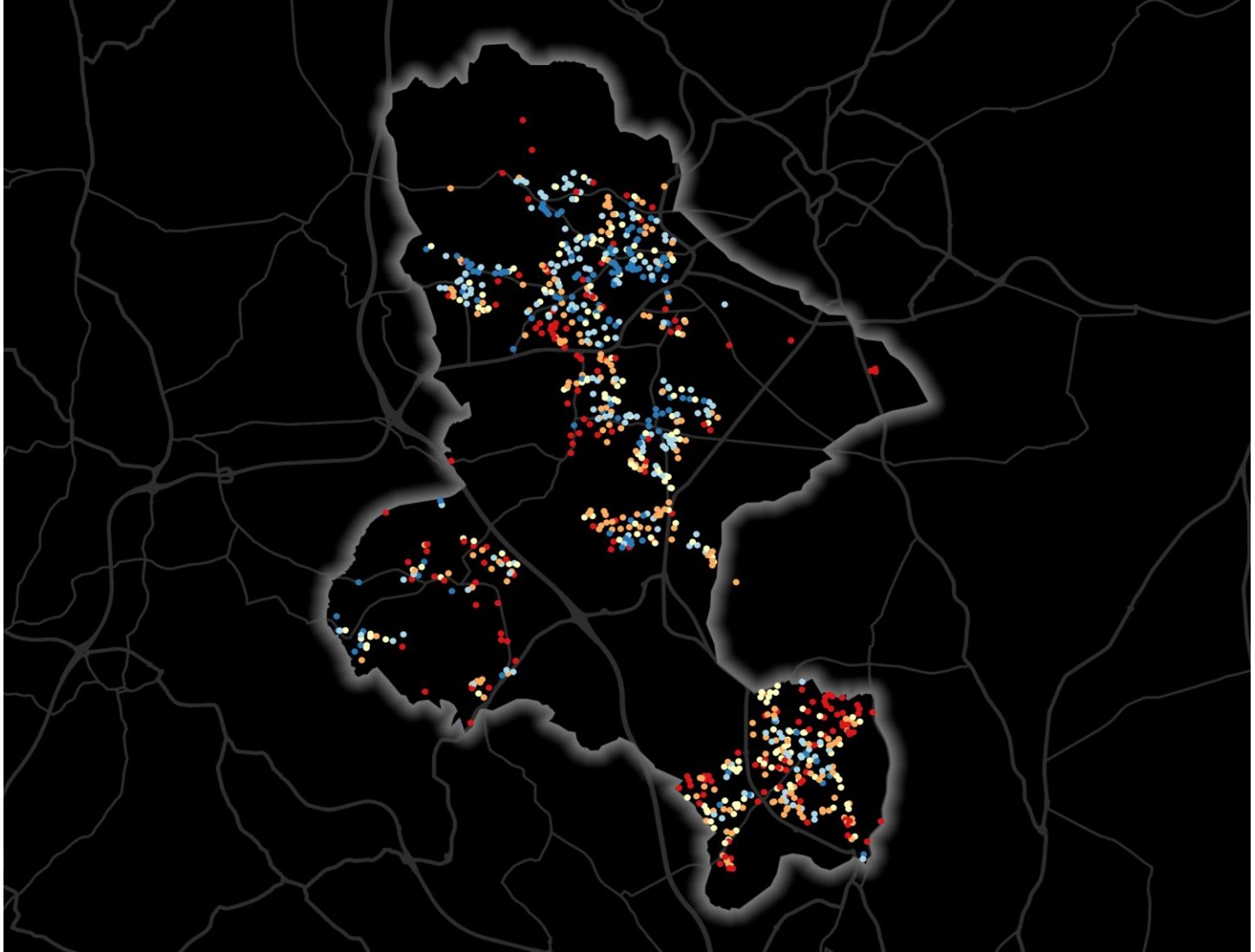
*Year-To-Date Change in House Prices, December to August*



Local prices have fallen by 2.0% in 2023 so far, compared to growth of 6.4% over the same period last year.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

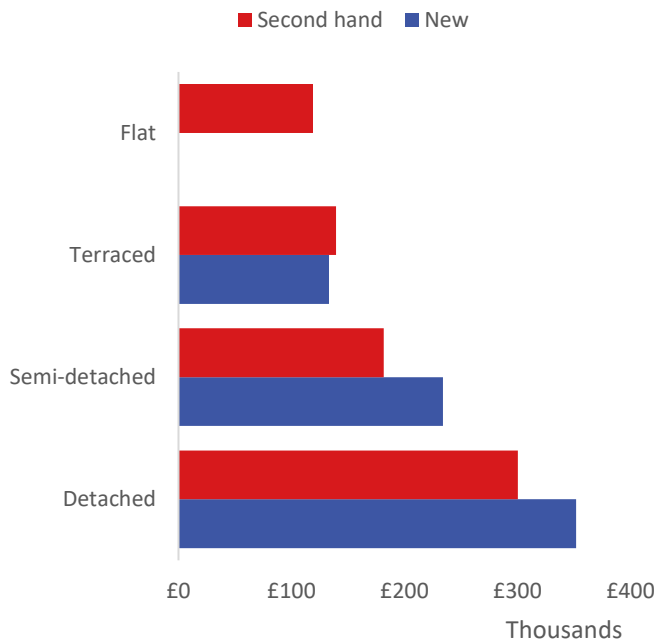

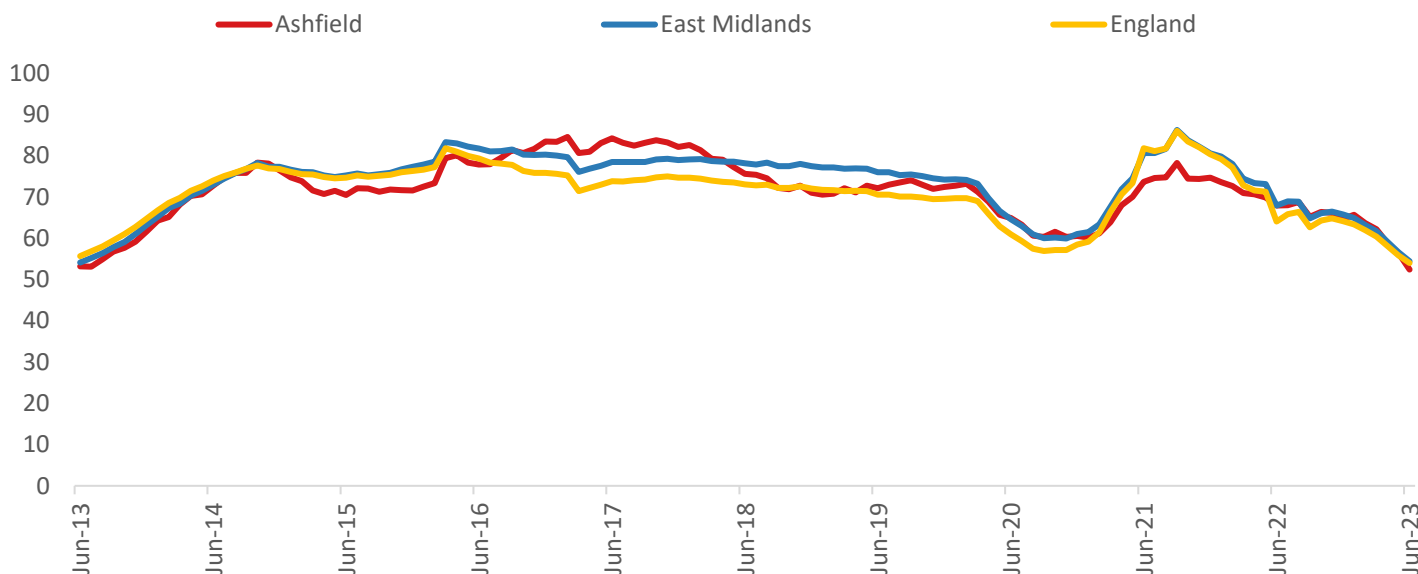

### Transactions (June 2023 data)

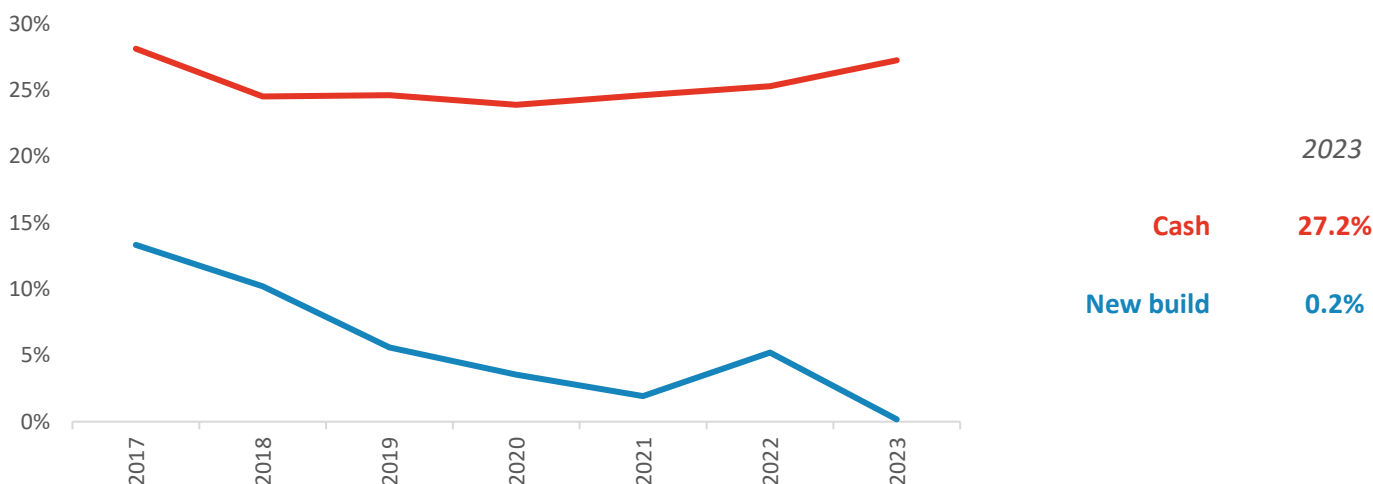
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,489 transactions in Ashfield during the 12 months to June 2023. This is 52% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Ashfield have fallen by 31.4% since 2014, compared to changes of -29.6% for East Midlands and -29.7% for England.

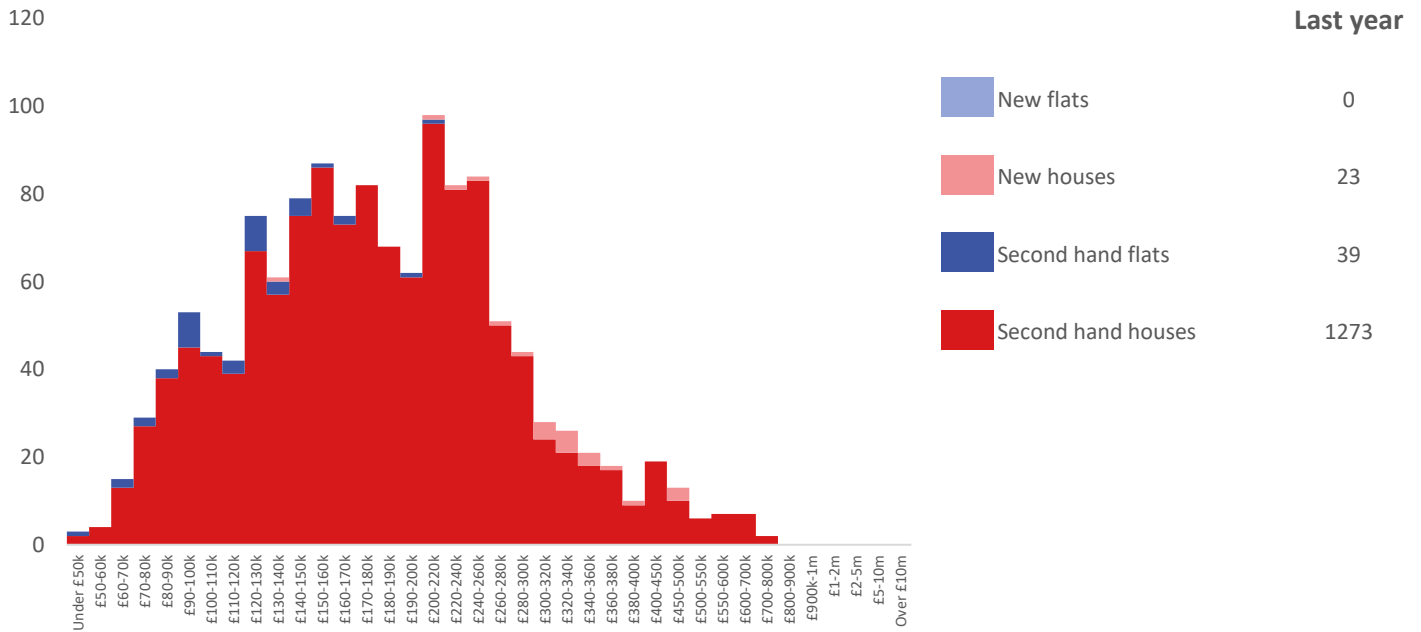
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

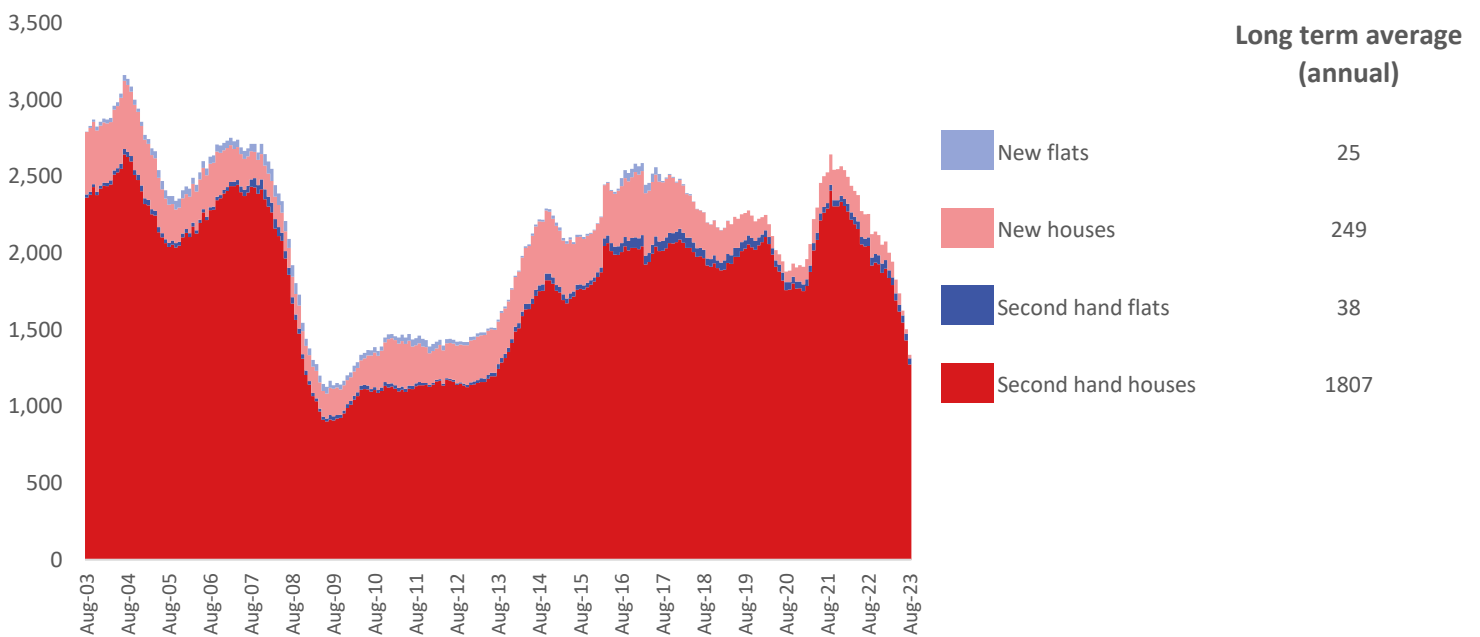
12 months to August 2023



The most common property type transacted over the past 12 months in Ashfield was 'second hand houses' with 1,273 sales, 95% of all sales over the same period. The annual total of 1,335 transactions is equivalent to 63% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,807 sales per year on average, making up 85% of the typical annual total over that period.
