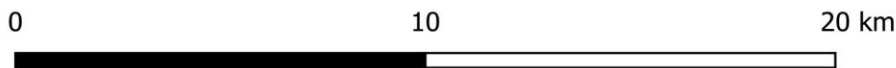
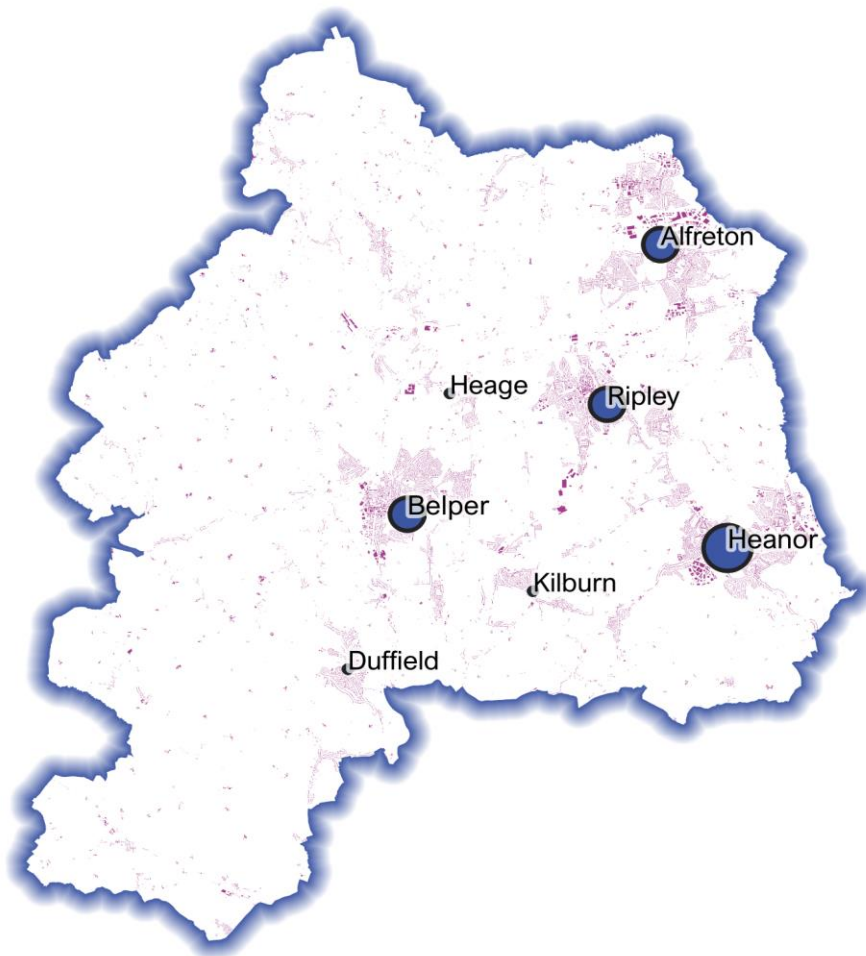

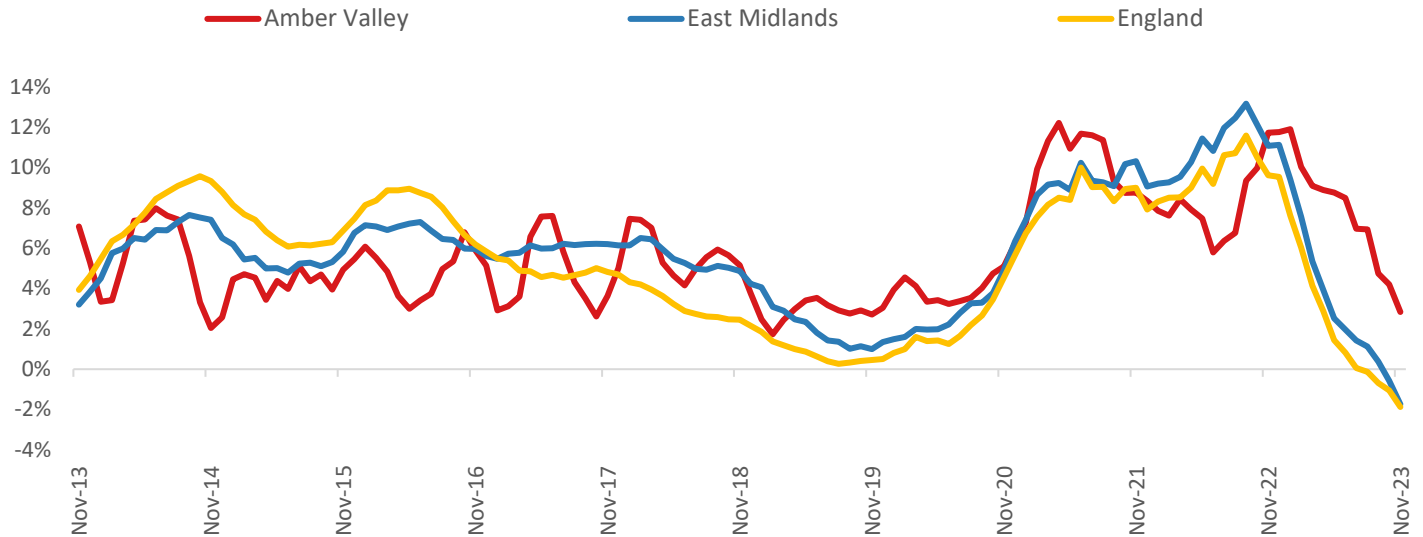

**House Price Growth (November 2023 data)**

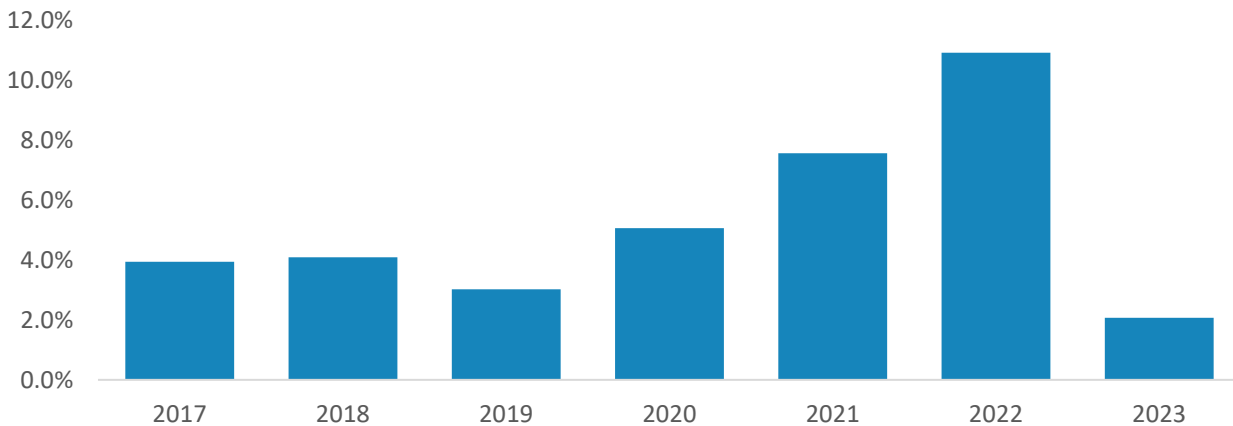
*Annual Change in House Prices*



House prices in Amber Valley grew by 2.8% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the East Midlands fell by 1.7% over the same period.

Amber Valley house prices are now 56.0% above their previous peak in 2007, compared to +55.5% for the East Midlands and +56.9% across England.

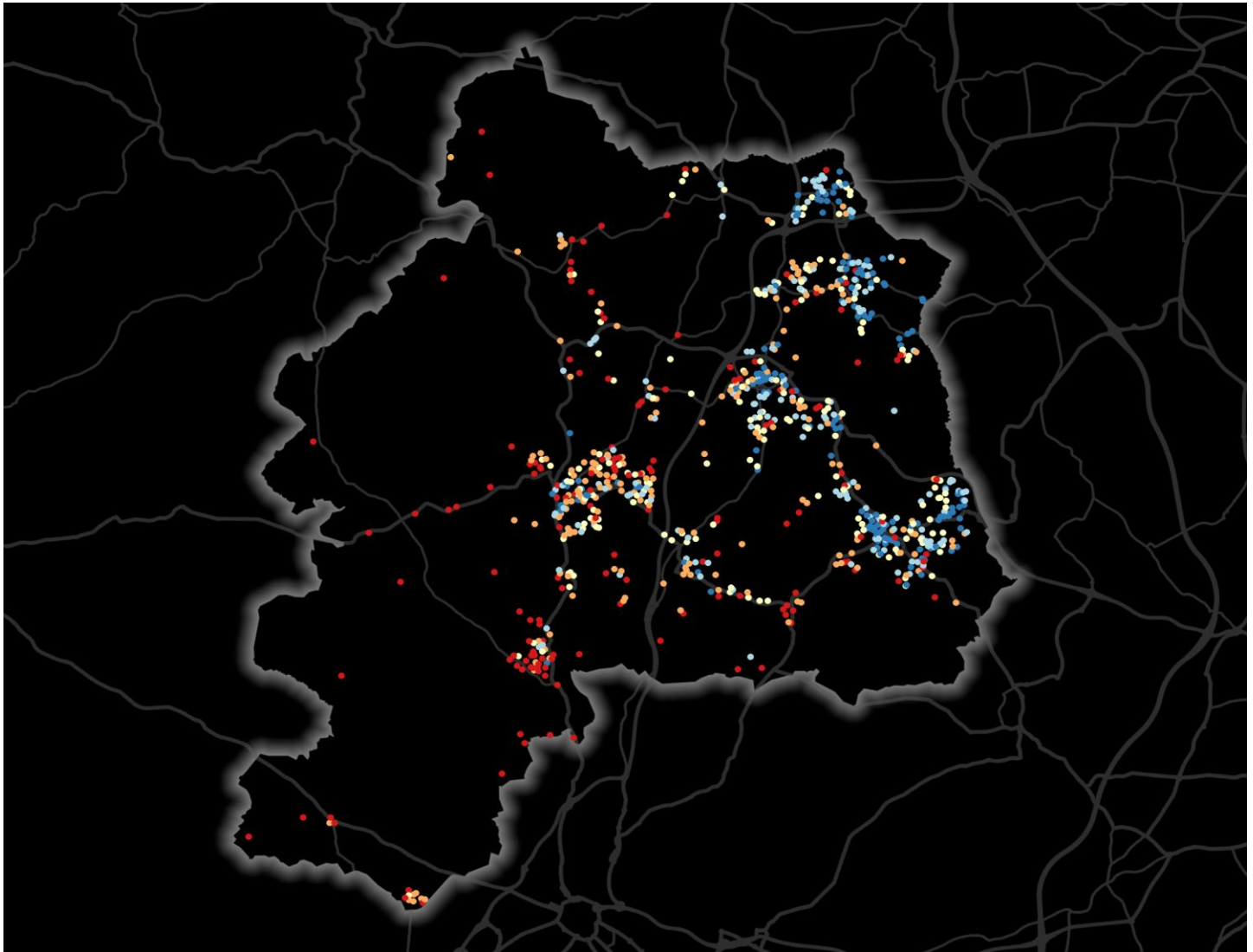
*Year-To-Date Change in House Prices, December to November*



Local prices have grown by 2.1% in 2023 so far, compared to growth of 10.9% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

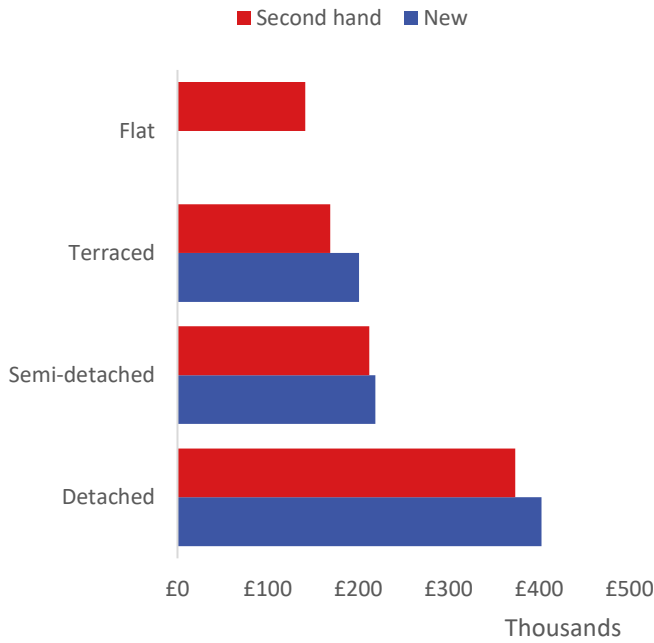

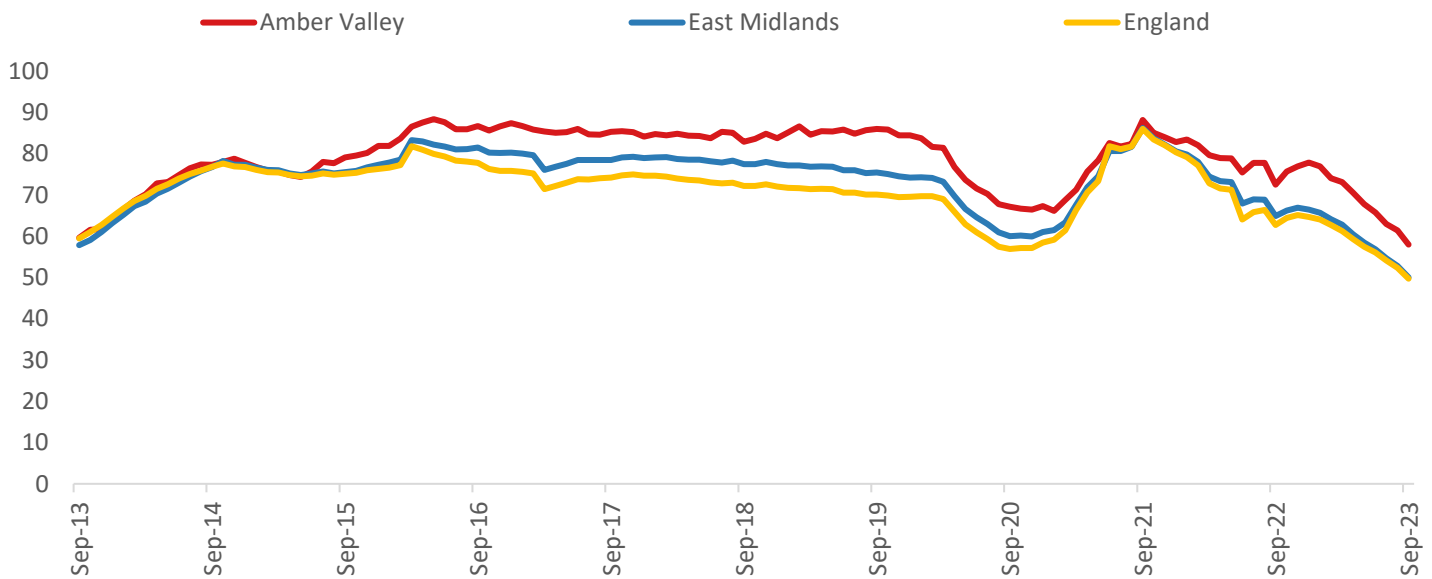

### Transactions (September 2023 data)

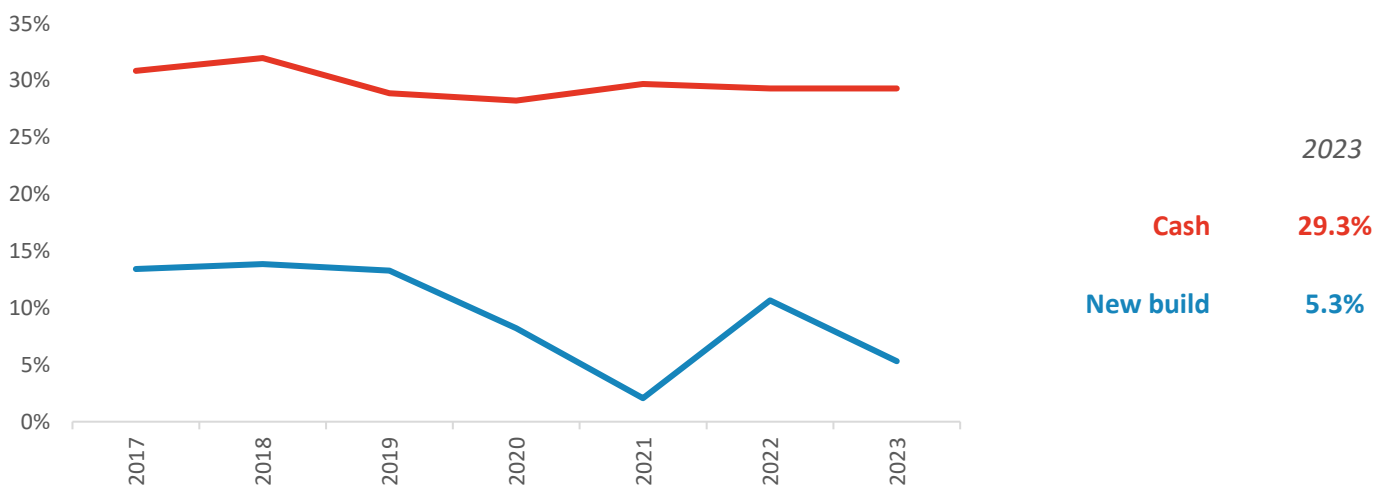
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,593 transactions in Amber Valley during the 12 months to September 2023. This is 58% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Amber Valley have fallen by 25.5% since 2014, compared to changes of -35.3% for East Midlands and -35.3% for England.

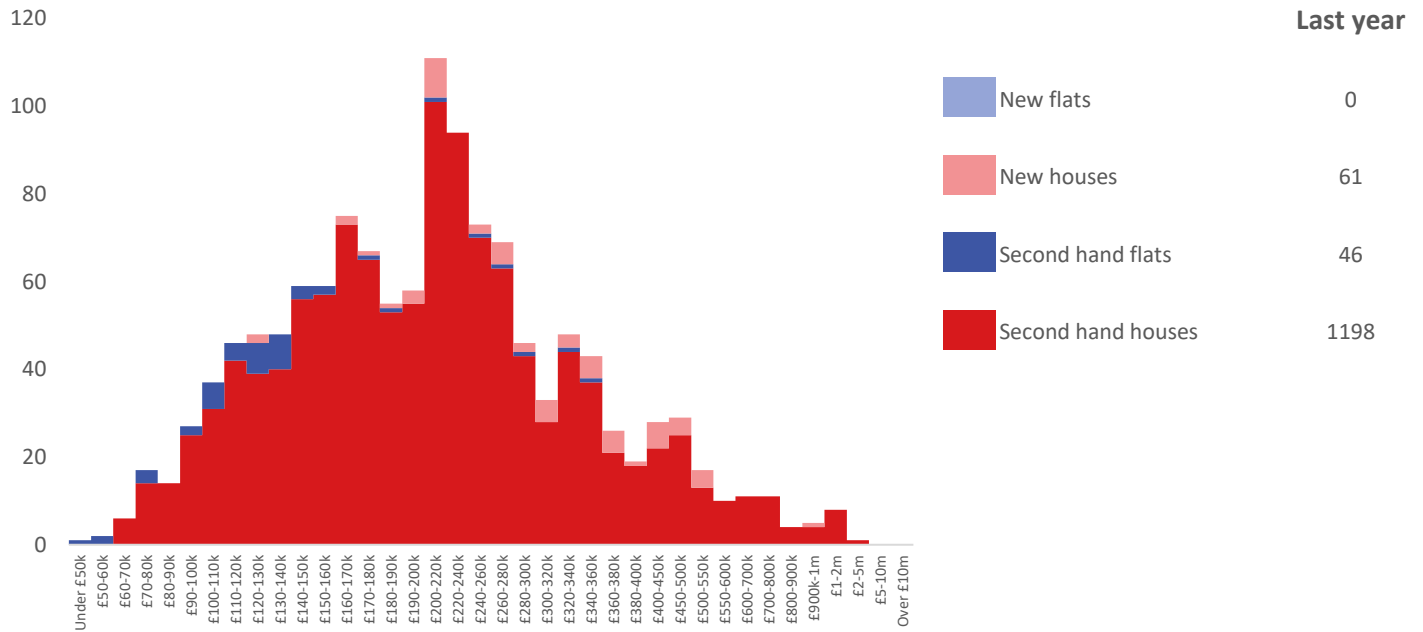
### Cash and New Build Sales as % of Total, by Year

### Depth of Market by Property Type

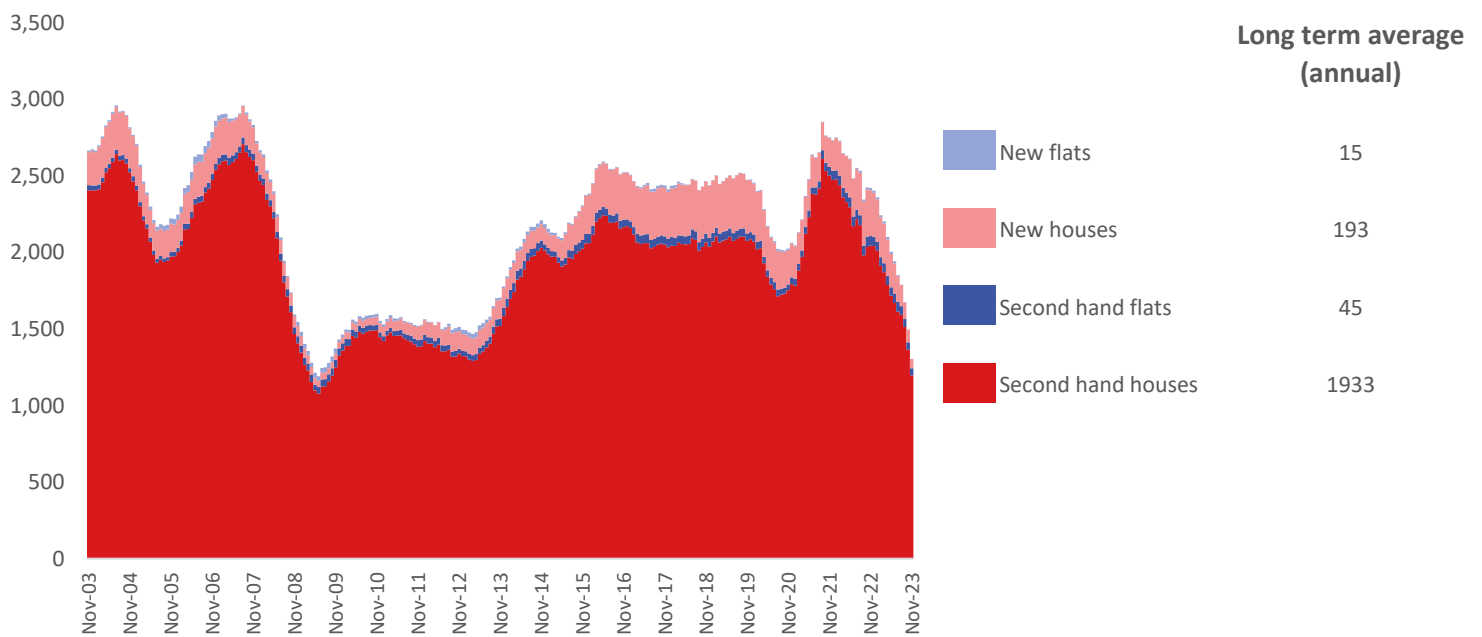
12 months to November 2023



The most common property type transacted over the past 12 months in Amber Valley was 'second hand houses' with 1,198 sales, 92% of all sales over the same period. The annual total of 1,305 transactions is equivalent to 60% of the long term average level of activity.

### Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,933 sales per year on average, making up 88% of the typical annual total over that period.
