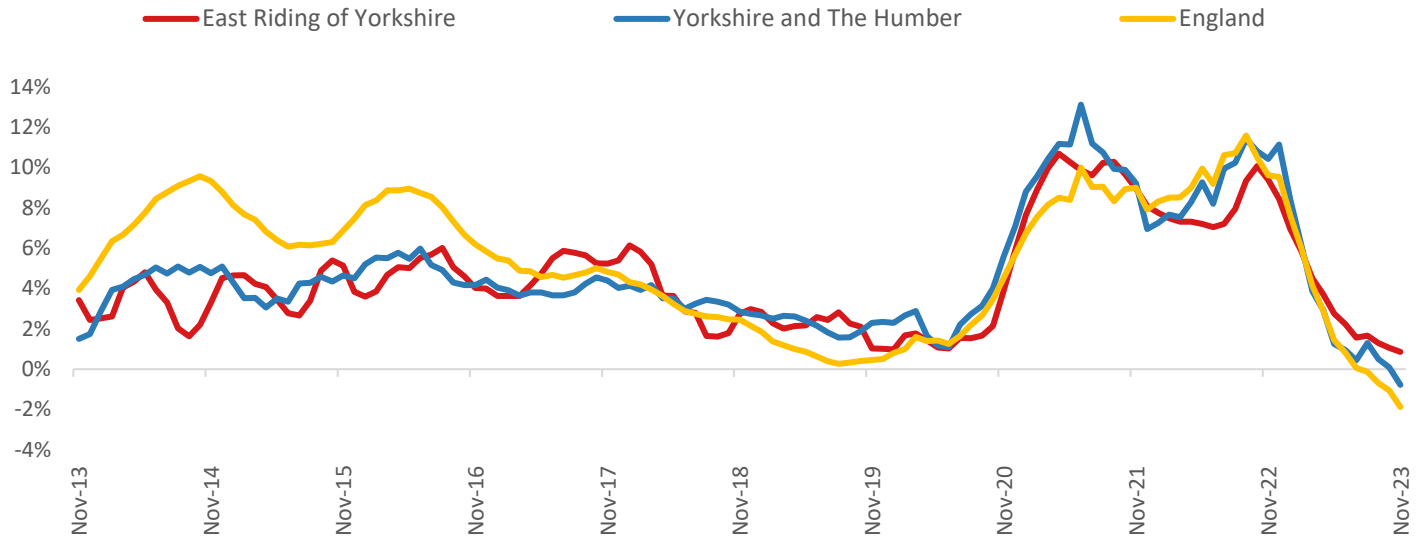

House Price Growth (November 2023 data)

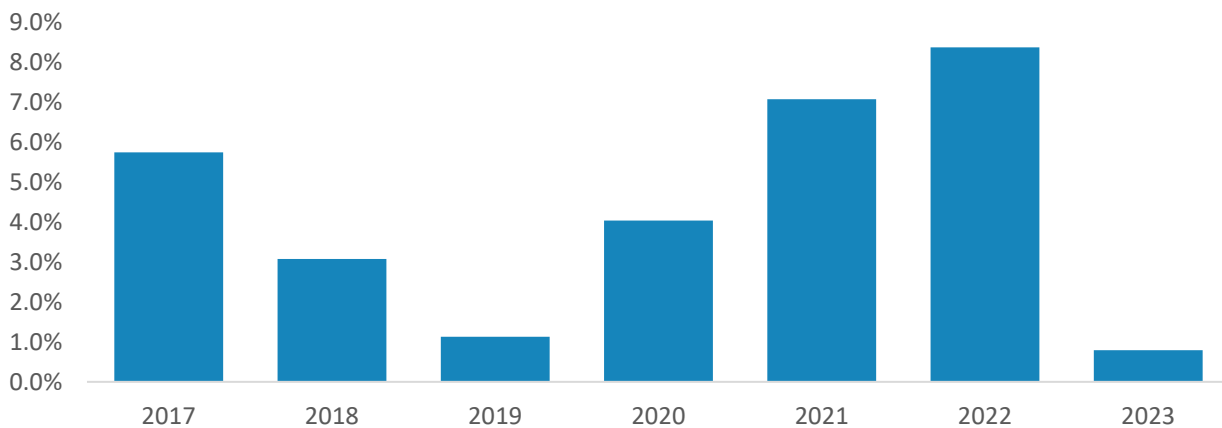
Annual Change in House Prices



House prices in East Riding of Yorkshire grew by 0.9% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in Yorkshire and The Humber fell by 0.8% over the same period.

East Riding of Yorkshire house prices are now 38.3% above their previous peak in 2007, compared to +39.5% for Yorkshire and The Humber and +56.9% across England.

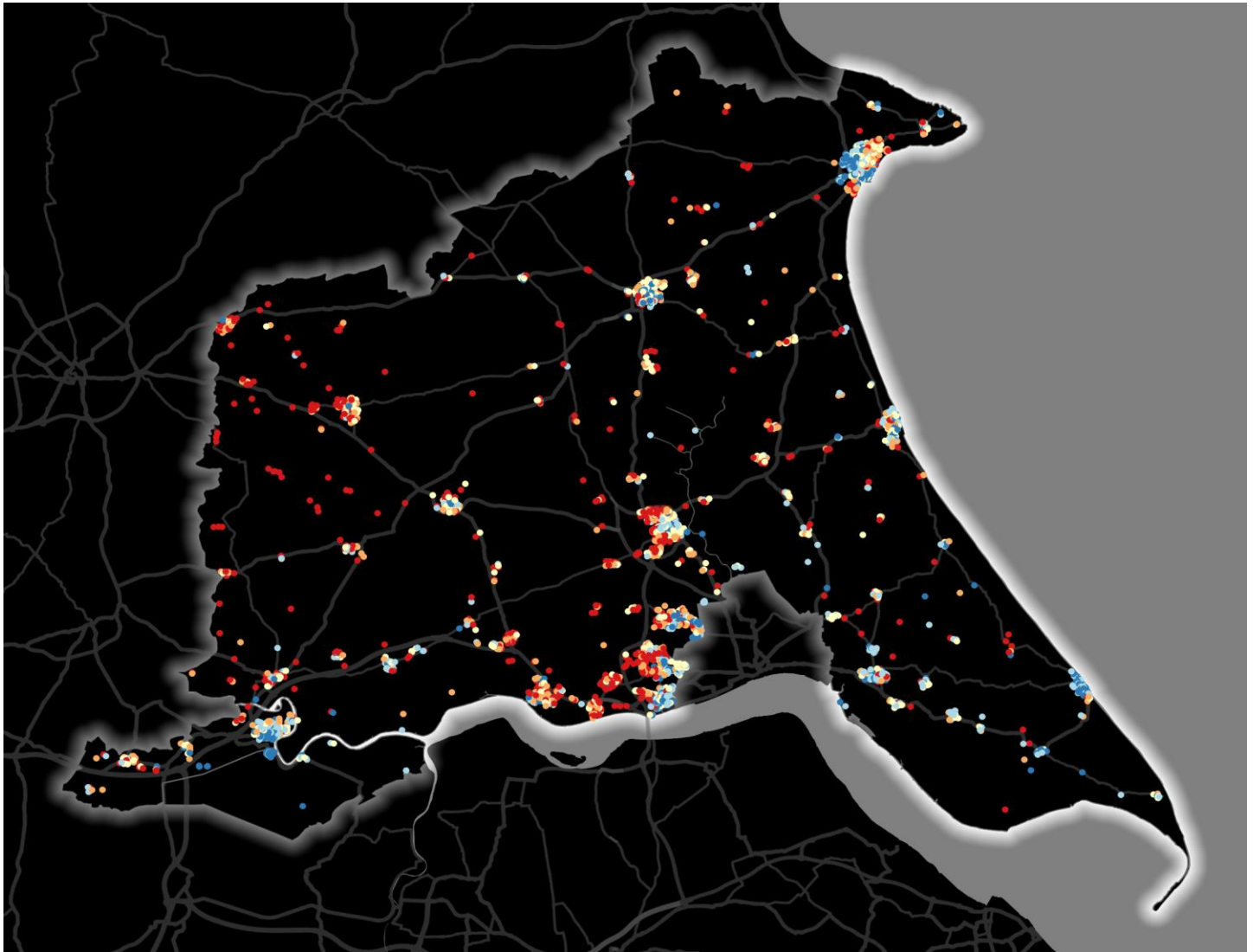
Year-To-Date Change in House Prices, December to November



Local prices have grown by 0.8% in 2023 so far, compared to growth of 8.4% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

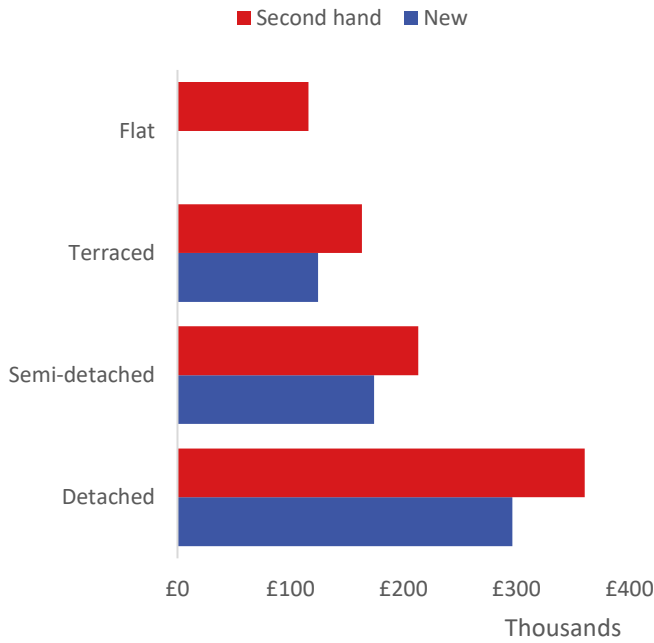

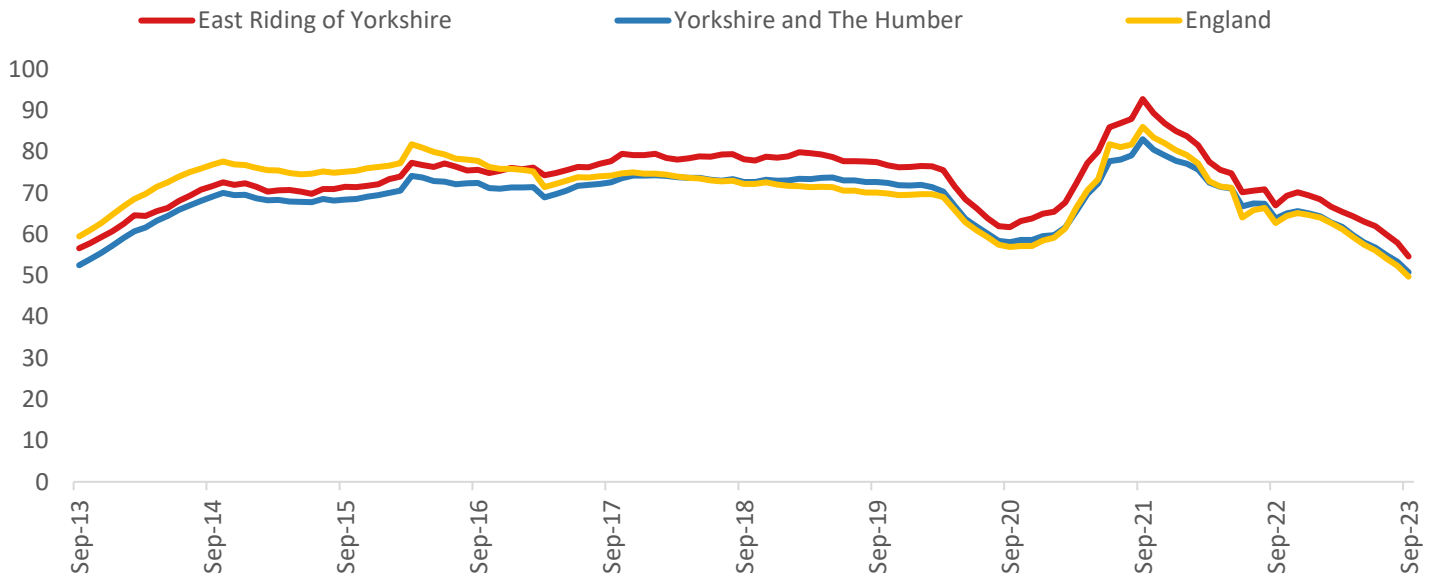

Transactions (September 2023 data)

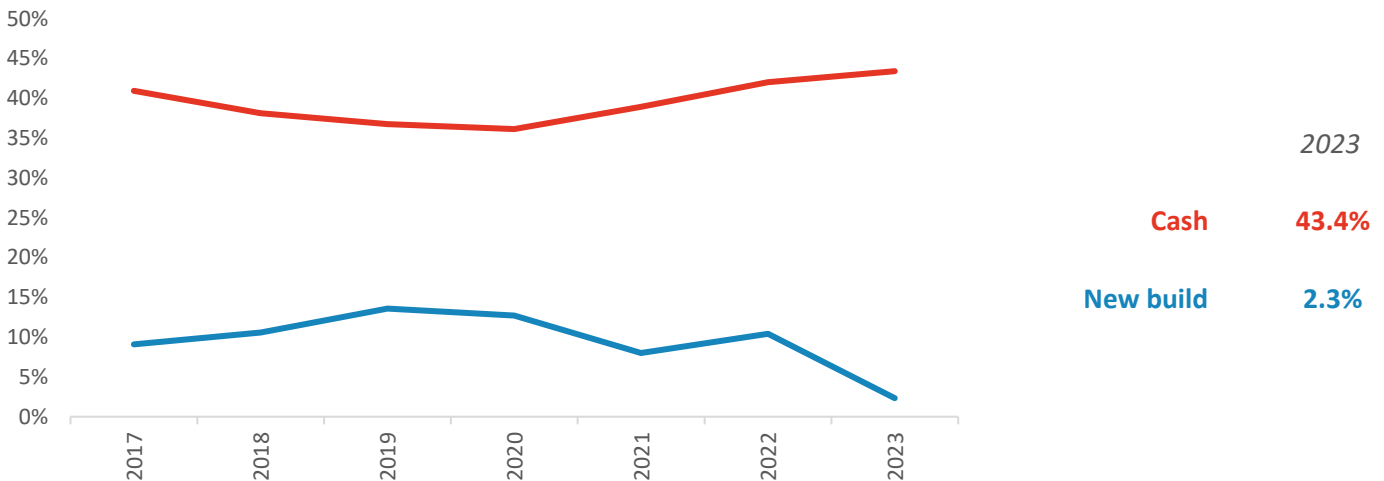
Annual Transactions, Indexed (2001-05 average = 100)



There were 4,712 transactions in East Riding of Yorkshire during the 12 months to September 2023. This is 55% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in East Riding of Yorkshire have fallen by 24.5% since 2014, compared to changes of -27.0% for Yorkshire and The Humber and -35.3% for England.

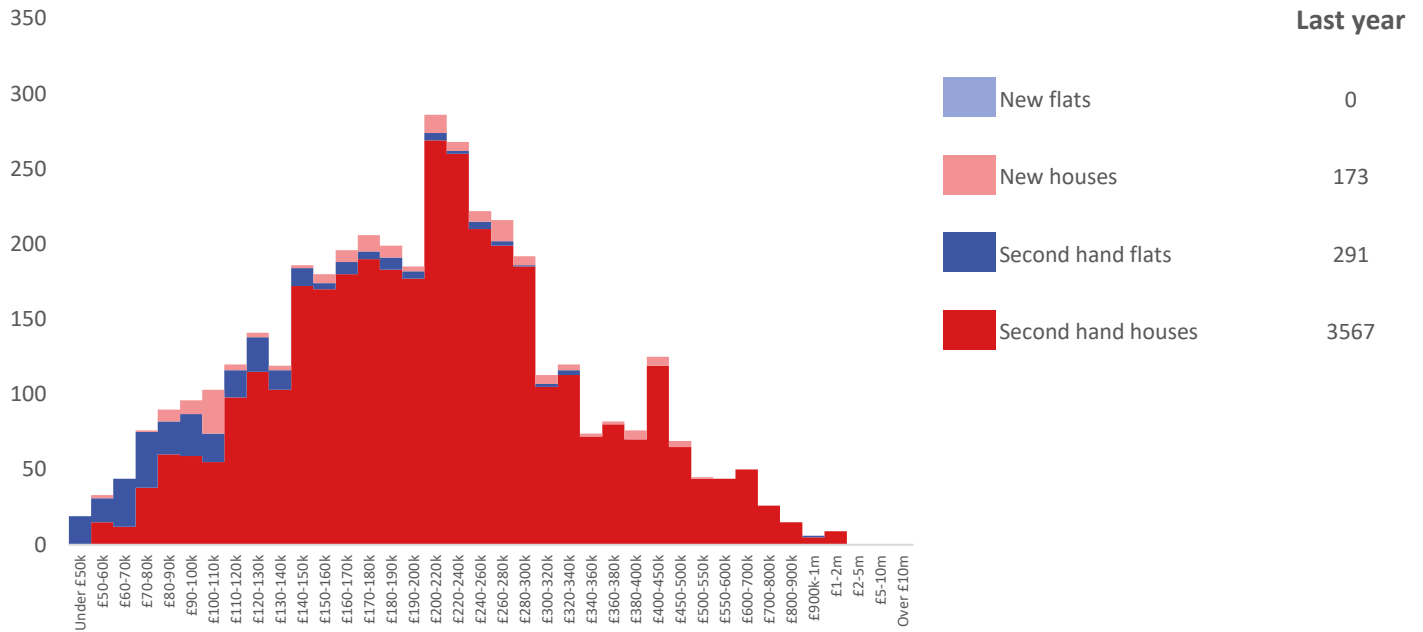
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

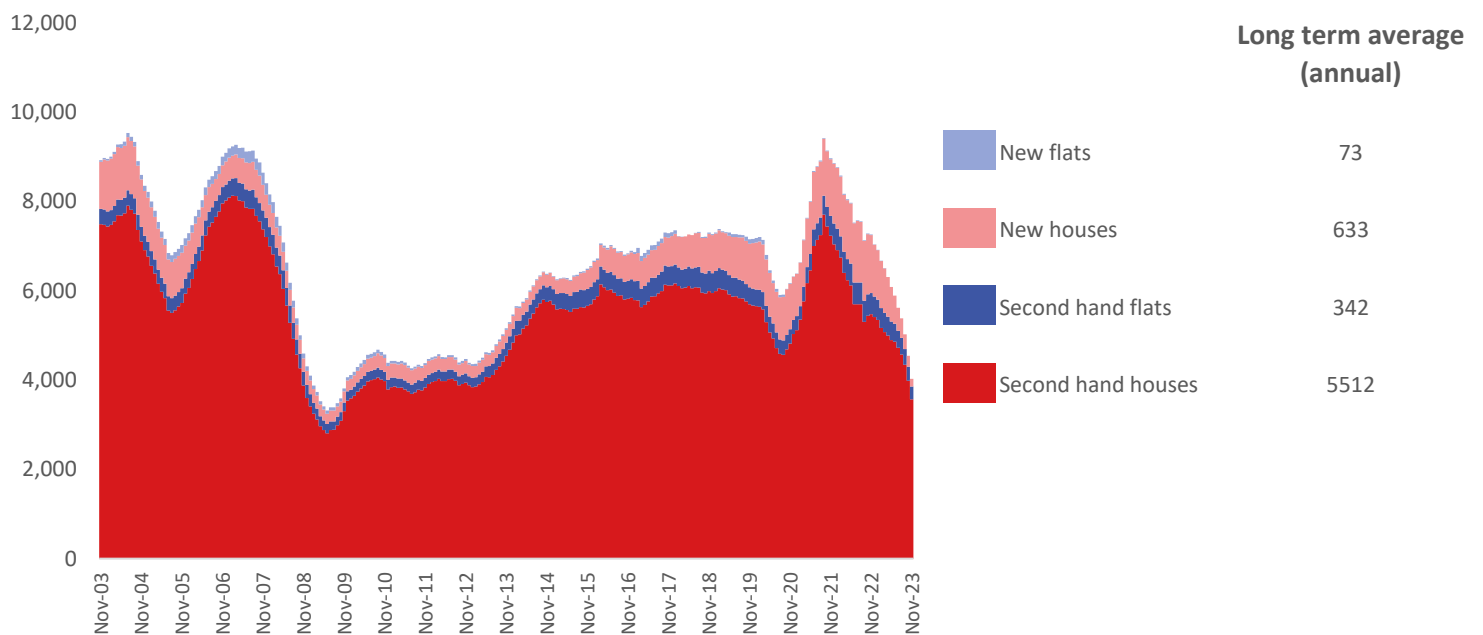
12 months to November 2023



The most common property type transacted over the past 12 months in East Riding of Yorkshire was 'second hand houses' with 3,567 sales, 88% of all sales over the same period. The annual total of 4,031 transactions is equivalent to 61% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 5,512 sales per year on average, making up 84% of the typical annual total over that period.
