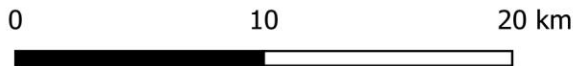
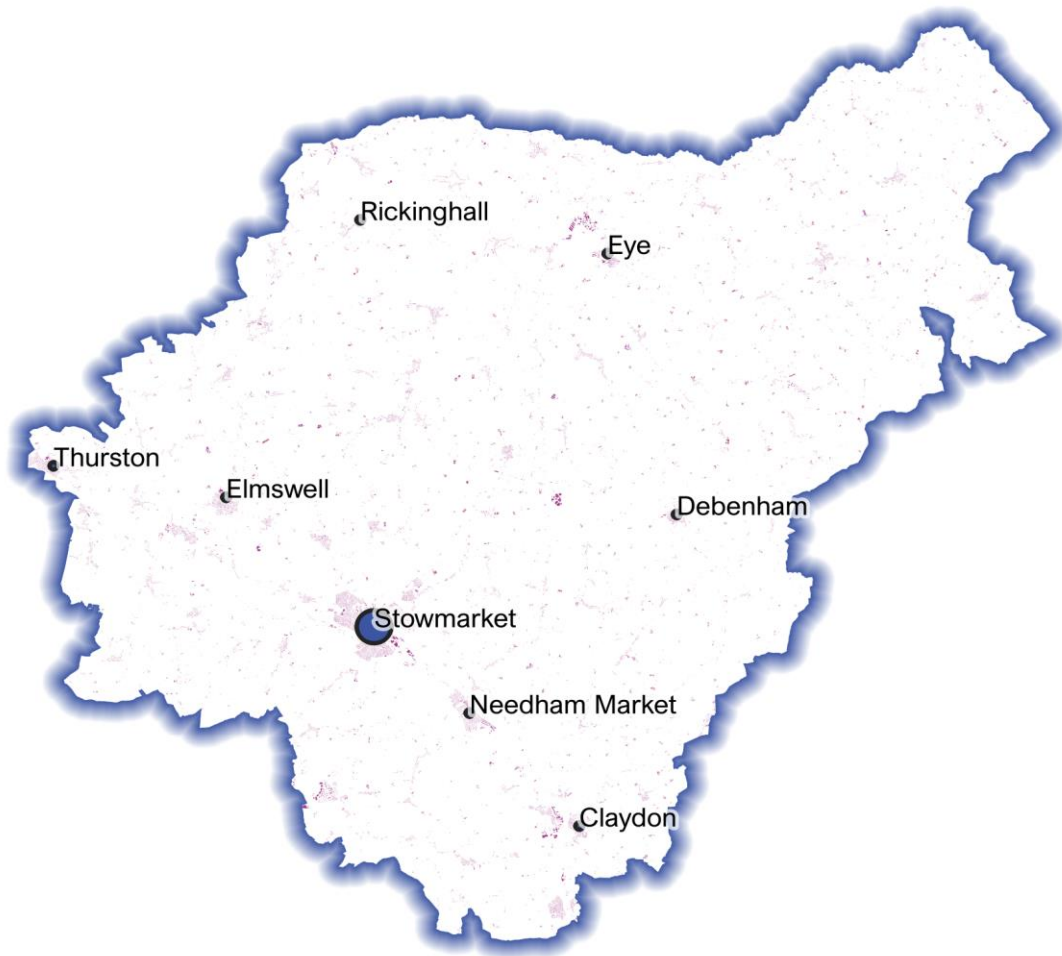

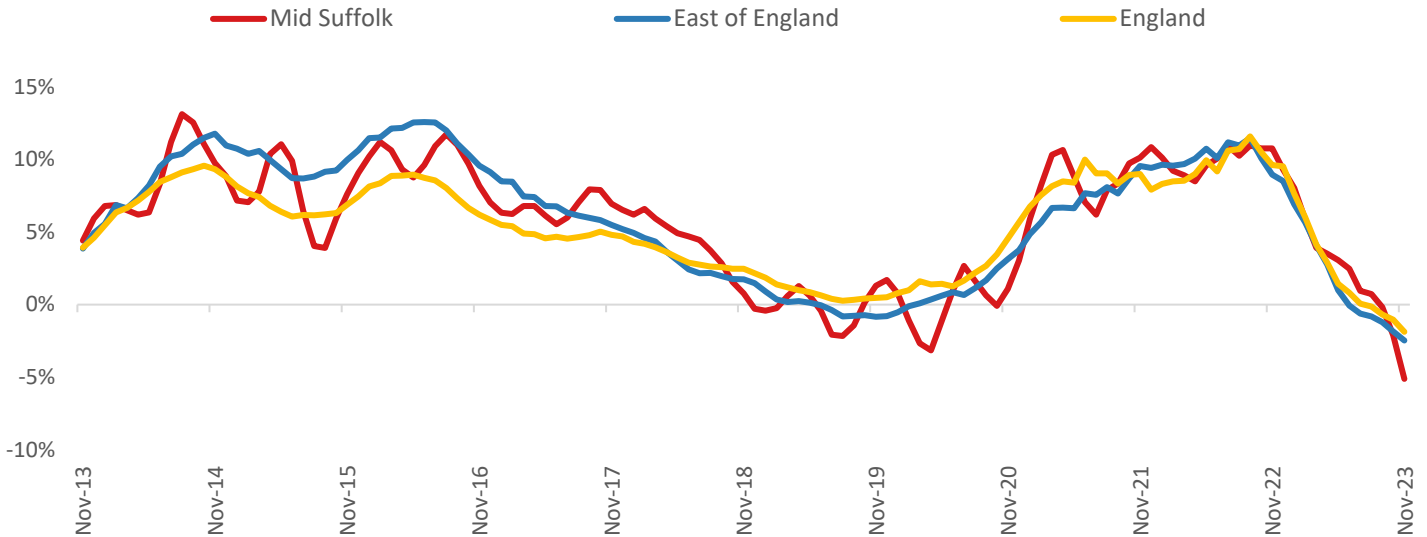

**House Price Growth (November 2023 data)**

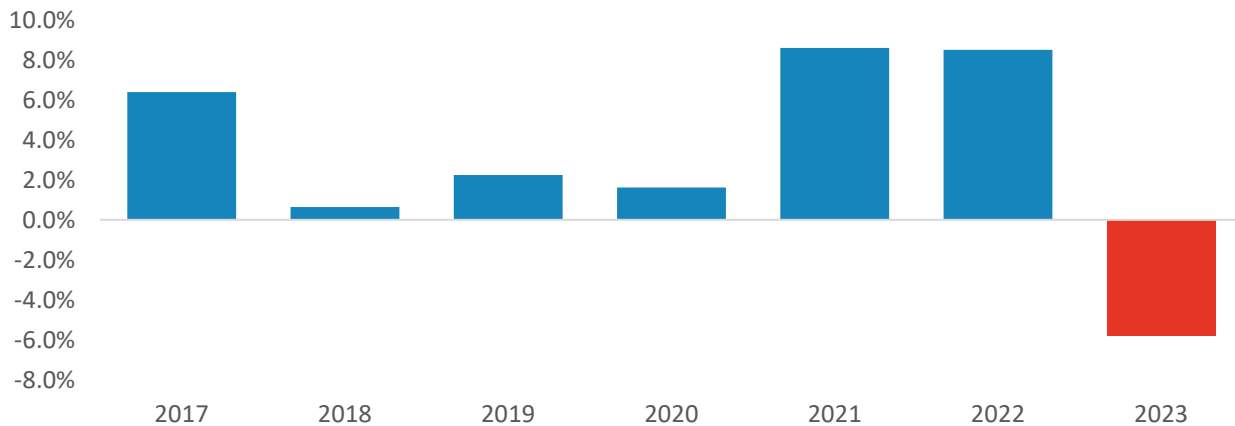
*Annual Change in House Prices*



House prices in Mid Suffolk fell by 5.1% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the East of England fell by 2.5% over the same period.

Mid Suffolk house prices are now 54.9% above their previous peak in 2007, compared to +67.0% for the East of England and +56.9% across England.

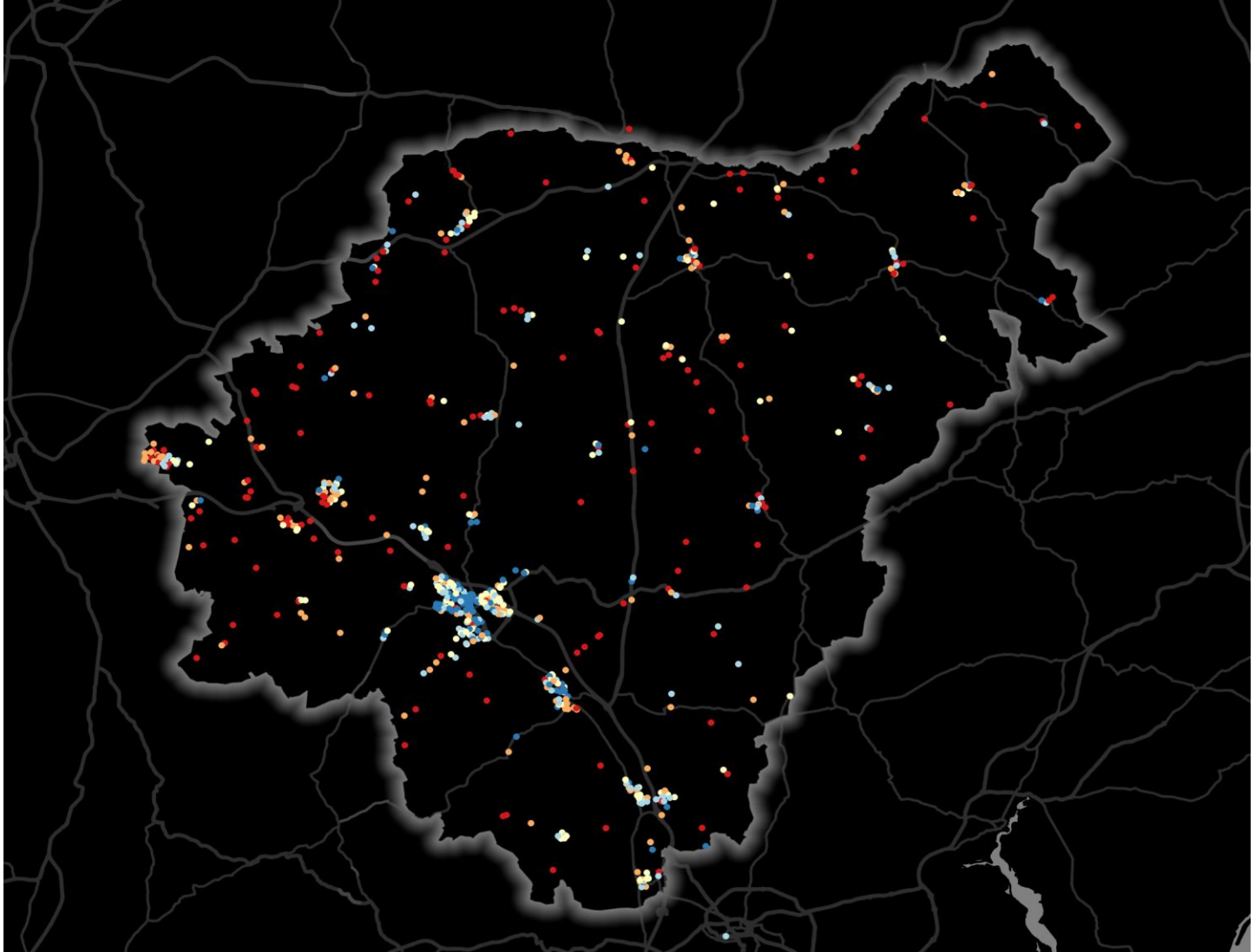
*Year-To-Date Change in House Prices, December to November*



Local prices have fallen by 5.8% in 2023 so far, compared to growth of 8.5% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

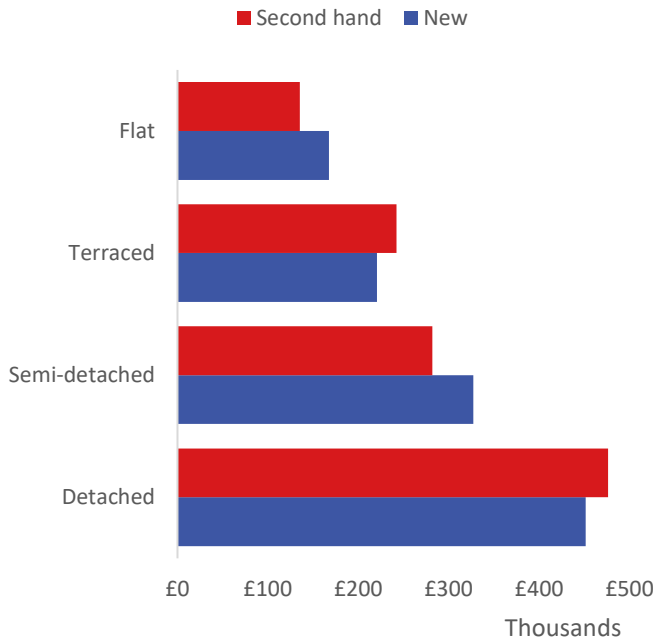

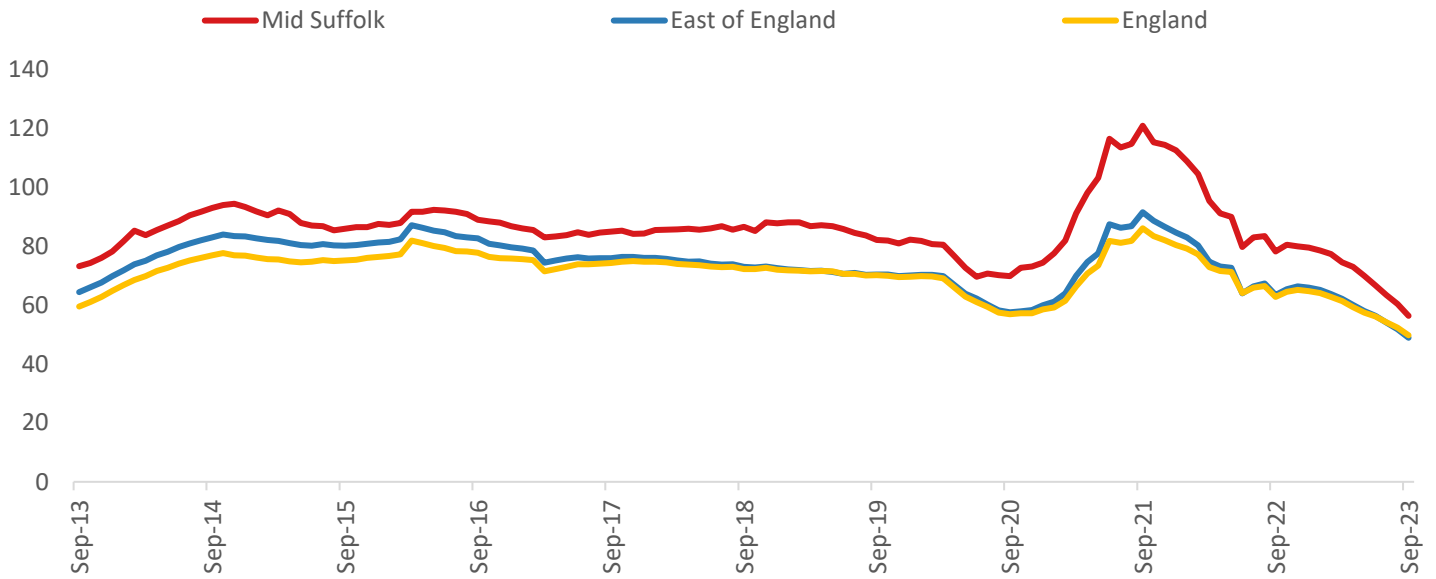

### Transactions (September 2023 data)

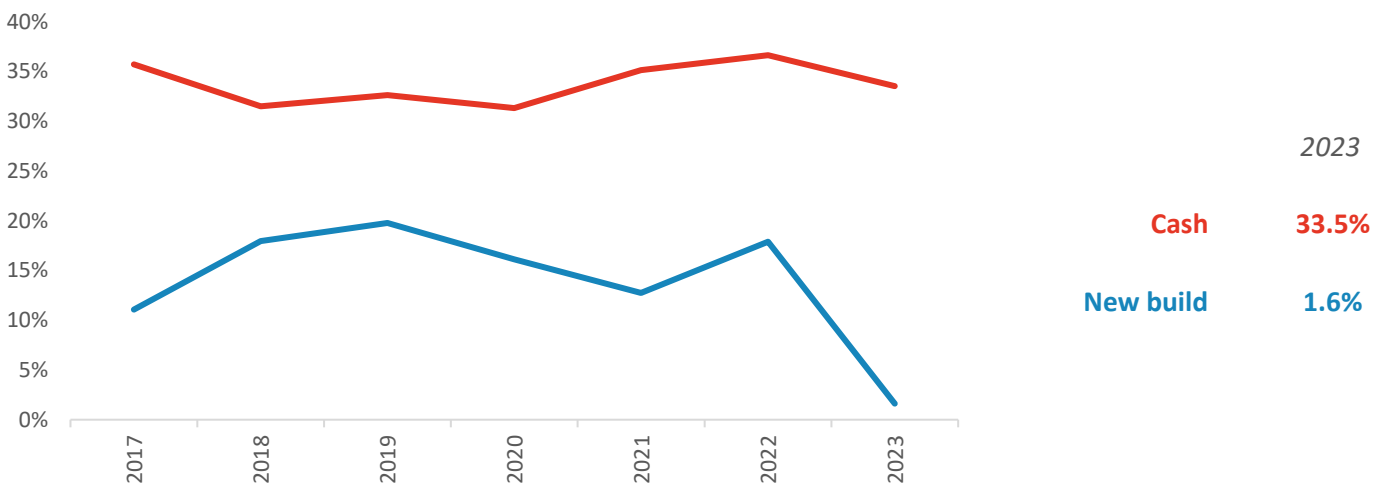
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,185 transactions in Mid Suffolk during the 12 months to September 2023. This is 56% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Mid Suffolk have fallen by 39.6% since 2014, compared to changes of -41.3% for East of England and -35.3% for England.

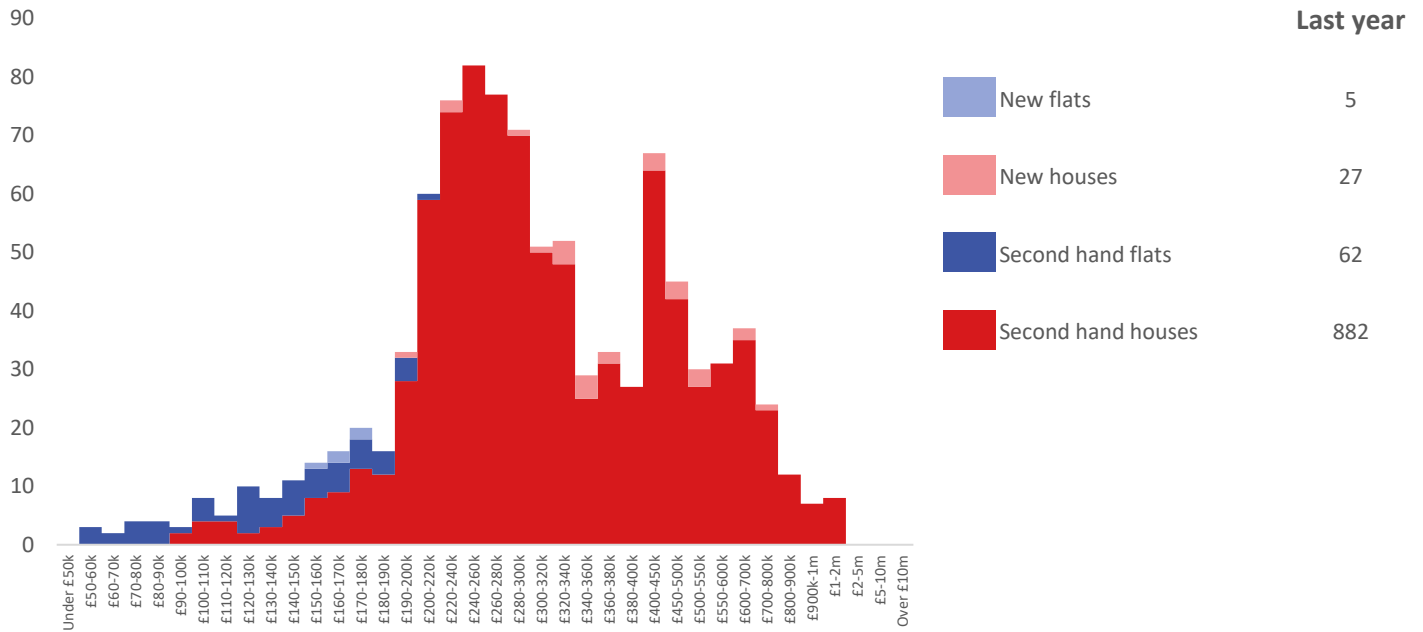
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

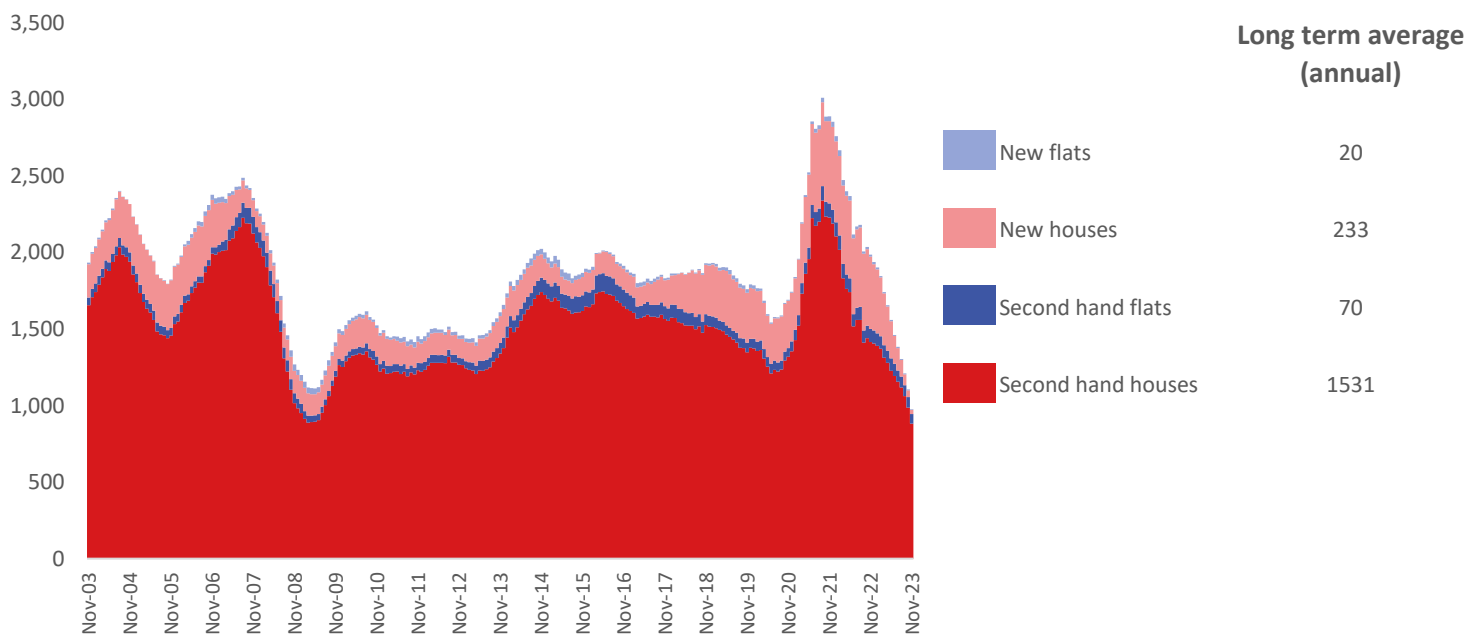
12 months to November 2023



The most common property type transacted over the past 12 months in Mid Suffolk was 'second hand houses' with 882 sales, 90% of all sales over the same period. The annual total of 976 transactions is equivalent to 53% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,531 sales per year on average, making up 83% of the typical annual total over that period.
