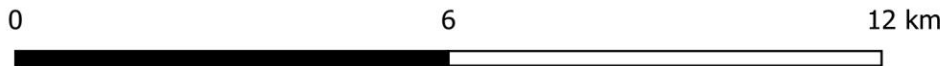
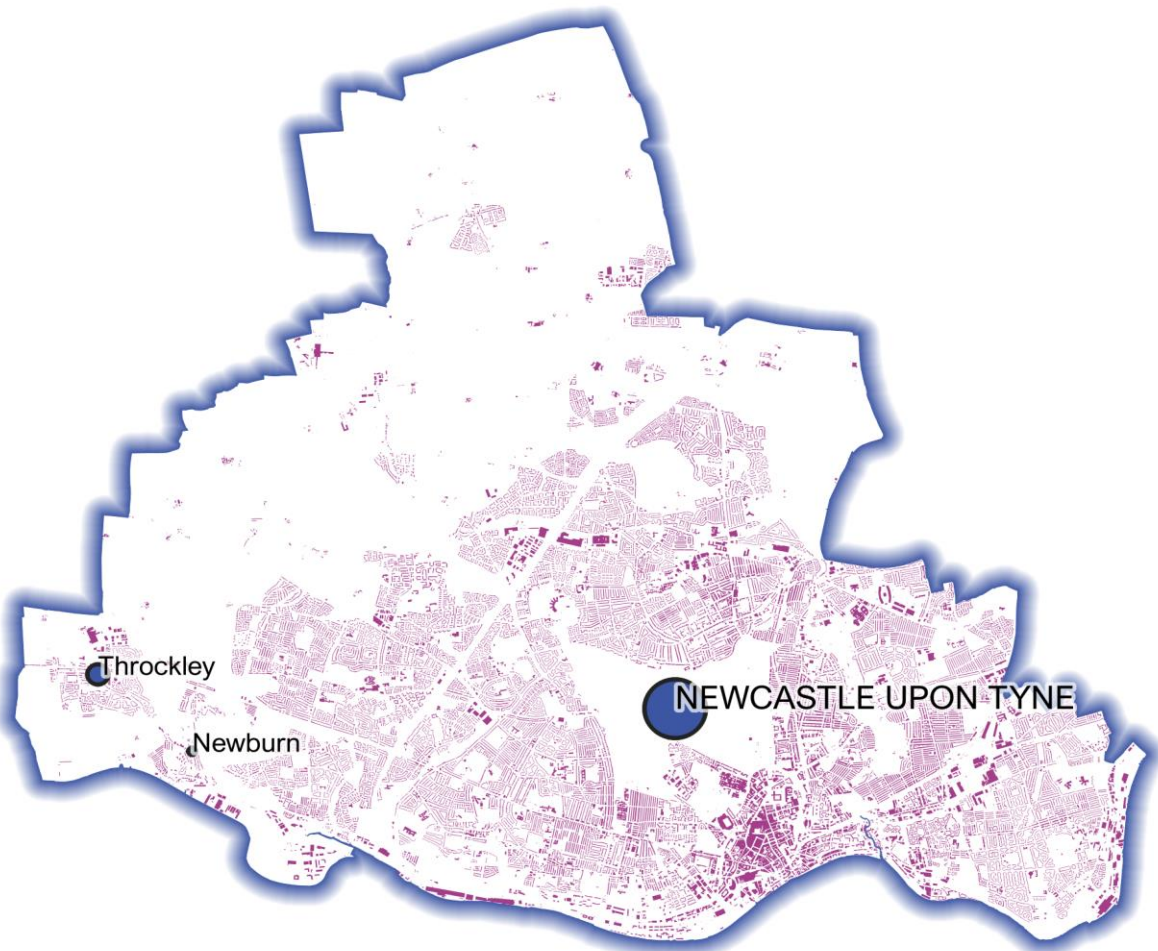

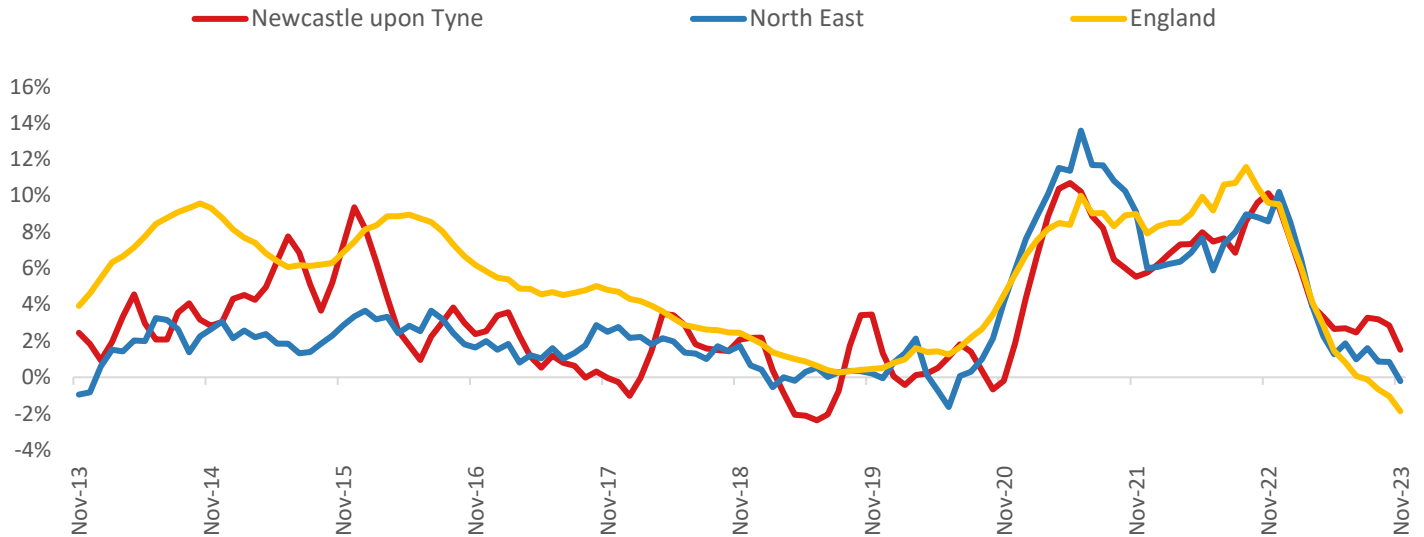

**House Price Growth (November 2023 data)**

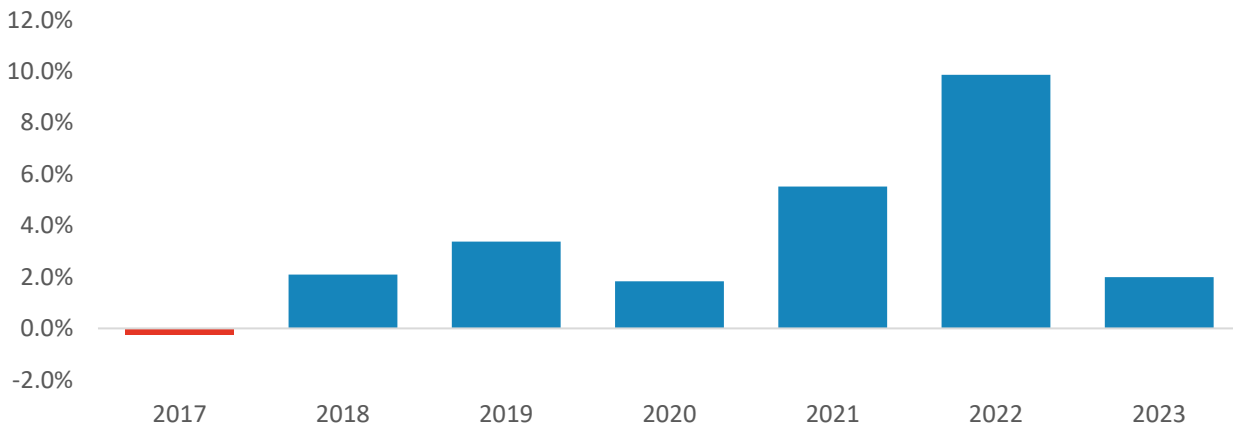
*Annual Change in House Prices*



House prices in Newcastle upon Tyne grew by 1.5% in the 12 months to November 2023 (based on 3-month smoothed data). By comparison national house prices fell by 1.9% and prices in the North East fell by 0.2% over the same period.

Newcastle upon Tyne house prices are now 20.7% above their previous peak in 2007, compared to +15.7% for the North East and +56.9% across England.

*Year-To-Date Change in House Prices, December to November*



Local prices have grown by 2.0% in 2023 so far, compared to growth of 9.9% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

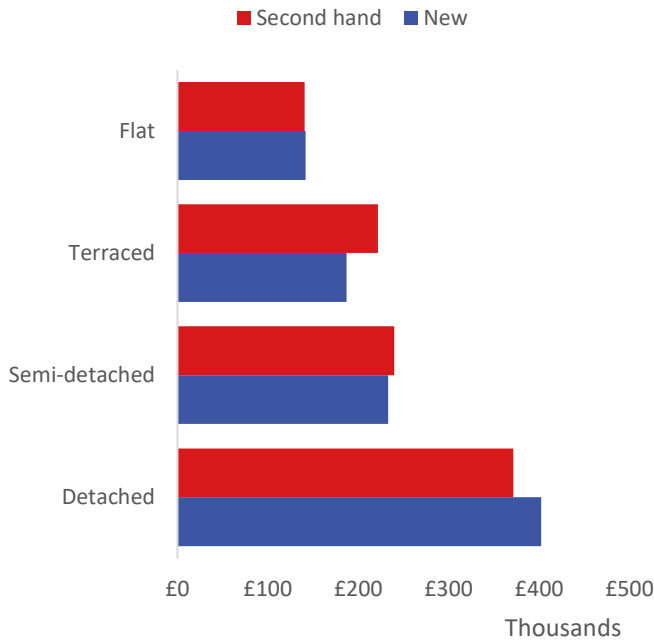

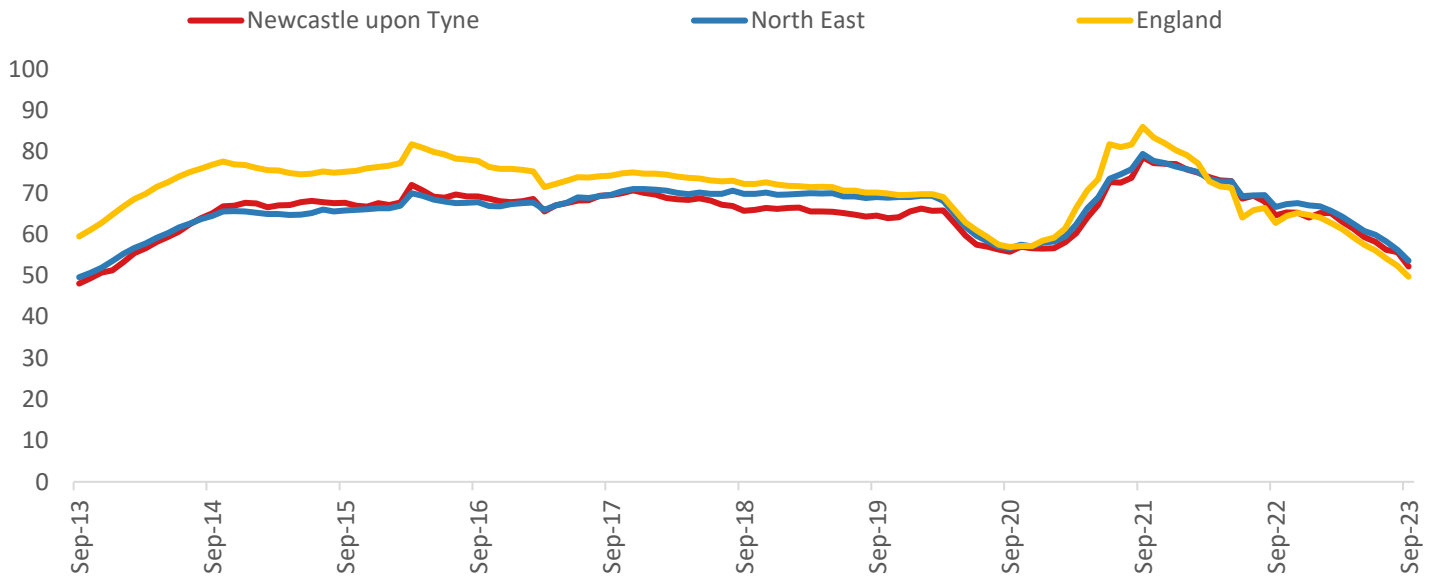

### Transactions (September 2023 data)

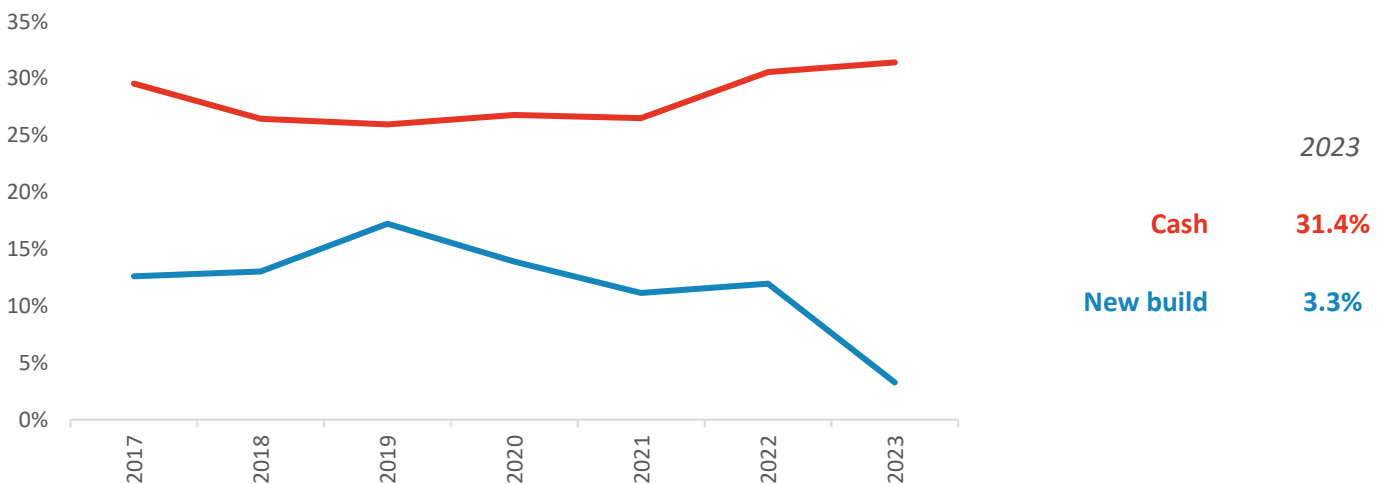
Annual Transactions, Indexed (2001-05 average = 100)



There were 3,026 transactions in Newcastle upon Tyne during the 12 months to September 2023. This is 52% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Newcastle upon Tyne have fallen by 22.8% since 2014, compared to changes of -18.3% for North East and -35.3% for England.

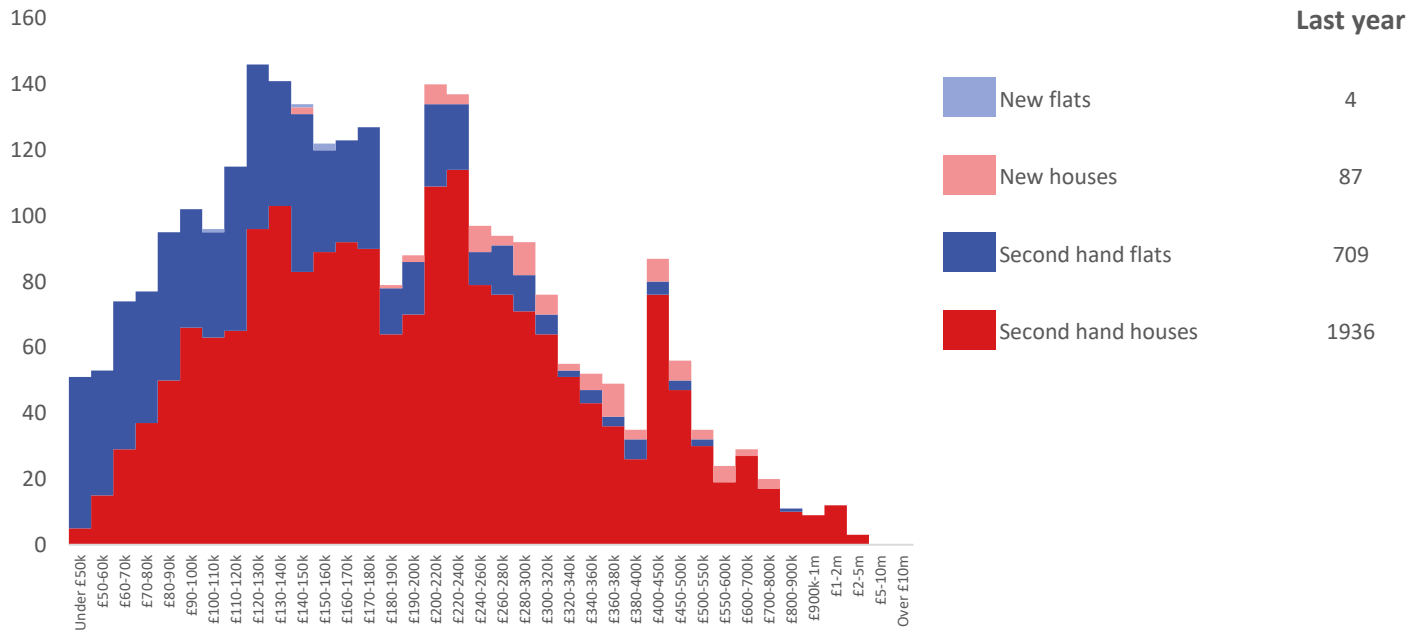
### Cash and New Build Sales as % of Total, by Year

### Depth of Market by Property Type

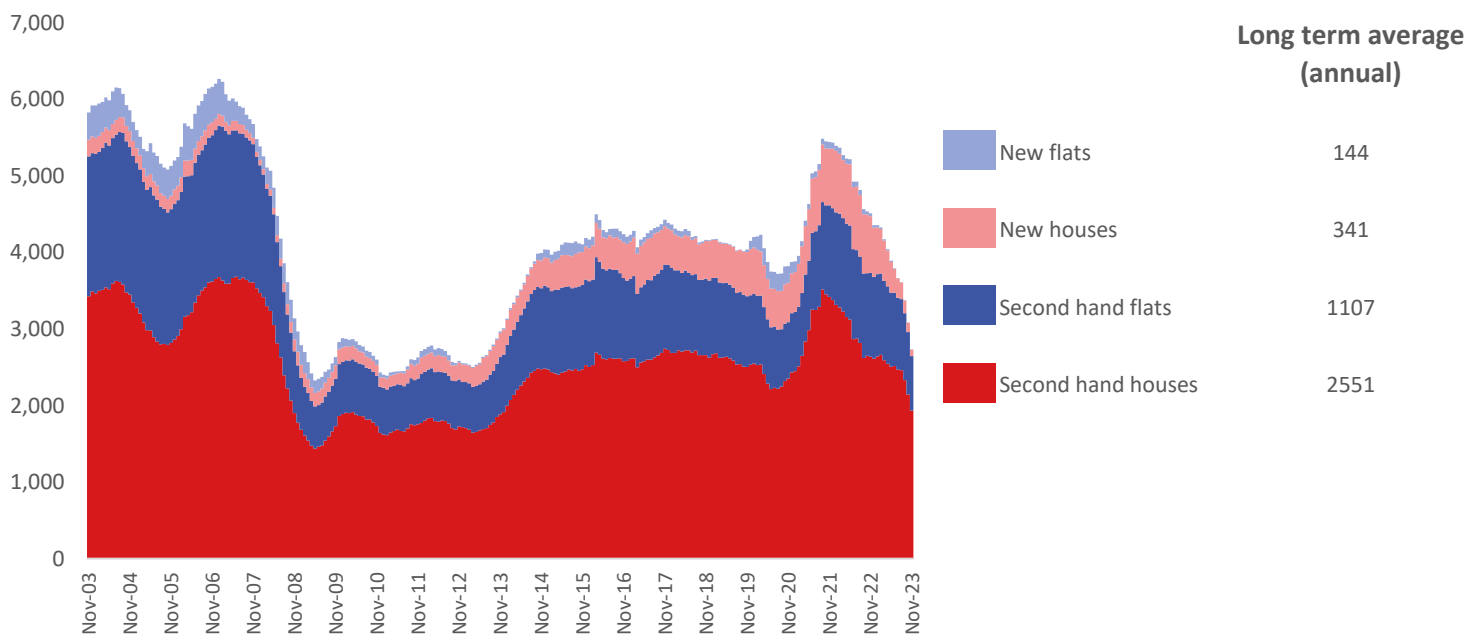
12 months to November 2023



The most common property type transacted over the past 12 months in Newcastle upon Tyne was 'second hand houses' with 1,936 sales, 71% of all sales over the same period. The annual total of 2,736 transactions is equivalent to 66% of the long term average level of activity.

### Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 2,551 sales per year on average, making up 62% of the typical annual total over that period.
