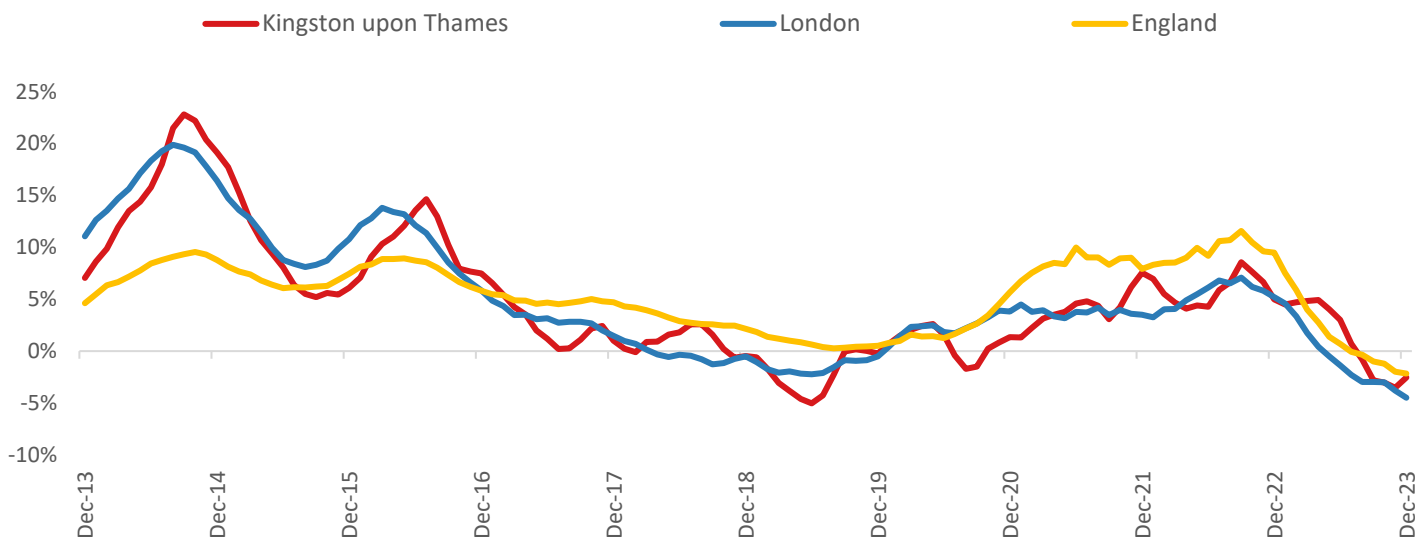

### House Price Growth (December 2023 data)

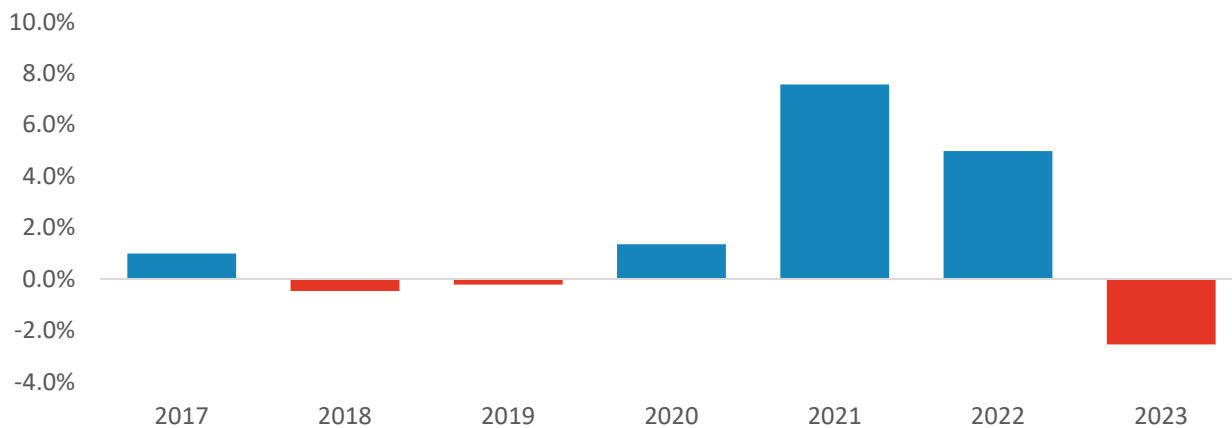
#### Annual Change in House Prices



House prices in Kingston upon Thames fell by 2.5% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in London fell by 4.5% over the same period.

Kingston upon Thames house prices are now 68.7% above their previous peak in 2007, compared to +71.5% for London and +56.0% across England.

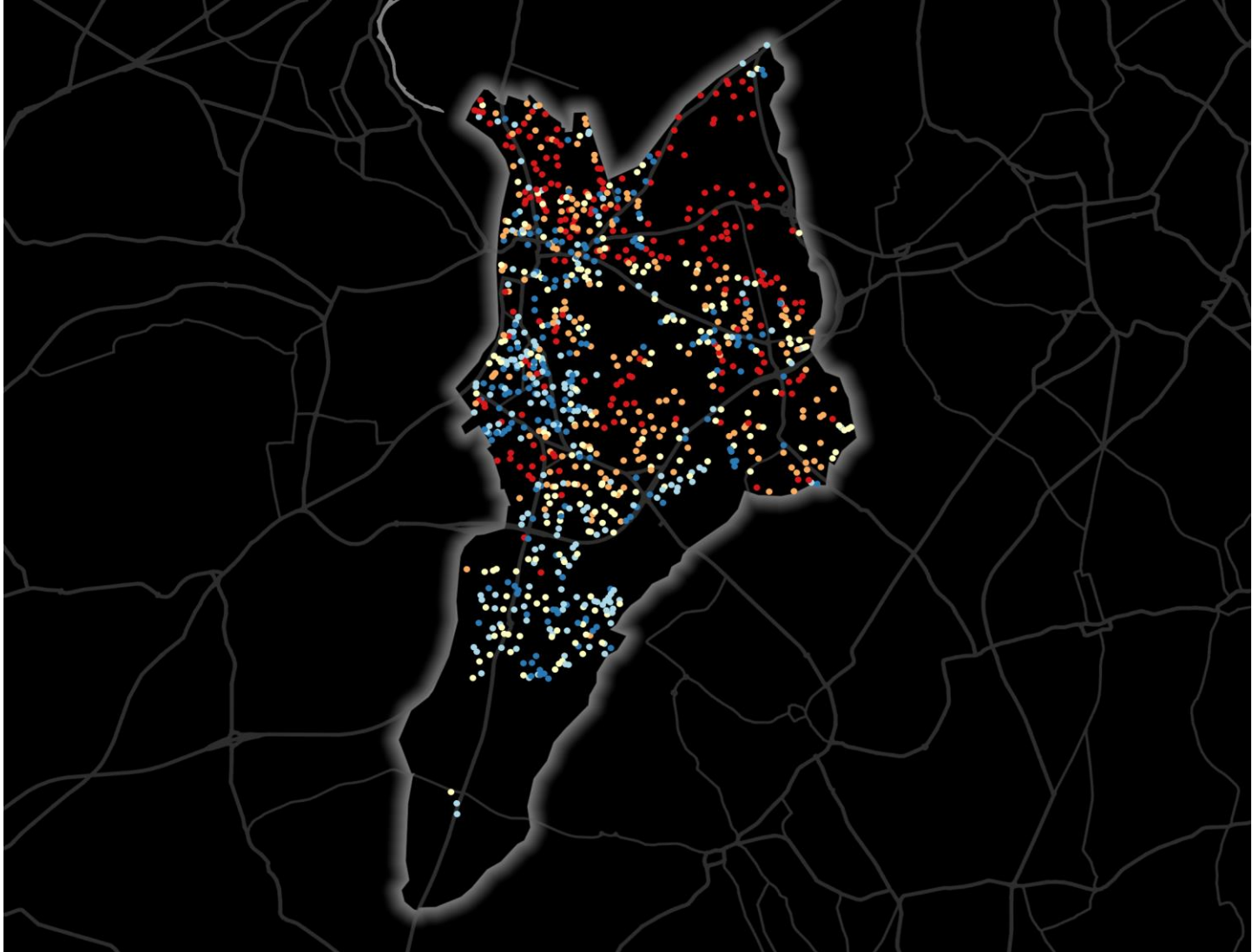
#### Year-To-Date Change in House Prices, December to December



Local prices have fallen by 2.5% in 2023 so far, compared to growth of 5.0% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

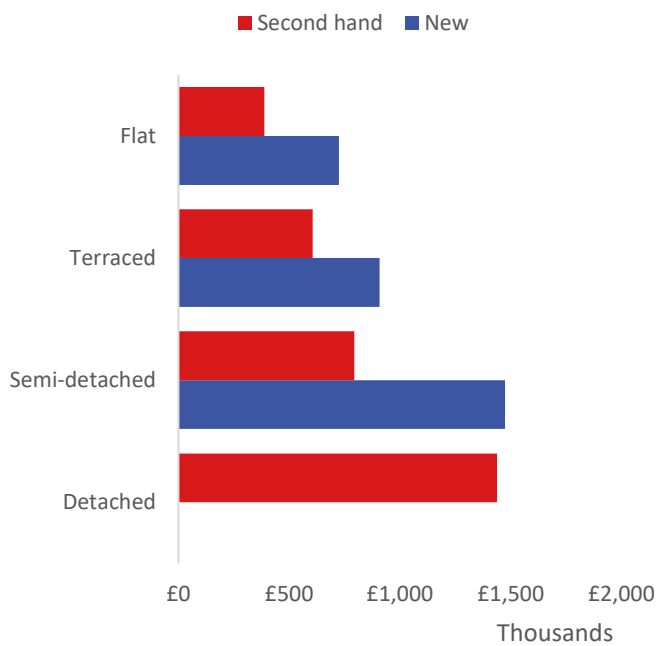

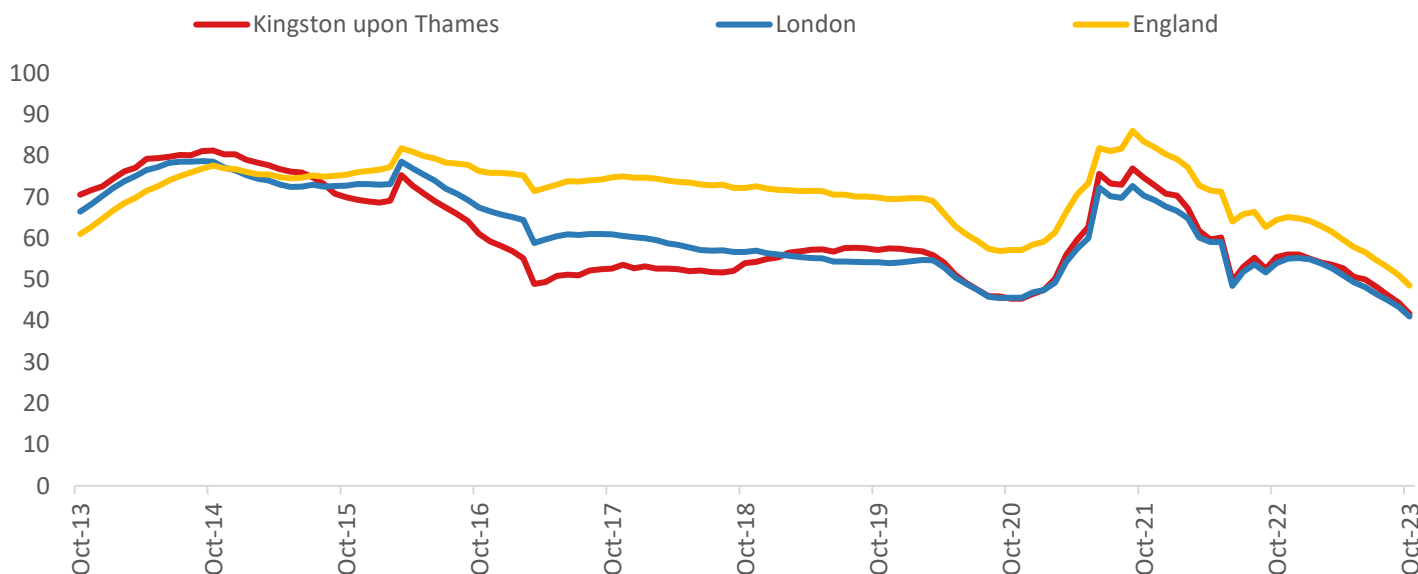

### Transactions (October 2023 data)

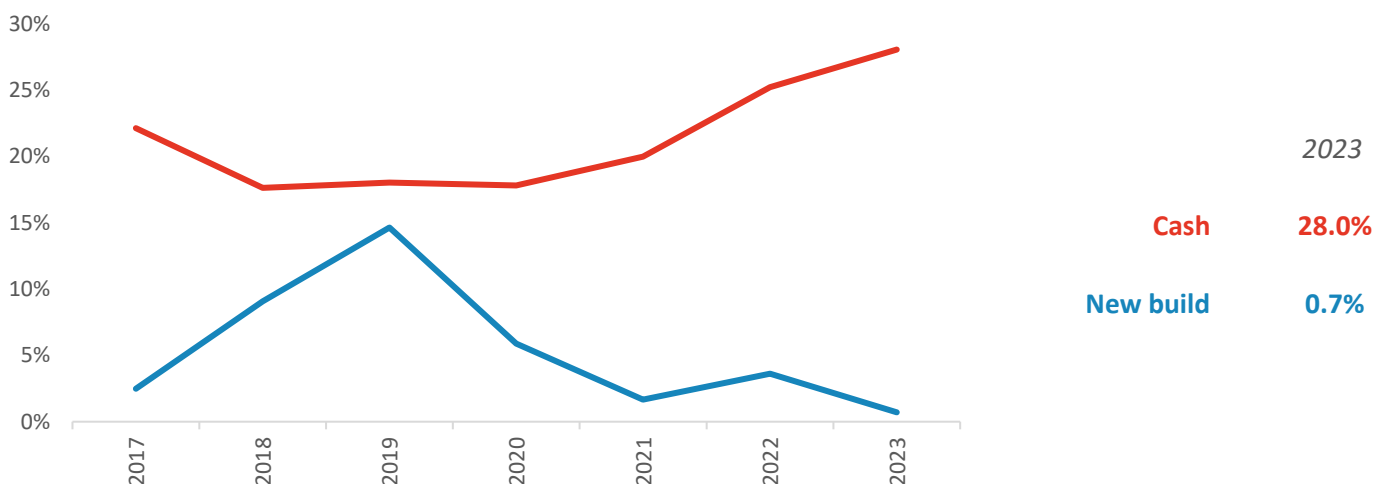
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,588 transactions in Kingston upon Thames during the 12 months to October 2023. This is 42% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Kingston upon Thames have fallen by 48.1% since 2014, compared to changes of -46.3% for London and -36.8% for England.

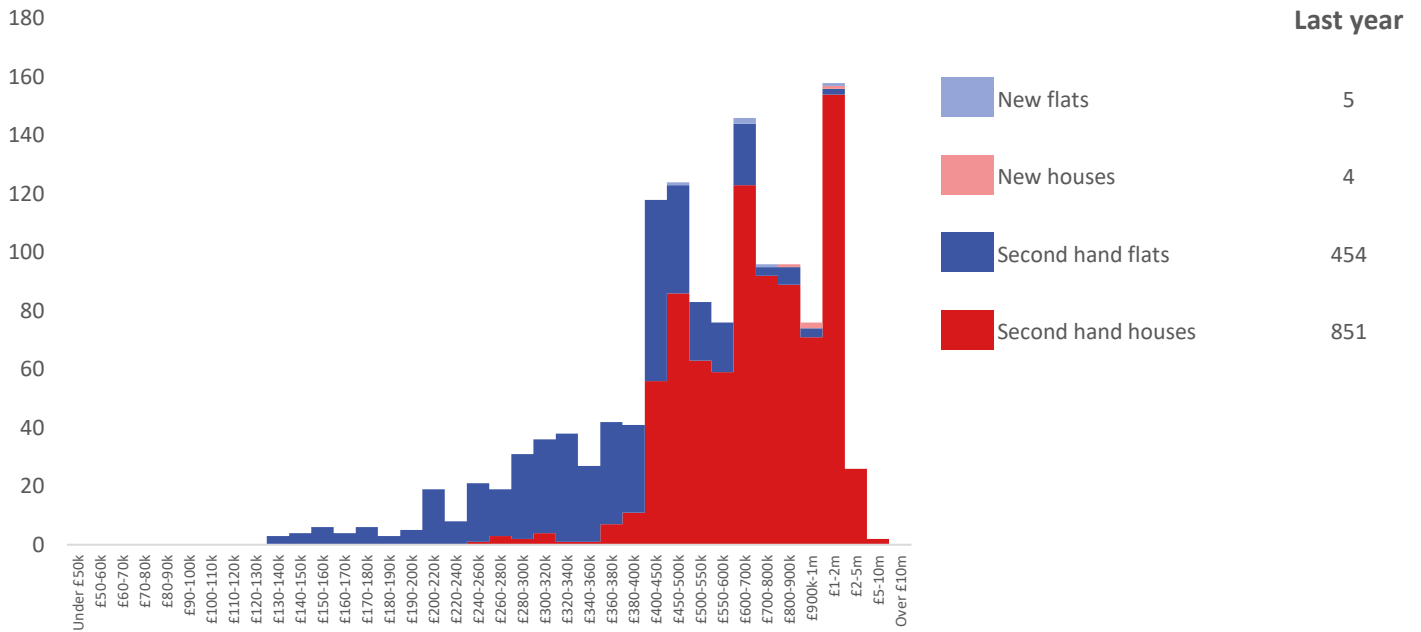
### Cash and New Build Sales as % of Total, by Year

## Depth of Market by Property Type

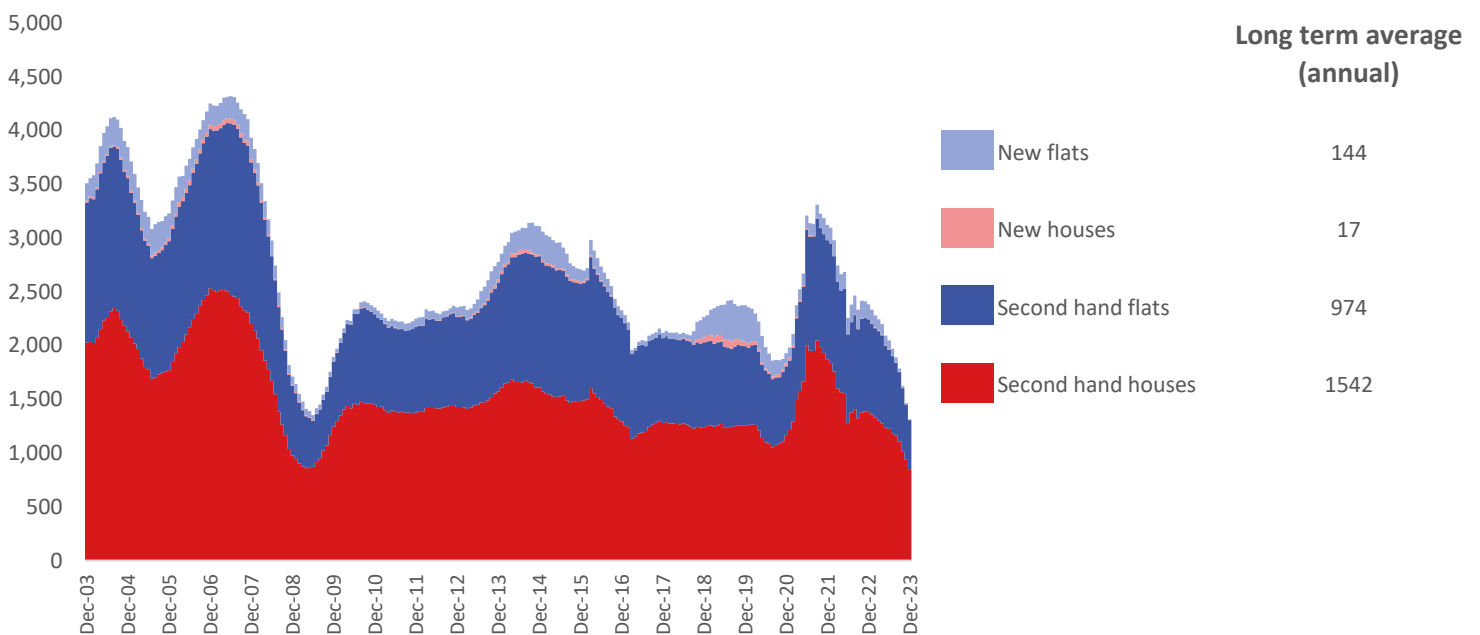
12 months to December 2023



The most common property type transacted over the past 12 months in Kingston upon Thames was 'second hand houses' with 851 sales, 65% of all sales over the same period. The annual total of 1,314 transactions is equivalent to 49% of the long term average level of activity.

## Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,542 sales per year on average, making up 58% of the typical annual total over that period.
