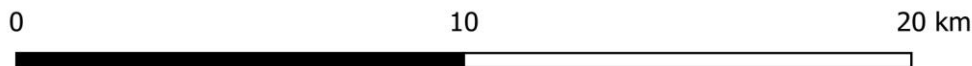
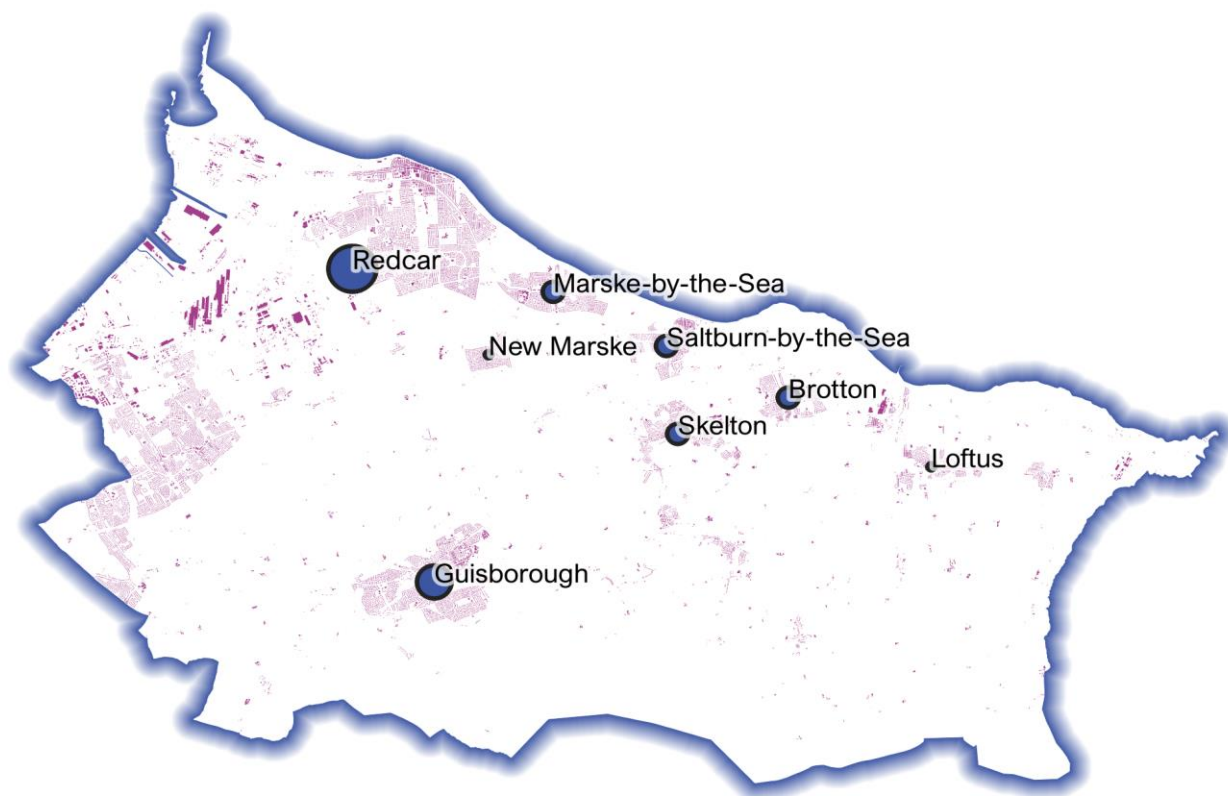

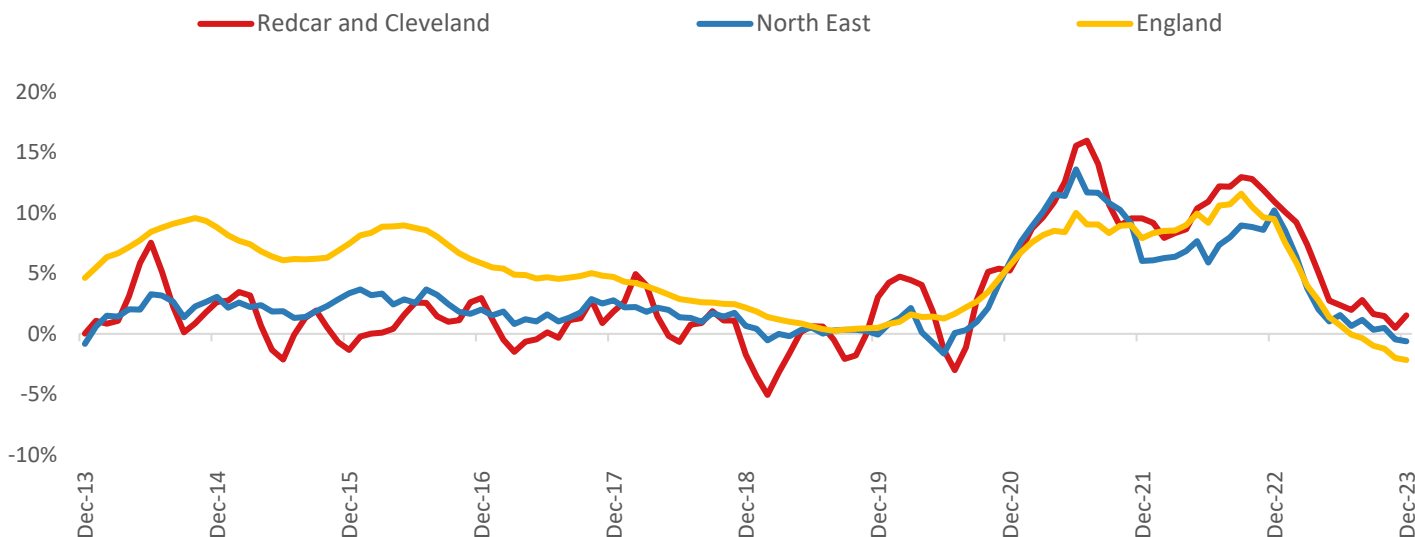

House Price Growth (December 2023 data)

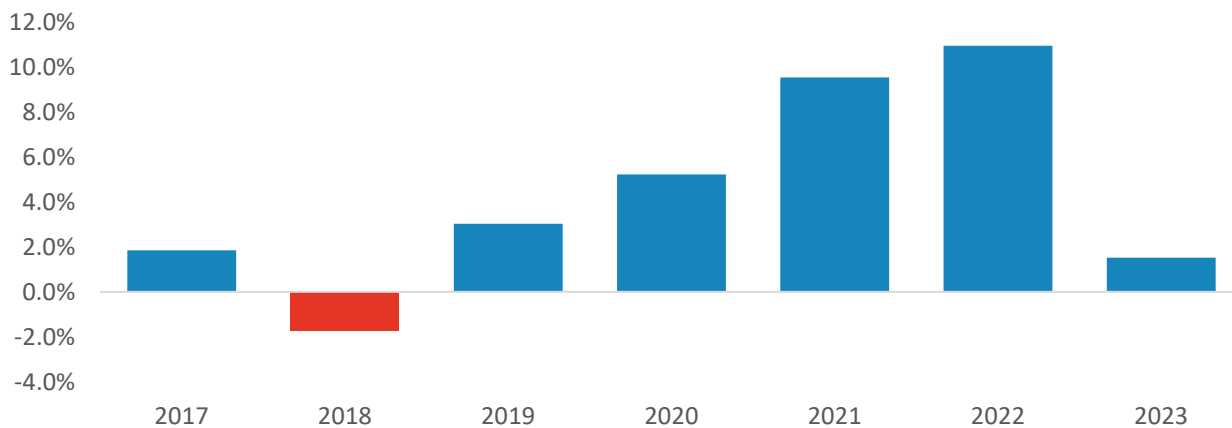
Annual Change in House Prices



House prices in Redcar and Cleveland grew by 1.5% in the 12 months to December 2023 (based on 3-month smoothed data). By comparison national house prices fell by 2.2% and prices in the North East fell by 0.6% over the same period.

Redcar and Cleveland house prices are now 21.2% above their previous peak in 2007, compared to +14.8% for the North East and +56.0% across England.

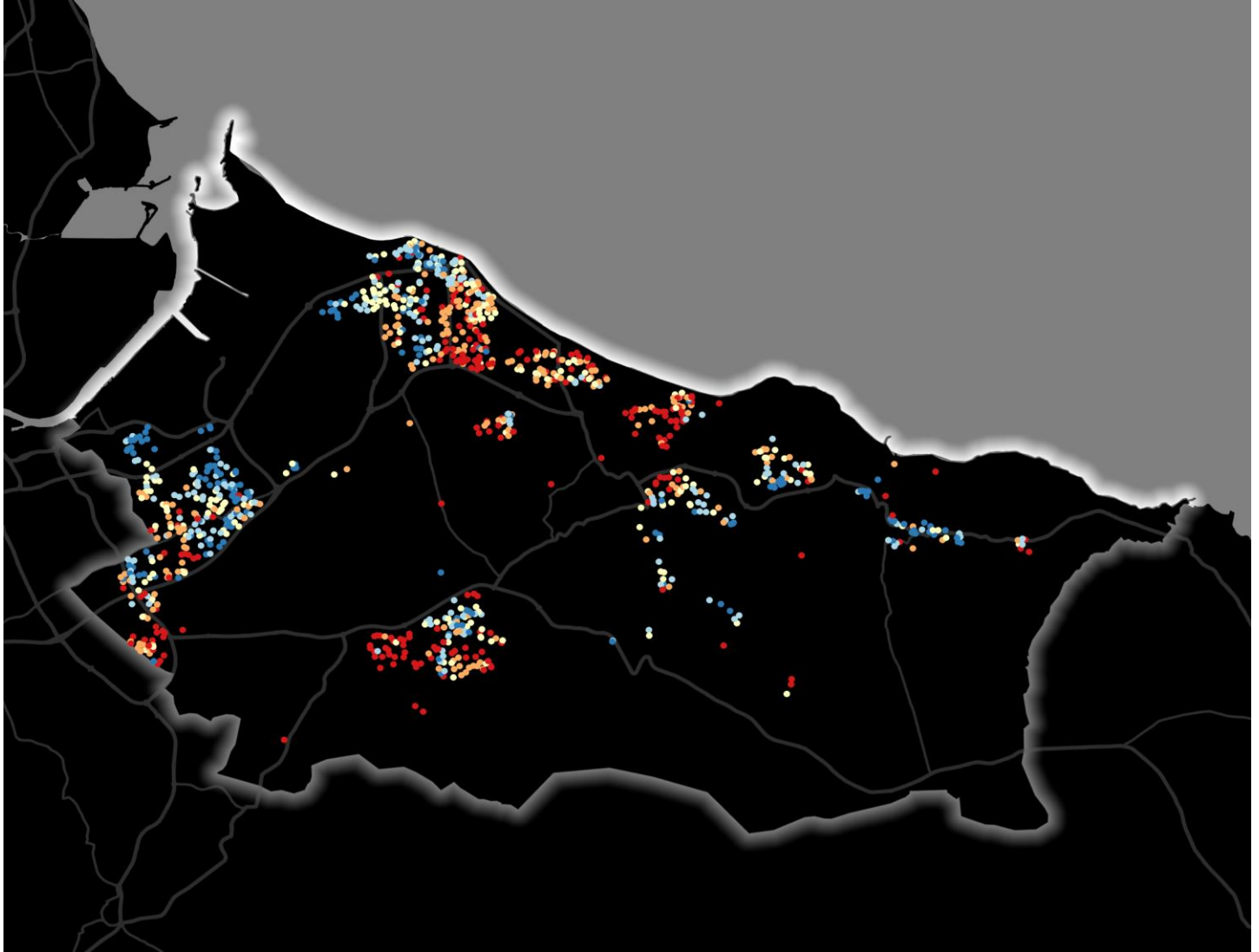
Year-To-Date Change in House Prices, December to December



Local prices have grown by 1.5% in 2023 so far, compared to growth of 10.9% over the same period in 2022.

Each point is one postcode, coloured by the average value relative to all sales in this local authority (price bands are LA-specific quintiles).

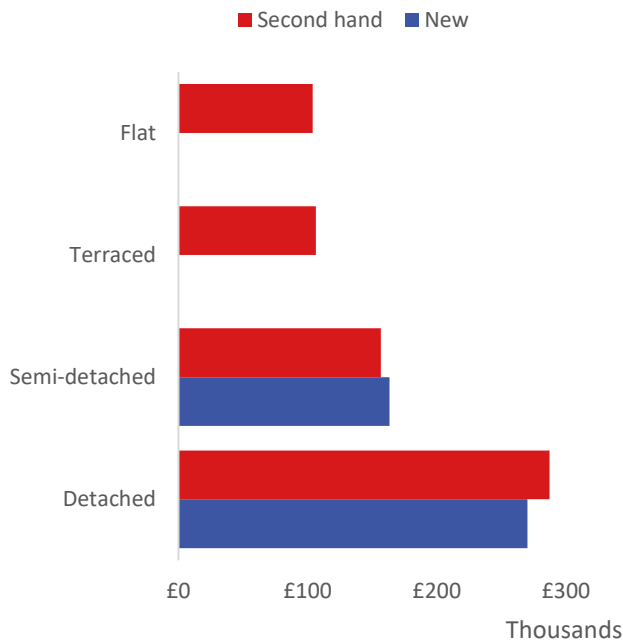

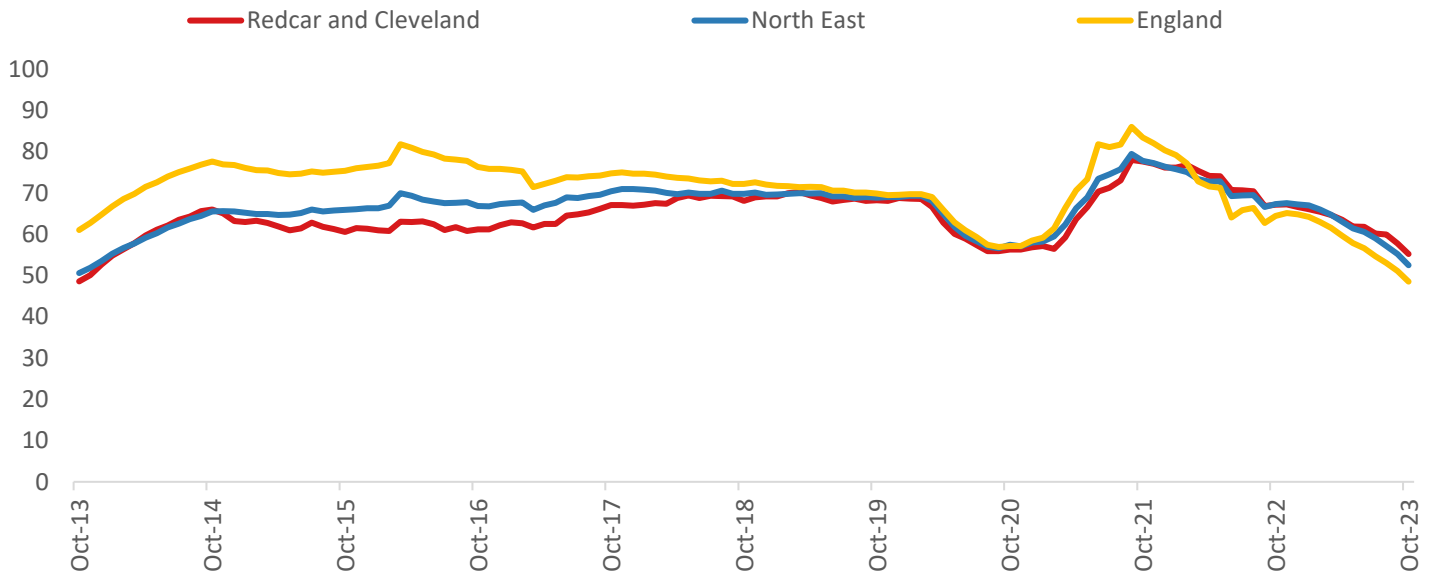

Transactions (October 2023 data)

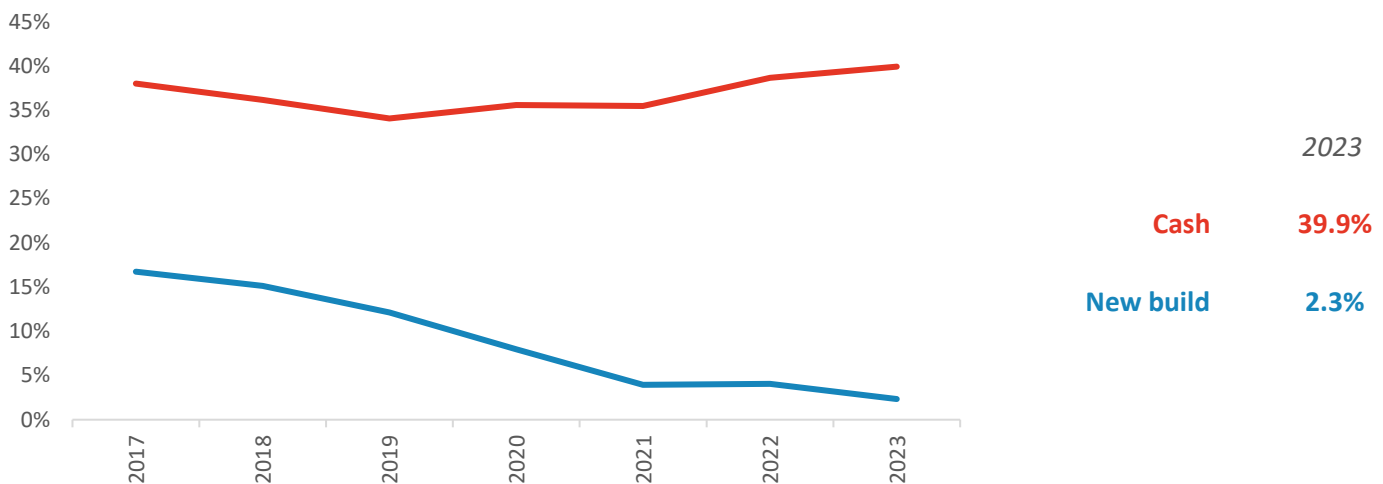
Annual Transactions, Indexed (2001-05 average = 100)



There were 1,681 transactions in Redcar and Cleveland during the 12 months to October 2023. This is 55% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Redcar and Cleveland have fallen by 12.7% since 2014, compared to changes of -19.9% for North East and -36.8% for England.

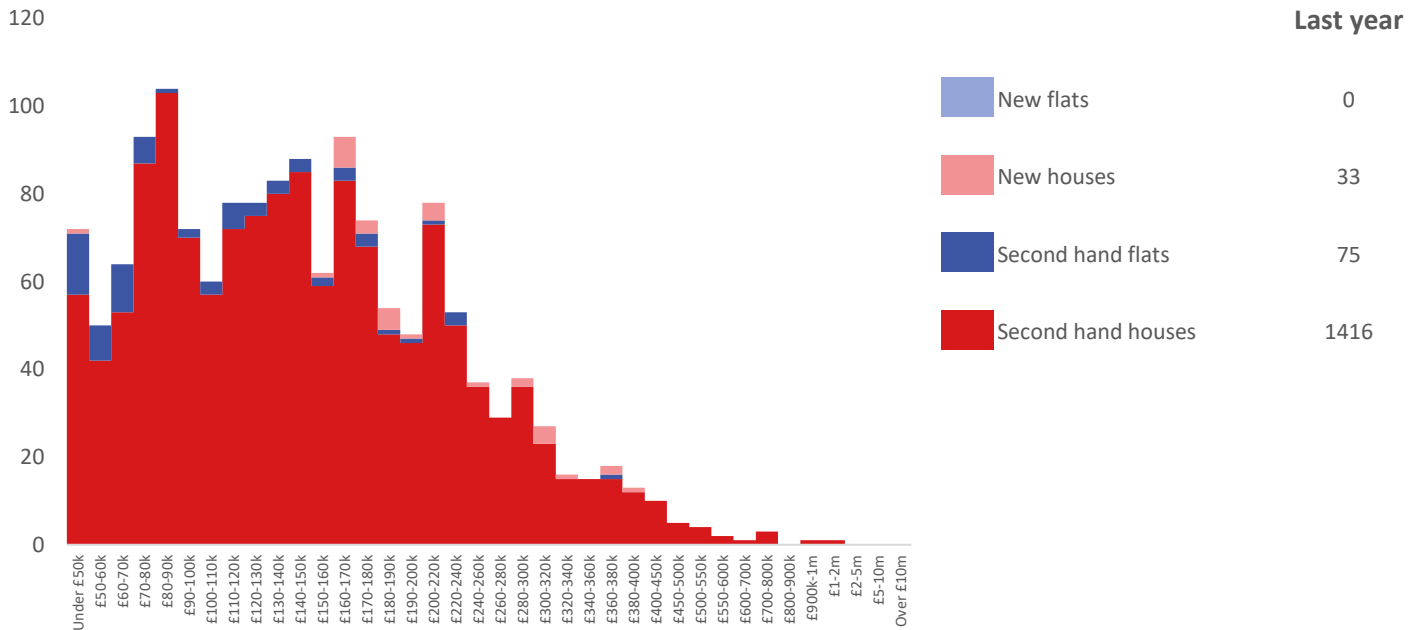
Cash and New Build Sales as % of Total, by Year

Depth of Market by Property Type

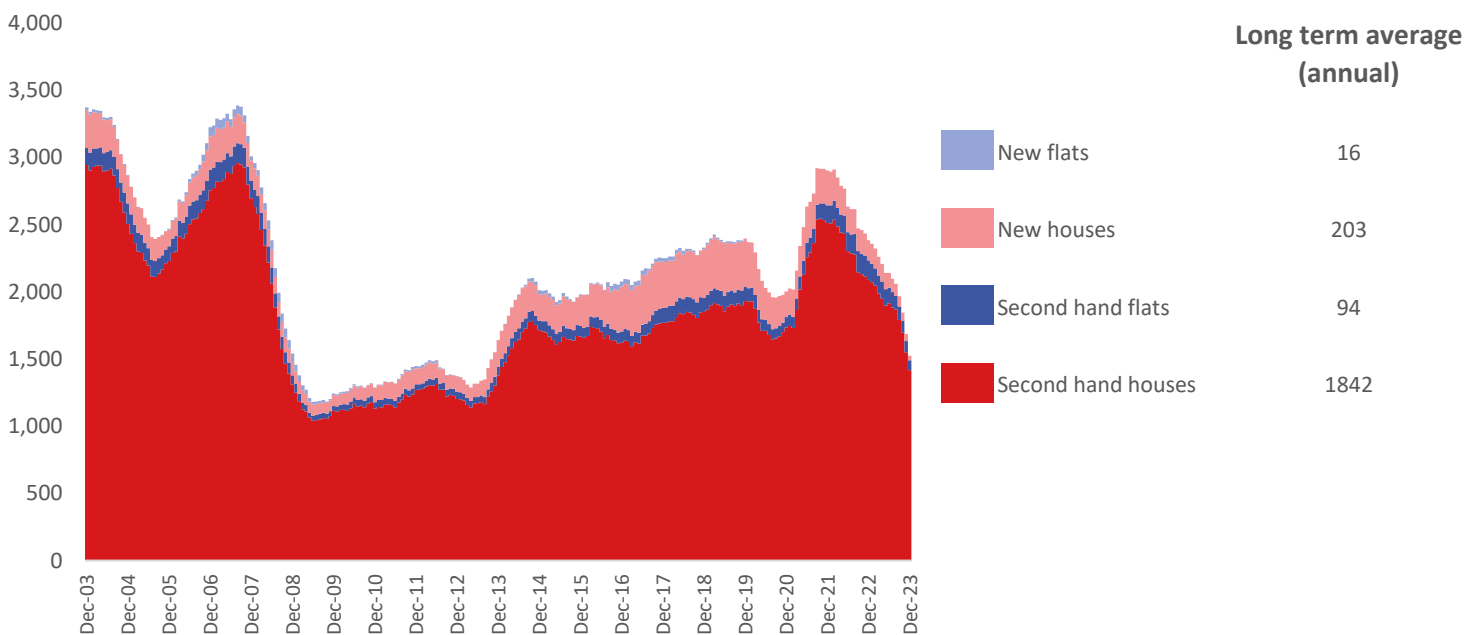
12 months to December 2023



The most common property type transacted over the past 12 months in Redcar and Cleveland was 'second hand houses' with 1,416 sales, 93% of all sales over the same period. The annual total of 1,524 transactions is equivalent to 71% of the long term average level of activity.

Timeline of Transactions by Type

Rolling 12 months, past 20 years



The most common property type transacted over the past 20 years was 'second hand houses' with the equivalent of 1,842 sales per year on average, making up 85% of the typical annual total over that period.
