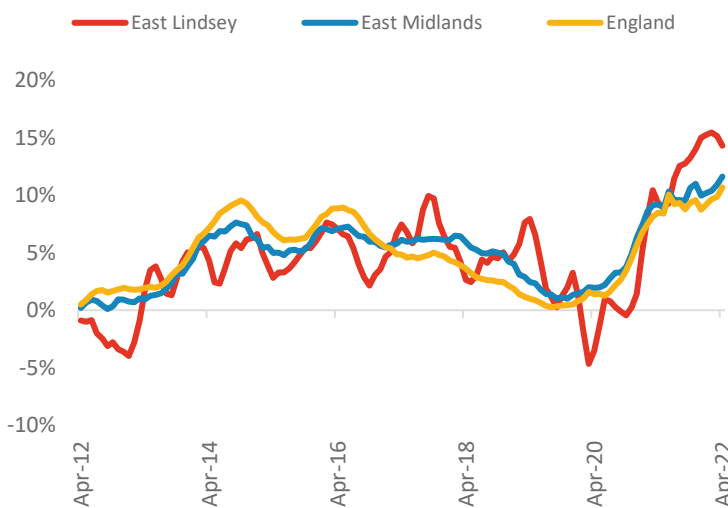

### House Prices (April 2022 data)

#### Annual Change in House Prices

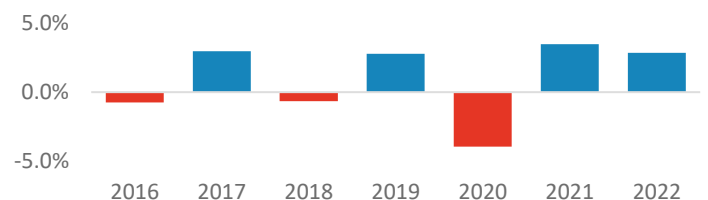


House prices in East Lindsey grew by 14.3% in the 12 months to April 2022 (based on 3-month smoothed data). By comparison national house prices grew by 10.7% and prices in the East Midlands grew by 11.6% over the same period.

East Lindsey house prices are now 37.6% above their previous peak in 2007, compared to +49.6% for the East Midlands and +52.7% across England.

Local prices have grown by 2.9% in 2022 so far, compared to growth of 3.5% over the same period last year.

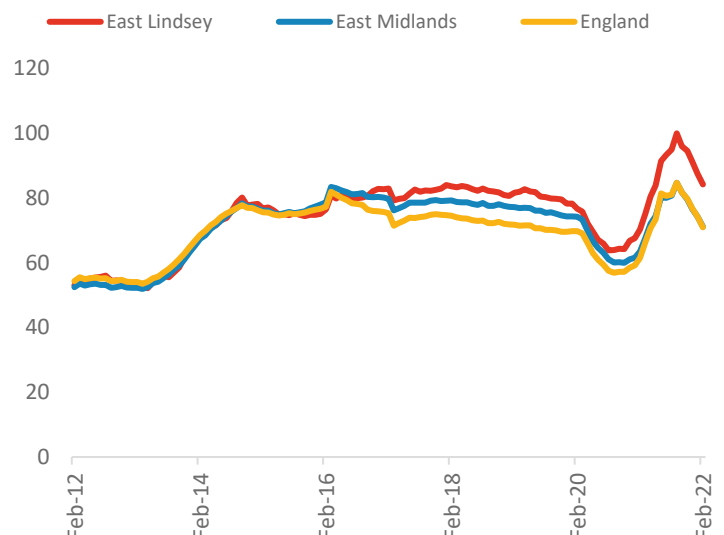
#### Year-To-Date Change in House Prices, December to April



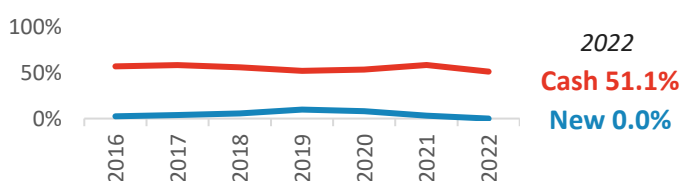
### Transactions (February 2022 data)

There were 2,728 transactions in East Lindsey during the 12 months to February 2022. This is 84% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in East Lindsey have grown by 8.0% since 2014, compared to changes of -8.0% for the East Midlands and -7.7% for England.
