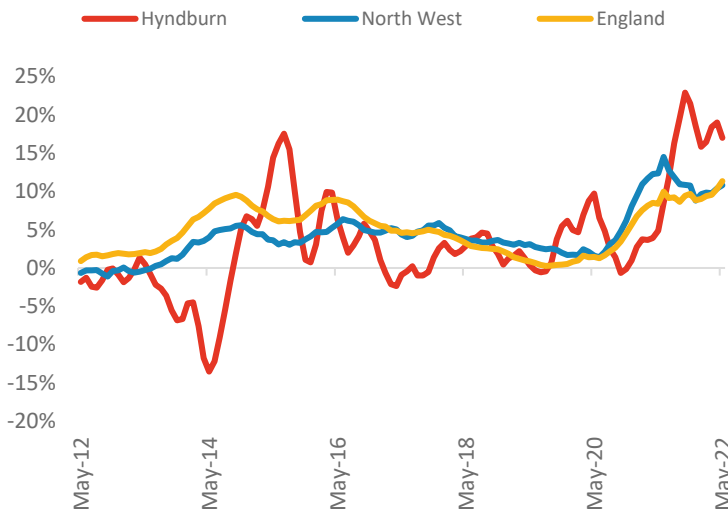

House Prices (May 2022 data)

Annual Change in House Prices



House prices in Hyndburn grew by 17.0% in the 12 months to May 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in the North West grew by 10.8% over the same period.

Hyndburn house prices are now 13.7% above their previous peak in 2007, compared to +35.5% for the North West and +53.6% across England.

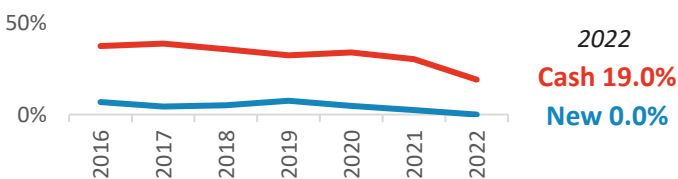
Local prices have grown by 3.4% in 2022 so far, compared to growth of 4.8% over the same period last year.

Transactions (March 2022 data)

There were 1,190 transactions in Hyndburn during the 12 months to March 2022. This is 51% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hyndburn have grown by 1.6% since 2014, compared to changes of -1.4% for the North West and -13.6% for England.

Cash and New Build Sales as % of Total, by Year*

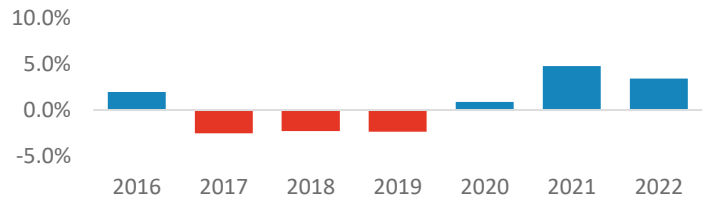
