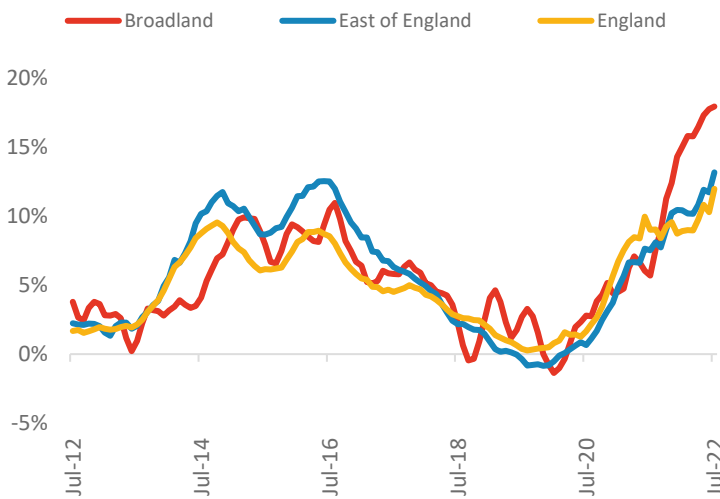

Annual Change in House Prices

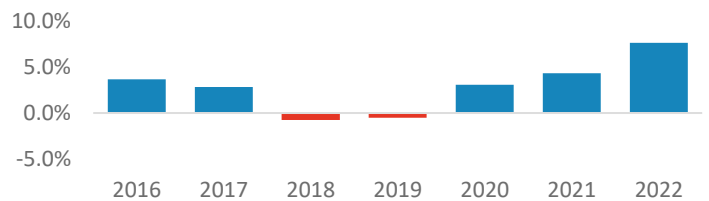


House prices in Broadland grew by 18.0% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the East of England grew by 13.2% over the same period.

Broadland house prices are now 64.6% above their previous peak in 2007, compared to +69.4% for the East of England and +57.1% across England.

Local prices have grown by 7.7% in 2022 so far, compared to growth of 4.3% over the same period last year.

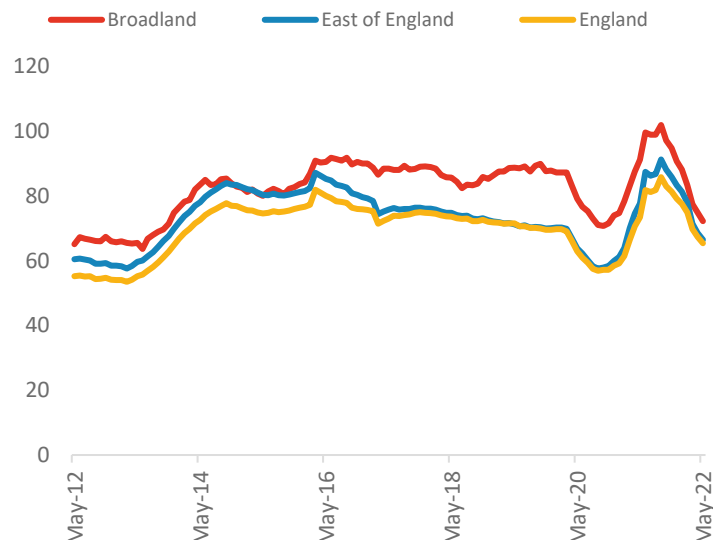
Year-To-Date Change in House Prices, December to July



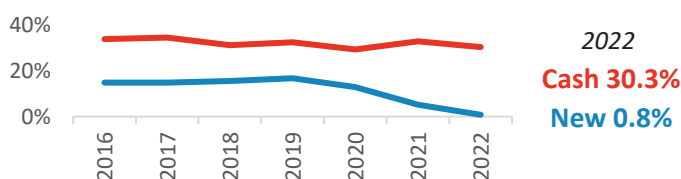
Transactions (May 2022 data)

There were 1,996 transactions in Broadland during the 12 months to May 2022. This is 72% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in Broadland have fallen by 12.8% since 2014, compared to changes of -20.3% for the East of England and -14.9% for England.
