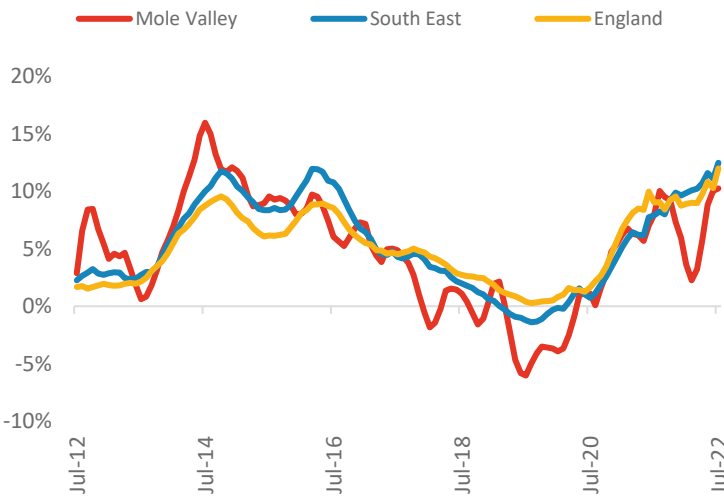

### House Prices (July 2022 data)

#### Annual Change in House Prices

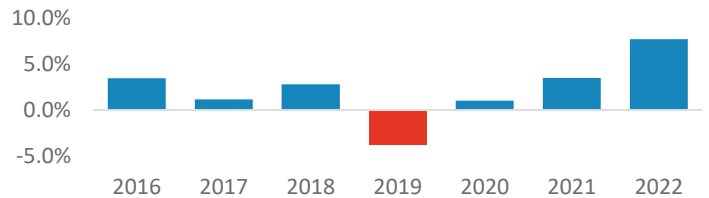


House prices in Mole Valley grew by 10.3% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the South East grew by 12.5% over the same period.

Mole Valley house prices are now 60.0% above their previous peak in 2007, compared to +64.3% for the South East and +57.1% across England.

Local prices have grown by 7.7% in 2022 so far, compared to growth of 3.5% over the same period last year.

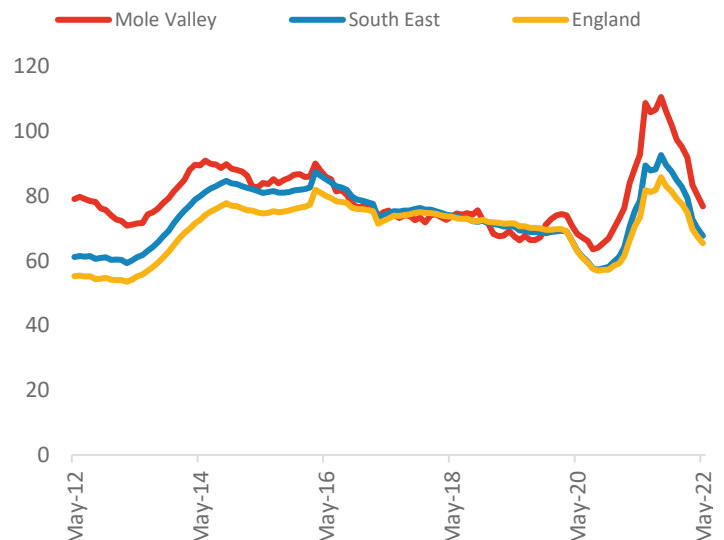
#### Year-To-Date Change in House Prices, December to July



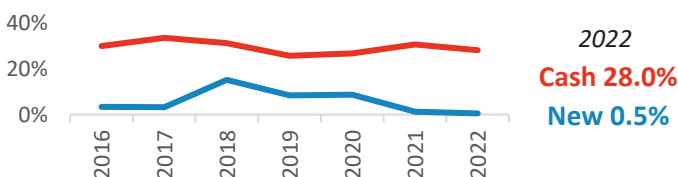
### Transactions (May 2022 data)

There were 1,313 transactions in Mole Valley during the 12 months to May 2022. This is 77% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in Mole Valley have fallen by 12.9% since 2014, compared to changes of -19.1% for the South East and -14.9% for England.
