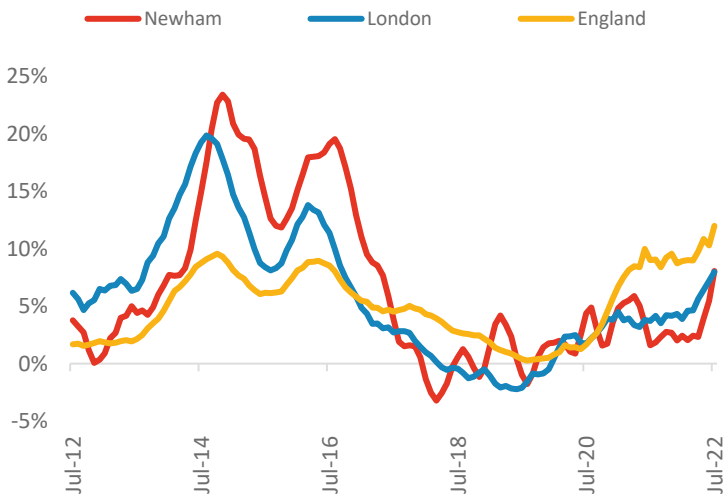

### House Prices (July 2022 data)

#### Annual Change in House Prices



House prices in Newham grew by 8.1% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in London grew by 8.0% over the same period.

Newham house prices are now 76.0% above their previous peak in 2007, compared to +79.9% for London and +57.1% across England.

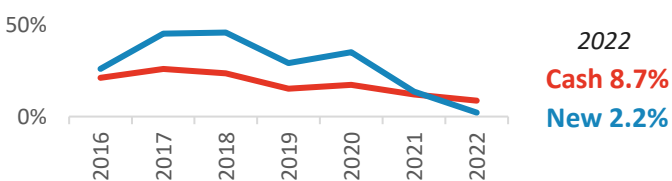
Local prices have grown by 7.8% in 2022 so far, compared to growth of 1.8% over the same period last year.

### Transactions (May 2022 data)

There were 1,815 transactions in Newham during the 12 months to May 2022. This is 36% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Newham have fallen by 40.4% since 2014, compared to changes of -28.5% for London and -14.9% for England.

#### Cash and New Build Sales as % of Total, by Year\*

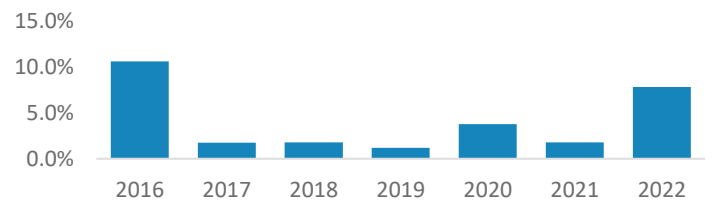
