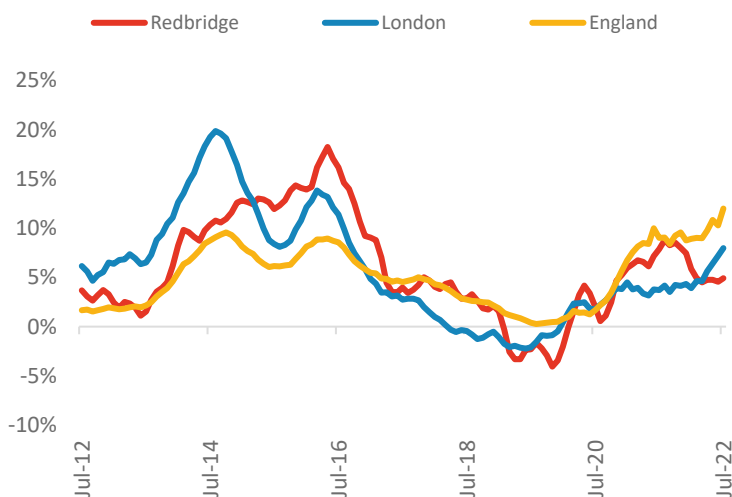

House Prices (July 2022 data)

Annual Change in House Prices



House prices in Redbridge grew by 4.9% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in London grew by 8.0% over the same period.

Redbridge house prices are now 70.3% above their previous peak in 2007, compared to +79.9% for London and +57.1% across England.

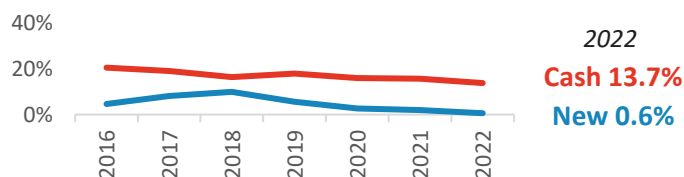
Local prices have grown by 0.8% in 2022 so far, compared to growth of 3.2% over the same period last year.

Transactions (May 2022 data)

There were 2,501 transactions in Redbridge during the 12 months to May 2022. This is 44% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Redbridge have fallen by 32.3% since 2014, compared to changes of -28.5% for London and -14.9% for England.

Cash and New Build Sales as % of Total, by Year*

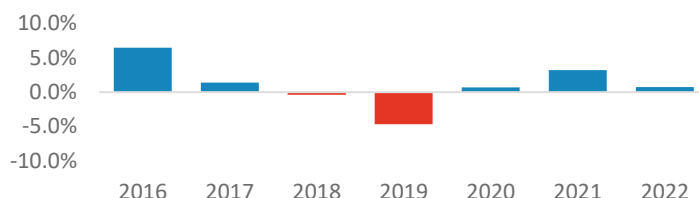
