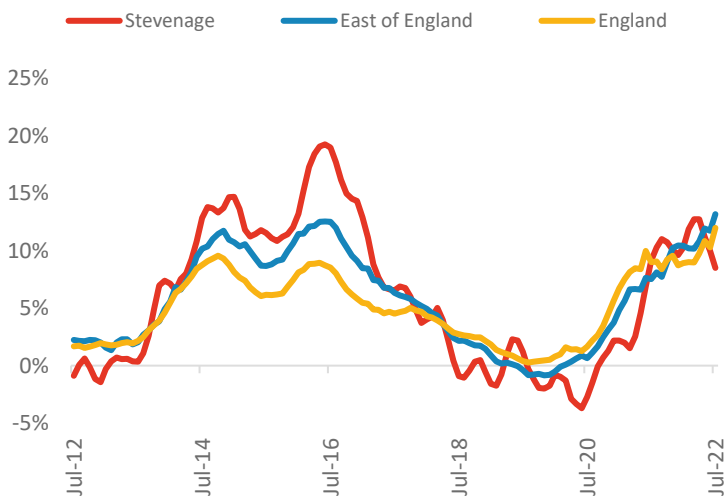

### House Prices (July 2022 data)

#### Annual Change in House Prices



House prices in Stevenage grew by 8.5% in the 12 months to July 2022 (based on 3-month smoothed data). By comparison national house prices grew by 12.0% and prices in the East of England grew by 13.2% over the same period.

Stevenage house prices are now 72.3% above their previous peak in 2007, compared to +69.4% for the East of England and +57.1% across England.

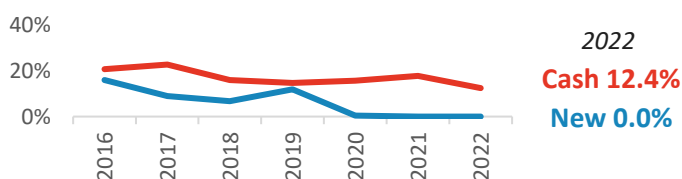
Local prices have grown by 4.8% in 2022 so far, compared to growth of 5.9% over the same period last year.

### Transactions (May 2022 data)

There were 1,031 transactions in Stevenage during the 12 months to May 2022. This is 60% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Stevenage have fallen by 21.8% since 2014, compared to changes of -20.3% for the East of England and -14.9% for England.

#### Cash and New Build Sales as % of Total, by Year\*

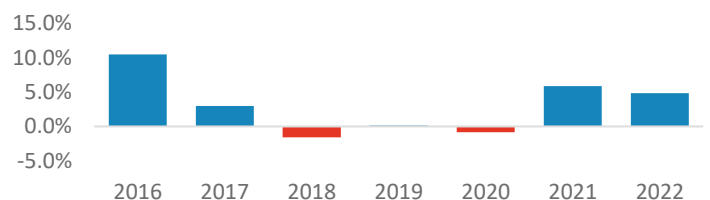
