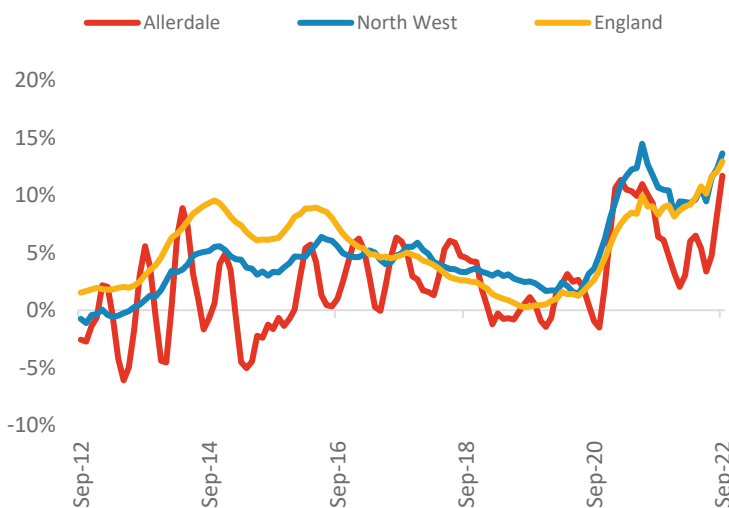

House Prices (September 2022 data)

Annual Change in House Prices



House prices in Allerdale grew by 11.7% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the North West grew by 13.7% over the same period.

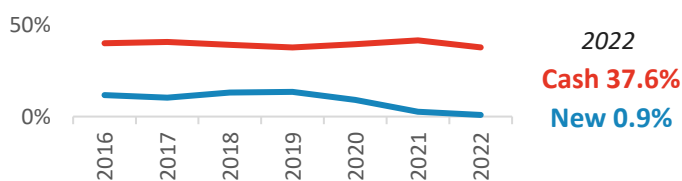
Allerdale house prices are now 21.0% above their previous peak in 2007, compared to +43.6% for the North West and +60.8% across England.

Local prices have grown by 11.3% in 2022 so far, compared to growth of 2.9% over the same period last year.

Transactions (July 2022 data)

There were 1,418 transactions in Allerdale during the 12 months to July 2022. This is 72% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in Allerdale have fallen by 6.3% since 2014, compared to changes of -7.5% for the North West and -21.9% for England.

Cash and New Build Sales as % of Total, by Year*

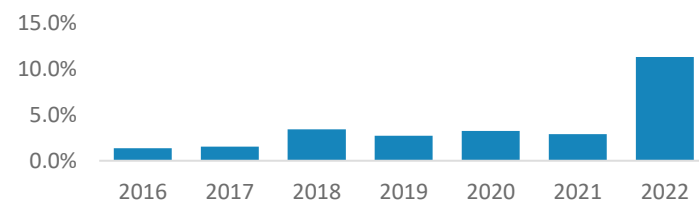
