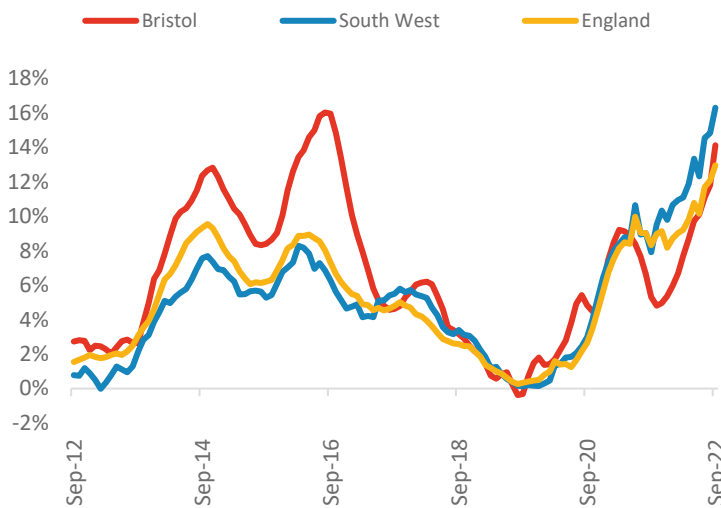

### House Prices (September 2022 data)

#### Annual Change in House Prices

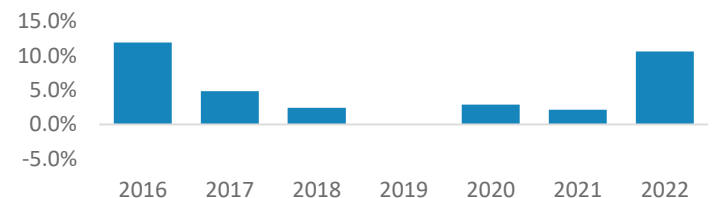


House prices in Bristol grew by 14.1% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the South West grew by 16.3% over the same period.

Bristol house prices are now 82.2% above their previous peak in 2007, compared to +57.6% for the South West and +60.8% across England.

Local prices have grown by 10.7% in 2022 so far, compared to growth of 2.2% over the same period last year.

#### Year-To-Date Change in House Prices, December to September

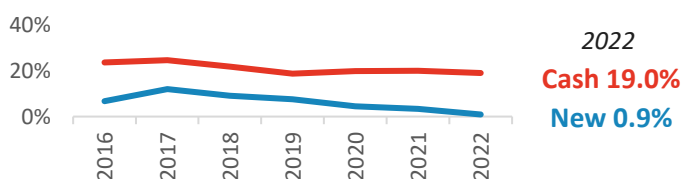


### Transactions (July 2022 data)

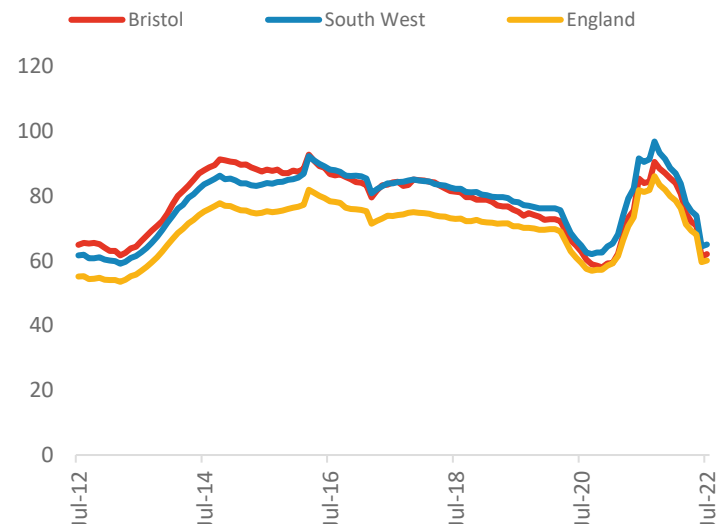
There were 5,724 transactions in Bristol during the 12 months to July 2022. This is 62% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Bristol have fallen by 31.6% since 2014, compared to changes of -23.8% for the South West and -21.9% for England.
