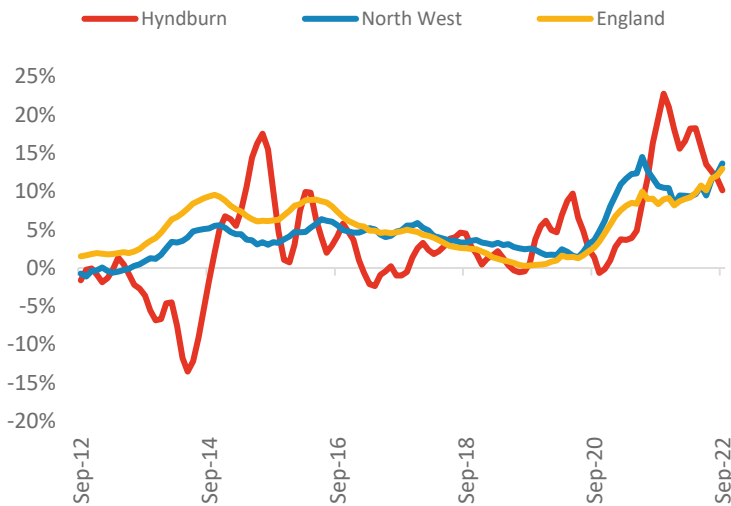

Annual Change in House Prices

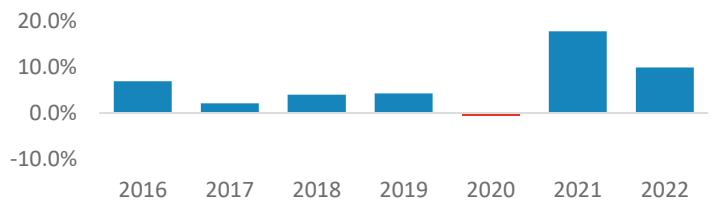


House prices in Hyndburn grew by 10.1% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the North West grew by 13.7% over the same period.

Hyndburn house prices are now 20.4% above their previous peak in 2007, compared to +43.6% for the North West and +60.8% across England.

Local prices have grown by 9.9% in 2022 so far, compared to growth of 17.9% over the same period last year.

Year-To-Date Change in House Prices, December to September

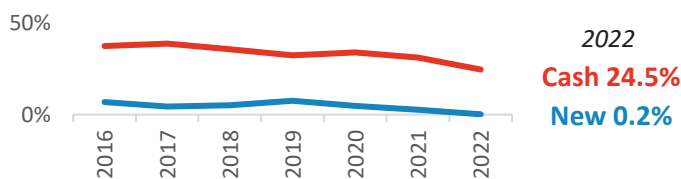


Transactions (July 2022 data)

There were 1,161 transactions in Hyndburn during the 12 months to July 2022. This is 49% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hyndburn have fallen by 0.9% since 2014, compared to changes of -7.5% for the North West and -21.9% for England.
