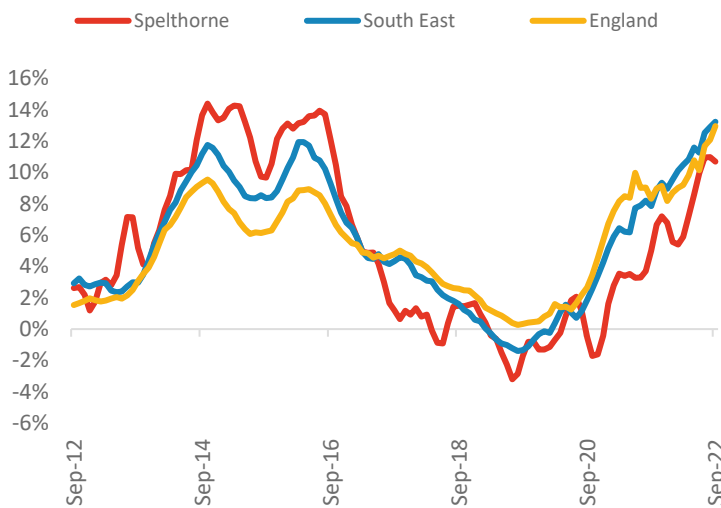

Annual Change in House Prices

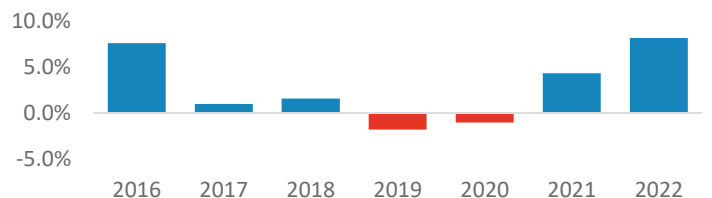


House prices in Spelthorne grew by 10.7% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the South East grew by 13.2% over the same period.

Spelthorne house prices are now 60.9% above their previous peak in 2007, compared to +68.4% for the South East and +60.8% across England.

Local prices have grown by 8.2% in 2022 so far, compared to growth of 4.4% over the same period last year.

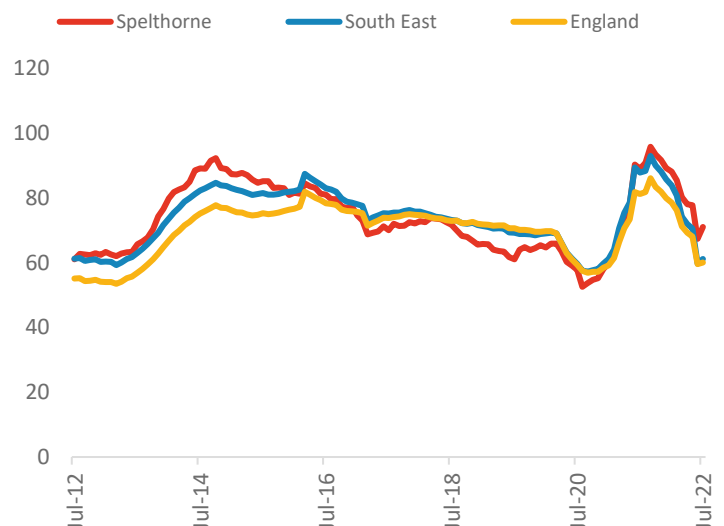
Year-To-Date Change in House Prices, December to September



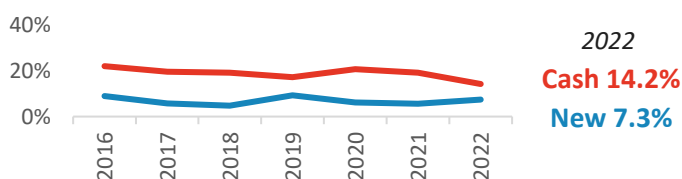
Transactions (July 2022 data)

There were 1,504 transactions in Spelthorne during the 12 months to July 2022. This is 71% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in Spelthorne have fallen by 20.1% since 2014, compared to changes of -26.9% for the South East and -21.9% for England.
