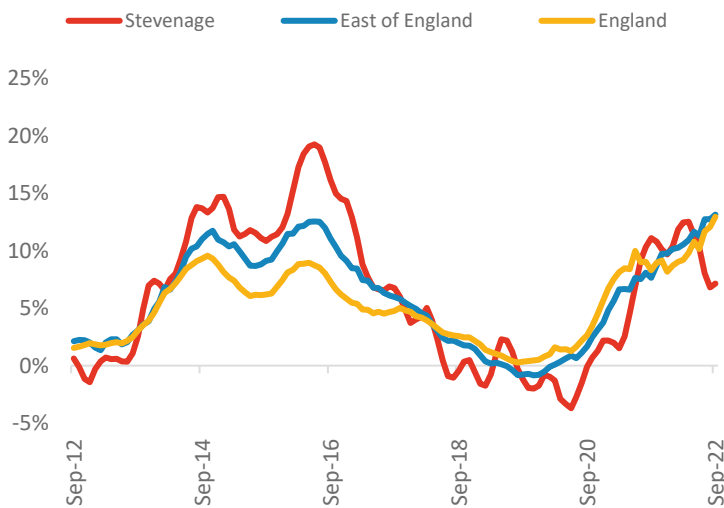

House Prices (September 2022 data)

Annual Change in House Prices



House prices in Stevenage grew by 7.2% in the 12 months to September 2022 (based on 3-month smoothed data). By comparison national house prices grew by 13.0% and prices in the East of England grew by 13.2% over the same period.

Stevenage house prices are now 75.7% above their previous peak in 2007, compared to +72.3% for the East of England and +60.8% across England.

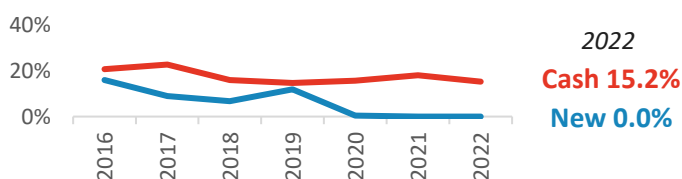
Local prices have grown by 6.8% in 2022 so far, compared to growth of 9.3% over the same period last year.

Transactions (July 2022 data)

There were 941 transactions in Stevenage during the 12 months to July 2022. This is 54% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Stevenage have fallen by 28.7% since 2014, compared to changes of -27.9% for the East of England and -21.9% for England.

Cash and New Build Sales as % of Total, by Year*

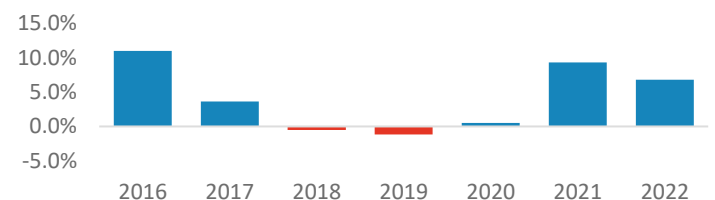
