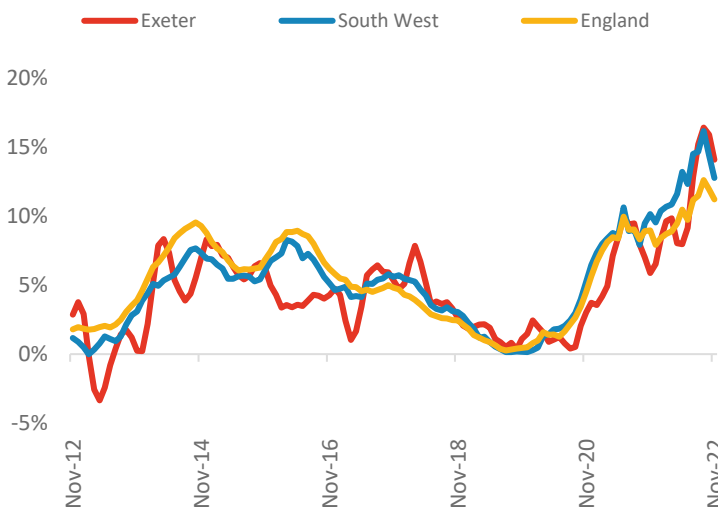

### House Prices (November 2022 data)

#### Annual Change in House Prices

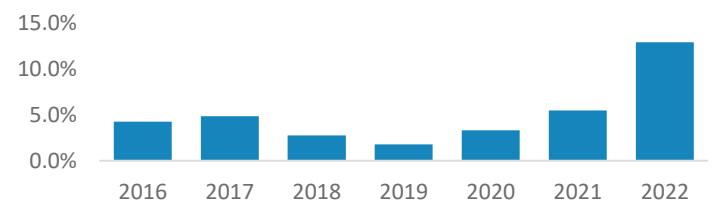


House prices in Exeter grew by 14.1% in the 12 months to November 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.2% and prices in the South West grew by 12.8% over the same period.

Exeter house prices are now 58.5% above their previous peak in 2007, compared to +59.2% for the South West and +61.9% across England.

Local prices have grown by 13.0% in 2022 so far, compared to growth of 5.5% over the same period last year.

#### Year-To-Date Change in House Prices, December to November

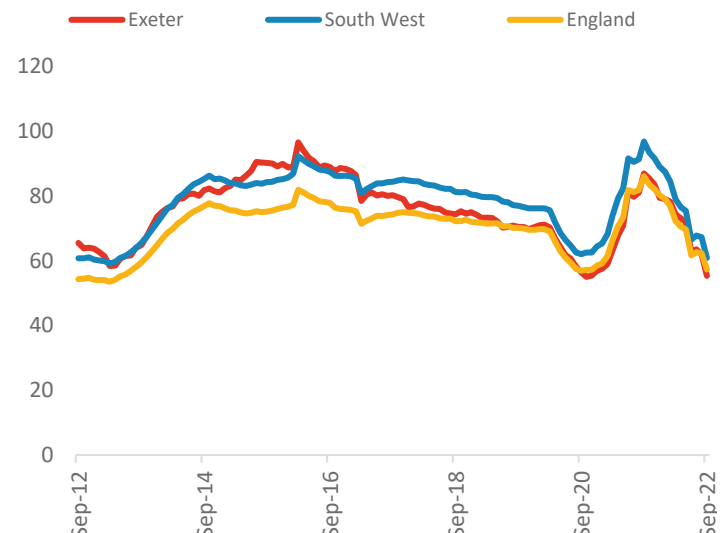


### Transactions (September 2022 data)

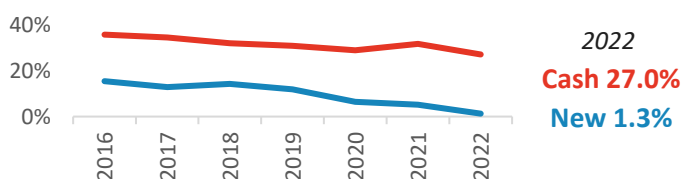
There were 1,511 transactions in Exeter during the 12 months to September 2022. This is 55% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Exeter have fallen by 31.8% since 2014, compared to changes of -28.7% for the South West and -25.4% for England.
