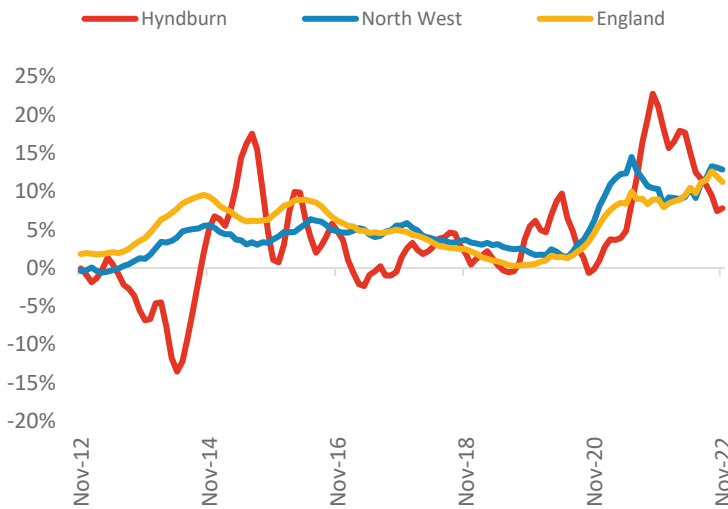

House Prices (November 2022 data)

Annual Change in House Prices



House prices in Hyndburn grew by 7.8% in the 12 months to November 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.2% and prices in the North West grew by 12.9% over the same period.

Hyndburn house prices are now 19.9% above their previous peak in 2007, compared to +45.4% for the North West and +61.9% across England.

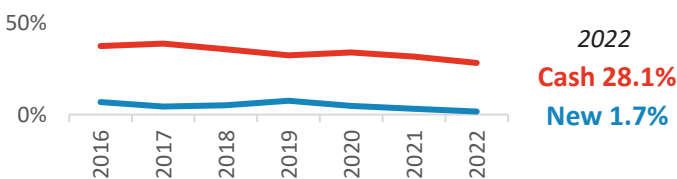
Local prices have grown by 9.5% in 2022 so far, compared to growth of 19.9% over the same period last year.

Transactions (September 2022 data)

There were 1,163 transactions in Hyndburn during the 12 months to September 2022. This is 49% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hyndburn have fallen by 0.7% since 2014, compared to changes of -11.9% for the North West and -25.4% for England.

Cash and New Build Sales as % of Total, by Year*

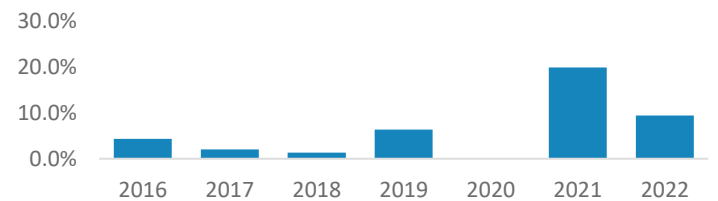
