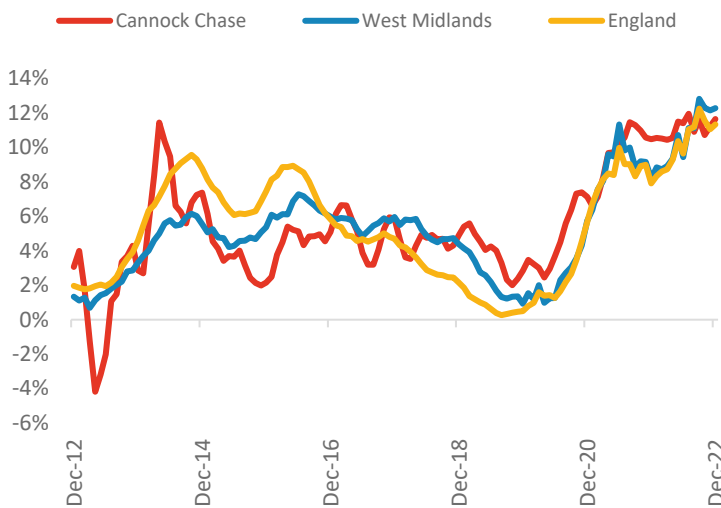

### House Prices (December 2022 data)

#### Annual Change in House Prices

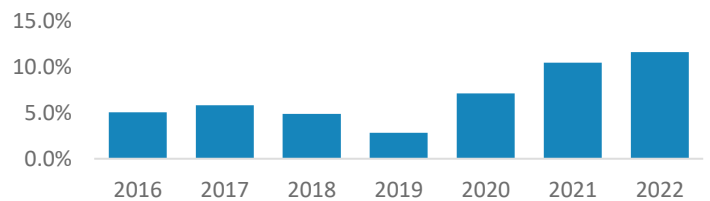


House prices in Cannock Chase grew by 11.6% in the 12 months to December 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in the West Midlands grew by 12.3% over the same period.

Cannock Chase house prices are now 55.0% above their previous peak in 2007, compared to +54.9% for the West Midlands and +61.9% across England.

Local prices have grown by 11.6% in 2022 so far, compared to growth of 10.5% over the same period last year.

#### Year-To-Date Change in House Prices, December to December

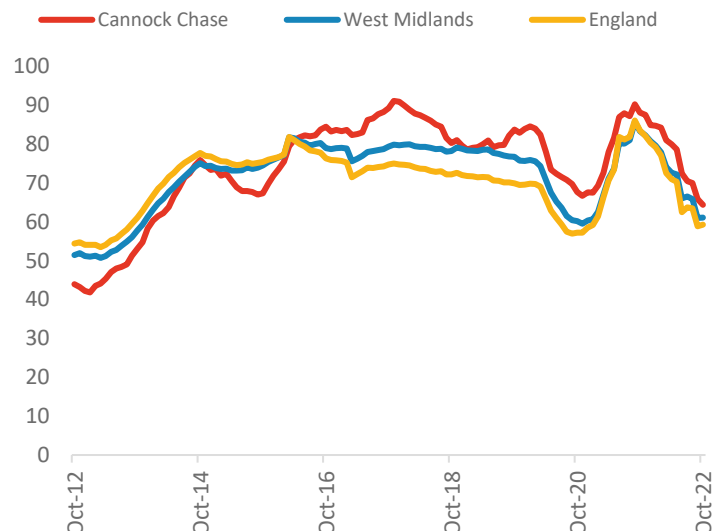


### Transactions (October 2022 data)

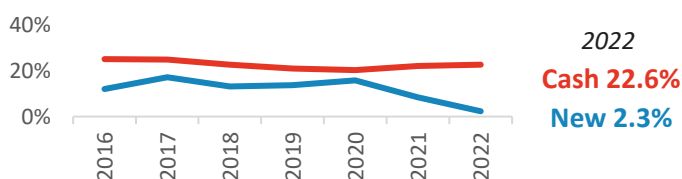
There were 1,323 transactions in Cannock Chase during the 12 months to October 2022. This is 64% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Cannock Chase have fallen by 12.3% since 2014, compared to changes of -17.9% for the West Midlands and -22.8% for England.
