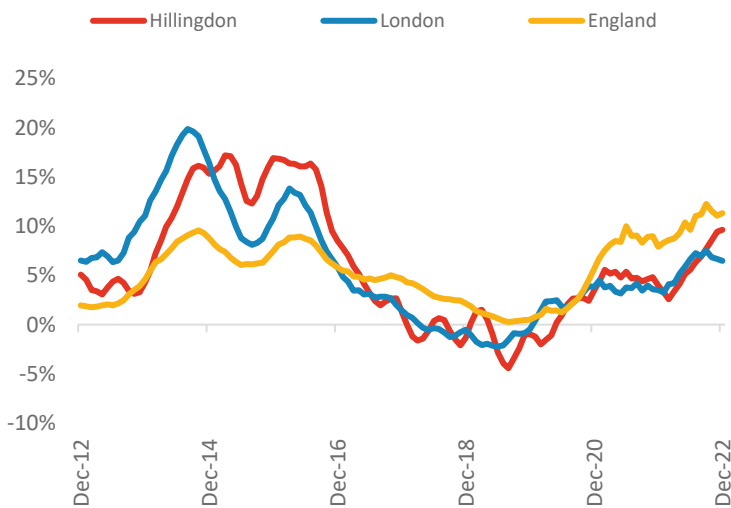

Annual Change in House Prices

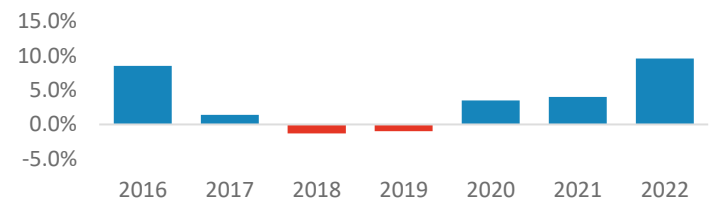


House prices in Hillingdon grew by 9.6% in the 12 months to December 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in London grew by 6.5% over the same period.

Hillingdon house prices are now 79.8% above their previous peak in 2007, compared to +81.8% for London and +61.9% across England.

Local prices have grown by 9.6% in 2022 so far, compared to growth of 4.0% over the same period last year.

Year-To-Date Change in House Prices, December to December

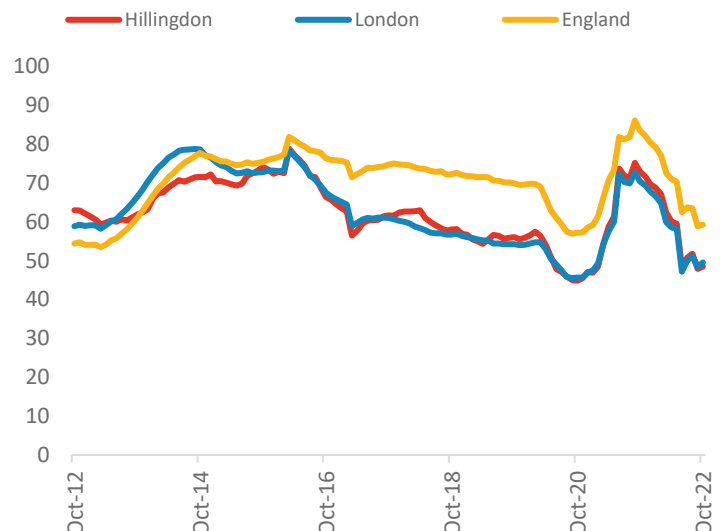


Transactions (October 2022 data)

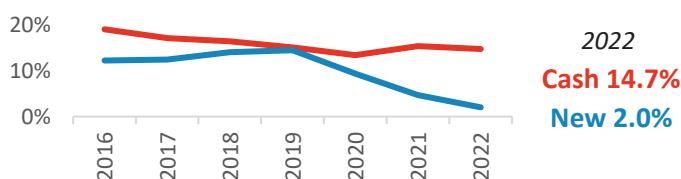
There were 2,571 transactions in Hillingdon during the 12 months to October 2022. This is 48% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Hillingdon have fallen by 32.9% since 2014, compared to changes of -35.3% for London and -22.8% for England.
