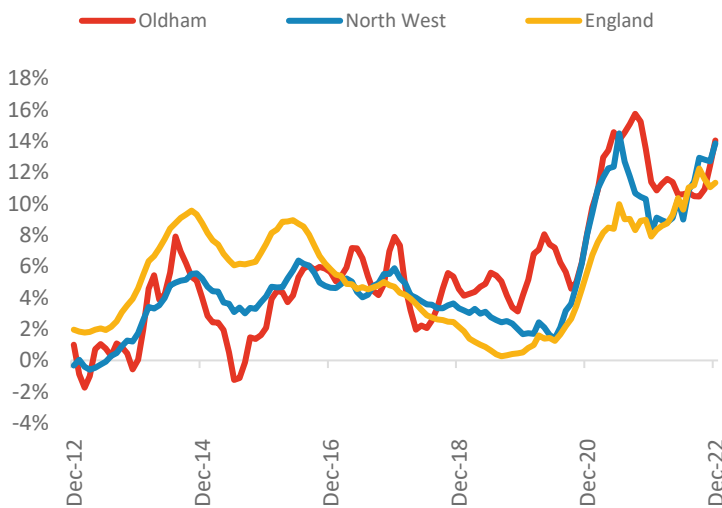

#### Annual Change in House Prices

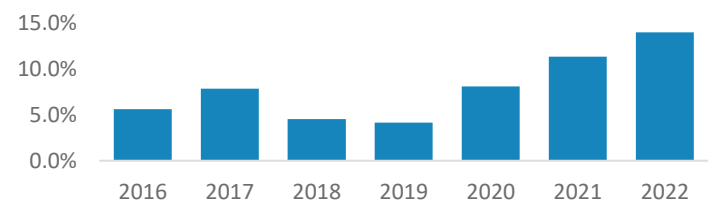


House prices in Oldham grew by 14.0% in the 12 months to December 2022 (based on 3-month smoothed data). By comparison national house prices grew by 11.3% and prices in the North West grew by 13.9% over the same period.

Oldham house prices are now 50.6% above their previous peak in 2007, compared to +45.8% for the North West and +61.9% across England.

Local prices have grown by 14.0% in 2022 so far, compared to growth of 11.4% over the same period last year.

#### Year-To-Date Change in House Prices, December to December

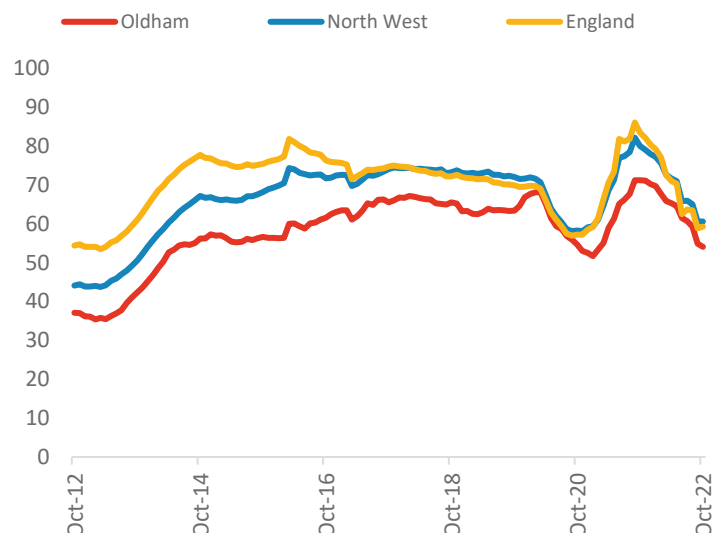


### Transactions (October 2022 data)

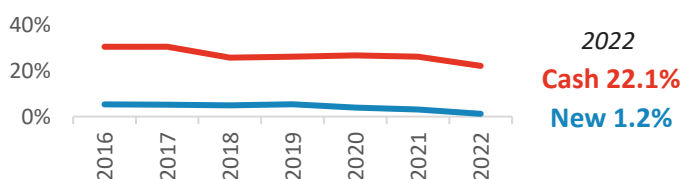
There were 2,491 transactions in Oldham during the 12 months to October 2022. This is 54% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Oldham have fallen by 5.6% since 2014, compared to changes of -9.5% for the North West and -22.8% for England.
