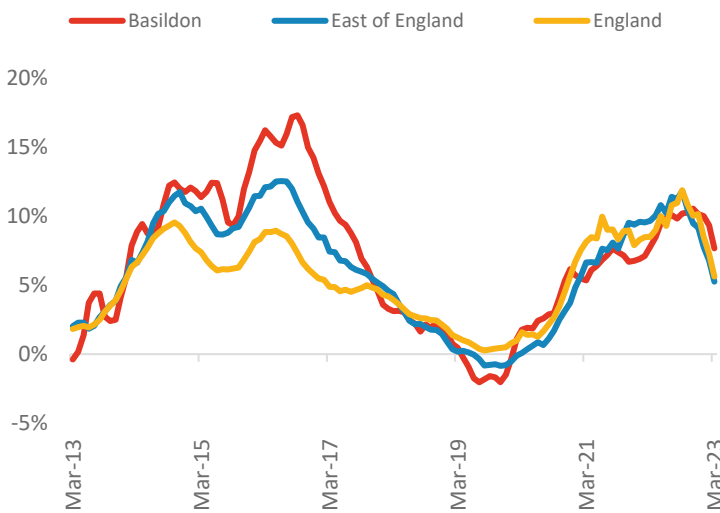

Annual Change in House Prices

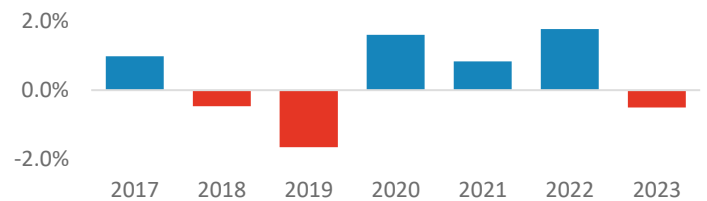


House prices in Basildon grew by 7.7% in the 12 months to March 2023 (based on 3-month smoothed data). By comparison national house prices grew by 5.6% and prices in the East of England grew by 5.3% over the same period.

Basildon house prices are now 83.2% above their previous peak in 2007, compared to +69.8% for the East of England and +57.9% across England.

Local prices have fallen by 0.5% in 2023 so far, compared to growth of 1.8% over the same period last year.

Year-To-Date Change in House Prices, December to March

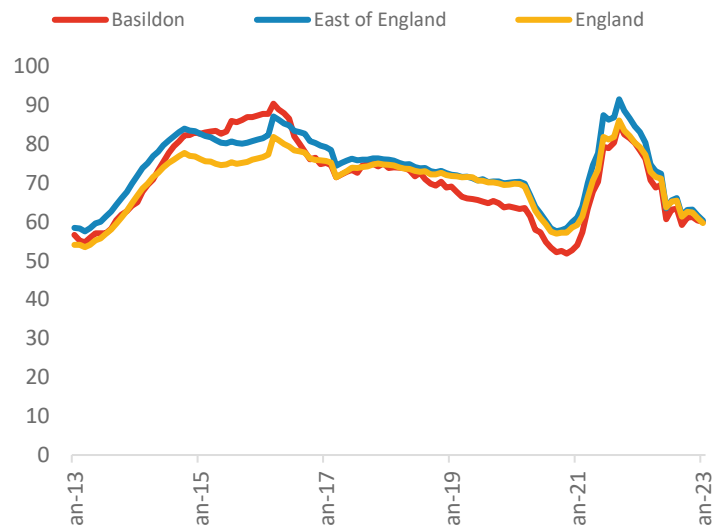


Transactions (January 2023 data)

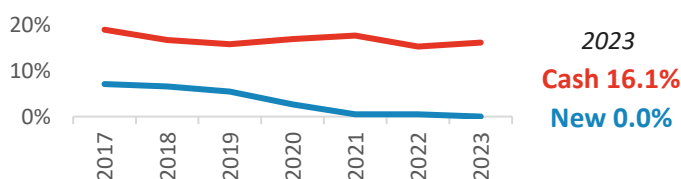
There were 2,374 transactions in Basildon during the 12 months to January 2023. This is 60% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Basildon have fallen by 27.7% since 2014, compared to changes of -27.7% for the East of England and -22.4% for England.
