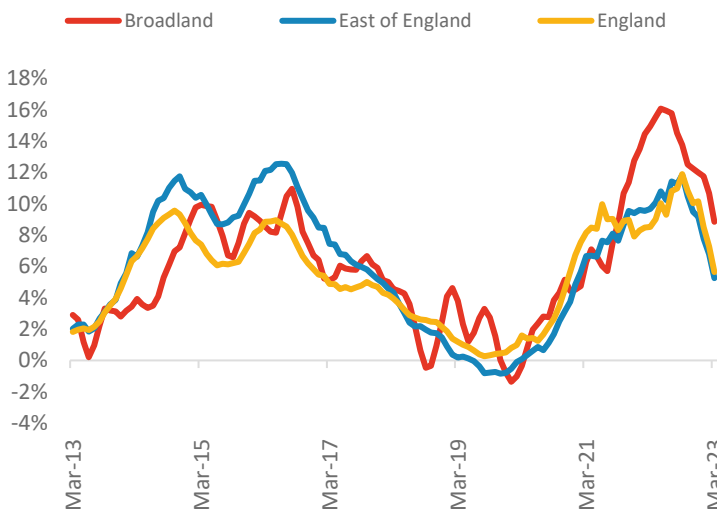

Annual Change in House Prices

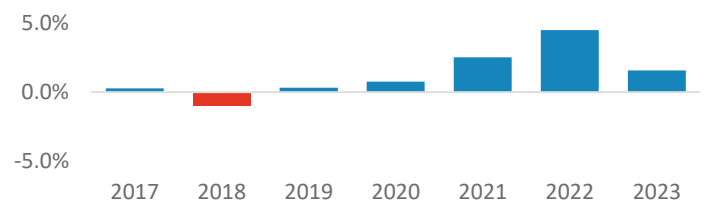


House prices in Broadland grew by 8.8% in the 12 months to March 2023 (based on 3-month smoothed data). By comparison national house prices grew by 5.6% and prices in the East of England grew by 5.3% over the same period.

Broadland house prices are now 71.6% above their previous peak in 2007, compared to +69.8% for the East of England and +57.9% across England.

Local prices have grown by 1.6% in 2023 so far, compared to growth of 4.5% over the same period last year.

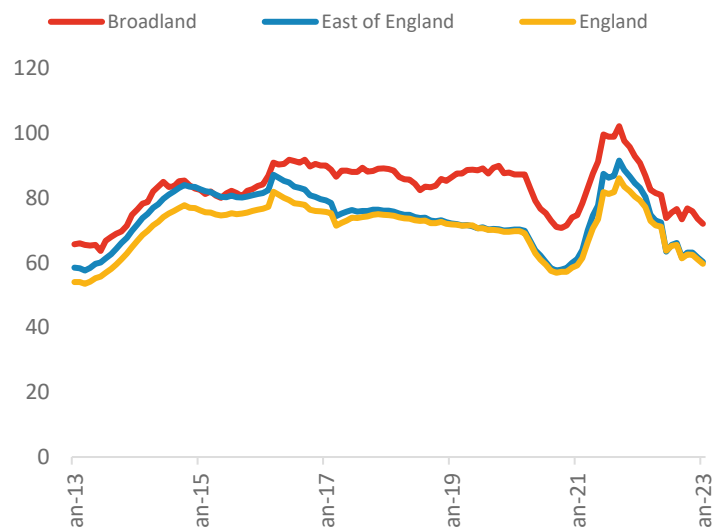
Year-To-Date Change in House Prices, December to March



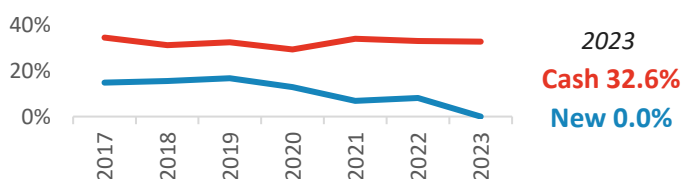
Transactions (January 2023 data)

There were 1,990 transactions in Broadland during the 12 months to January 2023. This is 72% of the average from 2001-05 and suggests activity is below pre-downturn levels. Transactions in Broadland have fallen by 13.1% since 2014, compared to changes of -27.7% for the East of England and -22.4% for England.
