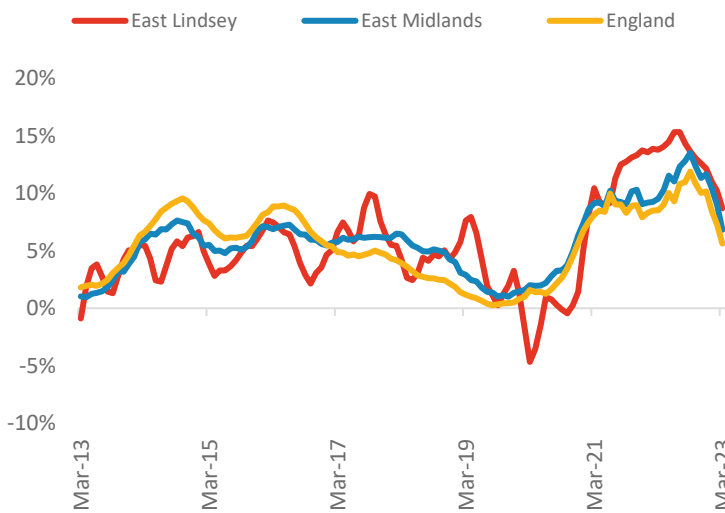

Annual Change in House Prices

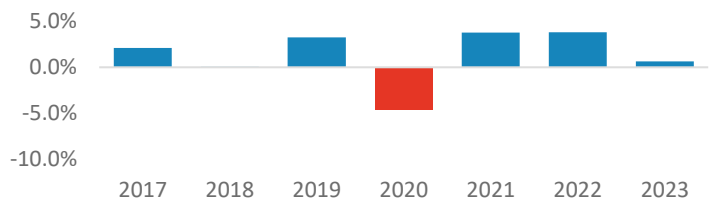


House prices in East Lindsey grew by 8.7% in the 12 months to March 2023 (based on 3-month smoothed data). By comparison national house prices grew by 5.6% and prices in the East Midlands grew by 6.8% over the same period.

East Lindsey house prices are now 49.3% above their previous peak in 2007, compared to +56.6% for the East Midlands and +57.9% across England.

Local prices have grown by 0.6% in 2023 so far, compared to growth of 3.8% over the same period last year.

Year-To-Date Change in House Prices, December to March

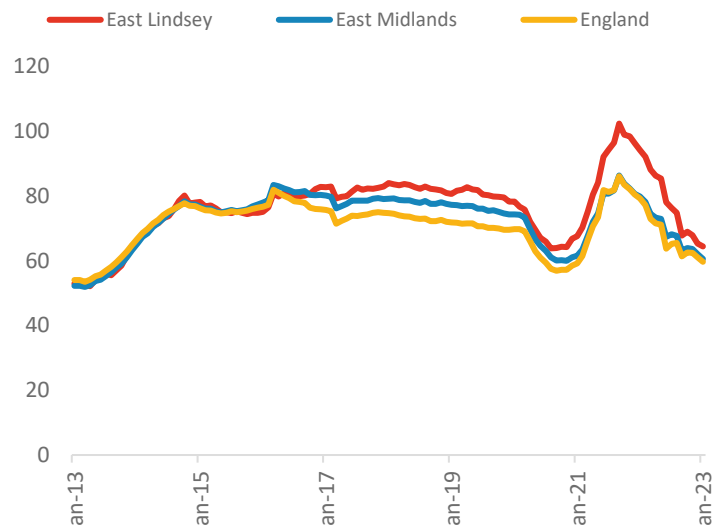


Transactions (January 2023 data)

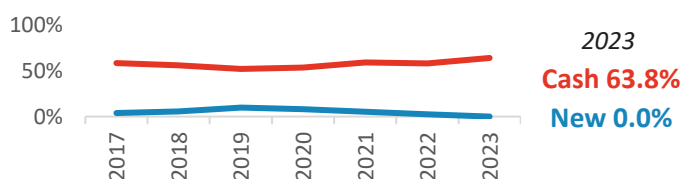
There were 2,088 transactions in East Lindsey during the 12 months to January 2023. This is 64% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in East Lindsey have fallen by 17.3% since 2014, compared to changes of -21.7% for the East Midlands and -22.4% for England.
