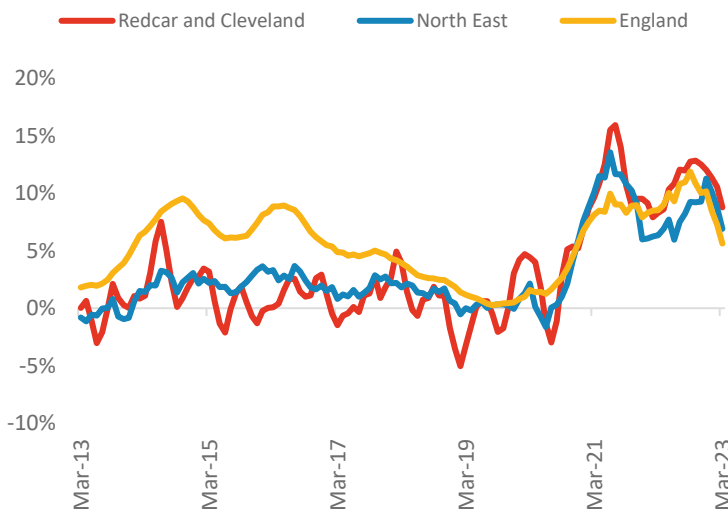

Annual Change in House Prices

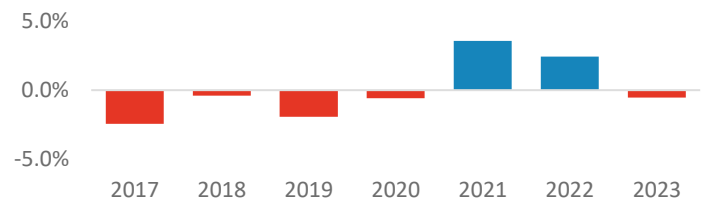


House prices in Redcar and Cleveland grew by 8.8% in the 12 months to March 2023 (based on 3-month smoothed data). By comparison national house prices grew by 5.6% and prices in the North East grew by 6.9% over the same period.

Redcar and Cleveland house prices are now 18.7% above their previous peak in 2007, compared to +15.1% for the North East and +57.9% across England.

Local prices have fallen by 0.5% in 2023 so far, compared to growth of 2.5% over the same period last year.

Year-To-Date Change in House Prices, December to March

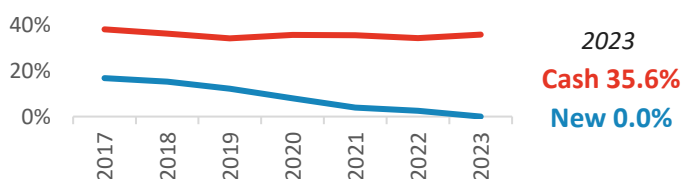


Transactions (January 2023 data)

There were 1,881 transactions in Redcar and Cleveland during the 12 months to January 2023. This is 62% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Redcar and Cleveland have fallen by 2.3% since 2014, compared to changes of -5.3% for the North East and -22.4% for England.
