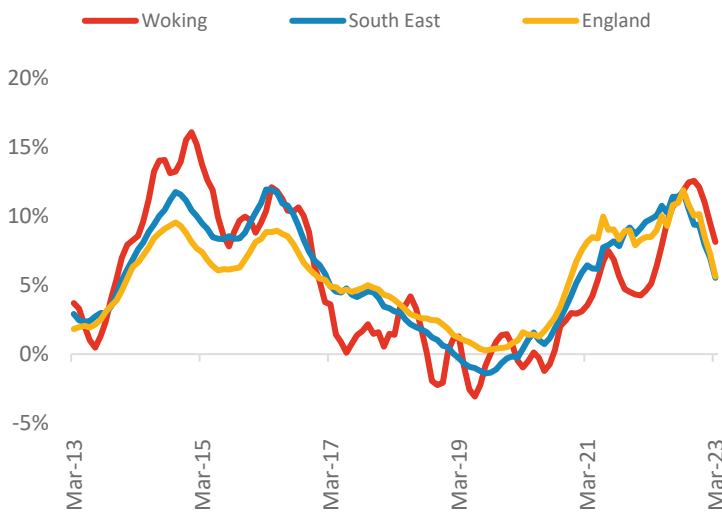

### House Prices (March 2023 data)

#### Annual Change in House Prices



House prices in Woking grew by 8.1% in the 12 months to March 2023 (based on 3-month smoothed data). By comparison national house prices grew by 5.6% and prices in the South East grew by 5.5% over the same period.

Woking house prices are now 65.9% above their previous peak in 2007, compared to +66.0% for the South East and +57.9% across England.

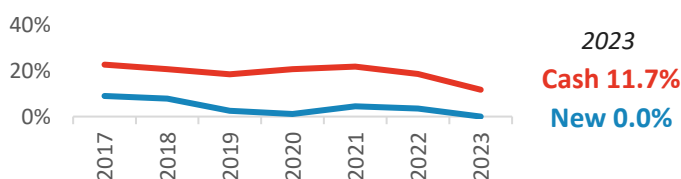
Local prices have fallen by 2.6% in 2023 so far, compared to growth of 1.0% over the same period last year.

### Transactions (January 2023 data)

There were 1,551 transactions in Woking during the 12 months to January 2023. This is 62% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Woking have fallen by 25.7% since 2014, compared to changes of -26.9% for the South East and -22.4% for England.

#### Cash and New Build Sales as % of Total, by Year\*

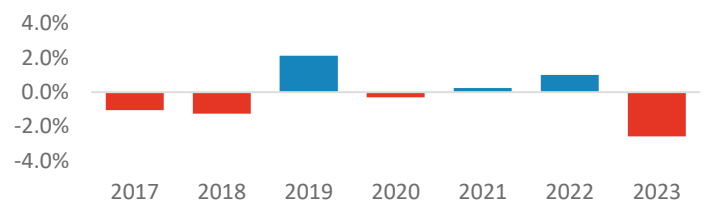
