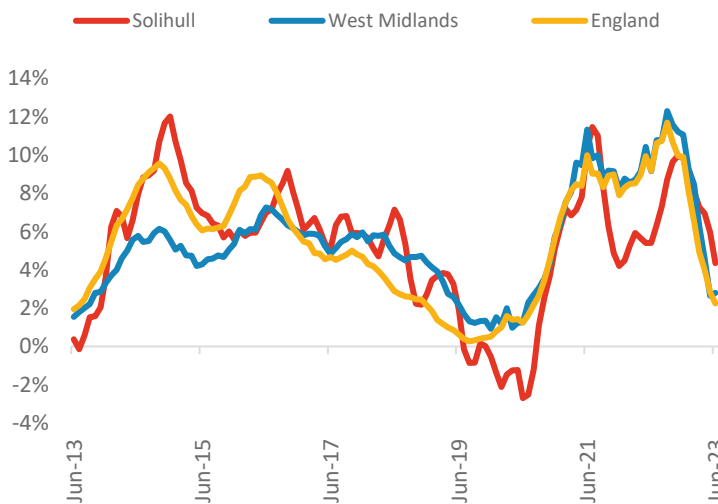

Annual Change in House Prices

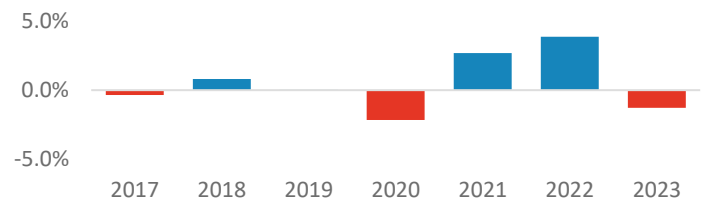


House prices in Solihull grew by 4.4% in the 12 months to June 2023 (based on 3-month smoothed data). By comparison national house prices grew by 2.2% and prices in the West Midlands grew by 2.8% over the same period.

Solihull house prices are now 52.6% above their previous peak in 2007, compared to +50.2% for the West Midlands and +56.6% across England.

Local prices have fallen by 1.3% in 2023 so far, compared to growth of 3.9% over the same period last year.

Year-To-Date Change in House Prices, December to June

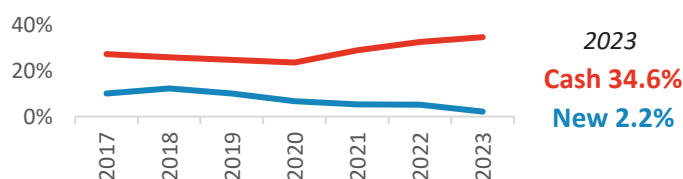


Transactions (April 2023 data)

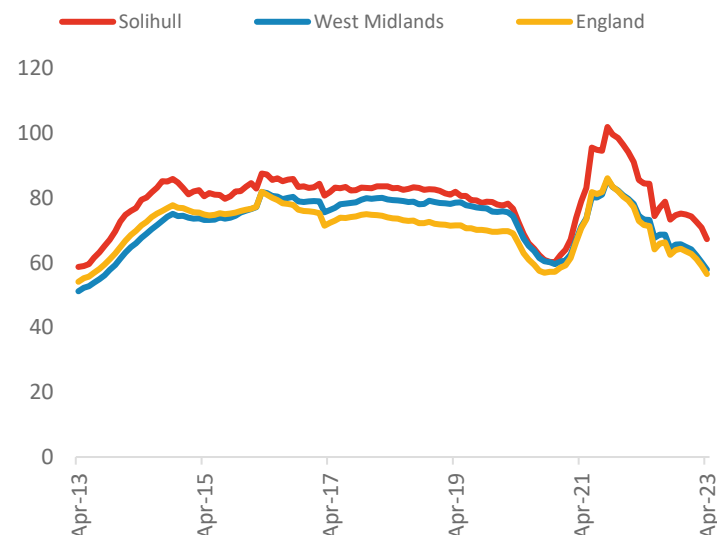
There were 2,851 transactions in Solihull during the 12 months to April 2023. This is 67% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Solihull have fallen by 19.1% since 2014, compared to changes of -22.3% for the West Midlands and -26.4% for England.
