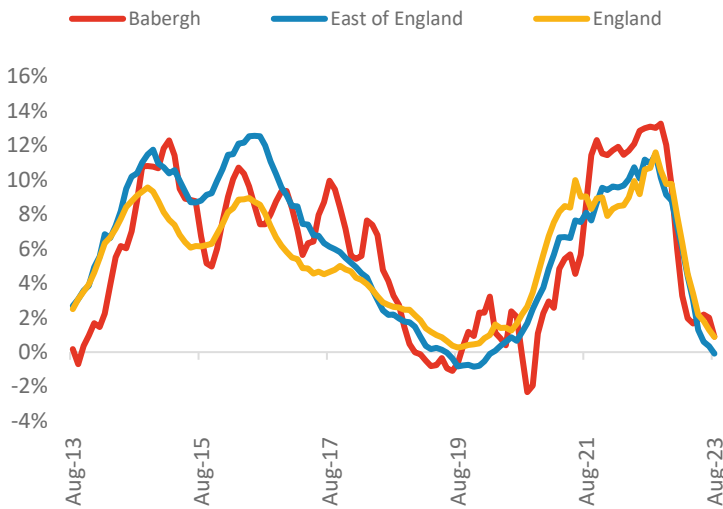

Annual Change in House Prices

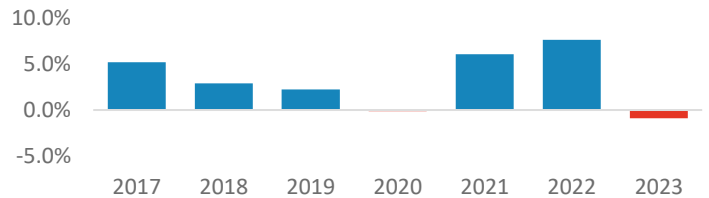


House prices in Babergh grew by 0.9% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in the East of England fell by 0.1% over the same period.

Babergh house prices are now 65.0% above their previous peak in 2007, compared to +67.9% for the East of England and +58.4% across England.

Local prices have fallen by 0.9% in 2023 so far, compared to growth of 7.7% over the same period last year.

Year-To-Date Change in House Prices, December to August

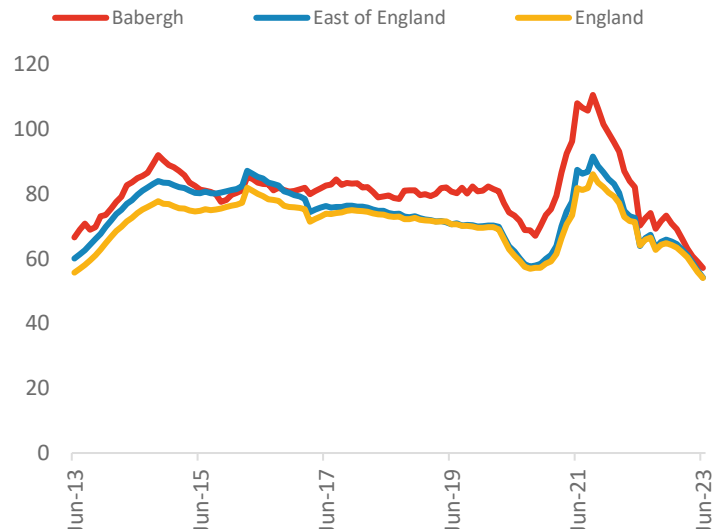


Transactions (June 2023 data)

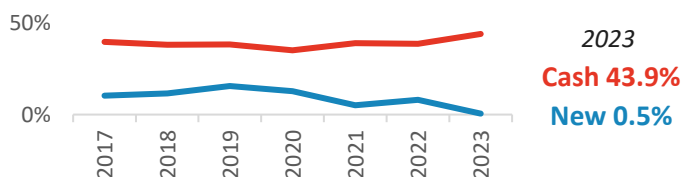
There were 1,058 transactions in Babergh during the 12 months to June 2023. This is 57% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Babergh have fallen by 35.7% since 2014, compared to changes of -35.0% for the East of England and -29.7% for England.
