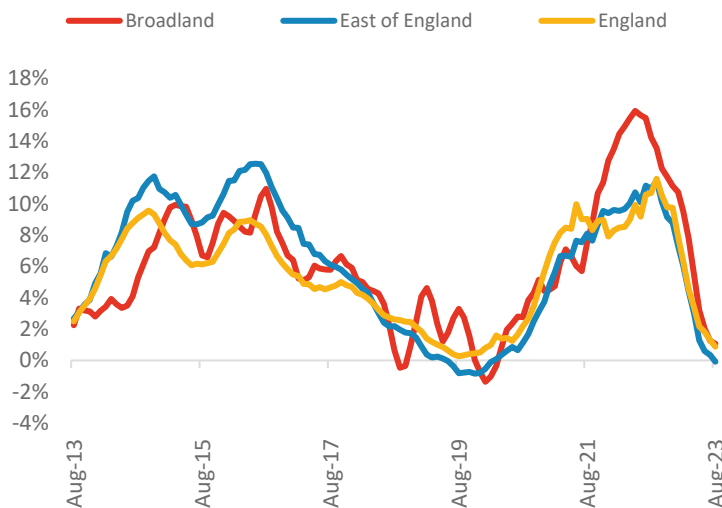

House Prices (August 2023 data)

Annual Change in House Prices



House prices in Broadland grew by 1.1% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in the East of England fell by 0.1% over the same period.

Broadland house prices are now 64.5% above their previous peak in 2007, compared to +67.9% for the East of England and +58.4% across England.

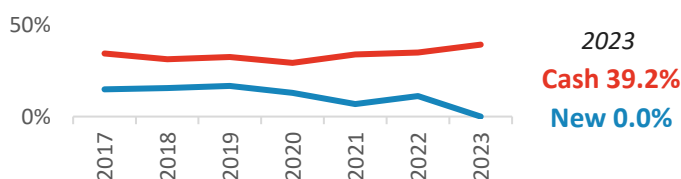
Local prices have fallen by 1.9% in 2023 so far, compared to growth of 7.9% over the same period last year.

Transactions (June 2023 data)

There were 1,757 transactions in Broadland during the 12 months to June 2023. This is 64% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Broadland have fallen by 23.2% since 2014, compared to changes of -35.0% for the East of England and -29.7% for England.

Cash and New Build Sales as % of Total, by Year*

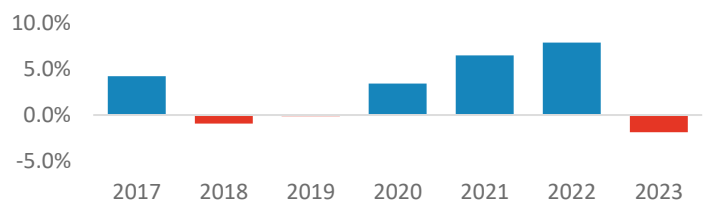
