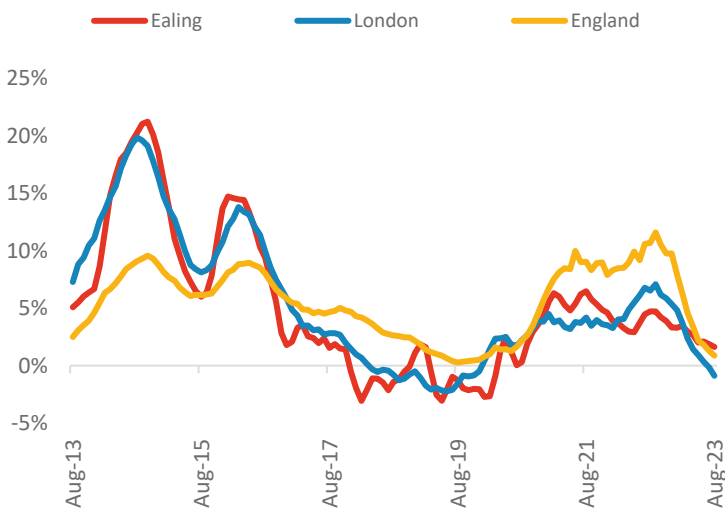

#### Annual Change in House Prices

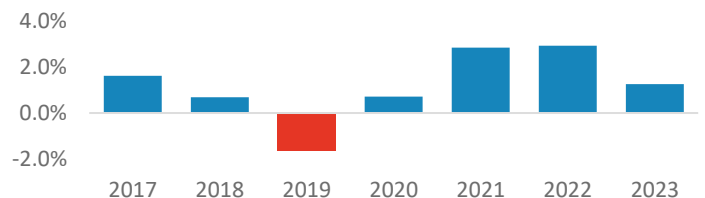


House prices in Ealing grew by 1.6% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in London fell by 0.9% over the same period.

Ealing house prices are now 74.2% above their previous peak in 2007, compared to +78.7% for London and +58.4% across England.

Local prices have grown by 1.3% in 2023 so far, compared to growth of 2.9% over the same period last year.

#### Year-To-Date Change in House Prices, December to August

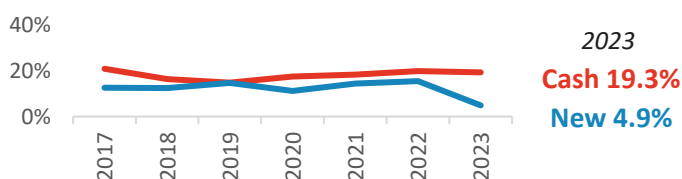


### Transactions (June 2023 data)

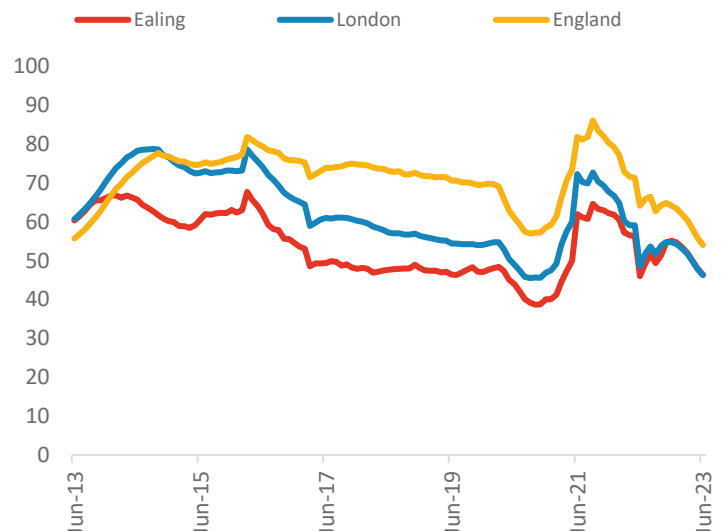
There were 2,704 transactions in Ealing during the 12 months to June 2023. This is 46% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Ealing have fallen by 22.8% since 2014, compared to changes of -39.6% for London and -29.7% for England.
