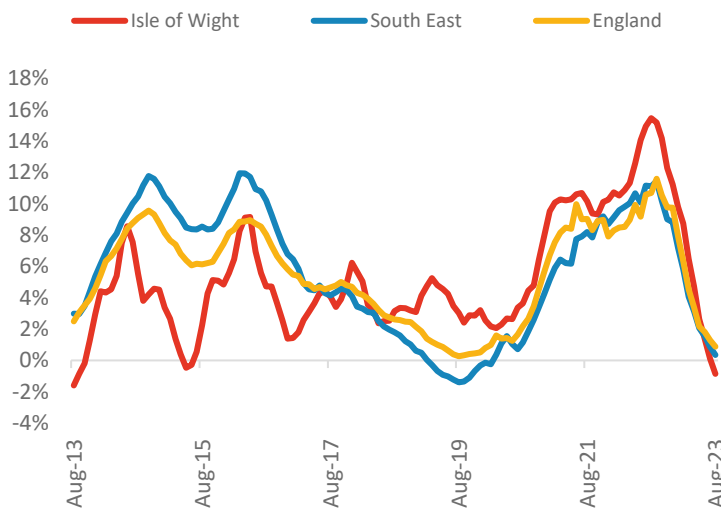

Annual Change in House Prices

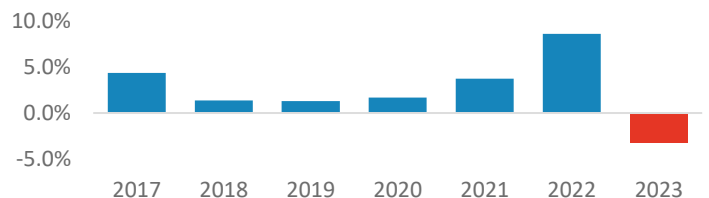


House prices in Isle of Wight fell by 0.8% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in the South East grew by 0.3% over the same period.

Isle of Wight house prices are now 46.4% above their previous peak in 2007, compared to +64.7% for the South East and +58.4% across England.

Local prices have fallen by 3.2% in 2023 so far, compared to growth of 8.7% over the same period last year.

Year-To-Date Change in House Prices, December to August

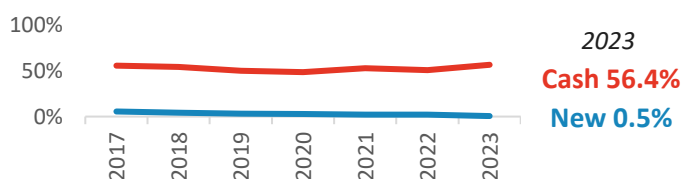


Transactions (June 2023 data)

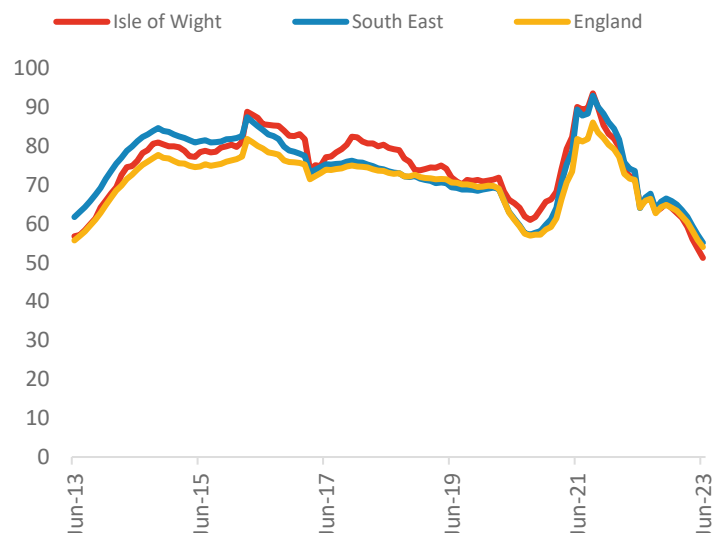
There were 1,981 transactions in Isle of Wight during the 12 months to June 2023. This is 51% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Isle of Wight have fallen by 35.9% since 2014, compared to changes of -34.1% for the South East and -29.7% for England.
