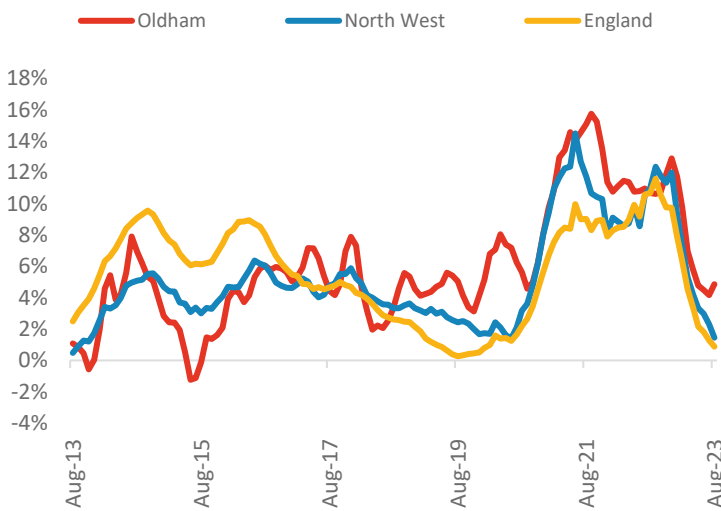

### House Prices (August 2023 data)

#### Annual Change in House Prices



House prices in Oldham grew by 4.9% in the 12 months to August 2023 (based on 3-month smoothed data). By comparison national house prices grew by 0.9% and prices in the North West grew by 1.5% over the same period.

Oldham house prices are now 49.0% above their previous peak in 2007, compared to +42.2% for the North West and +58.4% across England.

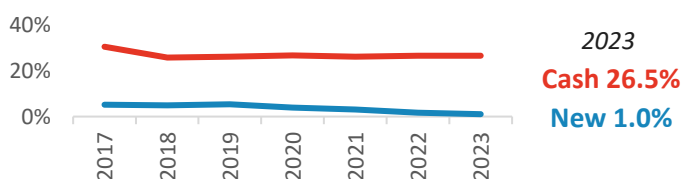
Local prices have fallen by 0.1% in 2023 so far, compared to growth of 7.5% over the same period last year.

### Transactions (June 2023 data)

There were 2,220 transactions in Oldham during the 12 months to June 2023. This is 48% of the average from 2001-05 and suggests activity is significantly below pre-downturn levels.

Transactions in Oldham have fallen by 15.8% since 2014, compared to changes of -19.0% for the North West and -29.7% for England.

#### Cash and New Build Sales as % of Total, by Year\*

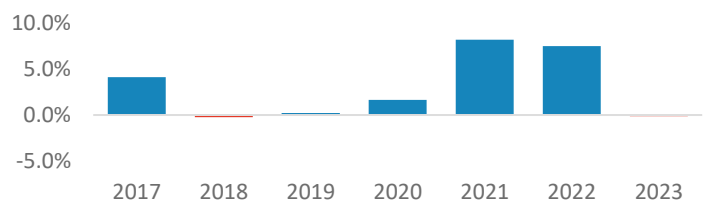
